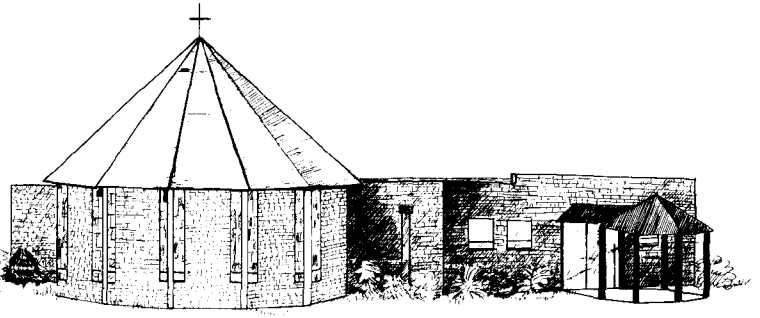

Your Grace,

My apologies for the manner in which I corresponded with you.
I realize that I didn't save any time after all.

I will try to explain our situation as clearly and as briefly
as I can. Last year we made a construction loan of \$50,000
for a period of six months. That period has expired. Now we
must make a permanent loan.

The banks position is that we must get your approval, the
Diocesan Council's approval and also an approval loan. The
same kind of approval that was required for the construction
loan. These matters must be taken care of by the end of this
month.

We have committed ourselves to expenditures of \$200,000 at
this time. \$150,000 has been collected to date and \$10,000
is still outstanding. We have approximately \$17,000 in the
building fund. This \$17,000 will enable us to finish more
inside and outside work on our structure. The \$50,000 we in-
tend to borrow will cover our immediate debts.

Enclosed you will find a copy of the minutes of the special
assembly and also a copy of the projected budget for the next
six months.

I hope I have been clear. And I hope you will be able to ex-
pedite this matter at your earliest convenience.
