As requested at your pastoral visit to our Parish last month, I have obtained some information regarding the status of St. Henry's Prep Seminary located in Belleville.

As I explained to you, the Seminary has closed its doors as a religious educational institution. The owners of the property, THE CENTRAL UNITED STATES PROVINCE OF THE MISSIONARY OBLATES OF MARY IMMACULATE, have appointed a task force to consider the Province's alternatives with respect to the property.

The Task Force has prepared and I have enclosed Exhibit "B" -Pre-Application for Utilization of St. Henry's Property and Facility. If you believe that the governing Board of St. Nerses Seminary is interested in making further inquiry, Exhibit "B" should be completed and returned to:

I recently spoke with Father Ferguson, a member of the Task Force, regarding alternatives the Province may be considering. He explained that the Task Force has three levels of priorities with regard to the use and/or disposition of the property:

- 1. Alternative uses within the Province or related missionary groups.
- 2. The sale of part or all of the property to other church bodies.
- 3. The sale for commercial development.

Father Ferguson intimated that an offer of \$500,000 by a church body might be roughly equivalent to an offer of \$1.5-\$2.0 million by a commercial developer. Therefore, I believe that the governing board of St. Nerses or perhaps even the Diocesan Council should give serious consideration to the possible use of St. Henry's Seminary in meeting the needs of our church for the next several decades.

I also enclosed a brochure which includes an aerial photograph of the 50-acre seminary. Please note that the description of the buildings is from my recollection and I am not certain as to its accuracy.
