

At the recent special assembly the Parish Council was directed to formulate a voluntary contributing program for the purpose of meeting the monthly mortgage payments and also to help meet the additional costs of maintaining our new church complex. This program should be on a regular weekly or monthly contributing system. This is very important.

We have a list of about 50 families and/or individuals who we think will participate in such a program. Assuming that all of them participate, the average contribution per person or family would be about \$20.00 per month. Some will voluntarily give more and others will give less. Your Excellency:

This is to advise you of a situation which occurred after a successful Parish Assembly meeting on January 27 being conducted as you had directed. There was some disruption from non-members and non-active members, though minimal. However, following is what transpired after the meeting:

A parishioner who had just had Hokehankisd said asked Hayr Sooren about the manner in which he performed the service. He immediately pointed his finger at a choir member (me) and said that he had told the choir to do this and we had "defied" I answered him by saying that he had never told the him. choir to do this. I'm sure other choir members will avouch to this. He then said to me, "You lie like you drink water" and then pointed to my husband who is a Parish Council member and said, "I told your husband this in a Parish Assembly meeting, too". I want to point out to you that Hayr Sooren has not participated with the choir at all this year until he had to for Christmas service; and then he only started two weeks before. We have had no other assistance from him. He has said that there can be no choir practice because we have no organ or piano.

This incident, alone, did not precipitate the chaos that occurred, however, due to the fact that everyone's feelings and emotions were high, everyone started yelling and the group was in complete disorder. The main point is that Hayr Sooren, after what he said, left in the midst of all this and could not be found. He did not attempt to calm down anyone or correct the damage he had done. He disappeared, later to be found hiding in the car of a nonmember of the church.

The primary purpose of this letter, however, is to implore you to send your emissary at once to attempt to resolve the obvious serious situation created by outsiders of the church. Also, we feel someone should be present -- preferably Your Excellency -- at the next Parish Assembly meeting scheduled February 17. This is imperative. We have worked too long and hard to allow non-members and nonactive members to create this situation in our church.

The reason I'm reporting these events is to stress the urgent need to settle this problem quickly. The sooner our problems are resolved, the better it will be for Hayr Sooren and for our parish.

Our Parish Assembly is set for February 17. We respectfully urge you to be present or send a representative before this date.



Your Eminence:

We have always considered ourselves fortunate that the financial improprieties and moral lapses that have become so evident in the Protestant Christian churches have not occurred in the Armenian Apostolic Church. However, we were recently shocked to see a situation with one of your clergy that we regard at the very least as an ethical impropriety.

Mrs. Vartanoush Vartanian of Belleville, Illinois, recently died at the age of 85. We are her closest relatives. She has been in declining health and mental awareness for several years. Father Gregory Kasparian helped greatly during these years. He has counseled her, kept us informed of her condition, and in this last year, took over the management of her financial affairs.

We are greatful for his help; however, we were shocked to discover after the funeral that our aunt, Vartanoush, named Father Kasparian as the sole beneficiary of her estate. In our discussions with Father Kasparian after the funeral, we discovered that in 1986 she declared her intent to Father Kasparian to leave him all of her estate; that he fully knew the provisions of the will; and in 1987 he even took her to a lawyer to redraft the will in legal form.

We have no objection to our aunt leaving her entire estate to the church. We strongly object to Father Kasparian permitting her to leave her estate to himself. It seems patently evident to us that in order for a priest to lead his congregation morally, his actions must show moral and ethical correctness. Ethical correctness for a priest must stem from duty, religious conviction, and love, not personal benefit. If a priest assists parishioners for his own personal gain, where does someone turn for moral guidance?

We know this matter will concern you as much as it does us. We also would appreciate knowing what actions you have taken to insure this situation does not occur again.
