DEAR SURPAZHAN HAYR, UNTIL THIS POINT IN TIME I HAVE FELT IT UNNECESSARY FOR ME TO ADD FURTHER TO ALL THE COMMUNICATION YOU HAVE BEEN RECEIVING FROM THE HOLY SHUGHAGAT PARISH. AFTER TODAY'S HAPPENINGS, HOWEVER, I CANNOT IN GOOD CONSCIOUS CONTINUE MY SILENCE. SURPAZHAN HAYR, I WAS AND AM APPALLED BY WHAT I WITNESSED AFTER OUR SPECIAL MEETING THIS AFTERNOON. TEMPER FLARED, ARGUMENTS ABOUNDED, AND HAYR SOORP DID NAUGHT TO STOP ALL OF THIS. IN FACT, HE HELPED INCITE THE SITUATION TO THE EXTENT OF TELLING A CHOIR MEMBER "YOU LIE LIKE YOU DRINK WATER" AND THEN HE DISAPPEARED FOR A WHILE. HE WENT, INCIDENTIALLY AND SAT OUTSIDE WITH SOMEONE IN A CAR. I LOOKED FOR HIM IN VAIN INITIALLY AS I WANTED HIM TO VIEW WHAT HE HAD CAUSED. I FOUND HIM AFTER ALL HAD SUBSIDED. SURPAZHAN HAYR, I HAVE BEEN AMAZED BY THE MISREPRESENTATIONS THAT HAVE RESULTED DUE TO THIS MAN-A MEMBER OF THE CLERGY. WE WORKED SO HARD TO GET WHERE WE ARE, AND THIS MAN HAS COME IN AND CAUSED TOTAL CHAOS. I KNOW HOLY SHUGHAGAT WILL SURVIVE, BUT WHY NEED WE ENDURE THIS DISENTER AND WHY SHOULD YOU BE BURDENED WITH THIS TYPE OF SITUATION? MY REAL REASON FOR WRITING IS TO EMPLORE YOU, SURPAZHAN HAYR, TO HAVE A REPRESENTATIVE OF THE DIOCESE PRESENT AT OUR FEBRUARY 17 PARISH ASSEMBLY TO HELP AVOID ANY FURTHER CONFRONTATIONS. I AM SORRY TO HAVE TO BOTHER YOU, BUT I FEEL WE HAVE AN URGENT SITUATION HERE. MAY THIS FIND YOU IN THE BEST OF HEALTH. HOPEFULLY, 1980 WILL BE AN EXCELLENT YEAR FOR US ALL,

WE ARE ACTIVE DUES PAYING MEMBERS OF HOLY SHAGHAGAT AND ARE CONCERNED ABOUT THE SITUATION HERE. WE ASK THAT YOU PLEASE SEND SOMEONE HERE TO LOOK INTO IT AND PLEASE HAVE SOMEONE PRESENT AT OUR PARISH ASSEMBLY ON FEBRUARY 17TH. OUR ACTIVE MEMBERS HAVE PUT IN TOO MUCH TIME EFFORT AND MONEY TO HAVE A "CONCERNED COMMITTEE" CRITICIZED PARISH COUNCIL ACTIONS AND TO QUESTION THE USE OF FUNDS BY THE COUNCIL AND ARCHITECTURAL COMMITTEE.
