SHLIMOVITZ October 26. 1960 Diocesan Council of the Armenian Church of America 630 Second Avenue New York 16, New York Gentlemen: I pray your indulgence and hope that you can devote a few moments to this, my voice to you, relative to the Church Building program you have authorized in the Greater Milwaukee Area, more particularly, the building in South Milwaukee, Wisconsin. It is difficult for me to comphrend, how with any business acumen, the council has authorized the building of such a new church without first determining the minimum financial requirements necessary for such an undertaking, the outstanding amount of a mortgage or funded debt and the method of amortizing payment of same, the submission of construction bids from various contractors, the amount of assessement per member for the initial financing, etc. . These requirements are set forth in the Constitution and By-Laws of our Church and are the orderly criteria for the council to determine in its own judgment not only the necessity of a new church in the area, but the probability of its success as well. I am sure that I need not supply the council with facts, which the writer feels sets forth a strong case against such an undertaking, however, it is necessary that someone answer these facts. The very fact that this area attempts to maintain two churches for a total congregation of three hundred is sheer idiocy. The fact that the purported land site is only 90 x 120 feet, an area hardly suitable for a single family residential structure without any available land for expansion is in itself imprudent. The fact that the congregation can afford only a part time Hayr Sourp should persuade a reasonable man to seek logical alternative means. It is further evident that within a period of ten years the churches in this area will be bankrupt, and NO ARMENIAN CHURCH will exist; a wise man would determine what are the available means for creating solidarity not disunity, if we desire our Church to exist for all times. Yet in total disregard of such obvious liabilities, the council has authorized the construction of such a church in South Milwaukee. I strongly question this judgment, gentlemen, for you cannot escape your responsibility to the present generation or to that yet unborn merely by saying "Well a majority of the South Milwaukee congregation desires it this way, and

our hands are tied." The Constitution of our Church places the responsibility of the final determination of such acts squarely upon the Council, the Board of Trustees and the Archbishop. Gentlemen, you as the spiritual and intellectual pillars of the Armenian-American communities are the fact finding and policy making body, and it is your determination and judgment which will live, and I regret, in the instant matter be living chaos until its death.

I cannot with human judgment place the fault upon the South Milwaukee Congregation, for in their limited way, they have acted in accordance with their emotional and personal feelings, without thought of the realities of today, without thought of the needs of tomorrow and without thought of determing a better way. As an unattended flock they have wandered aimlessly.

You as the shephard, cannot with a clear conscience say we shall concur with their judgment in light of the facts. You cannot in accordance with your acceptance of the oath of office, follow such judgment without being in complete dereliction of such an oath. You may with complacency, say that we in New York have a limited duty to those in Milwaukee. If this be your attitude, as is indicative of the failure of any of the council members to view the site in question, I beg of you to resign.

Yes, these are strong words, but gentlemen, I say as the present political aspirants to the United States Presidency have stated- These are critical years that lie ahead, and our existence tomorrow shall be measured by our actions of today.

The question whether we as a National Church and a ethnic group are to survive is to be resolved upon this generations positive and prudent acts, and gentlemen, upon you, its leaders.

If I am being outspoken, it is because of error being committed upon the entire Armenian-American community in this area.

If I may be of any assistance in this matter, please inform me.
