Greetings!

As a trustee during last year, I did my part-my share of work-in caring the yard, shoveling snow, sweeping and mopping the floor, varnishing the windows, taking inventory, caring the Parish House and participating in other jobs whether small or big, whether routine or unusual.

Even better than above aggregate services rendered by me was my composite stand and vote on fundamental policies and issues, notably on the Parish House composition and control. (Thanks to the General Assembly for sustaining my stand on January 18.)

Because it was verbally stated in the Assembly and before the Council that the treasurer could not be blamed for certain drawbacks inherent in the bookkeeping system used, I volunteered last Wednesday to remedy the situation.

Based on my specialized education, broad training and diversified experience as a Bookkeeper and Accountant, I promised then to setup a new system whereby succeeding treasurers could easily follow in rendering good service.

Yes, I pledged in so many words to rectify the defects if any, to improve it where possible. I promised to issue monthly statements. Despite my avowed willingness to provide such professional services so urgently needed, to my utter astonishment I was not even nominated as a treasurer, let alone being elected.

Consequently, I deem it proper and right, especially so in view of past episode to cust me from the Parish Council, to tender my resignation effective now.

In general truth, this resignation did not wholly stem from withholding the office I sought. That matter merely bears the same analogy as this proverbial saying: "The straw that broke the camel's back."

Fundamentally, this resignation is a protest against the dearth and deficiency of Christian attitude among some members of the Council.

Frequently, positive and constructive results emerge from negative actions. It is hoped that this resignation is used as a catalyst to increase and to augment Christian attitude of love, of consideration, of fairness.

One thing each one of us needs to keep in mind and in heart is this Biblical injunction: "Except the Lord build the house, they labor in vain that build it (Psalm 127:1). In other words, to merit God's blessings in any kind of upright undertakings, we need to have the right attitude and policy, coupled with concerted effort.







Your Eminence:

Following the receipt of the copy of your recent letter addressed to the Parish Council of the Holy Resurrection Church of South Milwaukee, I discussed the situation with Father Arshag Khatchadourian, President of the Parish Council, twice by telephone and once in a face to face conversation between Nov. 25 and Dec. 3. Not having received any notification as to the compliance of the Parish Council with your directive, I took the initiative of sending on Dec. 4 a personal note to Parish Council chairman Mr. Gil Jandegian, suggesting that he and I have lunch to discuss your letter. Mr. Jandegian telephoned me on the morning of Dec. 8, suggesting lunch in Milwaukee the same noon. As I had planned a trip to Milwaukee for the same afternoon, I accepted Mr. Jandegian's invitation and drove to his place of business.

Mr. Jandegian did most of the talking during lunch, but gave me a chance to state that in the hierarchical system of our church life it was the duty of the Parish Council to carry out your instructions. I agreed that it was to be painful, just like surgery is when it is necessary in order to restore a patient to health. I expressed to him my dismay at the arrogance displayed by Mr. Charles Kadamian of his Parish Council at the regional meeting held under your presidency at the St. Mesrob Church on Oct. 31.

Mr. Jandegian's objections are:

- a) The Parish Council whose chairman he is represents a team. If the majority of its members are to be dropped in accordance with your directive then he and Mr. Barsam Barsamian should be dropped, too.
- b) No clear answer or explanation has been given to the Parish Council on behalf of the Diocesan Council relative to the assessment amount set for the Holy Resurrection Church. Mr. Jandegian charges that his parish, with less members as compared to St. Mesrob Church of Racine, is obligated to pay higher dues to the Diocese.

When we parted, I suggested that Mr. Jandegian use his leadership position to see that the crisis developed between his parish Council and the Diocesan Council is resolved in a peaceful and right manner.

As I write this, I have not had a chance to inform Father Arshag of my private meeting with Mr. Gil Jandegian.

If I can be of further help in this matter, please advise.

We reviewed the minutes of your recent parish assembly, and noted that unacceptable liberties were taken with voting procedures.

First, the auditing and nominating committees were elected with a show of hands, whereas their election should be by secret ballot. Did not the previous nominating committee present a slate for these offices to the assembly? In any event, it was improper procedure.

Secondly, it is also improper for a member of the parish council to serve on the auditing committee. The purpose of the auditing committee is to examine the accounts of the parish council. How can parish council members, therefore, be given that responsibility?

We direct that a new assembly be convened as soon as possible for the express purpose of holding elections for these two committees; and that the previous nominating committee be charged with preparing slates of candidates for both committees for presentation to that assembly which will, by secret ballot, elect the parish's nominating and auditing committees for 1976.

Meanwhile please send us the names and addresses of the new officers of your parish council as soon as possible, if this has not already been done.

Dear Father Arshag:

We can appreciate the concern expressed in your letter of March 15, and we agree that the situation in the midwest can conceivably be a trying one because there are so few clergymen in service there.

Still, with respect to your parish, two considerations should be kept in mind.

First a visiting priest generally spends only Sunday, and at most another day in the parish being visited, and is in his own parish the rest of the same week. The amount set as a stipend for a visiting priest was arrived at accordingly.

Second, it is not mandatory for you to visit other parishes on a rotating basis. You can visit the neighboring parishes as often as is reasonably possible, even if that amounts to once a month. If you deem it best, you can remain in your parish for three Sundays a month and visit on the fourth, and rotate that fourth Sunday among the parishes you intend to visit. Your first responsibility is to your own parish.

We ask only that you do your very best to accommodate the other parishes, jointly with the other clergymen in the area, after the minimum needs of your own parish are met.
