Dear Mr. Nabedian:

In reply to your letter of May 10, 1961, we would like to inform you the following:

1. Whenever a church is built, customarily sixteen consecrated stones are placed in the foundation. The corners and under the beams, and then the foundation and cornerstones are blessed. Therefore the consecration takes place after the completion of the building.

In order to sanctify the entire building to make it the house of our Lord, and a place of worship, the stones, beams and altars are consecrated together. Therefore the blessing of the cornerstones and the consecration of the entire church does not take place at the same time.

2. We are planning to visit your Parish on July 1st and 2nd, and, since your parish is without a priest, we feel it necessary to inspect the building and bless the cornerstones.

We shall discuss the other matters mentioned in your letter, in person. During our stay in that area for a period of one week, we shall also visit the nearby parishes. The expenses incurred in this connection will be shared by the respective parishes.

Hoping that your Parish Council will make the necessary arrangements, in this connection. We wish you success and the blessings of our Lord.

Your Grace:

It was quite a rewarding and illuminating experience for me to have attended the 1961 Annual Diocesan Assembly in Boston on April 29 and 30. Above all it gave me an insight into the many, many problems that beset our diocese and its clergy. In spite of the almost insurmountable problems it was encouraging to note that we have many who are dedicated in both speech and action. May God grant Your Grace continued health, wisdom, and infinite patience in the years to come in the conduct of Your Office and its burdensome responsibilities.

As Diocesan Delegate of our Church, I reported to our Parish Gouncil on the salient points discussed in our meeting. That one foremost in their minds and mine is the need for a priest in our parish. As indicated to me by Your Grace during our Assembly we welcome your consideration in assigning one of the six seminary students as pastor of our Church. Our Parish Council Chairman is writing Your Grace in this regard officially requesting assignment of a priest.

I realize that there are many parishes that are in dire need of a dergyman. It is my fervent hope that the loyalty and dedication that our parish has shown to Your Grace and the Diocese will permit Your Grace to give our Church first consideration. If a priest were assigned to our parish we would make arrangements to share him with the South Milwaukee parish. With the combined parishes, a priest assigned would have a Christian flock of nearly 250 families.

It is with deep respect to Your Grace and to His Office that I ask for forgiveness if I appear to be obstinate in presenting our story to the Diocesan Assembly, but it was only with the aim of serving our Church and its Christian flock, who are in dire need of a "shepherd". If Your Grace would deem it necessary I humbly would appreciate comments in reply.

Most Reverend Sir:

May I express the wish that my letter finds you well and in the best of health.

Regarding your last visit to our church at which time you graciously arbitrated our problems, I find it necessary to report to you on that matter.

I have been successful in my efforts with various groups in the congregation, in affording Rev. Nerses an opportunity to start anew without bias or complaint.

The one group that spoke loudly in his behalf is now absenting themselves from all activity and apparently are boycotting us.

The complaining group has been magnificent in their cooperation and have advanced to the trustees financial sums which enabled us to pay a majority of all debts and to forward to the diocese a greater part of its due, which you now have.

The general meeting of January 21, was successful and without incident. Rev. Nerses is forwarding the names of the new Trustees with the Annual Report, which I have signed, but have not read, my signature is with reservation.


Rev. Nerses apparently has convinced himself, that any effort on his part will be fruitless, and now has adopted an attitude of withdrawel of co-operation which was very apparent at our last trustee meeting.

The problems he is creating are minor and trivial, and are remenecent of the attitude that precipitated your last visit. I fear we will have the same problems. Further I feel that since his family has withdrawn from all church activities and his various friends boycott us, it will be impossible that any harmony of any type to return to this congregation. At best we will loose at least 1/3 of the membership. Since you now are in process of re-aligning the priests in this part of the county, please consider our parish in this re-alignment.

I feel apprehensive about our building programs and our various projects will suffer.

The foregoing are my personal views. I have considered all possible means of alleveating this situation, and I honestly feel the Reverend's pride has been too badly hurt for him to remain here and to be of any value to us.

Your Grace:

During your recent visit, we discussed with you at great length the possibility of obtaining a full-time parish priest. You indicated that this was not possible at the present time. It was suggested by you that we keep Father Hairabedian as a part-time parish priest (three days a week) and that when a full-time priest was available, he would then replace Father Hairabedian.

As requested by you, a Parish Assembly Meeting was held on 1968 at which time the parishioners were to decide whether or not they wanted a part-time or full-time priest. After a great deal of discussion, a vote was taken. The result was: 24 in favor of a full-time and 20 in favor of a part-time priest.

Father was present throughout the entire meeting, and after the result of the vote was announced, he then stated that he was pleased with the decision because he truly wanted to devote more time to his missionary work and this enabled him to do so.

On June 3 during a regular Parish Council Meeting, the following information was revealed by Father Hairabedian quite unwilling and after much prodding:

- 1. He has purchased a home in South Milwaukee.
- 2. He says he will work three days a week but will not reveal what type of work he has obtained.
- 3. He will spend two days a week on missionary work with meetings to be held in his home.
- 4. On Sundays he would like to become a visiting priest and be available for different parishes.

In regard to Item No. 4 above, the Parish Council voted in favor of Der Hayr performing Sunday Mass for the four Sundays in July only, for which he agreed to do for \$75.00 per service, which is quite a large sume for 4 hours.

You must agree that the first and only solution to our problem is a full-time priest. If this cannot be done immediately, we feel that you should help set up a schedule for the few parishes in our vicinity to share a clergy --- but not just for 4 hours on a Sunday morning.

In closing, we would again stress the fact that a parish of our size and a mortgage to meet, its youth to train, and its various obligations to the Diocese, will require a leader who is available at all times --- not merely 4 hours each Sunday.

Your Grace:

At the Council meeting of the Holy Resurrection Armenian Church here in South Milwaukee held on Wednesday June 4, 1969, a motion was passed, instructing our priest to write you whether I should remain a member of the Council of Trustees or not because I did not abide to a decision of the Council passed last April.

That decision arbitrarily dictated that the Parish House Committee surrender all money and books to the treasurer of the Council so that all sources of money could be deposited to one account and all records could be kept at one place. The Parish House Committee of which I am also a member did not abide to that dictatorial dictum for these reasons:

1. Parish House Committee came into existence last September when its three members volunterred their services for a year before the general assembly meeting. Accordingly, the Committee was and is accountable only to the General Assembly.

2. The Council's action was tantamount to making the Committee members mere errand boys without authority and discretion.

3. The Council is immersed with ample obligations and duties without assuming additional responsibilities.

4. Had the money been surrendered to the Council and became commingled with all the rest of the money, there would have been a definite tendency to spend the money on some unnecessary items or for some less worthy purpose or for meeting ordinary operating expenses.

5. The Committee knew that the Congregation still owed your Diocese \$4000 which was promised to be repaid by September of 1969. So, by resisting the Council's move, the Committee made it certain that this Church's indebtedness to the Diocese would at last be paid-off fully on or before September.

6. The Parish House was purchased from money taken out of the Building Fund which is still "independently" chairmanned by Charley Kademian. So, the Committee deemed proper and necessary that any income derived from the rental of the Parish House should go back to the Building Fund so as to pay-off the aformentioned debt.

7. The Council flouted democratic processes. It used dictatorial method of action. It was arbitrary in its move. The Council did not even show semblance of courtesy and consideration by issuing its dictum without formally inviting and hearing the Committee's viewpoint.

8. The operation of the Parish House is systematically organized. The Committee has a checking account and a saving account. Every cent is vouched and accounted. This was substantiated by the Auditing Committee. Had we of the Parish House Committee yielded to the edict of the Council, this close accountability would have been jeopardized and undermined.

9. The Committee's action prevented the raid on this "extra" source of spending money.

10. By our withholding the rental money from the grabbing hands of the Council, the trustees will have greater opportunities to exercise more initiative, effort and ingenuity to raise additional money to defray anticipated expenses.

11. As a member both in the Council and in the Committee, I have <u>dual</u> responsibilities. By performing my duties as a Committee member, the disintergration and obliteration of the Committee as constituted and represented was "prevented."

12. The Committee's stand signalizes and sustains the functional strength of various committees which in reality perpetuate the healthy atmosphere by which the Church retains its vigor.

For the above reasons and conditions, it is incumbent that I be sustained and retained on the Church Council of Trustees.

This is a supplement and corollary to my yesterday's letter.

On July 2 the Council of the Holy Resurrection Armenian Church here in South Milwaukee willfully and incorrectly "abolished" that Parish House Committee which derived its existence and power from the Parish General Assembly. After this unsavory action, the Council immediately selected another committee composed of three trustees.

(To obviate confusion, the original Parish House Committee will be designated in this letter as Assembly Committee and the new parish house committee as Council committee.)

The disputed action of the Council was contrary to the interest and by-laws of the Church in these aspects:

The Council depended on mere hearsay that two Assembly Committee members had resigned or were about to resign as a pretext to appoint its own committee. Despite my willingness to remain on either committee, the Council excluded me from my rightful post.

All the three selections on the committee were made by the priest on the spot and had the Council confirm his appointments. Such method of selection is wrong and therefore null and void. It is like having the jury, judge and attorney as one and same person.

Had the Council been fair in its motive and outlook, the least it could have done from the standpoint of justice would have been retention of my membership and the appointment of two other nontrustee individuals as it was originally composed. Now there is conflict of interest.

The Council's action is a direct affront to the Parish Assembly before which the original Parish House Committee members voluntereed their services for a period of one year.

It is ironical and incongruous in the nth degree that on one hand the Council hopes to oust me from the Council itself and from the Parish House Committee because I for one transferred the rental money to the Building Fund rather than giving to the Council, and on the other hand when the Council was informed by me that the Building Fund balance had reached the needed goal of \$4000 due to the two deposits made to it Primate Manoogian

by the Assembly Committee, the Council went on record that the \$4000 indebtedness to your Diocese be settled on the occasion of your visit with us at this weekend.

In the light of above facts, I do not recognize the Council's ill-formed committee. I still regard myself as a member of the Assembly Committee which is still trying to function.

Accordingly, Your Grace, for the good of your office, for the benefit of the Church and for the direct and indirect well-being of all auxiliary and various church committees that you declare the Council's committee to be null and void and that the Assembly Committee is still in existence and functioning with me as a member.

Welcome to South Milwaukee. You can now set the Council of Trustees on the <u>right track</u> in the course of your visit here.



Dear Surpazan Hayr:

The Parish Council in their regular meeting No. 17 held on November 5, 1969 considered this matter very carefully and voted to inform you of the important situation existing here in South Milwaukee regarding Father Krikor Hairabedian.

Father Hairabedian has recently resorted to methods which are interfering with the regular duties of our parish priest. For example, when he was officially the priest of this Church, he made it a policy never to visit the sick unless he was personally notified by a member of the <u>family</u>. However, now he is visiting the ill without any knowledge of the family and without invitation. This is causing embarassment to our Hayr Soorp.

Also, he is now actively holding Bible class studies in his home, which practice we basically approve. However, the Trustees feel this should not take place in his home, and the proper place is here in the Church Hall. Some of our members are attending these classes, and we are afraid that a problem can be created between them and the non-participants, as has occurred in the past.

We beg you to consider this matter and take whatever steps you feel necessary so that in the end our Church will not suffer.


Due to increasing costs both at Holy Resurrection Church and the Diocese it would only be fair and reasonable that Holy Resurrection be re-imbursed for actual costs.

Your letter, dated December 23, advises us that our outstanding obligation with reference to our 1974 assessment shows a balance due of \$4,531.70.

Your letter, dated December 18, informs us that the assessment for our parish, in 1975, has been established at \$4,025.

We would like to point out that the assessment, in 1973, was \$1,992, to which was added an \$800 steward quota.

The same assessment, in 1974, was \$2,420, plus the \$800 steward quota.

As you are well aware, we paid our assessment of \$1,992 in 1973 but did not pay the steward quota of \$800. The \$800 for 1973, we understand, was added to the 1974 amount.

We have reviewed the minutes of the 72nd. Annual Assembly Meeting, held in May, 1974 which, in our opinion, shows gross inequities as related to the parish assessment schedules.

A church of our very small size cannot survive with assessments, as proposed. It does not help to tell us that this amount is required, and needed; nor does it help to state that the assessment schedule was approved in the annual meeting.

You can hardly expect us to accept the fact that the two votes we are entitled to cast at the annual meeting, can, in any way, influence an assessment schedule.

We have always been proud of paying our assessments on time, over the past 50 years. However, we now find that the amounts being asked of us are totally unreasonable and, therefore, do not intend to pay. Our first concern must be for the welfare of our own community and, at all costs, the responsibility of the trustees should be that that community and its' church survive. [continued on Page 2] We regognize that costs have gone up. We see this in the needs of our own church so we don't have to be convinced that the costs at the Diocese have increased as well. However, unless a more fair and equitable area of assessments is arrived at we can only sympathize with your needs and will be unable to make any payments towards your costs.

We have great difficulty in collecting the dues now assessed to members of our congregation, with several not paying their full amount and others arbitrarily deciding to reduce the amount expected from them.

For you to continue to send us notices, indicating the amount past due and the amount due in future years will accomplish nothing.

We ask that you review the entire matter and consider what we feel would be fair and equitable, namely \$2,000 per year.

We would be willing to pay the above amount, in full, for 1974, provided we receive your written assurance that this amount will be considered acceptable and would represent payment, in full, for our 1974 obligation and that our 1975 obligation will also be \$2,000.

Our annual meeting for the election of trustees will be held on Sunday, January 26. Your reply, by that time, will be greatly appreciated.

We, at Holy Resurrection, feel that the most equitable arrangement for parish assessments must be based upon the number of members at each parish. This is universally accepted in many societies and institutions in this country where a "per member" assessment is made. In those parishes where individual members, who are able and wish to do so, can always contribute their own desired amount over and beyond individual assessments. Any arrangement that does not follow this basic principle will continue to bring about disharmony from many directions.

We are confident that you will see the wisdom of our position and be guided accordingly.







- 5. We acknowledge that correspondence from the Parish to the Diocesan Council in the past which conveyed an attitude contrary to the spirit of the by-laws was improper and indicated ineptness on our part primarily due to inexperience and a lack of knowledge of the provisions of the by-laws.
- 6. We do hereby acknowledge that we are an integral part of the Diocese, and we will in the future abide by the bylaws and look to Your Grace for guidance.
- 7. We acknowledge that the withholding of Diocesan dues was improper and will in the future give every reasonable consider-

ation to future *i* assessments and will pay forthwith all Diocesan dues due as of December 31, 1975

- 8. We are mindful that Your Grace and the Chairman of the Diocesan Council, Judge John K. Najarian, met with the members of the elected Parish Council on December 19, 1975 and acknowledge your views of criticism
- 9. We further state that timely reports will be made of all minutes and reports to the Diocese as required by the Diocesan by-laws.

Considering the above, we would ask that this letter and request for reinstatement be acted upon by Your Grace and the Diocesan Council as soon as convenient.


