

His Eminence:

Since March, 1982, St. Gregory the Illuminator Armenian Church has been without a full-time Priest and Spiritual Leader. We are aware of the lack of clergy and know that this shortage is of great concern to you. However, since June, 1982, we have been fortunate in having Fr. Vahram Hazarian perform Badarak on Sundays on a semi-monthly basis (recently increased to three Sundays) but this is not enough to fill the void left during the week days. The responsibility of caring for the Church and Parish cannot be done effectively on a part-time basis, since we are always without clergy on important feast days, unable to fill requests for house blessings and visitations to the sick. This lack of leadership has also had a negative affect on our Sunday/Armenian School.

At the Annual Parish Assembly held on January 30, 1983, much discussion was devoted to our needs for a Parish Priest. The discussion resulted in a motion presented and carried to secure Fr. Vahram Hazarian's services as a full time priest on a one year trial basis. In view of this motion, the Parish Council has evaluated Fr. Hazarian's performance and believes he is capable of providing the spiritual leadership our Parish needs. Fr. Hazarian has expressed his willingness to serve our parish and would like to help strenghten our church and various organizations. He does not speak English, however, he is attending classes to learn the languate. We are not certain of the implications involved, since Fr. Hazarian is not a member of our Diocese. If need be, Fr. Hazarian will be glad to write you and submit his credentials. We would greatly appreciate your thoughts concerning this matter and await your action relating to this most important issue and will, of course, support your decision.

If you have any questions or feel the need to discuss this matter in greater detail before making a decision, please contact me at your convenience.
