In view of this, other more realistic and mutually satisfactory arrangements should be made, deriving from but not necessarily limited by the directive.

SUBJECT: Stipends for Visiting Clergymen

New policy guidelines concerning stipends for visiting clergymen were discussed and decided on by the Diocesan Council at its session of February 19. Due consideration was given to this subject in order to establish much needed uniformity throughout the Diocese in the treatment accorded to visiting clergymen, and thus minimizing confusion and misunderstanding.

The established guidelines are as follows:

- 1. A stipend of \$75.00 will be remitted for a visit that includes the celebration of the Divine Liturgy. The remittance will be made to the parish of the visiting priest.
- 2. If the visiting priest is without a parish, he will be entitled to the stipend personally.
- 3. In either case, the priest will be reimbursed by the parish being visited for expenses incurred in the visit, such as transportation, lodgings and meals.
- 4. These standards do not apply to Bishops and Archbishops of our Church.
- 5. The amount of \$50.00 will be remitted for any Sacraments performed, and under the same rules outlined above.
- 6. None of the above precludes voluntary gifts to the clergyman, nor does it prevent any parish from asking a gift as well for its own Church, where the Sacrament is being performed.

If any questions arise concerning these guidelines, they will be resolved by the Primate.
