Proposed Loan to: Diocese of the Armenian Apostolic Church of North America Premises to be Occupied by: Armenian Apostolic Church of Cleveland, Richmond Heights, Ohio

I am writing in regard to the real estate mortgage loan which has been requested by the Armenian Apostolic Church of CleveLand covering premises located on Richmond Road, Richmond Heights, Ohio. Title to this property is vested in the Diocese of the Armenian Apostolic Church of North America and it is our understanding that under the By-Laws of the Diocese any conveyance or mortgage of real property of the Diocese may be made only by the majority vote of the Diocesan Council and the Diocesan Board of Trustees assembled in a joint meeting presided over by the Arachnord.

Accordingly, our note and mortgage will have to be signed by the Diocese and we will need a resolution of the Council and Board of Trustees approving the terms of the loan and authorizing the execution of the mortgage. I enclose herewith copy of our form resolution, to which I have added the terms of the loan, and this resolution will serve as a guide as to what we desire to have included in any resolution that is passed.

In regard to the parties who are to sign the note and mortgage, the local church would like to know whether the Diocese can delegate local representatives to sign on behalf of the Diocese. In regard to the checks for the disbursement of the loan proceeds, it will be necessary that parties from the local church be authorized to sign same.

Since we do not have a copy of the By-Laws of the Diocese we would like to have a statement from you as attorney for the Diocese, to accompany the resolution, that the approval of the Council and Board of Trustees and the authorization of the named parties to sign the note, mortgage, and checks are all in accordance with the provisions of the By-Laws and Regulations of the Diocese and no further approvals or authorizations are necessary in THE CLEVELAND TRUST COMPANY

Supreme Grace:

A general Parish meeting was held on May 20, 1962 at our Parish house in Cleveland. The purpose of the meeting was to obtain approval to award the construction contract of our church to the lowest bidder, Huml Construction Co., and to proceed to negotiate for a loan from the Cleveland Trust Co. The above resolution was passed without a dissenting vote. Reverend Father Dajad Davidian and Deacon Nerses Jebejian were present at this meeting.

A joint committee of the Cleveland Parish Council and Building Committee proceeded to fill out the various forms and negotiate with the bank to obtain a loan. The amount of the loan would be the difference between the actual cash on hand and the amount of the construction cost. The church construction cost is \$81,000 and the cash on hand is \$31,000. Therefore, a \$55,000 loan for 12 years at $5\frac{1}{2}$ per cent annual interest was applied for with the Cleveland Trust Co.

The only item that is delaying our obtaining the loan is the legal technicality of the Diocese Council and Board of Trustees in New York passing a Resolution approving the mortgage loan and to delegate Cleveland representatives to act for the Diocese in signing disbursement checks as they are needed during construction.

The loan from the bank must be in the name of the Diocese of the Armenian Apostolic Church of America since it is the legal owner of the Cleveland Church property. The only way the loan can be in the Cleveland Diocese name would be for the Deed and Title to the property to be transferred to our name in Cleveland. Since this is evidently not possible due to the By-Laws of our Church Constitution, it will be necessary for the Diocese officials in New York to sign the Resolution for the loan and also to delegate Cleveland representatives to act for the Diocese in signing the disbursement checks. This last part is necessary so that the process of paying the Construction Company can be done in a quick and practical manner.

Mr. Robert J. Marquard, the legal attorney for the Cleveland Trust Co., sent an air mail letter on June 6, 1962 to Mr. Richard Gregory explaining these facts. I understand that you have this letter and the Resolution forms to be signed as required by the bank. If you have any questions concerning the Resolution forms, the matter of delegating local representatives to act for the Diocese, or if this conflicts in any way with the By-Laws of our Church Constitution, please call Mr. Marquard as he requested in his letter. He can be reached at the Cleveland Trust Co. Legal Department, the telephone number is MAin 1-1600.

Further delay in this matter will endanger our chances of obtaining the bank loan. The 30-day period on the construction bid submitted by the Huml Construction Co. has already expired. However, we feel that we can obtain a short extension on this time.

Your immediate actions on these matters would be greatly appreciated by your loyal and devoted worshipers in Cleveland. We in Cleveland have waited a long time to build our own church. You are certainly aware of all the trial and tribulations that have fallen on this community through the years.

May we pray to God that we can quickly complete this matter and begin construction of our Church so it can stand as a symbol to unite and strengthen our people through the years.
