Dear Mrs. Karoghlanian:

The Primate has asked me to respond to your letter of October 21, 1988.

The Diocesan Council, at its meeting on November 18, 1988, discussed the contents and determined that the Church address can be used only by the Church and its affiliated organizations such as ACYOA, Ladies Auxilliary, etc.

To do otherwise would give the appearance that the Church is sponsoring such an organization and might make the Church responsible for the collection and distribution of the mail received.

In light of the Diocesan Council's determination I do not believe it is necessary for you to vote upon the motion since you may rely on this letter as your authority.

We appreciate the support of the organizations which might wish to use the Church address but we feel the precedent set could create many future problems for our Diocesan Parishes. Perhaps these non-Church organizations could arrange, in common, to obtain a post office box for receipt of their mail, thus alleviating a problem which we do appreciate exists in receiving responses to their mailings.

We do not want to unnecessarily alienate members of the community, who are strong supporters and members of our Mother Church.
