On Wednesday, January 10, 1990, Mrs. Mekhag (Maggie) Abdo and Mary M. Mukhtarian attended a public meeting in the Niagara Falls City Hall regarding the proposed mall project expected to be approved for Niagara Falls.

As newly appointed representatives of the St. Sarkis Parish Council we had an opportunity to listen to the proposed timing for the mall progress and to ask questions regarding the status of our church. Following are some of the highlights of that meeting:

- o The meeting was conducted by William K. Clark, Director, Department of Community Development.
- o The city of Niagara Falls has approved the project and expects to give \$30MM to support it.
- The area affected by the project includes the 9th and Falls Street corner where the St. Sarkis Church is (that will be the entrance of the mall).
- o The general area is considered blighted, and the real estate there very inexpensive, so most residents are willing to be relocated. The St. Sarkis area is not considered blighted, but its residents are poor and the houses are modest.
- o Erre County has not approved the project yet pending the resolution of 15 issues submitted to the city.
- o New York State is expected to approve this project which will supply 1500 jobs, mostly for entry positions.
- o Clark explained that the project will pay for relocation of all individuals affected as allowed by the federal relocation program, in addition to compensating people for the appraised value of their homes.
- o Clark indicated they acquire the houses under the eminent domain statute, and are confident of getting the 95 or so acres they need for the mall.
- o The County Building, as well as the Baptist church, will not be acquired.

#### Our questions were as follows:

- o Is St. Sarkis included in their plan? He said yes and he was confident anything in that area will be acquired.
- o Was he aware that there were two churches, St. Sarkis and St. Hagop (officially recognized as a community center) on 9th Street? He said they knew, but he believed it will not be difficult to acquire them by invoking eminent domain.
- o Did he realize that the St. Sarkis church stood on consecrated ground as pointed out by one of the meeting attendees? Clark indicated he sympathized with the church community and did not see how a church could be properly classified under the project's requirements.
- o Would their appraisers know how to appraise the value of a church? As one of the attendees pointed out, it is like asking the Catholic church to move. Clark did not know what appraisers do in this circumstance.
- o When relocating the church, would they pay whatever value land is purchased? Clark thought they will have to pay no matter what the cost is.
- o Since the church is a beautiful stone building adhering to Armenian architectural guidelines, will they be willing to transport the church stone-by-stone to another location, no matter what the cost? Clark indicated they would.

When Clark was informed that St. Sarkis had not been officially notified, and no attempt had been made to reach any member of the Parish Council, he indicated that at Urban Renewal they had assumed that St. Sarkis' silence meant the church was plotting its legal attack on the proposed displacement.

A meeting is planned for Friday, January 19, 1990 at 4:30 p.m. in the offices of Larry Krizan, the Director of Urban Renewal who is the boss of Clark and is the sole authority on this project. Krizan had apparently indicated that he had been unable to contact St. Sarkis in repeated attempts.

Hurry up and wait.

Residents in the area to be cleared or the proposed Niagara Factory Jutlet Mega Mall found out Wedneslay that they will have to be patient a ittle longer before they get the final answers to their numerous relocation anestions.

The project is behind schedule but progress is being made, Community Development Director William K. Clark told them at a monthly meeting held in City Hall. "The Benderson people are very interested in getting going on this," he said. "They're waiting for the city's go-ahead."

The city hopes to settle on an appraiser for properties in the area by Jan. 31, he said. The environmental review of the site should be completed by mid-February. The city also needs state Job Development Authority approval for bonds to be issued to the Urban Renewal Agency for the \$27 million needed to clear the site, he said.

Larry Krizan, coordinator of development services, may travel to Albany next week to present the proposal. If all the pieces of the puzzle fall into place, officials should start making offers to residents in April, Clark

After an appraisal is done, an offer will be made. If the offer is not satisfactory to the owner, then an "appraisal review" takes place, Clark said. It there is no resolve, the city will take the property through eminent domain and the homeowner can go to court. But before the court date, a second appraisal will be made, he

Offers will be made first to residents living on the mall "footpath," or boundary lines of the building itself, he said. This covers roughly from Falls Street to about a block

Robert Yamonaco of Ninth Street wondered whether the city would try to force the East Side residents to resettle in properties that become available in Love Canal. Clark said the city cannot steer residents to a particular area.

On the other hand, Mark Mellon of 15th Street said he would not mind moving into the Love Canal neighborhood and asked if residents displaced by the mall would be given preferred status for properties there. Clark said no such arrangements have been made at this point, but that it was a possibility.




