Dear Mr. Stoneson:

On behalf of the trustees of the Holy Trinity Armenian Church, I am writing you to request clarification and the possibility of reimbursement concerning two items.

The Eighty-first Annual Diocesan Assembly, Palos Heights, Illinois, May 5-8, 1983, hosted by Saints Joachim and Anne Armenian Church, was attended by three delegates of our Parish. The Parish Council absorbed their transportation and lodging expenses.

Verified expenses of \$374.65 were incurred by Fr. Nourhan Manougian. These expenses were verified and paid by our parish. Since Fr.
