MINUTES OF 1986 ASSEMBLY  
(Continuation of March 12 Meeting)

A motion was made by Sylvia Tavitian and seconded by Alice Kasparian that the slate be accepted and that the Assembly Secretary cast one vote.

Alice Kasparian recommended that a report of the Diocesan Assembly be submitted by the Diocesan delegates and be included in the annual assembly reports and that the expenses for the Diocesan Assembly be shown in the financial statement.

Bids have been received for the remodeling of the church hall. The four small windows will be blocked and 8 foot paneling on walls and paint or wallpaper on top. Floors will be sanded and the large windows will be patched and sealed. Table storage space will be utilized on both sides of the stage. Final figures will be forthcoming.

George Tashjian recommended just cleaning the hall at this time so that the kitchen can be operable and we can continue our church functions as remodeling the hall could take several months to complete. Zarty Chilingirian was opposed to this and wanted the hall renovations be undertaken at this time.

A motion to adjourn the meeting was made by George Tashjian and seconded by Charles Asadoorian. The meeting adjourned at 10 p.m.
