

1994 Annual Parish Assembly Meeting

Minutes

The 1994 Annual Parish Assembly was held on Sunday, January 16, 1994. The Agenda with results follow:

- 1. Opening Prayer Rev, Father Sahag Kaishian began the meeting with a Prayer.
- Election of Assembly Chairperson and Secretary 2. Edgar Mosesian- Chairperson and Elaine Meuse- Secretary

35 dues paying members were in attendance. Those present were in agreement that they constituted the required amount for voting purposes. Zarty Chilingirian recommended that every person be invited to the Assembly, not just dues paying members. 3. Minutes of the 1993 Parish Assembly

The minutes were passed out and reviewed.

Avedis Derderian asked that a correction be made to page 3 to state that his comments were offered as constructive criticism not personal feelings.

Alice Kasparian asked that the minutes show that Marty Aaronian was elected Diocesan Delegate in 1988. Yn. Lana seconded the motion.

Michael Takesian motioned to accept the 1993 minutes as amended. David Tavitian seconded the motion. Motion passed.

Report of Nominating Committee 4.

Marty Aaronian presented the report. The committee consisted of Marty, Elaine Meuse and Virginia Tavitian. Every person who the committee felt could potentially serve was called.

Annual Report of Diocesan Delegate 7. Paul Tavitian our Delegate stated that he mailed out the report prior to the meeting. He asked that comments be made. Comments were favorable. Paul was thanked for his efforts. Zarty complimented Paul on his mailing the report in advance to the meeting.

Michael Takesian motioned that the roort be accepted. Marty Aaronian seconded the motion.⁴ Motion passed.

Paul thanked Sylvia Tavitian and Yn. Lana for typing the report.

8. Annual Report of Parish Organizations Marty Aaronian asked that the spelling of Vasken Gostanian's name be corrected in the Mr. and Mrs, Report.

Alice Kasparian presented the Choir Report. The Choir along with its traditional fundraising activities donated \$500. to the Anniversary Banquet. Alice pointed out that the Choir does fundraising in order to avoid costing the church any money. She also commented on the poor church attendence especially Christmas Services. The presenceof the Congregation is critical to the success of the choir. A written report will be submitted.

George Kasparian motioned to accept the Parish Reports. David Tavitian seconded the motion. Motion passed

9. Annual Report of Auditing Committee Cynthia Kasparian presented the report. The committee found everything to be in good order. It was recommended that the accounting be put on the computer. Cynthia will see that this will happen. A written report is forthcoming.

Quorum Status

Number of persons present were 31. Need 43 for a quorum. IT WAS MOVED by Alice Kasparian AND SECONDED by Martin Aaronian to move ahead with the meeting for a 2/3 majority vote. All present are dues paying members. THE MOTION PASSED UNANIMOUSLY.

Review of Agenda

The agenda for the meeting was described. IT WAS MOVED by Michael Takesian, to proceed with the agenda as presented. THE MOTION WAS SECONDED by Richard McNeil. THE MOTION PASSED UNANIMOUSLY.

Election of Additional Parish Council Member

Martin Aaronian announced that Sandra Dasho is a candidate for Parish Council. A MOTION WAS MADE by Edgar Movsesian to adopt a nine person Parish Council. Father Sahag clarified that the number of Council members may be between 5 and 15 according to the By-Laws. THE MOTION WAS SECONDED by Joseph Tavitian. THE MOTION WAS DEFEATED UNANIMOUSLY.

A MOTION WAS MADE by Alice Kasparian that Sandra Dasho be accepted as a member of the Parish Council. THE MOTION WAS SECONDED by David Tavitian. THE MOTION PASSED UNANIMOUSLY.

Membership Dues

Current membership dues are \$30.00 per person. We are assessed by the Diocese at \$47.00 per person. A MOTION WAS MADE by Sylvia Tavitian that the membership dues be increased to \$50.00 per person, effective January, 1994. THE MOTION WAS SECONDED by David Tavitian. Discussion was held regarding increasing the dues to a larger amount. Concern was expressed for those on fixed incomes and allowing for support of those who may need assistance. There was also discussion regarding how the dues per person ration is derived. It was suggested that where the dues go be shown on the dues invoice sent out to each member and that the dues invoices be sent at the beginning of the year. THE MOTION PASSED 20 in favor, none against, one abstention.

A MOTION WAS MADE by Michael Takesian to accept the 1994 proposed budget as presented. THE MOTION WAS SECONDED by Martin Aaronian. Janice Movesian answered questions regarding the 1994 proposed budget. Der Hayr made a suggestion to make a pledge committee to distribute pledge cards to all members. THE MOTION PASSED UNANIMOUSLY.

Father Sahag gave the Benediction to the meeting at 2:45 p.m.

ST. GREGORY THE ILLUMINATOR ARMENIAN CHURCH Haverhill, Mass. November 2, 1994 MINUTES OF SPECIAL PARISH ASSEMBLY Derderian Hall - 7:30 P.M.

The meeting opened with an invocation from Der Sahag Kaishian.

Chairman , Rafik Papelian (after welcoming all attending the meeting) introduced Michael Takesian as the person who has studied the issue of

Attitash Acres, Inc. Michael Takesian proceeded to first describe the limits . of the property in question and what events took place in the formation of the trust known as Saint Gregory the Illuminator Armenian Apostolic Church The property known as Attitash Acres was bought by 3 individuals: Trust. James Derderian of Methuen, Charles Tashjian and Abe Kezerian of Haverhill, Mass. It is siad to consist of 8.6 acres and includes a n unpaved road called Shore Road leading to teh property in Merrimack, Massachusetts. Later the three principals of Attitash Acres, Inc. (named above) drew up a trust document that was reported to have been recorded in November of 1969. The said purpose of the Trust is to manage the property in the interest of the church for charitable religious and recreational purposes. Moreover, M. Takesian explained that a deed was drawn up by Attitash Acres, Inc. in December of 1968 and a Note for \$21, 850 on the same day. The discussion that followed revolved around "the legal aspects of the "gifting" of two-thirds of the property inthe Trust to the Haverhill Church and one-third to the Holy Cross Church in Lawrence, Mass. Jim "Avedis" Derderian stated that there is a mortgage held by the three

principals named as Trustees above. And, they (the Trustees) no longer want "it". It's being gifted to both churches. Avedis indicated that the church owns the property and the 3 persons mentioned hold the mortgage. Michael Takesian indicated that the Trust agreement was recorded in the Registry in Salem and that if the Trust is disolved the proceeds would go to the Church.

Ouestion arose as to whether the approval of the PArish Assembly is needed to transfer one-third of the property to the Holy Cross Armenian Church of Lawrence, Mass.

Another question arose about dues and non-dues-paying members of the church A motion was made by Janice Mosesian and seconded by Margaret Kazarosian : that non-dues-paying members be allowed to voice their opinions at the Parish Assembly. Motion carried.

A motion made and withdrawn on a point of order accepting the 28 members present as a quorum for the purposes of conducting the business at hand. With reference to the By-Laws of the church, it was agreed that a two-thirds affirmative vote would carry a motion $\frac{1}{2}$

Further discussion focused on the proper passing and recording of the Trust, the Deed and the Note and whether or not the Faverhill Armenian Church should hire an impartial attorney to represent the church and advise the Parish as to the findings. - particularly in view of the fact the the assessed property value of the "Attitash Acres" parcel has risen sharply and taxes born by the two churches has jumped from a few hundred dollars to \$1,400 per year. Motion made by Joseph Tavitian and seconded by Edward DerBogosian that the Parish Council hire a good attorney to investigate documents and title and this Parish's interests in the parcel of property called "Attitash Acres" of Merrimack, Mass. for legal fees not to exceed \$1,000. Vote: 18 in favor. Motion passed.

Further discussion revolved around the rights of Trustees and whether or not they could could name new Trustees. Discussions continued around the intent to gift one-third of the Attitash Acres property to the Holy Cross Armenian Church of Lawrence.

Motion made by Barbara Arthur and seconded by Margaret Kazarosian to table item # 5 of the Agenda having to do with the assigning of i/3 interest to the Holy Cross Armenian Church of Lawrence, Mass. Carried -unanamous vote.

Agenda item #4 "Amendment of Trust Agreement" - not moved. Also, Agenda item # 6 "Election and Appointment of New Trustees" was tabled.

Der Sahag Kaishian gave the benediction and the meeting was adjourned at about 10:00 P.M.

DIOCESAN DELEGATE REPORT

The 92nd Annual Assembly of the Diocese of the Armenian Church of America was hosted by St. Kevork's Parish, Houston, Texas from April 28 - 30, 1994. Issues concerning churches of our Diocese were discussed in three sessions.

Archbishop Khajag Barsamian, Primate of the Eastern Diocese opened the first session on Thursday, April 28, 1994 with a worship service. Dr. Garo Garibian was elected to chair the Assembly. He presided over 187 registered delegates. A message from His Holiness Vasken I was read. Rev. Fr. Nerses Jebejian, host pastor, greeted the delegates on behalf of his parish. Prayers for deceased delegates, namely, Sara Dadourian, Edward Mardigian, Florence Karoghlanian, Martin Cholakian, Virginia Green, Harold Gregory and Dr. Robert Bogdasarian were said.

Delegate Deacon Allan Jendian, representative of the Western Diocese, was introduced and in his message brought greetings and noted that the most recent earthquake in California caused serious damage to their Diocesan Headquarters.

Reports were presented by Very Rev. Fr. Nareg Berberian from the Clergy Conference and Mr. Zaven Kasparian, Chairman of the New England Regional Council. Col. Victor Arzoomanian, Executive Director of the Armenian Church Endowment Fund presented his report and noted that the ACEF is one of the largest and most productive endowment funds in the world.

Nominating Committee read names of nominees for the Diocesan Board of Trustees, Nominating Committee and the Proposals and Auditing Committees.

Rev. Fr. Garabed Kochakian, Chancellor of our Diocese, encouraged all churches to focus on the theme "Year of the Family".

Delegates voted by ballot prior to Friday morning's opening session.

The second session began on Friday with Archbishop Barsamian's opening prayer. He also gave the Primates Message, concentrating on the theme "Year of the Family". His concern for the youth should be a living and influential part of the teachings of our church. He noted that the Department of Social Services was formulated to help our elderly and Armenian immigrants. He also emphasized that Unity is a goal we should continue to persue.

Judge Vincent Gurahian, Chairman of the Diocesan Council, gave the Council's report. He continued to give the Election results.

Reports were also presented by Deacon Hratch Tchilingirian regarding St. Nersess Armenian Seminary activities.

Sonia Harlan presented the report as the newly formed Mid-West Regional Co-Cordinator.

The fund for Armenian Relief report was given by Simon Yeznig Balian in which was stated that 15 million dollars worth of humanitarian aid was delivered into Armenia during 1993. F.A.R. has been chosen by the US Government as the relief agency of choice for delivering humanitarian aid to Armenia. Fr. Karekin Kasparian spoke briefly of the H.A.V.A.D. Committee and indicated the mission had three goals: to establish a mission program in Armenian; conduct a Christian Camp and promote religious publications.

Archbishop Khajag Barsamian was elected as Primate with 110 votes. There were 137 delegates that voted.

The following reports were received by the Assembly: Association of Armenian Church Choirs of America by Mary Selvinazian: Women's Guild Central Council by Margaret Atamian; Auditing Committee by Sahag Sahagian; Sahag stated that the committee is please to report that there have been vast improvements in the day to day operation of the Diocesan complex. Mr. Guy Pontillo, Financial Officer, was accredited for the improvement.

Prior to the conclusion of the second session Archbishop Khajag Barsamian, the newly elected Primate of the Eastern Diocese, was escorted into the church to his chair by the clergy as they sang Oorakh Ler. This was a very impressive ceremony.

The Third Session commenced at 9:25 AM Saturday, April 30 with a Worship Service by the Primate. The Unity Committee Report was presented by Zaven Kasparian, as follows: A document of understanding and acceptance was put together jointly with our Unity Committee and the Prelacy Unity Committee. Upon approval of this document by both the Diocesan and Prelacy Assemblies, a draft of unified bylaws will then be sent to all delegates. The 15 point contention which previously held up the Unity Committee talks has been discussed and resolved among the committees and are no longer points of contention. The Unity Committee will continue their work.

Baroness Caroline Cox was introduced to the Assembly. she had just returned from her 19th trip to Artsakh. She expressed her fear upon this last visit stating that it is the beginning of the end for the people of Karabagh. Though the situation is bleak the people of Artsakh are trying to live normal lives. Schools were opened for a brief period. She urged the delegates to pray for the people of Artsakh.

George Chakoian made a motion, which passed unanimously, that a FAX be sent to President Clinton and all of the U.S. Congress regarding the situation in Karabagh.

St. Gregory the Illuminator Armenian Church Merger Committee Report - 1994

A request was made by the Primate for a merger of the churches in the Merrimack Valley. A meeting of the Trustees of the three churches involved convened. During the discussion the Lowell church did not feel that they would care to merge. Haverhill had no comment, but Lawrence decided to accept and find a way to merge with Haverhill, and build a new church.

The board of trustees of Lawrence and the Parish Priest appointed a committee headed by Mark Kazanjian. They looked for possible sites for a new church. One was found in the Ward Hill area. A special Assembly was called to approve this site.

In the meantime, in early December, our Parish Council with our Parish Priest appointed James Derderian, Harry Kasparian, Stephen Arthur, Paul Tavitian, Edgar Mosesian and Kim Dandurant as a Fact Finding Committee only. Four meetings have been held since the formation of this committee. We were invited to the special assembly held by Lawrence where the subject was whether to purchase the land in Ward Hill.

James Derderian was invited to speak and express Haverhill's feelings about this issue. His comments were that the committee could not approve any such purchase at this time and that it was a little premature. His recommendation was that the committees should continue and that all options be thoroughly explored.

A vote was taken by the Lawrence Parish on whether to purchase the Ward Hill land. This was defeated. Another vote was taken on whether Lawrence and Haverhill Churches would merge. It was voted unanimously in favor of the merger.

As of this report this committee has been discussing all possibilities and no action has been taken.


