Most Reverend Sir:

The Annual Membership Meeting of the Cleveland Parish was held on January 10, 1959 in the Cleveland Parish Hall, 666 Richmond Road, Richmond Heights, Ohio, with Father Arnak Kasparian of Detroit, Michigan presiding.

Mr. Kevork Arslanian, Chairman of the Parish Council, called the meeting to order at 9:30 p.m. Roll was called to verify the number of duespaying members present—32 out of 71 members listed were in attendance. Those present unanimously voted to carry on with the meeting.

The Chairman and Secretary for this meeting were elected by the members. Those elected were Mr. Paul K. Apkarian, Chairman, and Miss Ann Chobanian, Secretary. The minutes of the last Membership Meeting were read and accepted. All Church-affiliated organizations gave their annual reports and all indicated that this community had a fairly successful year.

The Nominating Committee presented a slate of 10 names for the purpose of electing five new Parish Council members for a period of two years. A closed-ballot election took place and the following members were elected:
