Minutes of the previous meeting were read by George Sakian and were approved as read.

Alan Borazanian presented copies of the Land Contract regarding the sale of the Odian property as prepared and arranged with the prospective buyers. There were stipulations in the Contract which required correction which Alan would handle along with the proper transferring of insurance coverage, etc.

Alan also read his letter submitted to Mr. Henderson with a copy to Mr. Greenburg indicating the sale of the property. \$400.00 had been collected which makes him current.

Lee Pasquale, who happened to be in the hall was approached regarding another early preparation of an affair on Sunday, 4/27/80. Lee responded that he was unaware of this second incident and agreed that this was not right and will inform his people. Lee also reported that due to many broken chairs, there is a shortage which should be attended to.

Regarding the Odian property, the <u>RESOLUTION</u> as prepared by Alan was signed by Father Diran and George Sakian and witnessed by Armen Asadourian and Eric Ohanian.

The <u>LAND CONTRACT</u> was signed by Father Diran and witnessed by Armen Asadourian and Eric Ohanian.

The STANDARD CONDITIONS OF ACCEPTANCE OF ESCROW signed by Father Diran.

Alan reported his meeting with Krikor Ghazarian regarding property improvements, etc. may result in a more concise job description with additional responsibilities and salary adjustments.

Alan also reported that Alex Bagdasarian could take the Parish Car and dispose of the parts.

CORRESPONDENCE RECEIVED:

- 1. Letter received from Agnes Barnett representing AGBU requesting to donate dogwood trees to be planted on the church property. Approval was given with the stipulation that the location of the planting be determoned by the Parish Council.
- 2. Directive from Primate regarding donations to St. Vartan ACYOA Camp, July 13 to 19. It was agreed by members to have a special plate collection on May 18, for a \$25.00 total donation.
- 3. Letter from St. Mary's Church in Livingston, New Jersey requesting donations for help towards rebuilding their church which was vandalized and destroyed by fire. The question of insurance coverage will be presented to the Primate.

Florence Karoghlanian submitted her Treasury report as follows;

Florence inquired about the timing of the payments of the salaries prior the work period which is the current policy versus after the work period. After a discussion it was decided to maintain the present paying procedure.

JACK HATCHADORIAN reported that several prospects had been contacted to chair the Annual Church Picnic, but received no firm committments. He will continue to seek those who are willing to undertake this project.

Don D'Augustine (caterer) who was slated to attend this meeting did not appear.

Nat Arslanian and Florence Karoghlanian reported the dinner and program to be presented on the occasion of the visitation of our Primate.
