Dear Syraun,

We received your letter dated December 22, 1980 which included a copy of a parish council and financial report for the St. Gregory of Narek Church of Cleveland for the year 1979.

As a matter of information, a complete examination had been undertaken by the present members of parish council of all past records, not only of this particular case, but also of others within our parish as well.

Errors have been discovered as a result and in some cases very costly errors, which could have avoided unnecessary expenditures amounting to a high dollar volume.

This parish has paid for these past errors, which we are currently attempting to recover.

Referring to the dues to be assessed as derived from our Annual report for 1979, a careful and concise account was not made by the previous council regarding the reported 133 members.

Among that count of 133, there were individuals who never paid their required membership dues, or were relocated outside of the State or were deceased during the period.

As a result of a thorough screening of our membership roster, the letter directed to the Diocese dated November 24, 1980 by our treasurer, Florence Karoghlanian is in order with a corrected membership of 109 and a corrected balance as submitted to you in the amount of \$639.00 for the balance of 1980.

Again we repeat that this letter with its contents is in order and strongly urge its acceptance.

We recognize and fully admit the errors as committed by the previous councils and this is one as discussed at our recent meeting which will not be accepted by the present members.

Therefore, due to disclosing the above information, it is strongly requested by unanimous vote of council members that the diocesan dues for the year 1980 assessed St. Gregory of Narek have been paid in full. In addition, we have also received our statement for January, 1981 dues from Louise Simone, which we are holding until this matter is resolved.

It appears that Louise is not aware of the existing situation, since the billing is still in the amount of \$499.00.

Please inform Louise that payment of our dues will resume once this situation is settled.

It is our intention to keep our record unblemished regarding prompt payments, therefore, as soon as your acceptance is received, payment of dues will continue.

We are confident that your understanding and cooperation with us will produce a forecast of prosperity and success for the forthcoming year.

I received your letter of January 7 concerning your parish's assessments and must remind you of the strict procedures followed in arriving at the assessed amount.

Back in June a memorandum was distributed to all churches apprising them of the fact that information taken from their annual reports is assumed to be correct unless otherwise noted. An actual xerox copy of all church assessments, including the information used to calculate them, was also forwarded for correction, with the specific instructions that no changes could be made later in the year.

In October 1980, after the last assessment bill of the year was forwarded to the parishes, you informed us of the misinformation in the 1979 Annual Report of the St. Gregory Church. Unfortunately, there is nothing that can possibly be done now without affecting every other parish in our Diocese and we can only suggest that this year's assessments - based on 1980 information - will be able to reflect a more accurate membership and income figure for your church.

Please be so kind as to remit the remaining balance so that the 1981 assessments can be properly billed. I regret that nothing further can be done and do hope you understand our situation.

Your letter dated January 29, 1981 as disclosed to council members at our last meeting was indeed disappointing and considered unanimously as unacceptable.

Our total assessments as based on your formula should again as we are stating, be as follows:

St. Gregory of Narek has an excellent reputation for exercising its obligations, as your records will prove, but there is a matter of principle in this case which deserves recognition, but unfortunately is being ignored.

As a result, we will patiently rest with the present situation until your office decides to further discuss this matter in a more reasonable manner.

We are in receipt of your June 29, 1981 letter which stipulates in paragraph "A" that there is a dispute of \$903. which is to be credited or adjusted toward your 1981 assessment.

The procedure followed in apportioning assessments to each parish is based on certain pertinent information submitted by the parishes in their annual report to be computed. The total assessment figure approved by the Assembly is apportioned to each parish based on those computed figures.

Any parish wishing to change their submitted figures after apportionment of assessments will require the whole operation of apportionment to be done over since every parish within the Diocese is affected.

Changing assessments after they have been formally assigned becomes costly and a handicap to all involved.

Any adjustments to a parish after assignment of assessments become a total loss to the Diocese and you shall agree becomes most inequitable.
