Your Grace:

The 1984 Annual Parish Assembly of St. Gregory of Narek Armenian Church of Cleveland convened on Sunday, February 26, 1984 at 1:00 P.M. following the church services.

After roll call and verification of the eligibility of members, it was evident that the number of members present did not constitute a quorum; therefore, a motion was made, seconded and passed to accept the members present as a quorum and to accept the meeting as official.

For Tivan (Assembly Chairman and Assembly Secretary) the following names were presented with the following results: Mr. Sam Mirakian and Miss Martha Hacherian for Chairman and Mrs. Janice Nazarian and Mr. Nat Mirakian for Secretary. With secret ballot and majority of votes, Mr. Sam Mirakian and Mrs. Janice Nazarian were respectively elected to their positions.

The meeting proceeded according to the agenda. Welcoming words were given by Mr. Richard Aurslanian, Parish Council Chairman, and the minutes of the Parish Assembly of 1982 (convened on February 27, 1983) were read and approved and the elections for Parish Council (partial, 4 new members), Auditing Committee (3 members), and Nominating Committee (3 members).

Annual reports of the Pastor, Parish Council, Diocesan Delegates and church auxiliary organizations were received, as well as the Parish Council's financial report and projected budget for 1984 which was approved. Old and new business was discussed. The Pastor's message was delivered and the meeting was adjourned after the benediction.
