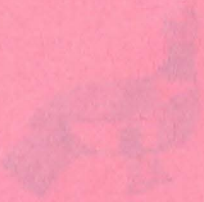
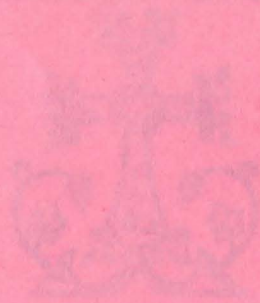

RULES AND REGULATIONS GOVERNING CHURCH MEMBERS IN GOOD STANDING

RULES AND REGULATIONS CONCERNING CHURCH MEMBERSHIP

"All persons who have been baptized and confirmed in the Armenian Church, who accept its doctrine, canons and rites, and who fulfill their obligations to the church and community, shall be members in good standing of the Parish Church and shall constitute the Parish Assembly".

"Every Member of the Parish, 21 years of age or over, shall pay the church an annual due".

"Members in good standing of a Parish Church, who are twenty-one years of age or over, may participate in the assemblies of the same parish and may vote, provided that at least six months have elapsed since the date of their registration as members of the Parish and their dues have been paid. They may be eligible for office one year after becoming members".

"Members who fail to pay their dues for one or more years, automatically forfeit their right to vote at Parish Assemblies, or to hold elective office within the Parish. Such members may reinstate these rights by payment of their dues in arrears for at least the previous two years".

Articles 5, 6, 7 and 8 respectively

BY-LAWS OF THE ARMENIAN CHURCH OF AMERICA

RULES AND REGULATIONS GOVERNING PARISH ASSEMBLY

"The agenda of the Parish Assembly shall be prepared by the Parish Priest and the Parish Council. Other matters of new business may be added by majority vote of the Parish Assembly".

"At Parish Assemblies the presence of a minimum of one-third of the eligible voting membership or fifty members shall constitute a quorum. Decisions shall be rendered by majority vote of members present and voting".

"In a Parish Assembly each member shall be entitled to one vote which is not transferable and must be cast in person."

MINUTES OF ANNUAL PARISH ASSEMBLY
ST. GREGORY OF NAREK ARMENIAN CHURCH

CLEVELAND, OHIO
February 28, 1988

The Annual Assembly of St. Gregory of Narek Armenian Church was called to order at 1:30 p.m. by Helen Atkian, Parish Council Chairman.

Helen Atkian thanked Florence Karoghlanian and the ladies who prepared the luncheon. Helen also gave her thanks and appreciation to Mona Karoghlanian who helped with the Annual Report; Sam Mirakian who has helped her over the past two years; Thelma Bagdasarian for her dedication to the choir; Anita Arpajian for playing the organ every Sunday; and Dr. Krikor Krikorian and Simone Ghazarian for Sunday Services and work around the Parish House. The Church has been fortunate to have Deacons Michael Ohanesian and Serop Demirjian, as well as Fr. Donikian performing Badarak monthly.

Ralph Chakerian, Parish Council Treasurer, conducted roll call which established a total of 57 dues-paying members in good standing out of an eligible membership of 111. This number constituted a quorum.

The meeting was turned over to George Sakian, Nominating Committee, who asked for nominations for Officers of the Day. Jack Hatchadorian was added to the ballot for Chairperson joining Richard Aurslanian who had already been written on the ballot. Leslie Bagdasarian and Debra Venditti were written on the ballots for Secretary of the Day. George Sakian pointed out that only vote for one person for each office. Results of the closed ballot were:

Martha Hacherian moved to approve as published the minutes from the 1987 Parish Assembly.

The next item on the agenda was the election of four Parish Council members to replace Helen Atkian, Dr. Krikor Ghazarian, Armen Arslanian and Harry Kananian. Nominations for Parish Council, Nominating and Auditing Committee were taken at this time. Sam Mirakian motioned to close the nominations for Parish Council and seconded by Grace Arslanian. Balloting for the Nominating and Auditing Committees were not taken at this time since a motion was made to have it separated from the Parish Council balloting. The motion was made because it would be conflicting to vote if the same name appeared on two separate ballots. The motion to have Parish Council's ballot separate from the Nominating and Auditing Committee 's ballot was seconded. Results of the closed ballot for Parish Council is as follows:

**The tie between Florence Karoghlanian and Dr. Abraham Arslanian was broken when Dr. Arslanian conceded the election to Mrs. Karoghlanian. Dr. Arslanian will be the first alternate should there a vacancy on Parish Council.

Richard Aurslanian, Chairman of the Day, resumed the program. Thelma Bagdasarian pointed out that the 1988 Parish Assembly Agenda didn't follow the motion that was made during the 1987 Assembly. The motion which passed stated that Old Business and New Business be placed on the agenda immediately after the election of Parish Council members and Nominating and Auditing Committees to ensure presence of a greater number of voting members and adequate time to act on important issues. Richard recognized the error and changed the agenda.

Old Business included Aluminum Siding on the Parish House, doors and restoration, altar curtains, hall expansion, and a canopy over the Church doors. Helen Atkian explained that the pulley and wire were fixed on the curtain and that a new system would run around \$18,000 to \$20,000. The repairs on the ceiling leak of the Cultural Hall and the chimneys in the Parish House were two emergencies, everything else got pushed back. Helen went on to say that the price quote for the restoration on the doors was ridiculous and that she was working on another quote. Naz Yessayan updated the aluminum siding business with estimates from contractors of \$7,000 and \$10,000. He also stated that the hall expansion was on hold.

Richard Aurslanian went on to the next item, New Business. At this time Harold Zahigian explained his concern over the Sunday School situation. He said that we are letting the youth down since there is a shortage of Sunday School teachers. At this time he asked for suggestions.

Kevork Arslanian recommended that we have a farewell affair for Dr. Krikor Krikorian.

Carol Ghazarian volunteered to teach Sunday School after a motion was made by Janis Nazarian to hire a Sunday School teacher. Jim Nazarian said that it is difficult to have one on one with a teacher and a child. Parents who have the children are not bringing the kids and are not coming themselves.

The election of the three members to the Nominating Committee and the three members to the Auditing Committee was done at this time. Results of the closed ballots are as follows:

Discussion continued on a Sunday School teacher. Dr. Abraham Arslanian explained that money is needed for the function of the church. We should appreciate the volunteers. He went on to say we need to open our eyes to world events and take more responsibility for Armenians around the world. David Andonian said that maybe parents don't think their qualified to teach. Harold Zahigian explained that anyone could teach. The curriculum is complete and easy to understand. At this time a motion was made to hire a Sunday School teacher and did not pass.

Other New Business brought up by Thelma Bagdasarian was what was going on with finding a new Priest. Helen Atkian said that Parish Council is up on the situation. That there were "none to be had". She had spoken to Surpazan Hayr and he said that we were not on the bottom of the list. He did say that there are five churches ahead of us and he commends the church on what we are doing in Cleveland. He also stated that Cleveland is doing more than the other five churches are doing. Helen Atkian concluded that the current situation has kept alot of people away. God Bless who ever can get a Priest.

Jim Nazarian went on to say that he is not critizing anyone but that we are not doing enough. Jim made a motion to form a "Pastoral Search Committee".

Discussion went on and the motion to form a Pastoral Search Committee was seconded and passed. Motions also authorized Parish Council the authority to appoint the Search Committee. Richard Aurslanian asked the floor if anyone would volunteer now at the meeting so Parish Council would have an idea on who to ask to serve on this Committee. Jim Nazarian, Florence Karoghlanian, Russ Arslanian and Thelma Bagdasarian volunteered.

Paul Arslanian brought up church membership. He said we need to get people to join and pay. Grace Arslanian suggested that the reason we do not have more members was because the dues are too high. To get membership up, Harold Zahigian made a motion to have wedding people and Sunday School graduates, have their first year free as members to the Parish. After the year was up, they would have to start paying for their membership. The motion did not pass.

The Annual Reports of the Parish Council and Auditing Committee were both approved as presented to the membership.

For the Parish Council Financial Report, Florence Karoghlanian motioned to propose \$25,000 for an incoming Pastor's stipend. After discussion, the motion to add \$25,000 in the 1988 Proposed Budget was seconded as passed.

Florence Karoghlanian brought up the Church Directory on why the income did not appear in the 1987 Parish Council Financial Report and where was the income from the Directory. Harold Zahigian explained that the purpose of the Directory was: 1) for communication 2) for a major fund raiser in which the profits would be the seed money. Harold went on to say that Parish Council was not interested in the Directory and that the Committee was formed by the Pastor. Ara Bagdasarian complimented the Directory Committee when he said the Directory was outstanding. The discussion closed when Sam Mirakian asked when the job will be complete and the books and money be turned over to the Parish Council. Harold Zahigian concluded that the Directory should be an on-going project.

Florence Goekjian brought up the subject of rent. She questioned why the church was not charging rent for non-church organizations when they use the Parish House. Ralph Chakerian said that there are no rules on charging rent for use of the Parish House. Further discussion of the pros and conc of charging a rental fee lead to a motion that any Armenian or non-Armenian organization that does not have an agreement with the church make a donation for use of the facilities. This motion was seconded and passed.

Florence Karoghlanian made a motion that \$10,000 be allocated for capitol improvements on the Cultural Hall. Such improvements as: wall paper, painting, carpeting, etc. The motion allocated \$10,000 for capitol improvements was seconded and passed.

Harold Zahigian commented why the pay phone disbursements are so high. Ara Bagdasarian said he would look into an alternative since his job relates to this subject.


Jim Nazarian questioned the savings account balance. He wondered why the accounts are not broken down. Naz Yessayan said that the checking accounts are combined into one, and Certificates of Deposits (CD's) were combined into one.


Ralph Chakerian pointed out that from the motions passed for the 1988 Proposed Disbursements and Income Budget, we would be approving a \$27,000 deficit. This figure comes from \$108,000 in Disbursements and \$81,000 in Income. The motion to approve the Proposed Budget for 1988, as amended, was seconded and passed.

The motion was made to approve all organizational budget reports was passed.

Closing remarks were given by Richard Aurslanian. He adjourned the meeting at 5:27 p.m.

Diocesan Delegate's Annual Report
1988

Helen Atkian, Parish Council Chairman, represented St. Gregory of Narek Church at the 1988 Diocesan Assembly in place of Diocesan Delegate Florence Goekjian who was unable to attend.

The 86th Annual Diocesan Assembly was held May 12-14, 1988, at Holy Trinity Armenian Apostolic Church in Cambridge, MA.

Dr. Dennis Papazian was elected Chairman. Once again, the unity issue and the building of a high rise structure on the Diocesan Administration Building site were discussed at length, then put on next year's agenda.

A 29-page report on revision of the Diocesan By-Laws was presented. It will be modified for next year's Assembly.

A budget of over \$2,000,000 was approved. A petition from the Primate to the Catholicos that marital status should not be a barrier to ordination of a priest nor to his ascension to higher positions of authority in the Church was presented. The Assembly proposed that the Primate direct each parish priest to be available at least four times a year for assignment as a visiting priest to mission parishes. Commitment of the Assembly to begin preparations to commemorate the 75th Anniversary of the Genocide in 1990 was assured.

Senator Edward Kennedy was honored as a Friend of the Armenians and Hon. George Keverian was named Man of the Year at the Saturday banquet.

St. Stepanos, Elberon, NJ, is the 1989 Assembly site. Meetings will be May 4-6, 1989.

Annual Report of the Armenian Women's Guild - 1988

Florence Karoghlanian served as Chairman for the year. The Vice Chairman was Alice Doyle, Recording Secretary was Florence Goekjian, Corresponding Secretary was Margaret Zahigian and the Treasurer was Mary Arslanian. Forty-six dues-paying members were enrolled.

At the January meeting, the Guild resolved to pay for the poinsettias which decorated the Christmas altar and to buy a typewriter for Church use. The February program was a talk on nutrition by Miss Julie Pschires. The annual Meeching Dinner on March 16 took the place of a regular meeting.

Plans for a trip on Lolly the Trolley were presented at the April 3 meeting by Alice Doyle. Thelma Bagdasarian reported on progress of the Martyrs' Day Concert. The Guild voted to support the event with a \$50 Friend of the Concert gift. The Guild furnished Easter lilies for the altar, and an Easter reception was chaired by Alice Doyle.

Our choir was again represented at the Annual Assembly of the AACCA held in New Britain, CT, October 28th through 30th. Choirmaster Thelma Barry attended and brought back with her much information on the projects and plans of the organization.

We were honored in a Choir Appreciation Day coffee hour sponsored by the Parish Council on December 11th. Parish Council Chairman, Florence Karoghlanian, individually presented each member with a personal audio cassette of the Khorenian Mass and a tasty package of choereg.

The choir performed on several occasions in cultural programs for the community, singing Armenian folk songs which we learned specially for each occasion. Response was overwhelming.

We've realized a need for new robes and veils to replace the ones we've worn faithfully for twenty years. The robes will be purchased from the diocese at a cost upwards of \$1000. A fund-raising project has been developed and will be implemented shortly to cover the expense.

ST. GREGORY OF NAREK ARMENIAN CHURCH SCHOOL

ENROLLMENT - 28 (Including 3 Nursery enrollees)

Sunday mornings begin with a class session from 10:15 to 11:15 A.M., then all the children attend morning Assembly, with the exception of the High School/Adult class which meets in the Parish House by special arrangement with the Parish Council. During the Assembly time in the Hall, there is worship with prayer in Armenian and in English. Sharagans (hymns) in Armenian are being taught and are being incorporated in the Assembly worship period. There is a continuing study of the life and teachings of Christ through guided Scriptural reference. The guide was provided by the Diocese. During the teaching period, the Armenian Church Calendar feast days are taught. The morning ends with Church attendance where the children reverently participate at the end by approaching the Bible held by the Celebrant and properly kissing the cross and making the sign of the cross. The children and staff have received Holy Communion whenever a Priest has attended.

- To familiarize the children with the concept of the "HAVADAMPK", the Creed--to learn what we believe
 - To learn how to reverently participate in the Divine Liturgy
 - To teach about the life and teachings our Lord
 - To teach the children about the Armenian Church Calendar Feast Days and Armenian traditions
 - To teach Armenian sharagons and use of the Armenian language during worship where appropriate.
 - To make Church School meaningful and memorable.

New Armenian Church curriculum was created, published and introduced in the Armenian Church Diocese in 1988. Its theme is "We Believe" ("HAVADAMPK" / The Creed). This new material has been put to good use in our Church School. A dedicated and motivated staff is providing a wonderful learning environment that is enriching our children and young adults.
