The year 1988 was a year of reorganization for the members of the Nairi Choir. It began slowly, but with the support and enthusiasm of our members our Choir is once again a strong, working organization. The Nairi Choir consists of 20 dedicated and hard-working members.

The Nairi Choir conducted 4 full membership meetings during the year and met for rehearsals approximately twice per month throughout the year.

Dr. Hampar Yazijian, our Choir Leader, has taken a short break from this duty. This role has been assumed by Mr. Gary Rejebian in his absence.

We opened our year on January 1, 1988, with a balance of \$200.00, and ended with \$200.00. A complete financial statement is attached.

#### ACTIVITIES

On February 7, 1988, the members of the Choir contributed the luncheon for the annual Parish Assembly Meeting.

We had planned to make a Halloween Party an annual event. However, there was another party planned for Halloween this year. Assembly hosted by the Holy Resurrection Parish and Choir of New Britain, Connecticut. To our great happiness, she brought back to us the great news that our Choir was recognized with Honorable Mention to the Gomidas Vartabed Award in 1988 due to our excellent record in 1987. We celebrated the 7th Anniversary of the Nairi Choir on Sunday, November 13, 1988, with a special service to bless the members of the Choir and Altar Servers following the Divine Liturgy. Also, on this special day, Der Vahram Hazarian presented the Choir Director's robe to Mr. Gary Rejebian. A delicious buffet and sweet table in celebration of our 7th Anniversary followed the Church services.
