The check has been submitted to department of Diocesan Fund for Armenia's Recovery to be utilized as per your instructions.

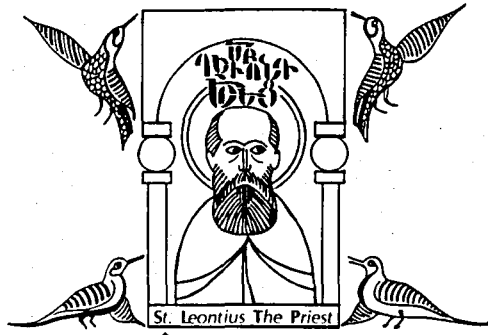
Kindly convey our gratitude to the Parish Assembly members for their concern and thoughtfulness and also our appreciation to the donors.

At the recently held Annual Parish Assembly Meeting, Sunday, February 7, 1993, the current situation of great needs in many areas was discussed. It was the fervent, unanimous desire of all those attending that, in addition to contributions which had already been received, \$10,000.00 should be taken from our Reserve Fund, added to those contributions and sent immediately to the "Winter Relief Fund" with the stipulation that these monies are to be used exclusively and specifically for the purchase of fuel.

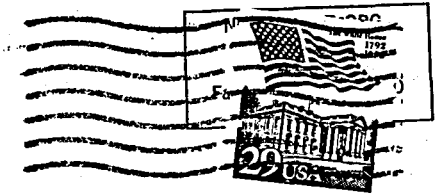
