The ^{chairman} president's report was given by Dr. N. Astarjian and the treasurer's report by Dr. V. Garabedian.

Budget report was read by Dr. Garabedian. He reported that funds were solvent although the church netted a loss of \$328.78 for 1974 church financial activities. Disbursements for 1974 exceeded \$21,600.00 and that estimated expenditures for 1975 to be about \$25,000.00. Budget was approved and seconded.

Money raising ideas were discussed and will be probed further. Among one of them was the possibility of applying to the New York State Youth Bureau that distributes funds for youth activities. All will be pursued.

Problem of putting on church dinners were discussed. Some families dropped out of the rotation for monthly church dinners. Most people want to continue it, and the board of trustees will discuss the solution to this problem at their meetings.
