

St. Gregory the Illuminator Armenian Church Annual Assembly Meeting

- 3.) How to raise return on investment for Capital Reserve Fund

Old Business

- 1.) Guidelines for Priest's stipend for services is \$150. A question was posed why we continue to give \$200 for stipend. Dr. George Rejebian answered this question with the statement that our goal is to attract priest's for a monthly Badaak for our parish; our objective is not to cut costs by cutting the priest's stipend.
- 2.) Delegate's Report from 1992 Diocesan Assembly, read by Mrs. Alice Bogdasarian.

New Business

- 1.) Need for an organized pledge system with a program for fellowship stated by Chairman Dr. George Rejebian.
- 2.) External sources of fund-raising, (ie, dances, bazaar, rug sales, etc.)
- 3.) Refugee Resettlement Fund - Mr. Joe Azadian
A TV and VCR were donated to the Guerkov family, bought with Fund Money.
- 4.) Refugee Fund depleted to \$221. Need donations to this fund.
