The Annual Parish Assembly of St. John's Armenian Church was convened on Friday, February 1, 1974, at 8:30 p.m. at our Cultural Hall. Mr. Martin Apkarian was elected the Chairman of the Assembly, and Secretaries were Mr. Yervant Azadian and Mr. Edward Korkoian.

The Assembly was conducted in accordance with the spirit of the Diocesan By-Laws. The only questionable area was the interpretation of the Diocesan By-Laws regarding the time and the procedure of casting the ballots. My personal feeling was that the actual casting of ballots should take place while the election was in progress. Yet, after the Assembly, by majority vote, chose to interpret the By-Laws to mean that physical presence at the Assembly qualifies a person to vote, I concurred with the will of the majority.

I herewith submit to Your Grace the following:

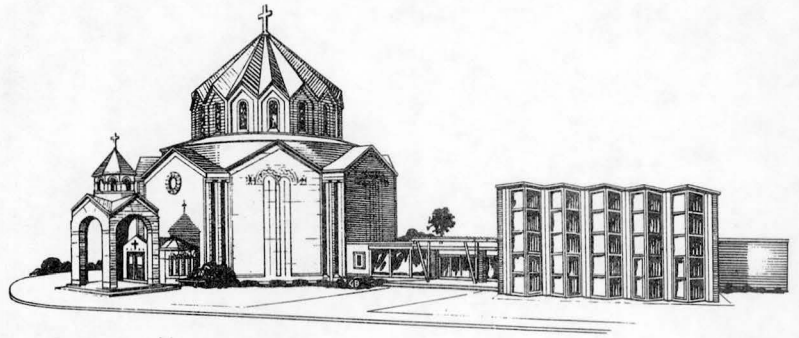
