

Dear Father Paren,

I appreciate the gesture from you and the Parish Council to host a dinner on the occasion of my departure as Assistant Pastor. While it is customary to honor one of your pastors with a farewell dinner, yet, I declined to accept this offer, because, at this time I find it unnecessary.

As you know, it has been three years and two months since my assignment as Assistant Pastor at St. John's. I must say that you have an excellent Parish and a beautiful Sanctuary for which I feel very proud and glad that I had the opportunity to be part of. I am also very grateful to the many individuals whose warmth and kindness welcomed me in their families and made me feel at home in Detroit.

Now the time has come for me to terminate my responsible relationship with this Parish. I will assume my next pastoral duty at the Armenian Church of Holy Martyrs in Bayside, New York, according to the arrangement of our Primate, Archbishop Khajag Barsamian.

Reflecting on my experience, I believe that I carried out what was possible according to the limited responsibilities delegated to me. I strongly believe that I could have contributed more if situations and relationships with the Parish Council had been more desirable and cooperative.

Prior to accepting this assignment, I was assured of the need for an Assistant Pastor. I came to this Parish with the intent and hope that I would be part of all aspects in serving this Church and community (in planning, decision making, guiding and participating); thereby only, the position of an Assistant Pastor could be justified.

There are two main reasons which made me decide to leave St. John's. First, the system under which the Parish operates does not require to have a second priest. Secondly, due to the shortage of clergy in the Diocese, the opportunity to serve and fulfill the needs of a Parish lacking a pastor is very gratifying to me.

If the Parish Council is planning to have an Assistant Pastor in the future, in order to avoid confusion or anticipated misunderstandings, I suggest that a detailed description of duties be prepared. Unfortunately, our Diocesan Bylaws is very vaque in its description of the position of Assistant Pastor. To this respect, I will also express myself to our Primate.

For affiliated organizations to participate in the productive operation and the well-being of the Church, it is important that the Parish Council be responsible for preparing plans and quidelines to be followed.

Once again, I thank you for the opportunity to serve in the this Parish. I wish you all success in all your positive efforts.

Dear Fr. Paren:

On December 9, 1992, I sent a letter to you as a reminder that the Diocesan Department of Youth Ministry would still like to plan a cultural weekend for the young adults of your parish. This was the program that we had originally scheduled for December 4-6, 1992, but which you found necessary to cancel.

Having not received a response from you, I am writing again to ascertain whether you are interested in pursuing this matter any further, or if you would instead prefer that the Department plan some other type of program for your parish.

If your preference is for another type of program, I would like to propose that the Department plan a one-day "Youth Workers Training Seminar" for your parish. The seminar would deal with the following topics: Youth and Their World; The Youth Worker; Practical Ideas for Youth Groups; and Questions-and-Answers. The seminar is geared to youth directors, youth liasons/advisors, and Sunday School upper-grade teachers, as well as parish priests.

A sample schedule for the seminar would be as follows:

11:30 - 1:00) p.m.	Session II
1:00 - 2:00)	Lunch
2:00 - 3:30)	Session III
3:30 - 4:30)	Session IV
4:30 - 5:00)	Vespers

If you feel that this training program will be helpful to your parish, I am ready to begin planning it. Also, please be aware that there will be no travel or lodging expenses for your parish to incur; the Department will take care of all that. All that your parish would be responsible for would be publicity and lunch for the participants.

I would like to offer for your consideration the same dates that I had suggested for the cultural program and have kept reserved for your parish. They are: May 22 or June 5, 1993.

Please let me know, at your earliest convenience, as to whether your would want me to plan such a program and as to which date is preferable. Thank you for your cooperation.



Your Eminence,

This is to inform you that I have a question as to the validity of the Elections held during our Annual Parish Assembly which was held on Friday, March 26, 1993.

My concern is the eligibility to vote of the Parishioners who pay less than the minimum dues. These individuals were not reported as members in our 1992 Annual Report. In 1991 three(3) categories of members were reported. Those that paid more than the minimum dues, those that paid the minimum required and those that paid less than the minimum. In this years Annual Report only two categories were reported. Those that paid more than the minimum and those that paid the minimum. The people that paid less than the minimum were not reported, so our membership in 1992 reflects a loss of 313 members.

When questioned during the meeting, a Parish Council member who is also a Diocesan Delegate responded that we (St. John's) considered these individuals members in good standing, but because they paid less than the minimum dues required by the Diocesan By-Laws, we weren't going to pay the Diocese for them since the Diocese doesn't do anything for us anyway.

The attitude and the audacity of the majority of the Parish Council members that they can do whatever they want and get away with it because they had the stamp of approval of our former Pastor is appalling. This type of activity goes on constantly. As a former Parish Council member, I know first hand that information from the Diocese, Diocesan Directives and even mail from Parishioners and the Assistant Pastor were censored by the Chairman and the former Pastor with the excuse that we (St. John's) are not interested in what the Diocese is doing or that "it didn't concern us."

I have a great concern about the future of our Church and with these individuals who are now in the process of looking for a new Pastor. I know that many of the Parishioners would prefer some one who has never served in Detroit. This would give our entire community the opportunity to start "on ground zero" with the new Priest. I fear that if an individual who has served here before returns, the current problems will continue to manifest.

I remain faithful and hopeful that things will get better in the near future and that my church will be a place where I can go to get spiritually renewed.
