

The Annual Parish Assembly Meeting of the Armenian Church of the Holy Resurrection was held Sunday, Jan. 28, 1973. The meeting started at 2:00 p.m. with a prayer by Father Vartan Der Assadourian. Elections were held for the ^{conducting} ~~presiding~~ officers of the meeting. Mr. Edward Simonian was elected Chairman and Mr. Given Hoosigian was elected Secretary. Minutes of the last year's meeting were read and accepted.

Father Vartan read the Pastor's report. Father Vartan was questioned as to why the English service was stopped and what was the reaction. Father Vartan stated that the ACYOA was queried and they preferred the Armenian Service. He also stated that Mr. Jack Antreassian from the Diocese said the same type of results were encountered at the other churches.

Mr. Charles Hovsepian Jr. read the Parish Council Report.

The Pastor's, Parish Council and Auditor's Reports were accepted with commendation. The Women's Guild report was read by Mrs. Henrietta Kallajian for Mrs. Arshal Hoosigian.

The balance owed on Stanley St. lot is \$5500. - It was recommended that the Parish Council write a letter to Mr. Blake thanking him for the one year extension on the last payment and for the fact that he has not charged the church any interest.

Joint venture with Hartford report was given by Mr. Arthur Simonian. - There were five (5) meetings held during the year. The main joint ventures, at the moment, appear to be with the ACYOA and the Women's Guilds.

The new budget was presented by Arthur Simonian as follows:

There is a \$2700 unbalance in the budget and it is recommended everyone increase their pledge 40%. The budget was accepted.

Mr. Greg Abrahamian made a motion that the Parish Council send a letter to each parishioner telling them of the needed added income and the Council wait four weeks to determine if the parishioners voluntarily increase their pledges the required 40%. If this does not occur then the Council appoint a committee other than the parish council, to visit the members to try to obtain the increase. The motion was seconded by Sarah Yagoobian. The motion was accepted.

Stephan Der Margosian made a motion that the Parish Council appoint a committee to contact church members and non members to obtain Yughakim donations at Christmas and Easter times. Motion was seconded by Mrs. Arshal Hoosigian. Motion was accepted.
