## 1. MEETINGS

- (a) At the first parish meeting on February 14, 1972, the members of the newly formed council were elected to their respective offices.

- (d) The regular special membership meeting was called after church on November 5, 1972, to elect the nominating committee that makes the preparations for the elections to be held at this Parish Assembly.
- (e) A special meeting was held on Monday, October 9th, with Mr. Jack Antreassian, Executive Secretary of the Diocese.

#### 3. MAINTENANCE

The regular maintenance requirements of the Church were met. In addition, the following special items should be noted"

- (a) A new de-humidifier was purchased for our Church hall.
- (b) New carpeting was purchased and installed in the Trustee's room and the Church entrance. These were donated by Peter and Monoog Bagdigian.
- (c) We would like to thank Peter Bagdigian for fixing the stair rails to the choir room.

#### 4. PUBLICATIONS

The "Looys" is published with the help of the Pastor, Trustees, A. C. Y. O. A., and John and Queenie Hovhanessian, and John Maljanian. They provided the parishoners information: about the activities of the Church. The content of the "Looys" is determined by the reporters of the various Church organizations and parishoners. We appreciate their cooperation.

#### 2. CHURCH ENTERPRISES

The Parish Council planned, organized, and conducted the following affairs in the course of the year.

#### (a) 31st ANNIVERSARY CELEBRATION

The 31st Anniversary Banquet was held on Sunday, April 30, 1972 in the Church Hall. It was unfortunate that His Grace, Archbishop Torkom Manoogian was unable to attend. However, we were indeed fortunate to have in our midst the Executive Secretary of the Diocese, Mr. Jack Antreassian who was the guest speaker for the banquet. He spent an enjoyable day here seeing his old acquaintances again. The highlight of the banquet was the presentations of the Godfathers for the day. Total donations amounted to \$2,233.00.

#### (b) ANNUAL CHURCH PICNIC

The picnic was held on August 20th, jointly with St. George's Church of Hartford. Under the guidance of Arthur Simonian and Clement Ashekian, the joint venture was a success and each Church realized a profit of \$550.00.

A car raffle was held jointly with St. George's Church of Hartford with Harry Badrigian as Chairman in cooperation with Guy Bedrosian from Hartford. The net profit for each church was \$874.00.
