MINUTES - ANNUAL PARISH ASSEMBLY

First Session

The Annual Parish Assembly of the Armenian Church of Our Saviour was held on Thursday, January 18, 1973 at our Church Hall.

The meeting was called to order by the Parish Council chairman, Jacob Hagopian, at 8:30 p.m. with our pastor Very Rev.Shnork Kasparian presiding.

After Fr.Shnork's invocation, the election of assembly officers took place. Elected were Antranik Yarumian, chairman, and Harry G. Sogigian secretary.

Pastor is Report

Fr.Shnork read his report covering the period from July 1972 to December 1972. During this period Hayr Soorp cited his many endeavors in all phases of our religious life, i.e., in sacraments, new members for our church, community relations, youth activities, bible study, and future plans of activity. Two successful affairs were the Madagh Services on the occasion of the 20th anniversary of the Consecration of our new Church on Salisbury Street and the celebration of midnight Divine Liturgy in English on the feast of St. Stephen, December 24th. Both events were very well attended and inspiring to all our parishoners

The Assembly unanimously thanked Fr.Shnork for his enthusiastic and dedicated services to our Church.

Parish Council Report

The Parish Council report for the year was read by its chairman, Jacob Hagopian. The financial report was given by treasurer, Peter Nalbandian.

Mentioned as two of the significant accomplishments of the Council were the paying off during the year the heavy financial burden of the Church, the \$75,000.00 bank note and the improvements of our properties.

The Assembly accepted with appreciation and thanks the two reports of the Council.

Auditing Committee Report

Committee member Henry Shooshan reported and verified that the financial reports given in the 1972 Annual Booklet are correct.

Budget for 1973

The budget for 1973 listing an income of \$59,700.00 and expenses of \$72,755.00 was presented by the Council. The \$12,500.00 expense item was questioned. The explanation given was that this amount will be paid by the Council in the event that funds will be available. (to apply to the mortgage)

Memorial Plaque

It was recommended that an appropriate memorial plaque be placed in our Church in honor of our first pastor and primate, the Very Rev. Hovsep Sarajian. This si to be done on the occasion of the 75th anniversary of the founding of our Diocese in 1898 in Worcester. This celebration will be held in May of this year in our parish in conjunction with the annual Assembly at which time, our Catholicos will attend.

This matter was referred to our Pastor and Parish Council.

Parish Assembly Attendance

Our Pastor, commenting on the attendance of this Assembly, said that in view of the size of our parish, this assembly is poorly attended and steps should be taken to increase attendance at our meetings. This idea was shared by everyone present.

A motion was made and unanimously passed directing the Pastor and the Parish Council to think up ways and means of involving more of our people at our assemblies.

This session closed at 10 p.m., and will resume Sunday at 10 a.m. for elections.

SECOND SESSION - SUNDAY, JAN. 21st.

The second session of the 1972 Parish Assembly resumed on Sunday, January 21, 1973 at 10 a.m. in the Church Hall.

The election of 5 parish coumcil members, 6 diocesan delegates, 5 nominating committee members and 3 auditing committee members followed.
