#### MINUTES - ANNUAL PARISH ASSEMBLY 1984

The Annual Parish Assembly of the Armenian Church of Our Saviour, Worcester, Massachusetts convened on Sunday, January 29, 1984 in the Church Hall immediately following Church services.

The polls were open from 11:15 a.m. to 12:30 p.m. for the balloting of members to the Parish Council, Nominating Committee and Auditing Committee. Luncheon was prepared and served by Mrs. Elizabeth Kazarian with the assistance of the Nominating Committee. All present at the Assembly agreed that it was delicious.

The Assembly was called to order by Chairman Francis Najarian at 1:35 p.m. with Reverend Deacon Onnig Terzian, Deacon-in-Charge, presiding. Deacon Onnig lead the Assembly in the opening prayer.

It was noted that 117 people were in attendance. Mr. Najarian then called upon Dr. Vahram Uluhogian, Chairman of the Nominating Committee, to present the nominations for the officers of the Parish Assembly. Mr. Francis Najarian and Mr. Bartev Der Bagdasarian were nominated for Chairman of the 1984 Assembly. A closed vote was taken and Mr. Najarian was elected as Chairman. Dr. Uluhogian then announced Rose Aslanian (Mrs. William) was a nominee for Secretary of the Assembly and called for nominations from the floor. There being no other nominations, Mr. Avedis Choolfaian cast one vote, which was seconded, to elect Mrs. Aslanian as Secretary.

Chairman Najarian called for the adoption of agenda items as follows:

- 1. Election of Officers of the Assembly
- 2. Adoption of the Agenda
- 3. Reading of the minutes of previous Assembly
  - 4. Report of Assistant Pastor
  - 5. Report of the Parish Council
  - 6. Report of the Auditing Committee
  - 7. Reports of all organizations
  - 8. Approval of proposed 1984 Budget
- 9. Report of the Parish House Study
- 10. New Business

Chairman Najarian asked for any new business items to be placed on the Agenda. There were no new business items at this time.

Upon a motion made by Ms. Berjoohie Zakarian and seconded by Mr. John Kabian, it was VOTED: to adopt the agenda as presented.

At this point it was suggested, and the Assembly agreed, to waive the reading of the Minutes of the 1983 Parish Assembly and of the individual organizational reports. The Chairman would call for discussions and questions on a page by page review, since all in attendance had copies of "The Annual Reports, 1983."

#### MINUTES OF THE ANNUAL PARISH ASSEMBLY - 1983

Upon a motion made by Mr. George Herosian and seconded by Mr. Arthur Yagjian, it was VOTED: to approve the Minutes of the Annual Parish Assembly - 1983.

#### ASSISTANT PASTOR'S REPORT

Mr. Van Aroian asked the Assitant Pastor, Reverend Deacon Onnig Terzian, if the statement in paragraph 3 of his report, "to continue his education," was the only reason Reverend Father Yeznig Balian had resigned. Deacon Onnig responded that the reason given in Father Yeznig's letter of resignation was "to continue his education." After some discussion on this subject, Mr. George Herosian suggested that the questions be directed to the Parish Council.

Parish Council member, Mr. Asbed Zakarian, stated that the writing is valid and that the statement is accurate and correct as recorded. Parish Council Chairman, Mr. Zarvin Kasparian, quoted the following portion of the letter dated June 2, addressed to Father Yeznig, from the Primate, Archbishop Torkom Manoogian, in the hope that it would clarify the difference between fact and impression — "Therefore, in the present situation a decision is left to be made by you. Either to continue according to our designed and agreed plan and serve in Worcester, or leaving out your educational plans and desire to be a full-time pastor. In the case of the latter decision, we will make the efforts to make proper arrangements in our Diocese for you."

Mr. Van Aroian asked if Father Yeznig was extended the opportunity to be the Pastor of the Church of Our Saviour.

Mr. Harry Sogigian stated that, in his opinion, reading from a letter sent to the parishioners, dated June 13, by the Parish Council it became obvious to him that two heads were appointed to our Church, thereby creating the problem.

Mr. Arsen Najarian referred to a petition with 240 signatures and a letter which were forwarded to the Primate, to which there was no response. He asked if the Parish Council was aware of this correspondence and if so, why did they not follow-up on the matter. Mr. Zarvin Kasparian, on behalf of the Council, stated that Father Yeznig informed the Parish Council that he had forwarded a petition to the Primate, and the Primate would act on it.

Mr. Vahan Pogharian remarked that some of the misunderstanding between us may have been avoided, perhaps, if the Parish Council had informed the 1983 Assembly the conditions under which Father Yeznig and Deacon Onnig had been assigned to this Parish.

Chairman Najarian stated that we are one family, that mistakes and misunderstandings occur in all families, and that they should be forgiven and learned from. Upon a motion made by Ms. Berjoohie Zakarian and seconded by Mr. Avedis Choolfaian, it was VOTED: to accept the Assistant Pastor's report.

#### PARISH COUNCIL REPORT

Mr. Van Aroian asked the Parish Council if the Council maintained an open meeting policy. The Parish Council's response "yes", that anyone is welcome to attend meetings, but that the office should be notified a week or so beforehand, in order that the agenda can be planned accordingly. Mr. Aroian stated that an open meeting policy should be an open meeting policy without condition, and that no one should be barred or ejected from a meeting.

It was pointed out by Chairman Najarian that this issue should of been brought up as an item under New Business when Agenda items were being discussed earlier. It was stated by several Assembly members that they did not understand that specific new business items were being called for in order to have them listed under New Business, when the Agenda was being discussed for adoption.

Upon a motion made by Mr. Van Aroian and seconded by Mr. Harry Sahagian, it was VOTED: to modify the adopted Agenda under New Business.

The five items requested to be discussed under New Business are as follows:

- 1. Assembly consider the policy of Parish Council open meetings-Mr. Van Aroian
  - 2. Use of Cultural Center Mrs. Ruth Haddon
- 3. Use of van donated by Mrs. Hannah Kalajian Mr. Haroutune Kasparian
- 4. Status of permanent pastor Mr. George Herosian
- 5. Feasibility of two-part Parish Assembly Mr. Kenneth Krikorian

At this point Chairman Najarian resumed with the Parish Council report.

The next topic of discussion was a request from Mr. Harry Sahagian to clarify "Return of vehicle donated by Mr. John Fashjian". It was explained that the vehicle Father Yeznig was using was a <u>loan</u>, and not donated, for the use of the Pastor for one year. This was a special arrangement between Mr. Fashjian and Chrysler Corp. whereby this vehicle was loaned to the Church, with Mr. Fashjian paying the monthly lease fee of \$350 to Chrysler Corp. The question was asked as to whether or not another loan would be possible, and Mr. Abe Sivazlian explained that Mr. Fashjian was unable to make the same arrangement with Chrysler Corp. for the continuance of another year.

Upon a motion made by Ms. Berjoohie Zakarian and seconded by Mr. Andrew Sarkisian, it was VOTED: to accept the Parish Council Report.

#### AUDITING COMMITTEE

Mr. Herbert Alexander reported that the Committee audited the the Church books and found them to be in good order.

Upon a motion made by Mr. John Kabian and seconded by Mr. George Herosian, it was VOTED: to accept the Auditing Committee's report.

#### SR. LADIES AUXILIARY

Upon a motion made by Mrs. Dorothy Yagjian and seconded by Mr. Harry Sahagian, it was VOTED: to accept the Senior Ladies Auxiliary report.

#### **AVAKS**

Upon a motion made by Mrs. Dorothy Yagjian and seconded by Mr. Avedis Choolfaian, it was VOTED: to accept the Avaks report.

#### EKMALIAN CHOIR

Asked if the Margaret E. Hagopian Memorial Fund is being used in any way, Mrs. Hazel Eljanian reported that one choir member, Mary K. Elloian, has taken voice lessons and another, Mrs. Karen Casey, is taking organ lessons.

Upon a motion made by Mrs. Lucy Kasparian and seconded by Mrs. Dorothy Yagjian, it was VOTED: to accept the Ekmalian Choir report.

#### ARMENIAN LANGUAGE SCHOOL

In answer to some questions concerning the status of the Armenian School, Chairman Najarian called upon Deacon Terzian to enlighten the Assembly as to the developments of the Armenian Language School. Deacon Onnig reported that numerous attempts had been made, through mailings, announcements, telephone calls and personal contacts to parishioners, to start Armenian Language classes. Two dates for registration were calendared, but there was minimal response. The parents promised to bring their children, but did not show up on registration day. Therefore, the school is presently inactive.

A suggestion was made to conduct the Language School and the Sunday School concurrently on Sundays, and it was also suggested that a feasibility study be made concerning this. The Assistant Pastor was encouraged to proceed with efforts to reactivate the Armenian Language School.

Upon a motion made by Mrs. Dorothy Yagjian and seconded by Mr. John Sagarian, it was VOTED: to accept the Armenian Language School report.

Upon motions made and seconded, it was VOTED: to have the following reports accepted as written:

#### THE MESSENGER

An expression of thanks was given to Ms. Marilyn Markarian and the Messenger staff.

The omission of the Sr. Women's Auxiliary Mid-Lenten supper is noted under - Activities in 1983.

Upon a motion made and seconded, it was VOTED: to accept the Messenger report with the above notation.

#### BEANO ACTIVITY REPORT - 1983

It was noted that this report will be a part of the Annual Reports hereafter. A vote of thanks was expressed to the Beano Committee, and to those who had the foresight to originate Beano a number of years ago.

Upon a motion made by Mr. Arthur Yagjian and seconded by Mr. Abe Sivazlian, it was VOTED: to accept the Beano Activity Report - 1983.

At this point the omission of the name of Mrs. Ruth Haddon, Chairman, Cultural Organization, under the listing of CHURCH ORGANIZATION CHAIRMEN - 1983, (back cover-page of Annual Report) was noted.

#### 1984 PROPOSED BUDGET

The following questions regarding the Proposed Budget were asked, to which Chairman Zarvin Kasparian responded on behalf of the Parish Council.

- Q. What does the figure of \$30,000, under Salaries and Other Services, represent?
- A. It is the same as last year secretary, custodians, choir directors, organists, etc.
  - Q. Why is the Building Maintenance figure so high?
  - A. The concrete shoulders around the Church and also the stucco around the arches of the Cultural Building are in bad shape and in need of repair. These are some of the anticipated repairs.
  - Q. Why is the assessment to the Diocese so high?
- A. The Canadian parishes now have their own Diocese and are no longer part of ours. The percentage of the toal Diocesan assessment formerly borne by the Canadian parishes will have to be absorbed, pro rata, by the Eastern Diocese parishes. Also, the 1983 Diocesan Assembly voted a sum of \$25,000 for the Theological Education Fund. This sum is to be assessed on a pro rata basis to each parish in our Diocese.
- Q. Line item "Church Car Replacement." Is the Church planning on purchasing a new car?
- A. Not immediately but the present car is not in good working condition and eventually will need to be replaced. It was therefore deemed advisable to begin to build up a fund to purchase a new one, when necessary.

- Q. Why is the Automobile Allowance slightly high?
- A. It has been the same for about five years.

A question was raised regarding the Equipment Purchases figure and what it represented. Mr. Leon Kachadorian responded that the large freezer in the Cultural Center is not working efficiently and that plans to replace it with new freezers are being made; that the refrigerator in the Church Hall kitchen needs replacement; and that the copying machine in the Church office needs to be replaced.

Mr. Torkom Boyajian asked why there was a difference in figures in the Transfer Account on page 24 and on page 18. The Assembly was informed that the noted difference was a result of the amount of money transferred by the Beano Committee in accordance with the Massachusetts Lottery Commission rules and regulations. The additional sum, having been accumulated over a period of time rather than over the course of one year, may not be available in the future.

Upon a motion made by Mr. George Herosian and seconded by Ms. Berjoohie Zakarian, it was VOTED: to accept the 1984 Proposed Budget.

Mr. George Herosian now complimented the Council for having kept the actual expenses of 1983 below the proposed budget figure.

#### PARISH HOUSE STUDY

Chairman Kasparian reported that at the last Special Parish Assembly the Council was charged to come up with the study and figures on three options for the Parish House. They were (1) to tear down the existing building and construct a new one, (2) to utilize the lower front area of the Cultural Center and, (3) to look into refurbishing the existing Parish House. He informed this Assembly that several contractors, architects and the WRA were contacted and all the above possibilities have been examined. He asked when the Assembly would like to hear the reports.

Upon a motion made by Mr. George Herosian and seconded by Ms. Bizer Simonian, it was VOTED: to request the Parish Council to call a special parish assembly within 60 days to discuss the status of the Parish House.

A couple of suggestions were made to the Parish Council for the special parish assembly. One by Mr. Harry Sahagian to have proposals available prior to the special assembly; and a second suggestion by Mr. George Herosian that the Council be prepared to give estimated figures as to what each project will cost.

At this point, Assembly Chairman Najarian called upon the Chairman of the Nominating Committee, Dr. Vahram Uluhogian, for the election results. Dr. Uluhogian reported that 199 ballots were cast, and that the results of the election were as follows:

Upon a motion made by Mr. Vahan Pogharian and seconded by Mr. Torkom Boyajian, it was VOTED: to accept the Nominating Committee's report of the election results.

Mr. John Kabian addressed himself to the Nominating Committee, and to the Assembly, regarding the importance of the Nominating Committee, and the fact that this year's ballot fell short of the number of candidates required for each post, as stated in the By-Laws - which is at least double the number of vacancies for the election. The legality of this ballot was questioned by Mr. George Herosian. Deacon Onnig stated that the ballot, together with the results, are forwarded to the Primate, and that it would be his decision to make.

A request to announce the number of votes received by each candidate was made once again. Chairman Najarian referred to a motion, on the same request, which was defeated by the 1983 Assembly (Page 7 of 1983 report). It was also noted that the results are a matter of record and can be seen upon request.

#### NEW BUSINESS

1. Policy of Parish Council open meetings.

Discussion on the above subject was the first item under new business.

Upon a motion made by Mr. Van Aroian and seconded by Mr. Harry Sahagian, it was VOTED: that parishioners be allowed to attend Parish Council meetings without prior notice. However, if they request an agenda item these items must be submitted to the office one week before the Parish Council meeting.

#### 2. Use of the Cultural Center Building

The use of the Cultural Center was brought up by Mrs. Ruth Haddon. A discussion ensued concerning the priorities for the use of the builing by the various organizations. After much discussion Mrs. Haddon withdrew her inquiry.

3. Use of van donated by Mrs. Hannah Kalajian

Mr. Haroutune Kasparian wanted to know the status of the van and what the Council has done to implement its use.

On behalf of the Council, Mr. Asbed Zakarian informed the Assembly that the Parish Council spent many hours during the course of the year discussing the van. Some of the problems they encountered were: special insurance; drivers; and geographic locations of the elderly parishioners. Recent pleas for volunteer drivers were unsuccessful. As an example of the frustration experienced by the Council in putting the van into use, Mr. Zakarian related his experience at a recent attempt in contacting 40 elderly persons in order to transport them to Church. Only two of these people contacted gave a firm commitment to attend Church, and because of the convenience to him, Mr. Zakarian used his own vehicle for their transportation. This discussion ended with the commitment by the Parish Council to contact the donor, Mrs. Kalajian, regarding the future of the van.

- Status of permanent pastor.
- Mr. George Herosian inquired what the status of a permanent pastor was.

It was stated that the Parish Council is in constant communication with our Primate in endeavoring to obtain a permanently assigned pastor.

5. Two-part annual parish assembly

Mr. Kenneth Krikorian suggested that the Parish Council look into the feasibility to have the annual parish assembly convene in two sessions. In response, the Parish Council said they would look into the practical aspect of a two-part annual parish assembly, or any other format lending itself to proper conduct of the assembly in accordance with the By-Laws.

At this point Chairman Najarian thanked the Nominating Committee and its volunteers and, also, Mrs. Elizabeth Kazarian for the preparation of a delicious meal.

There being no further business before the Assembly, it was moved, seconded and passed to adjourn the meeting, and it was recommended that the reading of the minutes of the meeting be waived due to the length of same, and also allow the secretary time to edit it. Deacon Onnig closed the meeting with a prayer at 5:30 p.m.

#### THE 82nd ANNUAL DIOCESAN ASSEMBLY REPORT

Clergy, Delegates and Parish Council Chairman of the Church of Our Saviour met with their counterparts from other parishes of the Eastern Diocese of the Armenian Church of United States of America in Fair Lawn, N.J., during the period of May 3 thru May 5, 1984. Hosted by St. Leon Armenian Church, the 82nd Diocesan Assembly convened in solemn convocation and had in attendance guests from Etchmiadzin the Very Rev. Father Momik Sarkisian and Rev. Father Moses Ghazarian as well as an observer from the Western Diocese.

The Clergy of the Diocese deliberated in conference from May 1 through part of the day May 3 at nearby Bloomingdale, N.J., following which the first session of the Assembly convened at St. Leon's presided by His Eminence Archbishop Torkom Manoogian. The usual preliminaries of confirming delegates, election of Assembly officers, approval of 81st Assembly minutes, appointment of courtesies committee, parliamentarians, etc., were quickly dispensed and proceeded to address of the Primate.

His Eminence Archbishop Torkom Manoogian seriously challenged his flock to respond actively to the demands of perpetuating our history both on a national and spiritual level. The first concern of our Church is to maintain and fortify the faith which our Fathers have practiced as it alone will hold our people together. His Grace extolls the virtues of the current generation in broad terms of strength in many areas of endeavor and asks that this training be brought to bear in our Church life. These resources must not be wasted but channeled to useful purpose for the glorification of our Church and ethnic continuity.

Archbishop Manoogian stresses the need for more educational materials for both language and Christian study. Development is now under way for new Sunday School curriculum which will enhance the schools for decades to come.

The Primate stresses again the continuing need to encourage our youth in the faith and language of their heritage. He cites the program where twenty of our young students are sent to Armenia every year as guests of the Catholicos resulting in untold measure tying us to the mother land.

Quoting from his address, Archbishop Manoogian says, "We owe our love and care for our past, but also to our future. We owe it to ourselves for our steadfastness and spiritual growth, and most of all, we owe it to the creator of the universe, to our God."

During the Second Session, on May 4th, a report was presented by the Nominating Committee announcing candidates for various Diocesan offices. Ballots were distributed to all accredited Delegates and upon voting, the results were posted as follows:

The Diocesan Council presented its report of activities for the year 1983 through Rev. Father Mampre Kouzouian, Chairman. All facets of operating the Diocese have been documented and published in both languages covering items pertaining to number and assignment of Clergy, Regional meeting details, establishment of Canadian Diocese, St. Vartan Camp, Bema, Fund Raising, Primate's Travel and activities, ecumenical relations, Diocesan Legate and Dept. of Religious Education, Programs and publications of the Armenian Language Lab, ACYOA Seniors and Juniors, Bookstore and Center Management and St. Nersess Seminary. Also numerous other details carried out by staff and volunteer effort.

A report from the Diocesan Council Treasurer, Mr. Sarkis Bedevian was considered by the Delegates. Assets of the Diocese were tabulated in various categories for a total of \$6,072,500. while the same balancing figure was indicated for Liabilities. Approximately \$1,300,000. of the Assets are invested for a return of interest while remainder is in property and funds held for others. Revenue for the year totaled \$1,738,604. while expenses were listed at \$1,632,874. thus establishing an excess of \$105,730. for the year 1983.

Details of accounting were independently certified by an outside firm and by the Diocesan Auditing Committee.

A Budget of \$1,579,000. was approved for current (1984) operations of the Diocese.

Rev. Father Arsen Barsamian was then invited to report on Proposals submitted for consideration by the Delegates. Two amendments of the By-Laws were submitted for the second year in succession and having been approved will now have to be ratified by His Holiness Vasken Catholicos and then will change Articles 59 and 65% as specified.

Clarifying changes to Article 62 and 97 were approved and will be implemented when approval has been made for a second time.

Approval was given to a proposal that will establish a Dept. of Continuing Pastoral Education and Renewal.

A proposal that the Diocese decree a nationwide commemoration of Martyr's Day was approved.

A proposal to have the Assembly review and justify the Diocesan Budget for the year ahead rather than that of the current meeting was approved.

A proposal to establish a Diocesan Commission to examine areas of Church liturgical life that may be in need of reform and report to next Assembly was approved.

A proposal to appoint a committee for study and preparation of standards to be used as procedural guide lines on the work of Standing Committees was approved.

Those through 1987 were confirmed, others tentative.

An extensive report for a possible Hye Rise building complex on the site where current Diocesan House stands was submitted by a committee authorized by the Diocesan Council. An appraisal has been submitted by a consulting real estate firm wherein a building 36 to 40 stories would be erected on the basis that a 99 yr. ground lease would be extended to a

be erected on the basis that a 99 yr. ground lease would be extended to a developer. There are numerous intricacies to the plan involving local zoning laws, air rights, etc. and the Assembly concurred that the Diocese be authorized to retain professionals to prepare the development criteria and contract negotiation with full consideration of aesthetic values involving the Cathedral, provision for an architectural rendition and submit for final review and approval by the Diocesan Assembly.

Mr. Zarvin Kasparian, Chairman of an ad hoc committee to prepare a Regionalization plan for use by the Diocese in decentralizing some of its responsibilities was submitted in detail and given considerable review by the Assembly. This plan has been a Project Study for the past 15 years and is now revised and recommended as an adequate solution to administer a region wherein a number of Churches will co-operatively enhance their mission.

The plan was approved and it was further decided that a trial period of one year in the New England Region be implemented. A budget of \$20,000. was approved for the period with the provision that one half of the amount is to be funded by the Diocese and one half by the Parishes of the Region.

Judge John Najarian reported again on the activity of the Unity Committee indicating an encouraging attitude for the completion of the current stage of negotiations. That is; completion of the By-Laws. Pending unforseen circumstances Judge Najarian expects this work to be completed by Sept. 1984 after which the document will have to be ratified by both sides. This should then lead to continued rapprochement and discussion of succeeding stages.

A statement by the St. Vartan Camp Committee was inconclusive and it was asked to continue its work for a comprehensive plan to acquire a suitable site for report to next Assembly.

Favorable response was made to a proposal by Mrs. Rose Akulian that videotapes of Diocesan commemorative programs, concerts, etc., be made available to the Parishes.

Armenian Church Endowment Fund reported that total deposits now stand at \$506,000. Note that 1983 revenues of the Diocese include a donation from ACEF in the amount of \$90,368. which is used in operations.

We cannot close this report without a reference to the exemplary preparations of St. Leon's Assembly Committee and the tremendous pride with which Rev. Fr. Paree Metjian conducts the affairs of his Parish. Everyone was extremely helpful and hospitable. A magnificent Badarak on Sunday, May 6th, was celebrated by Very Rev. Fr. Momik Sarkisian whose homily referenced a description of the Parish of 14,000 sould he officiates in Armenia, his gratification at being able to visit here and the profuse blessing he brought to us from His Holiness, Vasken Catholicos of All Armenians.

Furthermore, we must comment on the brilliant banquet closing the Assembly held in the beautiful Abajian Center. At this affair, the award "Friend of the Armenians" was made to Senator Bill Bradley of the United States Senate. He expressed deep concern for the Armenian Genocide. Sincere sympathy for the martyrs and their survivors. The Senator is now sponsoring a resolution with 19 members of the Senate that the United States State Dept. acknowledge the historical fact of the tragedies of 1915 to 1923. He received standing ovations on these statements and at the conclusion of his address.

Our Primate closed the Banquet with demanding and impassioned words that we hold fast to our Faith and closed with Benediction.

Finally, we report what we believed to be "good news" indeed. Delegates, and newly elected Parish Council Chairman Asbed Zakarian sat in conference with Archbishop Manoogian at which time he informed us that Deacon Onnig will be ordained a Priest in the Armenian Church on July 22, 1984, tentatively in Worcester. Upon ordination, Deacon Onnig will be assigned to the Parish of Church of Our Saviour.

The last four months of the year, commencing with our Antranig Badarak on August 19, I celebrated the Divine Liturgy and preached assisted by the deacons, sub-deacons and Church Choir. May God continue to bless them for their unselfish devotion.

Our sermons have been delivered in two languages - Armenian and English in order to reach our entire community. Aside from our Sunday morning liturgies, several special services were offered, such as the following:

#### PRIMATE'S VISITATIONS

His Eminence visited our parish on three occasions this past year:

May 29, 1984 - His Eminence came to Worcester for a special meeting with the Parish Council and Diocesan Delegates regarding arrangements for my ordination.

July 21 and 22, 1984 - His Eminence the Primate ordained me to the Sacred Priesthood naming me Father Aved Terzian.

December 9, 1984 - The Primate made his annual scheduled visitation to our parish. On this day His Eminence ordained five young men to the rank of the sub-diaconate. Also, at that time, His Eminence met with the Parish Council and Diocesan Delegates.

We are always thankful to our beloved Primate for the fatherly love and concern he continues to show us. We pray always for the Holy Spirit to grant him health and peace so that he may continue to guide us, his faithful children.

#### VISITATIONS

As part of our ministry, I have made regular weekly visitations to all-Worcester area hospitals, amounting to a total of 222. I have visited all eight of the area nursing homes during the Christmas and Easter Seasons to offer our elderly and shut-ins Holy Communion.

We have also visited both area cemetaries to bless the graves of departed loved ones at the request of the bereaved families.

In addition, I have shared joyous evenings in the homes of many of our parishioners.

#### COUNSELING

On various occasions, I offered counseling and assistance to individuals and families who were facing difficulties. We have also provided marital counseling, counseling of bereaved families, pre-baptismal counseling of the godfather, and counseling of the sick, the needy and the elderly. We pray that the Holy Spirit grant them all comfort and peace.

#### **PUBLICATIONS**

Our Church monthly publication "The Messenger" is mailed to all members of our parish. Our sincere thanks to the former editorial staff led by Ms. Marilyn Markarian and accompanied by Tara Stepanian, Mark Markarian, and Paul Kheboian, who worked diligently on the quality of the material entered into each issue. Upon undertaking other responsibilities in the parish, the staff was disbursed. The rejuvenation of the paper was a task recently undertaken by Harold Gregory with the accompaniment of Ms. Garine Arakelian, Ms. Susan Hagopian, Ms. Marianne Dodakian and Mr. Aris Arakelian. Our appreciation to both "teams" for their dedication of time and talents.

The Sunday Bulletins are prepared in our office and distributed each Sunday to our congregation, informing them of coming events and requiems. Special fliers and announcements for various occasions are also sent out to our parishioners to inform them of important parish activities.

#### ECUMENICAL RELATIONS

Our relations with all non-Armenian Churches throughout the Worcester area, are mainly through the Ecumenical Council of Churches in which we continue our membership.

We hosted a Week of Prayer and Unity service on Sunday, January 22, 1984 in the afternoon, in which members of the Ecumenical Council of Churches participated in our Church.

April 18, 1984, I attended an Ecumenical Service and participated by reading the Holy Scriptures at the Blessed Sacrament Catholic Church.

My assignment to a task force for the purpose of studying the feasibility of suggesting that special courses be added to the public education system to make the youth aware of history's holocaust, genocide and human behavior, had been successfully completed.

I had the opportunity to spend my post-ordination seclusion at St. Anthony on the Hudson monastery in Troy, New York, under the direction of Father Garen Gdanian. I had the occasion for spiritual renewal and meditation and the opportunity to take part in their daily worship services.

#### NEW ENGLAND REGIONALIZATION PROJECT

In effectuating the mandate of the 82nd Annual Diocesan Assembly to implement regionalization in the New England Parishes, the Primate and Diocesan Council have designated Worcester as the central office of the New England Region. The Parish Council in considering the importance of this project and its significance to the future of our Church in America, has made office space available in the Parish House for the Regionalization Committee. The Chairman of the committee and Pro-Tem Coordinator of the Project is Zarvin Kasparian. John Toromanian, Parish Liasion and I have represented our parish at these meetings.

#### REGIONAL MEETINGS

On December 8, 1984 a Diocesan Regional meeting was hosted in our parish and attended by His Eminence the Primate, New England Church Pastors, Diocesan Council members and Diocesan Delegates.

On March 10, 1984 the Director of the Department of Religious Education of the Diocese, Elise Antreasian and Nancy Basmajian held a Regional Teachers' Training meeting and luncheon. The teachers were informed of the new methods and materials being produced by that department.

On February 4, 1984 our Women's Guild hosted a Regional Meeting and luncheon. They exchanged ideas, made suggestions and shared their successful and not-so-successful event ideas.

#### **EDUCATION**

Due to the apparent lack of enthusiasm, interest and commitment, our efforts to revitalize the Armenian Language School have been in vain. His Eminence the Primate, on his last visit, has expressed his extreme concern and discontent with our present situation. It is a primary concern of the Parish Council and myself to re-establish a thriving Armenian Language School in our Church for our children and a language course for adults, with the help of our community.

## ALTAR SERVERS' TRAINING

We have successfully established a training program for altar servers. These fine young men have not only been learning how to serve at the Holy Altar, but also have learned the correct behavior of one who serves the Church. On December 9, their efforts were culminated in ordination to the rank of sub-deacon. They are: Francis Merzigian, Steve Migridichian, Louis Mikitarian, Robert Shamgochian and David Tateosian. I would like to thank George Sogigian for his time and assistance with this training. We pray for their continued spiritual growth in the Armenian Church.

#### LENTEN PROGRAMS

During the Lenten Season, special educational lecturers were held following a Lenten meal on Wednesday evenings after Church Services. The average attendance of each dinner was over 90 people. It was encouraging to see such a good response which we pray will continue and increase each year.

#### SUNDAY SCHOOL

Under the direction of Tara Stepanian and Steve Krikorian, the Sunday School has increased its enrollment this year. Their dedication, along with the invaluable support of the Sunday School teachers, continued to provide spiritual nourishment and enlighten our children in their faith. May God grant them strength, continued dedication and patience.

#### SEMINAR ON YOUTH MINISTRY

On March 22 through 24, 1984, I accompanied several young members of our parish at a Seminar on Youth Ministry sponsored by the Diocese in Groton, Massachusetts. The attendees found it very educational.

#### ST. NERSESS SEMINARY

On February 5, 1984, our parish welcomed the St. Nersess Seminarians and their Dean Reverend Father Arshen Aivazian. Father Arshen celebrated the Divine Liturgy with the assistance of the seminarians. A luncheon followed Church Services where our parishioners had the opportunity to get acquainted with the students. On this occasion, our parish donated the sum of \$1,000 to the Seminary.

During July and August, St. Nersess Seminary Summer Study Programs were offered at New Rochelle, New York. Several of our youth attended and found the experience rewarding and spiritually enriching.

#### CLARK UNIVERSITY

The Armenian Club members of Clark University, through their advisor, Professor Stanford Gerber-Hagopian, asked me to be the group's spiritual advisor. At their request, I joined them on two occasions and delivered opening prayers, and made myself available for counseling.

During the summer months, on two occasions, we welcomed religious studies and sociology class students from Clark University. They toured our Church and we presented to them a brief overview of the Armenian Church.

#### OTHER

On October 23, 1984, 6th grade students from Burncoat Junior High School visited our parish to view the Leon Hovsepian Art Exhibit. Prior to that they toured the Church and we entertained a question and answer period.

#### FIRST ANNUAL PARISH RECOGNITION DAY

On Sunday, December 9, in conjunction with the ordination of five young men to the rank of the sub-diaconate, our first annual Parish Recognition Day was held. His Eminence Archbishop Torkom Manoogian presided over the event. The co-chairmen for the event were George Herosian and Gilbert Markarian, assisted by their very capable committee. The banquet was well attended. The honorees for this year were: Mrs. Elizabeth Kazarian, Mrs. Armenouhi Jardarian, Mr. Bartev Der Bagdasarian, Mr. Carnig Alexanderian, Mr. George Yagjian, Mr. Antranig Yarumian and posthumously - Deacon Simon Zakarian. We look forward to continuing this yearly tradition.

# CHURCH SCHOOL

1984 was an active year for the Department of Religious Education in New York, and our own Church School.

Two new mini magazines, published quarterly by the DRE, for children and adults have been initiated and well received. The 1985 Curriculum Project is on schedule and expected to be in the classrooms in September 1985.

Here are some of the highlights of the first six months of 1984:

- 4. Children's Bazaar. Held in conjunction with the Church Bazaar and especially for young children. Balloons, games, food and fun and the first of many to come.
- 5. Regional Teacher's Meeting, conducted by the DRE as a workshop for local Church School teachers. This year's seminar, held at the Providence Church, focused on Armenian Religious History.
- 6. Christmas Activities. December was busy with making decorations, tree decorating and organizing a Christmas pagent. We are also proud that our children remembered that Christmas is a time to give. They raised \$272 in donations for the starving people in Ethiopia.

We hope to see the Church School program continue to grow and flourish in 1985.

# LIBRARY COMMITTEE

1984 turned out to be a fairly active year for the Library Committee. We continued to meet monthly with the Cultural Organization of our Church, and participated in programs of mutual interest accenting the culture and heritage of our people.

There were five such activities:

- 1. Promoting the sales of "Worcester Memories" Book
- 2. Lenten Supper
- 3. NAASR Book Fair
- 4. Author Puzant K. Thomajan, speaker
- 5. Art Exhibit of Leon Hovsepian
- 1. <u>Book Sale</u>: This being the first year, the sale of our published book "Worcester Memories" resulted to be a fairly successful venture. With some advertising in the Armenian periodicals and the endeavors of both the members of the Library and the Cultural organization, we realized the sale of 401 copies. At present, we anticipate a slow down of sales because selling books and making it somewhat profitable requires a few years.
- 2. Lenten Supper: Our customary Wednesday night Lenten dinner held on March 21 was a well attended affair where a congenial evening was enjoyed by all. A truly Armenian lenten soup menu was served followed by a color slide presentation by artist, Leon Hovsepian.
- 3. National Association for Armenian Studies and Research Book Fair:
  In April, a one day book fair was sponsored in our Cultural Center. The attractive book displays converted our auditorium into a colorful picture. This occasion offered our people, young and old, an opportunity to learn about their roots and the contributions of the Armenian people throughout their history of 3500 years. Over 550 books, posters and maps, all in English were on display. In addition to the fair, NAASR presented a series of 5 mini lectures delivered by Armenian authors. A question and answer period followed which captured the interest of those present. The excellent attendance at these lectures convinces one that more of these type of programs should be a part of our religious and educational life in our Church. We are spiritually and morally obligated to present to our youth and to the adults all the various phases of our heritage and culture.
- 4. Speaker P.K. Thomajan: On Sunday, May 20, at the fellowship hour, we planned a reception and invited Puzant K. Thomajan, a native son of Worcester and author of "Worcester Memories" to speak. His talk described the home and community life of the early Worcester Armenian settlers. A life that has all but vanished. His witty expressions and the humorous Thomajantic style reflected nostalgic experiences of those days which made it a pleasure to listen to. Books were autographed for those who desired.

Painting Exhibit: October, the month the Armenian people have designated as the month of culture was observed by exhibiting the oils and water color paintings of Leon Hovsepian, a gifted artist of national reputation and another one of our native sons. The exhibit spanned a period of 4 days and each day the artist delivered a lecture accompanied by slides. Those talks were most interesting because the artist brought out his inner most feelings namely the source of his inspiration, selection of subject matter and the colors needed to express his inspiration on the canvas.

Back in 1969, the Library Committee was given 25 volumes of Funk encyclopedia. Since then no one has used these books which are most useful for youngsters. The Library Committee in consultation with Father Aved turned them over to our Sunday School. They glady accepted them.

During this year, we renewed our subscription to the Mirror Spectator for our Church members to read.

We close our books this year with the thought that somehow we have advanced the purposes for which our library was established. Historically, the roots of our present library of our Church goes back to the year 1892. Shortly after the consecration of our Church, Father Sarajian and the Board of Trustees decided that the next important project be that of establishing a national library. At a meeting held on May 22, 1892 with a contribution of \$100.00, a loan totalling \$1,000.00, the Library organization of our Church was established and 230 persons subscribed as members. What a wonderful spirit prevailed then and how we wish the same spirit would prevail today.

We wish to express our gratitude to Mr. & Mrs. Roy and Anne (Zakarian) Hill for their donation of seventy dollars (\$70.00) to the Church Library. Of this amount fifty (\$50.00) is to be used for the purchase of books in memory of the late Kevork and Araxie Zakarian and twenty dollars (\$20.00) also for the purchase of books in memory of our deacon, the late Simon Zakarian. We appreciate their generosity and thoughtfulness for the support of our Church Library.

Also, we wish to express our sincere thanks to Mrs. Yeranoohi Abrahamian for her donation in the amount of ten dollars (\$10.00).
