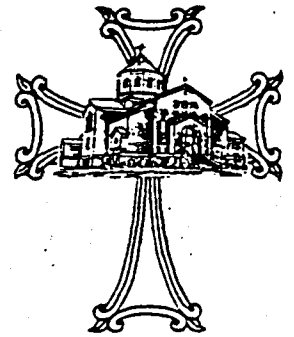

In accordance with the By-Laws of the Armenian Church of America (Eastern Diocese), all dues paying members of the Armenian Church of Our Saviour are hereby invited to participate in the Annual Parish Assembly to held on Sunday, February 20, 1994 at 11:00 a.m. in the Cultural Center immediately following the conclusion of the Divine Liturgy.

All persons 18 years of age and over, may participate in assemblies of the Parish and may vote provided that at least six months have elapsed since the date of their registration as members of the Parish and their 1993 dues have been paid. Members may make payment of outstanding dues on the day of the Assembly to remain a member in good standing. Any question of eligibility may be referred to the Parish Council Secretary and Treasurer.

Voting will take place after the Nominating Committee's report has been accepted by the Assembly at approximately 11:30 a.m. and will close at exactly 12:45 p.m. All voting must be in person. During voting hours, all candidates and parishioners are requested to leave the voting area after they have cast their individual ballots. A luncheon will be served after Church Services between 12:00 noon and 1:00 p.m.

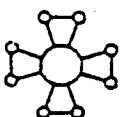
