

#### Minutes of the Annual Parish Assembly Armenian Church of Our Saviour

Worcester, Massachusetts March 10, 1996

Following Church Services, the Annual Assembly of the Armenian Church of Our Saviour convened on Sunday March 10, 1996 at 11:40 AM, with Der Aved Terzian presiding. The meeting was called to order by Richard Maksian, Chairman of the 1995 Assembly. An opening prayer was offered by Der Aved.

72 dues paying members were present at the opening of the Assembly.

#### Election of the Chairman and Secretary

Louis S. Mikitarian, speaking for the Nominating Committee, nominated Richard Maksian as the Chairman of the Assembly. There being no other nominations from the floor, a motion was made and approved to close nominations. The Secretary was asked to cast one vote for Richard Maksian.

Louis S. Mikitarian, again in the name of the Nominating Committee, nominated Arthur Surabian as the Assembly Secretary. There being no other nominations from the floor, a motion was made and approved to close nominations. The Secretary was asked to cast on vote for Arthur Surabian.

#### Adoption of the Agenda

The Chair stated that prior to the approval of the agenda, all topics to be discussed under New Business should be identified at this time.

Jerry Aharonian requested that the Agenda include a proposal asking for the introduction of more English in the Badarak.

Thomas Garabedian requested that the agenda include a proposal asking that the Investment Committee be allowed to invest up to 50 percent of the assets of the Investment Account and Special Account in equity investments.

There being no other additions form the floor, the Chair asked for a motion to adopt the Amended Agenda. Zarvin Kasparian made a motion to adopt the agenda as amended with the above topics. The motion was seconded by Kap Maksian. The motion was passed.

Louis S. Mikitarian thanked his fellow Nominating Committee members for their diligent and dedicated effort and they were applauded by the Assembly.

Louis went on to thank all candidates for supporting the parish by being candidates and stated that there were no losers...all of the individuals are winners for becoming candidates and that they should be congratulated.

The floor was opened to nominations. Louis S. Mikitarian pointed out that for the six positions to be elected, the slate of 12 candidates satisfied the By-laws of the Diocese. There being no further nominations from the floor, Charles Sharigian made a motion to close the nominations for Parish Council. The motion was seconded by Steve Sahagian and was approved.

#### Nominations for the Nominating Committee

The Nominating Committee put forth the following names as candidates for the Nominating Committee (Five to be elected):

- 2) Jay Kapur

- 3) Steven Migridichian
  - 4) Laura Purutyan

Louis S. Mikitarian informed the Assembly that only 4 candidate's names appear on the ballot for the 5 Nominating Committee positions needed to be filled. He informed the Assembly that per the Diocesan By-laws double the amount of names is required. In the event that the conditions of the By-laws are not satisfied, the elections would be subject to the approval of the Primate.

Kap Maksian nominated Bryan Davis who accepted the nomination. The nomination was seconded by Joan Handleman. There being no further candidates nominated from the floor, the Chair asked that the nominations be closed. A vote was taken, with a majority approving the closing of the ballot for Nominating Committee.

#### **Nominations for Auditing Committee**

The Nominating Committee put forth the following names as candidates for the Auditing Committee (two to be elected):

- 1) Richard Dodakian
- 2) Jan Mikitarian
- 3) Norman Noorjanian

The Assembly was informed that four names were required to complete the ballot.

Seth Bilazarian nominated Thomas Garabedian who accepted the nomination. Hazel Eljanian seconded the nomination. There being no further candidates nominated from the floor, George Migridichian made a motion to close the nominations for the Auditing Committee. The motion was seconded by Arek Thompson and was approved.

#### **Nominations for Endowment Committee**

The Nominating Committee put forth the following names as candidates for the Endowment Committee (one to be elected):

- 1) John Sagarian, Jr.
- 2) L. Jerry Stepanian

There being no further candidates nominated from the floor, a motion was made and seconded to close the nominations for the Endowment Committee. The nominations were closed.

Louis S. Mikitarian informed the assembly that the names nominated from the floor would be added to the ballot. He estimated that it would take 5-10 minutes to do so, at which time Der Aved would seal the ballot box and the elections could begin.

to 1:00 PM. The motion was seconded by Kap Maksian. The Chair did not send the motion to vote ruling that a motion to set time is not required. At 12:10 PM the Chair recessed the Assembly and announced that the voting could begin at 12:15 PM. The Chair announced that the voting would close at 1:00 PM at which time the Assembly would reconvene. The Chair announced that lunch would be served during the voting.

Voting was closed at 1:00 PM and the Assembly re-convened. Chair asked for a count of voting members present. There were 70 voting members present. The Chair was informed that 119 ballots were cast.

#### 1995 Annual Assembly Minutes

In light of the fact the 1995 Annual Reports were issued two weeks prior to the Assembly, Arthur Yagjian made a motion to forego reading of the 1995 Minutes as well as the reading of the Pastor's Report, the Parish Council's Report, and the Church Organizations' Reports. Elizabeth Avakian seconded the motion. The motion passed.

Edward S. Bilzerian noted that on page 7, the work "accepted" be changed to "expected" so that the text read: the \$45,000 shown under the transfer account is not all expected.....

Pauline Agazarian made a motion to accept the 1995 Annual Assembly Minutes. Bizer Simonian seconded the motion. The motion passed.

#### **Auditing Committee Report**

Richard Dodakian, a member of the Auditing Committee, explained the general scope of the audit conducted by the Auditing Committee. He noted that on page 66 of the report, the proceeds from the Church Function Christmas Dance should not have credited to the General Operating Fund. It should have been credited to the Church Building Fund. Richard stated that the reclassification would be properly taken care of.

Bart der Bagdasarian asked if the Auditing Committee prepared all the financial statements and was told that indeed they were.

#### Adoption of the 1996 Budget

The Chair asked Jay Kapur, Chairman of the Parish Council, to address the Assembly on the 1996 Budget

Jay informed the Assembly that in preparing the budget, the Parish Council examined prior years' results, as well as general trends, unusual circumstances from prior years as well as any anticipated changes. He noted that in 1995, income exceeded expenses by approximately \$20,000. Jay stated that in preparing the 1996 Budget, the Parish Council was conservative in projecting income and liberal in estimating the expenses.

Jay noted that on page 78, the income derived from in Lieu of Flowers was budgeted at \$30,000 which represents a \$5,000 increase from prior years. Jay said that the increase was budgeted based on a multi-year trend over the past 4-5 years which showed an average of over \$30,000.

Jay explained the nature of the Transfer account. The number one transfer source is Bingo. Other transfer income is derived from the Church Organizations' year-end transfers. It was noted that Bingo income has been on a steady decline and that the actual 1995 Transfer income did not reach the budgeted figure (29K vs 45K). As a result of this, the 1996 Transfer amount is less than prior years and Jay informed the Assembly that with the adjustment, this year's amount appears realistic.

It was explained that the parish's investment portfolio performed very well in 1995. Though 1995 was exceptional, Jay informed the Assembly that Edward Bilzerian of Dean Witter, the parish's investment broker, anticipated a conservative yield from earnings and gains from the sale of investments at approximately 6%. Based on that information, the Council was conservative in budgeting \$85,000. Jay advised the Assembly that this number appears to be realistic.

Jay noted that the audited figures for the 1995 Armenian Festival showed a \$19,000 profit compared to a \$22,000 figure that the Council was working with when preparing this year,'s budget. He said the council hasn't reviewed the audited numbers and based on their 22k profit, the Council budgeted \$25,000 for 1996. The Council feels that they need to be aggressive with this fund raiser and with an early jump in 1996 and a strong helping hand from the parish, the 25k profit can be attained.

Other fund raising such as the Golf Tournament as well as innovative fund raising by the Church's organizations (Jay thanked the Men's Club and its 1995 Chairman Kap Maksian for the \$1800 generated from their placemat sales program) were addressed. The Golf Tourney under the direction of Edward Kachajian is growing and it is anticipated that it could earn 6-7K this year. Jay indicated that the 10k budgeted for fund raising appears realistic. He stressed that the Council must look at new fund raising opportunities especially in light of the downward trend of Bingo earnings.

Jay presented the following overview on the expense portion of the budget:

A freelance bookkeeper was hired in July '95

The Diocesan Assessment represents the single largest budgeted expense item

The Diocesan Youth Ministry Assessment has not been paid over the last couple of years. Seven thousand dollars has been budgeted however the Parish Council has voted to forego paying the assessment until the Diocese provides a detailed presentation of programs. The Parish Council has discussed that Diocesan Youth Ministry programs may not be as effective as programs that could be developed on a local level. Other parishes in the Diocese have taken a similar stand and in light of this complaint, the possibility exists that the Diocese could rescind the assessment.

Last year the Parish Council asked for a Building Renovation Fund be established. Since then, roof specialist who work with Raymond Hovsepian have advised the Parish Council that there's no need to rush into a program. The roofing company proposed that minor repairs costing around \$3000 would extend the useful life of the roof approximately 3 years. The Parish Council approved the proposal.

The Parish Council received a check for \$24,000 as an insurance settlement for damages incurred in the Cultural Center as a result of Water damages to the floor, carpets, stage curtain, ceiling tiles etc. The floor on the main level was refinished as well as the roof repair and other minor repairs. A 1995 Christmas dance held in December added approximately \$2800 to the current fund balance of approximately \$18,000. The fund appears in the equity section of the Balance Sheet.

The Parish Council is to establish a Building Renovations Committee with General Guidelines. Some of the areas to be studied will be: Fund Raising to subsidize the program, a list of repairs and improvements (Jay advised that the Cultural Center air conditioner is at the end of its useful life and that parts may not be available when it breaks), a renovation

program to the Cultural Center and the Church hall to make the facility more appealing for our parishioners and outside groups interested in renting the facility. The committee will also explore improvements that though they aren't 100% necessary, would be nice to have such as a walk in refrigerator and kitchen updating. Jay explained that the expenditures will be limited to the amount of money that is in the fund. This project is not a budgeted general operating item. Projects will be prioritized and the Committee will communicate with the parish for its input.

The cost of the Catholicos' visit came in at under \$3000. The Parish Council Chairman concluded by answering questions from the floor.

George Migridichian pointed out that on page 75 Estimated Earnings/Gains from investments is budgeted in 1995 at \$75,000 but actual is only \$33,871. Jay explained by saying that approximately \$43,000 of Interest/Dividend income which is another line item, is part of the \$75,000 budgeted item. George stated that this is confusing and recommended that in 1996 the Interest and Dividend Income should be budgeted separately from the Gains account since the items are reported separately in the Income Analysis.

George Migridichian also pointed out that he felt that in light of the 1995 performances, some of the budgeted Church Function items may have been budgeted overzealously. The Parish Council Chairman responded by stating that may be a bit aggressive, but were realistic. He cited the Golf Tourney as one of those functions where growth was anticipated.

George Migridichian stated that through no fault of the Parish Council, the parish is not getting its moneys worth from our full-time custodian Dennis Wilson. Jay responded that the Parish Council has discussed the matter and agrees with Mr. Migridichian and that Mr. Wilson did not receive a pay raise in 1996. The Parish Council is reviewing ways to improve this matter, and that the Council is not at liberty to discuss it further at this time.

Zarvin Kasparian made a motion that when budgeting Investment Income, Gains from the Sale of Investments should be budgeted separately from Interest/Dividend Income. George Migridichian seconded the motion. After an exchange of various views on the matter, Arthur Yagjian asked that the motion be moved. The motion was approved.

A question why the Parish Council hasn't taken an aggressive position in budgeting additional revenue from dues was raised. The Parish Council Chairman, Jay Kapur, explained that until an active Pledge Membership Committee is established, the Council hesitates raising the budgeted Dues Income figure.

Tom Garabedian asked for comments on how the Parish Council was attempting to fill the position of Assistant to the Pastor. The Parish Council Chair explained that since Deacon Randy left that position, Garo Papazian was hired part-time for a 6 month period to help in the Educational and ACYOA programs. Mr. Papazian resigned at the end of 1995, and since that time, the Parish Council is attempting to fill the void.

Dora Garabedian stressed the needs of our youth and made a motion that the parish hire a

full-time Assistant to the Pastor of which one of their responsibilities would be to head up a Department of Youth Ministry. Pauline Agazarian seconded the motion. Various opinions on the matter were expressed. The need for more parental involvement was cited as well as the need for more volunteers to get involved. Der Aved expressed his feelings by telling the Assembly the need to develop programs for our youth is vital for the future existence of the parish. He explained that there is no quick fix to this program. A learning curve will exist as it has in the past. Der Aved informed the Assembly that according to the Primate, there are no current clergy available for this position. Der Hayr referred to his Pastor's Report where it states that the effort will be made to hire a qualified individual to fill this position.

The motion passed.

Zarvin Kasparian asked why the Patriarch of Jerusalem Fund Payable does not reflect any interest income. It was explained that at a prior Assembly it was voted not to allocate interest to the account since the intention of keeping the funds were not intended to be long-term. Der Hayr explained that communication with the Patriarch is going on at this time to determine what is needed so that this fund can be transferred to Jerusalem to do the good work that it was intended for.

Marilyn Larkin asked for an explanation of the cost of Cable Television which is part of the Telephone/Cable account. The Parish Council Chairman said that it was an insignificant amount, somewhere in the \$10-\$15 per month range.

Mrs. Larkin asked if overhead fans in the sanctuary have been considered to lower our heating costs. She pointed out that it becomes extremely warm in the Choir Loft. The Parish Council Chairman stated that the efficiency of the heating system is high on the Building Renovation Committee's priority list.

Mrs. Larkin asked if the Parish owns the residence that Der Aved and his family reside in and was told that Der Hayr personally owns the residence.

Berjouhie Zakarian asked why there's an expense for elevator maintenance. It was explained that periodic maintenance is required by state law to insure the safety of all who use the elevator. The parish has an elevator maintenance agreement.

Arthur Yagjian asked why Etchmiadzin Looma appears on the budget again when in 1995 it was budgeted for \$5,000 and zero funds were transferred. It was noted that funds haven't been transferred in two years, but the allocation is on the records. Der Hayr explained that in prior years Etchmiadzin was fairly self-sufficient and the annual parish transfer was \$500. However, most recently, there is a greater need for funds and the Diocese forwards the funds and bills the parish's when they need the funds replenished, hence the allocation is carried forward on the books in the event that a transfer is requested.

Greg Donoian, Parish Council Assistant Treasurer, asked the Assembly for guidance in establishing the annual salary for the Assistant to the Pastor. The Parish Council Chairman expressed that since three months have already passed in 1996, and that an immediate hiring

is not conceivable, the \$15,000 budgeted for 1996 may be adequate for the remainder of 1996.

Karnig Durgarian made a motion to accept the Amended Budget. Gary Dodakian seconded the motion. There was discussion related to the fact that the \$15,000 budgeted for an estimated six months would not send a feeling of job security to the candidates for the Assistant to the Pastor position. The motion to accept the amended budget passed 30-26. Arthur Yagjian challenged the vote and another vote was taken. Voting members were asked to please stand, and when the votes were counted, there were 29 in favor, 29 opposed.

Agnes Sahagian, Treasurer of the Parish Council, made a motion that the Assembly pass the budget as is, and then when an individual is chosen to fill the position of Assistant to the Pastor, hold a special Assembly to approve the salary offered. Ruth Surabian seconded the motion. The motion was defeated.

Marsha Hovenesian made a motion that the following explanation be added to the line item Assistant to the Pastor Stipend: The \$15,000 budgeted for the Assistant to the Pastor's Stipend is for a partial year and not a full year. Bizer Simonian seconded the motion. The motion passed.

Scott Najarian pointed out that the budget was a guideline for the Council to act upon and expressed a vote of confidence that the council will use sound judgement in establishing the salary in question.

Greg Donoian made a motion that the amended budget be adopted. Agnes Sahagian seconded the motion. The motion passed and the 196 budget was adopted.

Dora Garabedian inquired as to how many times the Messenger is published each year. Jay Kapur indicated that the Messenger comes out 4 times a year.

At this time, the Assembly Chairman, Richard Maksian, acknowledged the delicious luncheon that was served earlier in the afternoon. Kitty Dodakian of the Nominating Committee thanked her co-workers who were applauded by the Assembly.

#### New Business....Ways and Means Committee Report

The Chair asked Arthur Surabian to present the report of the Ways and Means Committee to the Assembly. Arthur thanked all the Committee members who contributed their time to the project and gave special thanks to Joan Davis, Zarvin Kasparian and Richard Maksian who were the core group that put the final package together. The survey that was sent out in late 1994 and 1995 was instrumental in some of the data that was included in the report. Arthur indicated however that in October of 1995 an unexpected roadblock occurred in building the data base that was to be used in inputting the survey. At the time, the Committee was in the midst of the first draft of the Master Plan, and tabled the data base until 1996. The Committee plans to go forward in electronically entering the data.

The Ways and Means Committee made a formal presentation of its plan to the Parish Council

on December 5, 1995. The Council approved the plan and Arthur gave a general overview of the program to the Assembly. He informed the Assembly that it was not the intention of the Ways and Means Committee to present the entire program to the Assembly. It was stressed that if the Assembly endorsed the plan, that the Ways and Means Committee, through the Parish Council, would begin to implement the program. Mr. Surabian stressed that it was the intention of the Committee to have every member of the parish exposed to this program. Arthur explained that our parish is in transition and that the program titled "Reach Out and Touch: Vision 2000...A Working Plan for the 21st Century" is intended to do just that...reach out and touch every parishioner. The presentation gave the Assembly a firm grasp of the plan and an understanding of the overall objectives.

Gary Dodakian made a motion to that the Assembly endorse the plan of the Ways and Means Committee and to give the Committee its support in implementing the program. Steven Sahagian seconded the motion. The motion passed.

Rose Houmere, Chairperson of the Cultural Organization, asked the Ways and Means Committee not to forget to include the Cultural Organization in its plan.

#### New Business.. Memorial Endowment Committee Proposal

On behalf of the Memorial Endowment Committee, George Migridichian, the MEC Chairman, made a motion that the Assembly amend the By-laws of the Memorial Endowment Fund to include the following: The stated minimum amount needed to establish a Memorial Endowment Fund be established at \$500. Agnes Sahagian seconded the motion.

Zarvin Kasparian amended the motion by adding the following: If an individual does not make an initial \$500 contribution, donations can be made in lesser amounts at the donor's discretion, and the funds will be placed in a Memorial Fund Pending. When the \$500 amount is attained, the Pending account will then be transferred to a perpetual living Memorial Endowment Fund account. Mr. Migridichian agreed to the amended proposal. The proposal passed.

#### New Business....Publishing a List of Dues Paying Members

Louis S. Mikitarian submitted the following proposal in writing to the entire Assembly:

- a) That the Parish Council publish and distribute annually via a parish mailing, the list of dues paying members of the Armenian Church of Our Saviour for the previous year.
- b) That the list consist of members in good standing according to the Diocesan Bylaws and the policies of the Armenian Church of Our Saviour.
- c) That the list not contain amounts attributed to individuals.

Mr. Mikitarian's written proposal contained a summary of his views on the proposal. The motion was seconded by Greg Donoian. After an exchange of various views, the proposal was

moved to a vote and the proposal was defeated.

#### New Business.....Reduce the Size of the Parish Council

George Migridichian made a motion to reduce the number of members on the Parish Council form 11 members to 9. As part of the motion, Mr. Migridichian stated that finding candidates is difficult because the job description of Parish Council is so intense. He noted that Church Functions such as the Picnic and Festival were projects that contributed to this overload of responsibilities. He added that he was making the motion with mixed feelings in light of the fact that this year's Nominating Committee did such an outstanding job in filling the ballot. He pointed out that over the past 5-7 years, this year's success was not the case.

Cynthia Houmere seconded the motion. In light of recent success of the Nominating Committee, Der Aved suggested to Mr. Migridichian that he give consideration to tabling the motion. Mr. Migridichian agreed to table the motion. Motion was tabled.

#### New Business....A Study to introduce English into the Badarak

Jerry Aharonian made a motion to appoint a Committee in the parish consisting of Der Hayr and other volunteers to conduct a year long study and to report to next year's Parish

Assembly as to what conclusion it may have regarding the introduction of English into the Badarak. The motion was seconded by Elizabeth Sheehan.

Der Hayr pointed out to the Assembly that the motion was out of order because we are not an individual parish that can go off on our own private mission apart from the Diocese. When it comes to liturgical issues, Der Hayr pointed out that the sole jurisdiction on these matters lies in the hands of the Diocese. Der Hayr concluded by saying that the Primate is aware of this concern and is working with some Midwest parishes on the matter. Der Hayr said that he was open to any suggestions on how to create a better understanding of the service. The motion was defeated.

#### New Business....Investment Committee Investment Policy

Thomas Garabedian made a motion requesting that the Investment Committee be given the authority to invest up to 50 percent of the Investment Account and Special Investment Account in equity investments. The motion was seconded by Karnig Durgarian.

As a result of discussion from the floor, Mr. Garabedian amended his proposal so that it read....Special Investment Account in equity funds and not individual investments. The motion passed.

#### Other Discussions....

Berjouhie Zakarian asked why a Day Care Center can't be established in the Sunday School area. The Parish Council Chairman told her that a committee is needed to volunteer and pre-

sent a plan to the Parish Council since the Council does not have the time to address the matter due to its heavy workload. Diane Johnson pointed out that a fence would be needed to enclose a play area, and that she would be willing to share her expertise on the matter.

#### Acceptance of the Annual Reports

(The Chair went page by page through each report and asked for comments)

#### Diocesan Delegates Report

A motion was made to accept the Diocesan Delegates Report by Bizer Simonian. Hazel Eljanian seconded the motion. The motion passed.

#### Pastor's Report

Zarvin Kasparian made a motion to accept the Pastor's Report. Arthur Yagjian seconded the motion. Bizer Simonian commented that after reading Der Aved's report, it makes us realize how lucky our parish is to have such a hard working, dedicated Der Hayr. The Assembly applauded Bizer's comment. The motion passed.

#### Parish Council Report

Arthur Yagjian made a motion to accept the Parish Council's Report. The motion was seconded by Bizer Simonian. Michael Gulbankian thanked fellow Councillor Mark Der Mugriditchian for finding the roofing company that assisted the parish on the roofing dilemma.

Paul Andonian questioned whether our insurance coverage paid the settlement in the Norma Hohne case. Jay Kapur informed the Assembly that the answer to that question was no, and since the settlement was a "No Fault Settlement", insurance would not have covered the parish.

Arpie Migridichian made a motion that the parish should acknowledge In Lieu of Flowers contributions made by non-parishioners. Mrs. Migridichian volunteered to coordinate this project. The motion was seconded by George Migridichian. The motion passed.

#### **ACYOA Junior Report**

There was no written report from the ACYOA Juniors.

Seth Bilazarian expressed his concerns on the status of the youth organizations. Scott Najarian, Chairman of the 50th Anniversary ACYOA, announced that the 50th Anniversary of the ACYOA events will be held on Memorial Day weekend on Cape Cod and that alumni of the organization would be invited. He noted that the Primate would attend and encouraged inquiries.

#### **ACYOA Seniors Report**

Kap Maksian made a motion to accept the report. Anne Kachajian seconded the motion. The motion passed.

#### **AVAKS Report**

Bizer Simonian made a motion to accept the report. Anne kachajian seconded the motion. Zarvin Kasparian noted that the name of Andrew Shadbegian was omitted and should have been listed as a volunteer. The motion to accept the report passed.

#### Babies' and Toddlers' Program Report

Anne Kachajian made a motion to accept the report. Kap Maksian seconded the motion. The motion passed.

#### **Cultural Organization Report**

Paul Andonian made a motion to accept the report. Elizabeth Sheehan seconded the motion. The motion passed.

#### **Ekmalian Choir Report**

Pauline Agazarian made a motion to accept the report. Elizabeth Sheehan seconded the motion. The motion passed.

#### Memorial Endowment Committee Report

Agnes Sahagian made a motion to accept the report. Mark Der Mugriditchian seconded the motion. The motion passed.

#### Men's Club Report

Bizer Simonian made a motion to accept the report. Anne kachajian seconded the motion. Kap Maksian mentioned that the financials of the Men's Club were late in being submitted and hence were not included in the Annual Reports. The motion passed.

#### Sunday School Church Report

Paul Andonian made a motion to accept the report. Elizabeth Sheehan seconded the motion. Berjouhie Zakarian asked why expenses are shown, but income from the endowment funds are not shown. In answer to the question, it was pointed out that indeed that there was income derived from the endowment funds, and that they were credited to the Sunday School expense account in the General Ledger and that the endowments were netted against the expenses. It was requested that in future Sunday School Reports, endowment income be listed in the Sunday School Report as well as in any other reports that endowments might

affect. The motion passed.

#### Women's Guild Report

George Migridichian made a motion to accept the report. Bizer Simonian seconded the motion. The motion passed.

#### **Bingo Activity Report**

Zarvin Kasparian made a motion to accept the report. George Migridichian seconded the motion. John Toromanian said that the Bingo Committee was very disappointed that the smokeaters hadn't been cleaned. The Parish Council Chairman told him that the matter would be addressed.

Mr. Toromanian thanked the loyal individuals who have given of their time so unselfishly over the years. He went on to say the recruitment of new volunteers has been void and that he wanted to make the Assembly aware that volunteers are needed now to replace the current group of Bingo volunteers immediately.

The motion to accept the report passed.

#### **Auditing Committee Report**

Zarvin Kasparian asked why the report says the Auditing committee prepared and examined the financial reports. He noted it should have read "examined the financials and prepared the following reports." The correction was duly noted.

Bizer Simonian made a motion to accept the Financial Statements appearing of pages 64 through 76. Elizabeth Avakian seconded the motion. The motion passed.

#### **Election Results**

For the Nominating Committee, Louis S. Mikitarian read the results of the elections. The results were as follows:

### **Diocesan Delegates Report** 94th Annual Assembly

May 2-5, 1996

Our Delegates Attending: Rev. Father Aved Terzian, Seth Bilazarian, Suney Kachadoorian, George Migridichian, Robert Shamgochian, Lutwig Stepanian and Asbed Zakarian. Louis S. Mikitarian, Parish Council Chairman and Zarvin Kasparian, Chairman of the Diocesan Unity Committee and Chairman of the New England Regional Council were also in attendance. Also in attendance from the Armenian Church of Our Saviour were Marilyn Larkin, Womens Guild Chairlady, Marilyn Markarian and JoAnne Sivazlian delegates from the Womens Guild. Marilyn Larkin also represented the Womens Guild Central Council as an advisor.

The first order of business was the election of the Assembly Officers. The Assembly elected Dr. Garo Garibian of Cheltenham, PA as its Chairman and Arthur S. Mardigian of Detroit as its Vice-Chairman, Armenian Secretary, Very Rev. Father Nareg Berberian and English Secretary, Berjouhie Haigagian. Upon approval of the 93rd Diocesan Assembly minutes,, a message from His Holiness Lord Lord Karekin I, Supreme Patriach and Catholicos of All Armenians was read to the delegates as well the telegram from the Primate to His Holiness. In his message, His Holiness Karekin I expressed his appreciation for the achievements on the part of the Primate, the Delegates, the Diocesan Council and other bodies of the Diocese, Parish Councils and affiliated organizations made over the last year on behalf of the people of the Eastern Diocese of the Armenian Church and the Mother See of Holy Etchmiadzin.

A Clergy Conference report to the Assembly was given by Deacon Norman Odabashian which took place April 30 - May 1. Matters discussed were the visitation by His Holiness Karekan I, a unified Church and the importance of our youth in the Church and a reflection of the importance of maintaining our cultural heritage.

The Diocesan Report was presented by Judge Vincent Gurahian, Diocesan Council Chairman. Some of the major points of interest were as follows:

- a) The St. Varian Cathedral and Diocesan Complex renovation was close to completion by the end of 1995 at a cost of \$3,500,000.
- As of December 31, 1995, the number of fully organized parishes in our Diocese is 43. Of these, 35 have pastors. There are 17 mission parishes and 4 mission communities that comprise those without elected officers and delegates. New mission parishes were organized in Nashville, TN and Lansing, MI. There are older parishes that are considering merging.
- c) Achieving a balanced budget was a major concern of the Diocesan Council. With the cooperation of the Diocesan staff, efforts are on going to keep budget expenditures in line with revenues.

d) There are a number of immigrant Armenians within our Diocese who must be helped by the Church and who in turn will bring added strength to our Church heritage and culture.

The Fund for Armenia Relief (FAR) was presented by Simon Balian who indicated that the fund continues to be the most important Humanitarian relief fund and stabilizing factor for Armenians in Armenia. In 1995, \$28,000,000 in goods and services were distributed in Armenia and hopefully the same amount will be distributed in 1996.

#### 2nd Plenary Session, Friday, May 3, 1996

The first order of business was the election of members to auditing, nominating and proposals committees and one member to the Diocesan Board of Trustees.

Next order of business was the Primates address. In his address, he stated the most remarkable event of the last twelve months occurred at the beginning of 1996 was the Pontifical Visit of His Holiness Karekin I. His visit galvanized our Diocese like no other event had in the past. His Holiness touched the hearts of our people and captivated their imagination. His Holiness and Our Primate Khajag Barsamian met with President Clinton and other political and religious leaders. These visits left deep and positive impressions and generated enormous good will for and among Armenians in this country. Despite our small numbers in this country, Armenian prestige in America is very high.

One of the factors consistent in the Diocese mentioned as a barrier to greater participation in the Church concerns the continuing division throughout our communities. Having witnessed our people from every rank and quarter gathering around His Holiness, there is no longer any reason to remain separated. Now is the right time to take an important and historic step. With this in mind, the Primate announced to the delegates that in accordance with the prerogatives granted him as Diocesan Primate, he will begin allowing clergymen serving under the jurisdiction of the Catholicate of Cilicia to participate in liturgical functions with his permission. On each occasion, the local priest shall apply in writing to the Primate for permission to hold a joint service. The purpose of taking this bold step is an attempt to heal the fracture in the Armenian Church in this country.

He focussed on 1996 as "The Year of the Youth" and 1996 also marks 50 years of the AC YOA founding by Archbishop Tiran Nersoyan. The Primate reminded the delegates that in the year 2001 the Armenian Church will celebrate its 1700th anniversary of the conversion of Armenia to Christianity.

After the Primates address, the delegates attended one of three (3) discussion panels where the focus was on youth and their involvement in the Church. In each of these panels view points were expressed by our youths ranging in age from early teens to young professionals.

#### 3rd Plenary Session, Saturday, May 4, 1996

The 1996 Diocesan proposed budget in the amount of \$3,573,260 was reviewed and approved

by the delegates. In 1995, the Diocesan expenditures exceeded total revenues by the sum of \$70,657. In addition \$3,100,000 dollars was borrowed from the Armenian Church Endowment Fund (ACEF) to complete the renovations of the Cathedral and Diocesan complex

The Diocesan Unity Committee Chairman Zarvin Kasparian noted that no further meetings with their Prelacy counterparts took place since October 1, 1994. Mr. Kasparian noted that a letter was sent to the Prelacy Committee Chairman on November 22, 1995 requesting that the joint committees commence meeting again and immediately schedule regional seminars for the purpose of review and discussion of the unity by-laws. As of this date no response has been received.

A St. Nersess Armenian Seminary report noted that there were three (3) full time students and seven (7) pre-theological students at the seminary at this time. The renovations to the seminary included heating, air conditioning, plumbing and electrical systems and improvements made to the seminary grounds and facilities.

The ACEF report was presented by Colonel Victor V. Arzoomanian, Executive Director, and he noted that 1995 donations exceeded \$8,900,000 bringing the total fund to over \$32,000,000. The income earned in 1994 and distributed to beneficiaries in April 1995 was \$1,247,000.

The Diocesan Assembly honored two noteworthy individuals during the Saturday night gala banquet: Former Ambassador from the United States to Armenia, Harry Gilmore as Friend of the Armenians and Mrs. Helen Mardigian of Detroit, Michigan as Armenian of the Year.

The 95th Diocesan Assembly will take place May 1-4, 1997 at St. Gregory of Narek Armenian Church of Cleveland, Ohio whose administrator is Deacon Norman Odabashian.

The Armenian-American Church rejoiced at the visit of our spiritual leader, His Holiness Karekin I, Catholicos of All Armenians. As a result of his visit we embark upon a new era - and promise of long-awaited unity with our separated brethren.

The new year ... the first Pontifical visit of His Holiness brought all Armenians of the Worcester Community together. Although it was for just one day ... several hours, in reality, the Catholicos bestowed his blessing upon the Armenians of Worcester, and ushered in the New Year with revived hope and joy. The Catholicos wished to visit the site of the first Armenian Church in America - Laurel Street and witness the humble beginnings, and perhaps feel the spirit of the forefathers of our Church, which lead the way for the establishment of the Armenian Church in America.

Young and old filled the Church on the morning of his arrival. Worcester area clergy including Bishop Patrick Reilly, of Worcester Diocese who addressed the congregation, participated in a most moving celebration. His Holiness Catholicos Karekin I impressed the congregation with his eloquence and knowledge. His message was uplifting and inspirational: "... You have the life your fathers dreamed of..." Our community welcomed His Holiness with open arms and hearts. My appreciation to all who took part in the planning and preparation for the day. Their efforts left a most favorable reflection upon our community. The Mayor of Worcester proclaimed the day "His Holiness Karekin I Day" in Worcester. We presented the Catholicos with a framed photograph of the Laurel Street Church and our present Church, which he admired.

<u>January 18, 1996</u> – marking of the historic occasion. The Catholicos of All Armenians, The Primate of the Eastern Diocese of the Armenian Church of America, and the Pastor of the Armenian Church of Our Saviour, pictured on the front page of the Worcester Telegram and Gazette, with a related story regarding the visit of His Holiness. A photo and caption was also printed in the New York Times on the following day.



#### **ANNUAL ASSEMBLIES**



#### Diocesan Assembly:

Along with delegates from our parish, I attended the annual Diocesan Clergy Conference and Diocesan Assembly which was held, April 29 through May 4, hosted by the Philadelphia, PA. In a surprise announcement, His Eminence the Primate stated that he would grant requests for

participation of the clergy of our Diocese and members of the clergy of our separated brethren.

#### A.C.Y.O.A. Assembly:

The General Assembly of the A.C.Y.O.A. was held, May 23–25, 1996 in Cape Cod, Scott Najarian was chairman. Due to unforeseen emergencies and scheduled annual Memorial Day Weekend grave blessings at our three local cemeteries I could not attend the well-attended Assembly and Celebration of the 50th Anniversary of the A.C.Y.O.A. One of our parishioners, Arthur Yagjian, was honored for being one of the members of the original council.

#### Choir Assembly

The 50th Annual Assembly of the Armenian Church Choirs was held in New York, in October. The Archbishop Torkom Manoogian, Patriarch of Jerusalem was the honored guest of the event. Along with other Diocesan Clergy, I had the honor of meeting with the Patriarch on Friday, October 25, and also met with the Patriarch the following day. Our Choir was represented by its Chairman Norman Noorjanian, who is a member of the Choir Association's Central Council and Vahe Jardarian.

#### <u>VISITATIONS</u>

As part of our ministry, I have made regular weekly visitations to all Worcester area hospitals, and on many occasions, visitations to our parishioners in Boston, the Cape and Rhode Island hospitals. Although routine telephone calls are made to each area hospital by our office, we sometimes learn that a parishioner has been hospitalized and released without a visit from me or my assistant. Sometimes we learn of the hospitalization and plan a visitation only to learn that the person was discharged that morning.

Again, we must remind our parishioners that hospitals do not notify the Church of pastor of a hospitalized parishioner. We request the assistance of each of our parishioners to rectify that situation, sot that no one feels neglected in their time of need. Names of hospitalized individuals may be withheld from the Church Bulletin upon upon request.

We encourage families to notify us of all hospitalizations, even if they are out-of-town. if it is not possible for me to visit, I will request that another Armenian priest make the visitation, as we have done in the past, when parishioners of another Church are hospitalized in the Worcester area.

We have also visited parishioners in all Worcester and Greater Worcester area nursing homes, during the Christmas and Easter seasons, and as requested, to offer them Holy Communion. Once a month, we offer services at Salisbury Nursing Home. Armenians and non-Armenians have been attending our services. Along with our traditional Armenian hymns, we have included a few in English for all to participate. We offer a message, also in English to make them feel welcome. In Holy Trinity and Salisbury Nursing Homes I have met with the Directors and have orga-



nized social programs for our Armenian residents. I have also attended some meetings and luncheons of the Women's Welfare Association.

On many occasions, I have gladly visited the homes of the sick or elderly (shut-ins) who are not able to come to Church, to offer comfort and Holy Communion. In 1996, I have made over 65 such visitations (in addition to hospital visitations). They are most beneficial to the elderly who have felt forgotten by the Church. As much as I enjoy these visits, my schedule does not usually permit me to make these visitations unless they are requested. Please, do not hesitate to make such requests known to me.

We have also visited area cemeteries to bless the graves of departed loved ones: on Memorial Day, following 40-day mass (karrasoonk) services, and at the special request of the bereaved families.

In addition, when our schedule allows, we have taken part in many family celebrations: anniversaries, engagements, birthdays, retirements, achievements, testimonials and social gatherings, at the request of our parishioners. Please notify us in advance, as we are often faced with scheduling difficulties.

#### COUNSELING

Most of my evening hours are passed in counseling sessions. On various occasions, I offered counseling assistance to individuals and families who were facing difficulties, including youths and college students, some of whom are non-Armenian. I consider this an integral part of our ministry. I pray that with God's help I offer comfort to those whom I counsel. I feel strongly about the necessity for pre-nuptial and marital counseling (creating stronger ties with the Church), pre-confirmation counseling, counseling of bereaved families and pre-baptismal counseling of the parents and godparents. And, to ensure that the participants are properly prepared, many of my evenings are spent helping to educate and bring these indiaviduals closer to their Church in anticipation of these sacraments. We pray that the Holy Spirit grant them spiritual growth.

#### Social Services:

In recent years there has been an increased number of parishioners, in need of attention, assistance and consolation. Due to changing laws and language limitations, many are not aware of their benefits and recourse when faced with difficulty. More often than not, the need is greatest when the individual no longer has members of her family to rely upon. Their needs are often physical, psychological, emotional and becoming more frequent this year – financial.



At times we are faced with parishioners who are in desperate need of temporary financial assistance for food, rent or other necessities. They often do not qualify or cannot wait for public assistance – and come to their Church as a last resort. The assistance made to them is available through the Outreach Fund and Pastor's Discretionary Fund – however, the need is greater than we can afford. I sincerely thank those who selflessly donated to these funds this year, so that we may continue to help those in need. I also thank the Parish Council for their support in this endeavor.

Further, I try to make myself available for the sick, troubled and the needy of our community, as they are in spiritual as well as physical pain. I pray that my visits lighten their burdens and help ease their suffering.

#### CHURCH PUBLICATIONS

#### The Messenger:

The Messenger, was not published in 1996. Currently the Ways and Means committee has on its agenda to research the viability of this publication and seeks ways to improve communication with our parishioners. We await their recommendations.

#### The Sunday Bulletins

The Sunday Bulletins are prepared in our office and are distributed each Sunday to our congregation, informing them of the day's Requiem Service, English translation of the Gospel reading and announcements.

We sincerely thank Yeretzgin Vivian, who alleviates some of the pressure upon the Church Office by preparing most of the flyers, booklets and special Bulletins, that are published throughout the year.

#### **ECUMENICAL RELATIONS**

Our relations with all non-Armenian Churches throughout the Worcester area are mainly through the ecumenical Council of Churches, in which we continue our membership. On several occasions, we have had the opportunity to perform sacraments with non-Armenian clergy, giving us the opportunity to share the richness of our service with them and they with us. We attended:

#### **NEW ENGLAND REGIONAL COUNCIL**

This year, along with Zaven Kasparian, Chairman, and Jerry Stepanian, I continued membership on the New England Regional Council. As a member I have attended numerous meetings this year. Nov. 16 - Diocesan Council and Primate held a Regional Meeting in Worcester to discuss current issues concerning the Diocese and the Parishes.



#### **EDUCATIONAL PROGRAMS**

#### Armenian Language Classes for Children

Planning for an Armenian Language Program for children began last spring after the results of the Department of Religious Education Council's questionnaire was mailed to parents. The promise of interest and support amongst the parents warranted the effort to make a program available. Through the efforts of Yeretzgin Vivian, a program was developed over a short period of time and was adapted to meet the needs of the participants. Please see the report of the Armenian Language Program for Children for details on the classes. My sincere appreciation to Yeretzgin Vivian for organizing and coordinating the program, as well as developing the curriculum; to Datevig Mardirosian who is developing the lessons and teaching the advanced class to read and write in Armenian; to Ara Billian who is teaching the intermediate level and sharing his knowledge of Armenian history with the children as well; to Alice Piligian who is enjoying sharing her knowledge and gentle ways with the youngest non-reading students. May the language of our forefathers never die!

#### <u>Lenten Programs</u>

During the Lenten Season, we enjoyed very good attendance at special educational lectures which were held following a Lenten meal, on Wednesday evenings after Church Services. The guest speakers were (in order): Dr. Richard Bedrosian, Prof. James Russell, Rev. Fr. Haroutune Dagley. We also enjoyed a comedy play in Armenian "Heevant Des." We thank the members of each of our Church organizations who prepared and served an appropriate Lenten meal on their assigned day. As the Lenten period is a time for inner reflection, we strive to bring forth informative programs to our parishioners and hope that many more of them will take part in the future.

#### · Vacation Bible School

Next summer's program: Monday, July 14 – 18, 1997.

With the invaluable assistance of Kitty Dodakian, I organized a week-long Vacation Bible School this summer. The increased enrollment and enjoyment of the children is indeed an indication of the success of this program. Our gratitude to Datevig Mardirosian, (Armenian Language lessons) Garo Papazian (who assisted with teaching), Linda Bullock, Ann Derderian, Lucy Garabedian, Margaret Pottle, JoAnn Sivazlian and Barbara Wasgatt - who assisted greatly in this a very worthwhile program. This year we had a field trip to the Hiefer Project where the children were exposed to problems of the third world developing countries. This year 26 children participated in Vacation Bible School.



In 1995 we formed a Religious Education Council of qualified individuals to help us better meet the needs of our children. The committee consisting of Yeretzgin Vivian, Karen Durgarian, Dora Garabedian, Paul Avakian, Garo Papazian and Donna McDonald met on 11 occasions. As a result of the meetings, the council prepared a survey for parents, and after many brainstorming sessions, came up with some very creative ideas which lead to the advancements we are now seeing in the Sunday School. Some of the areas that were discussed were: enhancement of the Sunday School curriculum, Teachers Training, Communication with parents

and expanding the Team Teaching concept. We are most pleased that a member of the council, Dora Garabedian accepted the huge responsibility of becoming our Superintendent. She brings with her much enthusiasm, interpersonal and organizational skills.

#### Sunday School

Donna MacDonald, once again, helped us out tremendously and took over the responsibilities of Superintendent, until the position could be filled. Her devotion and dedication to our Sunday School is truly commendable.

In 1996 we witnessed a slight drop in attendance in our Sunday School. Although this is discouraging to the devoted teachers who take time in preparing their lessons, I believe that the unusually harsh winter and prolonged cold and flu season had much to do with the inconsistencies in attendance.

In September, the Sunday School opened with a fresh, clean look. The teachers were treated to a "warm-up day" where they set up their classrooms and got a look at the new Resource Room. Weekly assembly programs were reinstituted which presents an opportunity for announcements, lessons, group singing and worship.

Our deepest appreciation to Dora Garabedian, and all the teachers and staff who have devoted their Sundays to giving the gift of Christian Education to the children of our parish. I cannot thank you enough. Although you may not see the fruits of your labor, know that you are helping to shape the lives of the children entrusted to your care. What we need in our Sunday School is the continued active support and encouragement of the parents. Parents, you ar the primary teacher of Christian Education for your children. The learning never stops, the Church and the home compliment one another – Be good examples to your children, in all that you do. This includes your attendance in Church, participation in Sunday School and in Church activities.

#### Babies and Toddlers Program

The Toddlers' Program provides a place for infants and toddlers to get their first taste of Christian Education, in a loving and playful atmosphere. The parents enjoy each other's companionship, and many friendships have formed or been renewed in that classroom, amongst the children and parents. The "graduates" of the Toddlers' Class are all enrolled in the Sunday School, and many of their parents have become teachers, sing in the Church Choir, and often attend Church Services.

The class is not a babysitting service, far from it. I see it as a unique opportunity for the little ones to share the experience of hearing their first stories of the Bible with their parents. It opens a door for the parents to pray with them before meals, cross themselves, and repeat the stories they hear in class. In addition, the children see their parents participating in the classes, during project and song time. This places an unquestionable sense of importance upon their Christian education. Upon graduation, the children, and equally important, the parents, are better equipped to participate in Sunday School.



I applaud the efforts of Yeretzgin Vivian and the Toddler parents – who for the past 9 years have provided a great service to this Church, by nurturing the babies and toddler children from that young and tender age, which can only lead them closer to God.

#### **CHURCH ORGANIZATIONS**

The Church Organizations and Special Committees are among the fundamental necessities that sustain the Church. Their success and stability are vital to our Church's future. It is not only through their fund-raising efforts, but in the service they provide that we can offer a wide variety of programs for the social, spiritual, educational and enjoyment of our parishioners.

We acknowledge the monetary support of our Church organizations in the past, however over the past few years, this support has been not a primary concern. Perhaps, we have not stressed the importance of the fund-raising function of the organizations. We are pleased that the organizations are, for the most part, enjoying increased attendance, however, due to increased financial obligations, once again, we must urge the executive boards of all Church organizations, to concentrate on at least one fund-raising activity, for the purpose of securing a monetary contribution to the Church, at year-end, and again thank those who have done so this year.

I take a personal interest in each Church Organization, and generally attend each group's regular meetings and functions, and we maintain regular contact with the Chairmen, to keep abreast of their respective organizations.

May God bless all who serve His Church, through our organizations.

#### A.C.Y.O.A.

Lynn Ann (Nanigian) Handleman was given a part-time position to oversee the activities of the A.C.Y.O.A. Jrs. She organized several successful functions and developed a good relationship with the members. We held a meeting for parents and unfortunately only a few attended - we strongly urge parents to become more involved with the A.C.Y.O.A. Jrs. and to provide the necessary support and guidance that is required. Our plans for 1997 are increased activities and membership. In addition, the A.C.Y.O.A. Seniors is in great need of reorganization and leadership, unfortunately they were inactive as a group in 1996.



#### Avak Group

For over 18 years, this organization has provided a place for our Senior Citizens to gather weekly. For many of them, it is the highlight of their week. The hard-working committee provides social activities, holiday dinners, and fair-weather outings. It is difficult to witness the loss of members each year. It is important that we never forget the elderly and their contributions to our Church. New members are always welcome.

#### Basketball Teams

We currently have several active Basketball Teams in our parish, thanks to Kap Maksian. The Sunday night League which involves members of the Men's Club, Junior and Senior ACYOA, is enjoying increased participation, while creating a place for these groups to come together. The newest program which began last year – a Youth Basketball League for ages 7–11, which was coached by Gary Dodakian, and was very well attended.

#### Beano Volunteers

An era has come to an end ... a commitment made 22 1/2 years ago to supplement the Church's income through Bingo. Throughout the years there have been countless number of volunteers who have done their best to make a good impression on those who visited our complex to play Bingo. It has been well-proven that we could not have accomplished all that we have, had it not been for the financial contribution of this organization. This fund-raising effort may or may not continue in our Church, but we will always be grateful for the years of financial support it has given us.

#### Church Choir

We are very fortunate to have dedicated members of our Church Choir. I cannot say enough about their commitment and devotion, and offer, on behalf of all our parishioners, our gratitude. New members are always welcome to our Church Choir.

#### Cultural Organization

It is encouraging to see that this organization has gone through an adjustment period and, and self-evaluation, and has emerged with rejuvenation. They have many wonderful plans to bring different examples of our traditions and culture for the enjoyment and awareness of our community. Meetings

During 1993, the Parish Council, under the Presidency of the Pastor, Rev. Fr. Aved Terzian, held sixteen regular meetings, one Picnic planning meeting, one Armenian Festival planning meeting, and two special meetings.

Church Membership

At year end there were 251 dues paying members of our parish. This is a significant drop from past reported levels. Although the amount reported for dues collected is within \$3,000 of the budgeted amount, it is clear that fewer individuals are participating in full. Many individuals and couples have made a partial payment. Many who have paid dues in the past did not do so at all in 1996. The Parish Council is working to correct this situation.

<u>Visit From His Holiness Karekin I</u>

On January 17, our Church was honored to welcome His Holiness Karekin I to Worcester as part of his visit to North America. On that day, His Holiness led the Hrashapar service, which was followed by a reception in our Cultural Center. The tremendous turnout by the entire Armenian and ecumenical community of greater Worcester demonstrated the recognition and respect for the spiritual leader of the Armenian Church. The presence of His Holiness in our midst proved to be one of the most exciting events our Church has experienced — a day of great excitement and religious renewal. Our parish met the challenge once again in planning for His Holiness' visit (a moving target) and organizing a first class reception for His Holiness. That day, without question, was truly the highlight of 1996.

Major Renovations, Repairs and Maintenance

At the beginning of this year the Cultural Center floor was refinished. In order to protect the newly finished floor, new rubber feet were purchased and installed on all our Cultural Center chairs and tables.

In June, the carpeting in the Church Hall and in the Sunday School classrooms were cleaned.

Painting, plaster and woodworking repairs were performed in the Church proper where water damage had occurred. The Church was insured for these repairs.

The Parish House roof, which had been leaking leading to cosmetic damage on the second and third floors, was temporarily (due to seasonal conditions) repaired. Plans have been made to perform permanent repairs in the Spring on 1997.

Additional repairs and renovations will be performed in the Cultural Center during the first quarter of 1997.

Meeting With Diocesan Delegates

The Parish Council met with the Diocesan Delegates during its March 26th meeting in preparation for the Diocesan Assembly. As this is the final year of a four year term for the Delegates, the Parish Council recognizes and thanks them for their years of dedicated representation and service in matters of importance to our Diocese and on diocesan issues which directly affect our parish.

Youth Director

In April of 1996, Lynne Ann Handleman was hired as a part time Youth Director for our parish. She has been involved with helping to organize and inspire the ACYOA Jrs.

Parish Council Farewell Dinner

The Parish Council Farewell Dinner for "outgoing" Parish Council members Jay Kapur, Mark DerMugrditchian, John Fashjian and Gregory Donoian was held on April 22nd. The Parish Council extends its gratitude to Jay (Chairman for two years), Mark, John and Greg for their years of dedicated service to our Church.

Church Picnic

The Parish held its Church Picnic on June 23rd under the organization of several Parish Council members and the Church Organizations. Along with delicious food and exciting sounds of live Armenian music, the wonderful weather that day helped to make it a successful picnic. Thanks to the many volunteers and contributors, an enjoyable time was had by all.

Dismissal of Custodian

On July 11, the Parish Council dismissed its full time custodian, Dennis Wilson, for performance reasons.

**Contract Services** 

The Parish Council contracted with companies to clean the interior of the Church buildings, to perform landscaping and to remove snow from our walkways, stairs and entrances.

Camp Vartan Subsidy

The Parish Council awarded a partial subsidy to Camp Vartan for Alexis Babaian. The Parish Council encourages all the parents and youth of our parish to discover and participate in Camp Vartan, the St. Nersess Summer Religious Study Conference, Young Professionals Trip to Armenia, and other retreats and religious programs. Each year, funds are budgeted to subsidize the young men, women and boys and girls of our parish for these activities.

Armenian Basketball Team Preparation

In July, the Armenian National Basketball team was scheduled to play in a tournament in Worcester. After a significant amount of planning and preparation to welcome the team and display our hospitality, the Parish Council was disappointed to learn at the last minute that they would not attend. The Parish Council thanks Kap Maksian, who with short notice, led the activities our parish had planned for the team during the week that they would have been in Worcester.

Mailing List Upgrade

As it turned out, the upgrading of the Church mailing list during the second half of the year was one of the Parish Council's largest projects during the year. Late this past Spring, the Parish Council became aware that many names were missing from the existing Church mailing list. It was clear that for several reasons, the mailing list had become out of date and inaccurate. The most serious ramification of this situation was that many members of our parish were not receiving any form of written communication from their own church — a situation which the Parish Council and Der Hayr recognized required immediate action. Several members of the Parish Council spent many hours reviewing the old mailing list, the Church Rolodex, phone books and dues lists to come up with a starting point. Prepaid address correction postcards were included in the first mailing using the new mailing list. Even though the Parish Council worked hard to make the list as accurate as possible, many responses were received from address corrections to "OK as is" comments.

This resulting computerized database includes over 150 new addresses. It's easy

to maintain and update. It will greatly improve the ability of Der Hayr, the Parish Council and other organizations to communicate with the Church of Our Saviour, family. It will also be a valuable tool for the Church Secretary. In the future, it will be enhanced with phone numbers and information acquired through the Church Survey and can be used to support other church committees and activities.

The Parish Council thanks our parish for its patience while the mailing list was being updated. The Parish Council feels it was a worthy and vital task.

### **Golf Tournament**

The Church held its third annual Golf Tournament at Sterling Country Club in September. After a round of golf under perfect conditions, the players returned to the Cultural Center for a delicious meal prepared by Anne Kachajian and her committee.

### Primate's Visit

On October 6, His Eminence Archbishop Khajag Barsamian, Primate of our Diocese, visited our parish and celebrated the Divine Liturgy. At the end of the Divine Liturgy, His Eminence consecrated the beautiful new side altar in our church which was so generously donated by Mr. and Mrs. Gary Degermajian in memory of the Degermajian and Kalashian families. Following Church services, a banquet was held in the Cultural Center. During the banquet, Ramon Hovsepian was bestowed with the St. Nersess medal for his dedicated service throughout the years, especially in the recent renovations of the St. Vartan Cathedral in New York.

### **Armenian Festival**

The days October 18-19 marked another successful Armenian Festival. All the popular booths were represented, along with the traditional delicious Armenian Festival meals. Especially pleasing this year was the increased success of the country store. The Parish Council was pleased to sell most of the remaining food during a one-day sale on a November Sunday after Church, thus increasing the bottom line.

The Parish Council hosted a Festival Follow-up Dinner and meeting to thank all the Festival volunteers and solicit feedback on the Festival. The Parish Council would like to thank and acknowledge everyone who contributed their time and resources to once again make the Festival an outstanding success. One of the most redeeming rewards was to see the outpouring of volunteerism by our parishioners. This spirit of working together toward a common goal demonstrated what it takes to achieve success both for the Festival and for the Church overall.

Organization of Cultural Center Attic and Supply Room

After the Armenian Festival, a few Parish Council members organized the Cultural Center Attic and the Supply Room. Many people do not even know we have an attic in the Cultural Center. It is accessed through the cloak room outside the main hall. The attic, which is used for storage, had accumulated a lot of "stuff" over the 28 years of the Cultural Center's existence. The stuff was all over the place. Items which would never be used again were tossed out and the remaining items were organized.

Also, the Supply Room in the connector was reorganized and labels were place on the shelves. A supply order sheet was created to that paper goods and other items kept in that room will be easier to order via the Church Secretary.

### Christmas Dance

On December 14, our Church held its second annual Christmas Dance in our Cultural Center. A festive time was had by the over 125 people who attended the dance. The Parish Council thanks Ed Atamian, for chairing this affair, and his committee. Thanks also to John Fashjian, who generously donated the band expense with the hopes that this affair continue to grow in popularity on an annual basis.

Deactivation of Bingo

On December 22, the Parish Council voted to deactivate the Church's Bingo Activity effective at the end of 1996. First and foremost, this Parish Council, on behalf or previous Parish Councils and our entire parish, extends its heartfelt thanks to all the Bingo volunteers, including all the volunteers who worked Bingo since its inception. A special thank you is extended to Bart Bagdasarian and John Toromanian who led our Bingo operation with great skill for over 22 years. The financial results speak for themselves: over one million dollars raised for our church over the years. There is enough room in this report to say what needs to be said about Bart, John and the all the Bingo volunteers throughout the years. Suffice it to say that the Parish Council will be making plans to honor them in the future.

This decision was reached after much consideration, but with a feeling of inevitability. Initially, the issue of the continuation of Bingo was raised because the Member-In-Charge, Bart Bagdasarian, and Co-Chairman, John Toromanian, had submitted their resignations to the Parish Council in November. However, the decision to discontinue Bingo was based on other factors as well.

For years, the Bingo committee has been operating without the proper staffing of volunteers. Attempts to fill its ranks with new blood have not been successful. Many of the same volunteers who worked at Bingo when it started in 1974 were still part of the operation. For various reasons, the existing volunteers were gradually leaving or didn't want to do it any longer.

Also, Bingo revenues and attendance has dropped significantly in the last couple of years. Players are finding are other more rewarding outlets for their gambling dollars. Although our Bingo operation continued to make money, the amount of money being generated made it questionable as to whether the investment of the Bingo volunteers time each Thursday was worth the gradually decreasing rewards.

All of these factors led to this decision, but Bart's and John's resignations forced the hands of the Parish Council to view the reality that no new volunteers would be on the horizon for Bingo and that it was fruitless to encourage an ever dwindling number of workers to continue this endeavor.

Along with the Parish Council's decision to deactivate Bingo was a decision to place the continuation of Bingo on the agenda of the Parish Assembly. Deactivation means that the Church maintains its current one-year license and may decide to reactivate Bingo before the expiration of the license. The Parish Council has no plans to pursue this course but felt that the matter should ultimately be presented before the Annual Assembly.

### <u>Christmas Eve</u>

On December 24, the traditional Feast of St. Stephen and Christmas Eve service was held in our Church. This year, our parish was joined by members of the Worcester Holy Trinity Church. It was a thrilling sight to see so many members from both of the Worcester Armenian Apostolic churches participate in this evening of joy and caroling. After the service, everyone attended a special Christmas eve fellowship organized by our Church's Parish Council and Holy Trinity's Board of Trustees. Thanks go to Father Aved and Father Vazken Bekiarian for "making this happen".

Friday Night Dinners

Friday Night Dinners were held on the first Friday of each Month in September, October and November. These family-priced buffet style informal dinners which are held in the Church Hall are open to the entire Worcester Armenian community. The first two dinners were catered. The November dinner was put on by the Parish Council using the food leftover from the Armenian Festival. The menu varies each Friday. These casual dinners have been well attended by our community.

### Church Hall and Cultural Center Rentals

Our Church was fortunate to be able to rent its facilities for an unexpected number of occasions this year, leading to some unplanned but welcome revenue. These opportunities occurred by word of mouth, by informal promotion and sometimes completely by chance. The Parish Council hopes to more formally promote the use and rental of our Church facilities in 1997. Thanks go to Jay Kapur for promoting our facilities and to Jay and some Parish Council members who monitored the facility for certain events.

Parish Council Attendance at Calling Hours

The Parish Council continued its policy of attending and participating in all Wake Prayer Services of our parishioners who have passed away. In 1996, the Parish Council added a policy to provide a cooked ham to the family of the deceased.

Standing Committees

The Parish Council was once again pleased and thankful to have the valuable assistance of the Standing Committees. The volunteers of these committees have lent their time and talents to their associated activities. Their work has reduced some of the Parish Council's burden and resulted in benefits to our parish for which the Parish Council is grateful.

Ways and Means Committee

The Ways and Means Committee is responsible for assisting the Parish Council in forecasting the organizational, administrative and financial needs of our parish

and laying the groundwork for implementing appropriate modifications to "the way our church does its business." The report of the Ways and Means Committee can be found with these Annual Reports.

### **Investment Committee**

The Investment Committee is responsible for assisting the Parish Council in monitoring the Church's investment portfolio and makes investment recommendations to the Parish Council. The members of the Investment Committee are: Father Aved, Louis S. Mikitarian, Agnes Sahagian, Thomas Garabedian, Karnig Durgarian and Amar Kapur. Edward S. Bilzerian serves as the financial adviser and account manager for the Church.

### **Insurance Committee**

The Insurance Committee is responsible for thoroughly reviewing and making recommendations to the Parish Council on all of the Church's insurance coverages and policies. These policies include Automobile, Religious Institution, Health and Workmen's Compensation. Serving on this committee were: Steven Jorjorian, Richard Maksian, Louis S. Mikitarian, Jerry Stepanian and Gregory Donoian.

Elderly Housing Committee

The Elderly Housing Committee was formed to keep the Parish Council informed of opportunities and the feasibility for the Church to acquire properties for senior members of our parish. In 1996, the property at 30 Boynton St. was placed on the market. The committee has met a few times to discuss this property and some members of the committee toured the building. At the end of the year, the committee remained positive about pursuing this property, though not concrete actions or plans have taken place. Serving on this committee were Father Aved, Louis S. Mikitarian, Tina Bilazarian, Ramon Hovsepian, Steven Jorjorian, Zarvin Kasparian and Asbed Zakarian.

Zakarian Scholarships

Through the generosity of the Asbed and Margaret Zakarian Scholarship Fund, the Church awarded \$500 scholarships towards undergraduate education expenses to two young members of our parish: Andrea Arakelian and Mark Shooshan. Serving on the committee were Father Aved, Louis S. Mikitarian, Jerry Stepanian, Laura Purutyan and Asbed Zakarian

### Personnel And Staff

Reverend Father Aved Terzian served as our Church's Pastor during 1996 for the 12th consecutive year. The Parish Council thanks Der Hayr for his service, devotion and most of all spiritual leadership and compassion to his Worcester flock. The Church is extremely fortunate to have such a gifted, loyal and tireless Pastor. The Parish Council has again enjoyed working with Der Hayr on its various activities.

June Jardarian continued as the Church's Secretary during the year. Also during the year, the Church received other secretarial support from Elizabeth Avakian. Dennis Wilson served as Custodian for a portion of the year. Gharib Gambari served as the part-time Assistant Custodian. Kenneth Burgess continued to serve

as the Church's Bookkeeper during the year.

The Parish Council thanks those mentioned above for providing their essential services to our Church.

### Miscellaneous

A new automated soap dispensing system was installed in the Cultural Center kitchen dishwasher.

The Parish Council replaced many light bulbs in the Cultural Center main hall.

More than a dozen windows or window panes were repaired this year.

During the year, the Church received gifts, bequests, donations and memorial contributions. On behalf of the parish, the Parish Council thanks those who have made donations of these types. # Armenian Language Program for Children

I am very pleased with the progress of this new Armenian Language Program for Children. We currently have approximately 35 students registered in our Program. Although weekly attendance varies, there are many who attend regularly and, naturally, are benefitting the most from our efforts. The classes, outlined below, meet every Sunday morning, during the School year, from 10:00 a.m. to 10:30 a.m. at the conclusion of which the students are led to the Sunday School Assembly area.

The breakdown of our Program is as follows:

**Datevig Mardirossian** – instructs a class of approximately 6 students, who already have a working comprehension and vocabulary of the language. She fortifies their knowledge of the spoken language and is currently instructing them in the written alphabet. The class is conducted solely in Armenian.

Ara Bilian – and I instruct the largest group of approximately 25 students, with varying degrees of knowledge of the language, ranging from "very little" to "good." With repetition and constant reinforcement of past lessons, the class is beginning to develop working knowledge of vocabulary, common phrases and verbs. New material is not generally presented until the majority of the group appears comfortable with what has already been presented. The difficulty is that although there is a good core of students who attend faithfully, there are some who attend sporadically - and naturally, cannot keep up with the group. For them, and for the benefit of the others as well, previously lessons are constantly being reviewed.

In addition to the lessons, Mr. Bilian has presented several history lessons which the class has enjoyed. Although not the main focus of our program, this has added a certain depth to their studies and appreciation of the Armenian Language.

Alice Piligian – has the utter joy of teaching the youngest members of the Program. The class ranges in size from 5 to 10 students, who are not yet able to read. Their curriculum material is prepared specifically for them with coloring pictures - key words are written on the sheets for the parents. Again, the pace of learning new material is somewhat slow, and dependent upon the grasp of the material previously presented. In this class as well, there is a core group of students who attend regularly; however, some attend sporadically and repetition is key.

If the interest in learning the language is sparked in the students of this group, surely they will continue their quest for learning the language. That is our hope.

Although just barely out of the developmental stage, our Program has the potential of being a very beneficial one. The students who attend seem to be very eager to learn the language and appear to be absorbing the material presented to them. With periodic review lessons and constant repetition – and perhaps a little practice at home – they will have the basis for speaking the language comfortably.

My personal gratitude, and on behalf of the children and their parents, to **Datevig Mardirossian**, **Ara Bilian**, **Alice Piligian** and **Dawn Varjabedian** (who has assisted in Miss Alice's class) for their weekly commitment and devotion.

Special acknowledgement and appreciation, to Der Hayr – who initiated this Program and is directly involved in the careful preparation of its curriculum along with the Coordinator.


# Babies' and Toddlers' Program Report

We currently have 30 students registered in our Class (and counting...)! The class meets every Sunday morning, during the School year, from 10:30 a.m. to 12:00 Noon. Parents are welcome to stay with their children, or attend Church Services, at any time during the Class. We often have grandparents, aunts and uncles join us too!

The Toddler's Class is both a learning and fun experience for our "littlest Churchgoers" - and their parents. We strive for easy goals – learning the Sign of the Cross, hearing the name of Our Saviour Jesus, and simplified Bible stories. A very short Armenian Language lesson precedes the Bible Story of the day and is well-received. During June 1996, with dedicated volunteer help, a Resource Room was prepared in the Sunday School wing. The room was painted, and outfitted with bookcases, file cabinets, storage areas, and teacher mailboxes. Religious and teaching materials and resource supplies were combined within the one room. Necessary books and materials were updated for the teaching staff and students. Tote containers, filled with classroom supplies were created for individual classroom use and could be signed out at the Resource Room.

One major goal identified for the 1996-1997 year was to enhance communication between Sunday School and home. Three large bulletin boards were added to the assembly area: two for student decoration and information, a third as a communication center for parents and parishioners. The *Sunday School Exchange*, a newsletter from the Sunday School serves as a communication tool to families and has been published three times in 1996, September, October and December. The first edition was targeted to reach families at the beginning of September, prior to opening exercises. Families have also received notices by flyer.

In addition, the Sunday School published a <u>Family Guide to the Sunday School Curriculum</u>. This publication provides parents with an overview of the scope and sequence of the "We Believe" curriculum.

Other goals identified at the beginning of the year were to provide a warm and welcoming environment, and to promote a Christian Armenian education that is the foundation to a living faith. The theme that was chosen for this year for the Sunday School to help us meet our goals was ... with Praise and Celebration. A banner was donated and is on display in the Sunday School Assembly area as a reminder of our united focus.

Weekly assemblies are being held prior to classroom time. New Assembly Worship booklets were written specifically for the students to help guide them through the service. Mrs. Laura Purutyan has been leading the assembly time where children actively participate through prayer, song, offertory and service.

Keeping to the goal and commitment to contemporize the Sunday School curriculum, additional resource material is being provided to teachers in the Resource Room. Creation of the teacher *Monthly Planner Communication Sheet* provides an avenue to keep abreast of attendance, new students and teachers' needs. A tuned piano was moved into the Sunday School assembly area for use during assembly worship, pageant rehearsals and classroom time. The Sunday School was pleased to welcome the incoming pre-school students, three new families and returning students, giving us a total of 100 families on the Sunday School roster.

The following is an overview of important Sunday School activities from August to December 1996. There has been Sunday School every week with the exception of one cancellation due to snow and two Sundays during Christmas vacation where families were encouraged to worship together.

Aug. 29, 1996:

Teacher Orientation Meeting, 7:00-9:00 p.m. Teachers were introduced, teaching assignments clarified and refined. All teachers received a teaching packet containing the Church's mission statement, Sunday School goals, 4 month calendar of dates, telephone/teaching roster, a sample Sunday School time-agenda. Sunday School Exchange deadlines, Communion/Badarak Schedule for each grade level, a redesigned Registration Form, Monthly Planner Communication Sheet, Opening Day Student letter, various teaching aids and educational materials. A Telephone Calling chain was developed for teacher/student notiftion. It was established that a teachers' meeting would be held once a month alternating between Sunday mornings with a weekly evening meeting to allow Der Hayr to attend.

This plan – termed **Vision 2000** – was developed and presented to the Parish Council and then twice presented to Parishioners in open forums.

The plans summarized the following status and trends affecting the Parish:

- Strong clergy and religious programs, with the diversity of programs constrained by resources
- Stable membership and a slight increase in Church attendance
- Increasing number of marriages with non-Armenian spouse
- Fewer families which speak or understand the Armenian language
- Strong Sunday School enrollment, especially pre-school and early grades
- Expense rate growth higher than income, with declining income from traditional events such as Beano, Rug Sale and Bazaar
- Greater geographic diversity, i.e., increasing population in adjacent and outer suburbs from Worcester
- Multitude of "competing" school and community activities

Based on the committee's research, interaction with parishioners and solicited input, Ways and Means outlined the following Parish Goals:

- Strong Religious and Educational Programs
- Effective and Broader Programs, e.g., elderly, outreach, youth
- Increased Membership and Active Participation
- Financial Stability
- Improved Administrative Management

These goals have been transformed into tangible **Programs** to achieve progress. After further definition and based on input from Der Hayr, the Parish Council and Parishioners, the Committee prioritized and established three initial sub-committees:

- Administrative management
- Communications
- Youth Programs and Organizations

These committees are in various stages of activity. The Communications sub-committee has been evaluating the feasibility and make-up of a Parish newsletter and is finalizing recommendations for Parish Council review. The Administrative Management sub-committee has formulated a thorough questionnaire which will be used with both Armenian and non-Armenian Churches to determine potential improvements in the management of our Parish. The Youth Programs and Organizations sub-committee will be holding its kick-off in February and is designed to develop interactive programs for youth and adults to provide an improved environment within the Church community and to meet the changing demographics of the community.

Our goals for 1997 are to have the three sub-committees develop and present plans to the Parish Council with concrete implementation recommendations. In addition, new sub-committees will be formulated based on the next priority topics from our **Vision 2000** plan. The Ways and Means Committee will continue to monitor the progress of the sub-committees and serve as a catalyst for the entire process.






