#### ARMENIAN CHURCH OF OUR SAVIOUR 1998 Annual Parish Assembly Minutes March 1, 1998

#### Election of Assembly Officers

The Annual Assembly of the Armenian Church of Our Saviour was called to order on Sunday, March 1, 1998 at 11:45 a.m. by Louis S. Mikitarian, Chairman of the Parish Council (Chairman of the 1997 Annual Assembly, George Migridichian, was unable to attend). The opening prayer was given by Reverend Father Aved Terzian.

Richard Bedrosian, Chairman of the Nominating Committee, nominated Gary Dodakian as Assembly Chairman. His nomination was seconded by Joan Handleman. No other candidates were nominated from the floor, and nominations were closed. The Secretary cast one vote for Gary Dodakian.

Richard Bedrosian nominated Jay Kapur as Assembly Secretary. The nomination was seconded by Agnes Sahagian. No other candidates were nominated from the floor, and nominations were closed. The Secretary cast one vote for Jay Kapur.

#### Quorum

The newly elected Chairman of the Assembly, Gary Dodakian, requested a show of hands of duespaid members to indicate a quorum. 86 members were in attendance at this point of the meeting.

#### Adoption of the Agenda

The Assembly agenda was presented for review by the Parish Council. Edward J. Bilzerian made a motion to add item 9b. (Old Business) regarding the Pastor's Health Insurance, seconded by Michael Gulbankian. The motion passed. Zarvin Kasparian made a motion to add item 9c. (Old Business) regarding Stewardship, seconded by Seth Bilazarian. The motion passed. Seth Bilazarian made a motion to add item 13d. (New Business) regarding Youth Programs, seconded by Ruth Haddon. Louis Mikitarian asked if there was a specific proposal, as the Assembly would need to know what it was at this point in order to consider the item. Seth said that there was no specific proposal, but that he just wanted to know the status of any diocese or parish youth programs and participation by our parish youth. The motion passed.

John Chicknavorian made a motion to adopt the agenda as amended. The motion was seconded by Dorothy Surabian. The motion passed. The Chairman called on Richard Bedrosian to present the nominations for the 1998 Ballot.

#### Nominations for Parish Council

Richard presented the following names of the Parish Council candidates nominated by the Nominating Committee:

Der Hayr indicated that the number of nominees did not meet the Diocesan By-Laws requirements for two times the number of candidates as open positions (6) and requested additional nominations from the floor. Several persons were nominated and respectfully declined to become candidates. They were Kap Maksian, Paul Avakian, Herman Purutyan, Seth Bilazarian, Steven Migridichian, Edward S. Bilzerian, Harry Dodakian, Gladys Andonian, Ruth

Haddon, Vahan Pogharian, Louise Toromanian, Richard Bedrosian, John Chicknavorian, Darrin Migridichian, Jay Kapur, and John Sagarian, Jr.

Michael Arakelian was nominated by Herman Purutyan, seconded by Paul Avakian. Michael accepted the nomination.

Der Hayr expressed concern that the ballot was still considered "illegal" according to the Diocesan By-Laws, and would be subject to approval by the Diocesan Council. He mentioned that while we were allowed to present a ballot with an insufficient number of nominees in the past, it was not guaranteed that it would be accepted this time. He said that a parish of our size should be able to put forth a complete ballot, with all positions duly contested. Ruth Haddon said that in order to attract more candidates for Parish Council, we would have to lessen the workload of the Council. Arthur Yagjian asked if we could reduce the number of Parish Council members. Der Hayr said that it would be the decision of the Assembly, and that a minimum of seven and maximum of fifteen members were the only requirements of the By-Laws. Michael Gulbankian was adamantly opposed to such an idea, and said that the number of Parish Council members had to be representative of the number of parish members.

Der Hayr suggested that dues-paid parishioners submit their names for the purposes of completing the ballot, with the understanding that they were not interested in actually getting elected. The Chairman stressed that anyone doing so would be still considered a candidate and that nothing was guaranteed. Der Hayr said that if someone was elected that did not wish to serve, they could resign. Der Hayr said that other churches in the Diocese have used this method in the past in order to complete the ballot. Edward J. Bilzerian asked if there were any dire consequences if we did not present a legal ballot. Der Hayr said that the likely worst-case scenario would be that we would have to hold another Assembly.

Herman Purutyan and Seth Bilazarian expressed concern about Der Hayr's suggestion, and advised against putting together a "misleading" ballot. Nevertheless, Charles Sharigian volunteered to have his name added to the ballot, seconded by Joan Handleman. Arthur Yagjian also volunteered to have his name added to the ballot, seconded by Edward J. Bilzerian.

Ben Bullock was nominated by Katherine Dodakian, seconded by Vahe Jardarian. Ben accepted the nomination.

At this point, Berjoohie Zakarian made a motion to close the nominations for Parish Council, seconded by Richard Dodakian. The motion passed without objection, and the final Parish Council ballot was as follows:

Elizabeth Avakian nominated Paul Avakian, seconded by Mark Markarian. Paul accepted the nomination. Louis Mikitarian nominated Steven Migridichian, seconded by Katherine Dodakian. Steven accepted the nomination.

At this point, Ruth Haddon made a motion to close the nominations for Nominating Committee, seconded by Berjoohie Zakarian. The motion passed, and the final Nominating Committee ballot was as follows:

Richard indicated that the number of nominees did not meet the Diocesan By-Laws requirements for two times the number of candidates as open positions (2) and requested additional nominations from the floor. Edward J. Bilzerian declined nomination for this position. Jan Mikitarian made a motion to close the nominations for Auditing Committee, seconded by Ruth Haddon. The motion passed, and the final Auditing Committee ballot was as listed above.



#### **Nominations for Memorial Endowment Committee**

Richard Bedrosian presented the following names of the Memorial Endowment Committee candidates nominated by the Nominating Committee:

Seth Bilazarian John Chicknavorian Mardieros Mooshagian Arthur Yagjian

Arthur Yagjian asked why there were two open positions for Memorial Endowment Committee. Der Hayr explained that because Gilbert Markarian was unable to complete his term due to illness, the next available alternate from prior elections, John Sagarian Sr., completed the term for a period of one year. Therefore, the highest vote getter would serve for five years, and the next highest vote getter would serve for four years. Elda Malesky made a motion to close the nominations for Memorial Endowment Committee, seconded by Margaret Belles. The motion passed, and the final Memorial Endowment Committee ballot was as listed above.

The Chairman proposed that the voting begin as soon as the final ballots are prepared (approximately fifteen minutes), that lunch and voting take place at the same time, and that the meeting reconvene at 1:15 p.m. This schedule was approved by the Assembly.

Louis Mikitarian announced the procedure for vote counts during the Assembly. At the time of ballot voting, blue ("yes", "for") and yellow ("no", "against") cards would be handed out to dues-paying, voting members of the parish. These cards would be used during the Assembly.

The Chairman reconvened the meeting at 1:25 p.m. The Chairman requested a show of blue (yes) cards to note the number of voting members present. 70 members were counted.

#### 1997 Annual Assembly Minutes

The 1997 Annual Assembly Minutes were reviewed, and the following changes were approved:

Page 4 - The sentence, "He agreed with Zarvin Kasparian that the church should have professional help to audit the books at the end of the year" be stricken.

Page 8 - That "...a list of amounts given by each member be published" be changed to "...a distribution of the amounts given by the membership be published"

#### **Auditing Committee Report**

Zarvin Kasparian objected to the terminology used at the beginning of the Auditing Committee Report stating that the report was "prepared" in "accordance with" Diocesan By-Laws. He noted that the responsibility of the Auditing Committee was not to prepare the reports, but to audit the financial records of the church. Richard Dodakian of the Auditing Committee explained that the Auditing Committee reviewed and audited the financial records and results provided by the Treasurer of the Parish Council and the church bookkeeper. Zarvin thereby made a motion, seconded by Edward J. Bilzerian, that the term "prepared" be eliminated from the report. This motion was approved.

Berjoohie Zakarian expressed displeasure that income from her ACEF fund did not show up in any of the financial reports or the Sunday School report. She said that interest from the fund she established in the ACEF was intended to benefit the Sunday School of our church. She noted that there was no acknowledgment of this income in the Sunday School report. Louis S. Mikitarian noted that on page 75 of the financial reports, there was a notation on the income statement that ACEF interest income subsidized Sunday School expenses. He said that



donors are not individually listed because the amount listed is an aggregate total of several donors. He did note, however, that every effort would be made to acknowledge these donors in future reports. Edward J. Bilzerian said that the names of all such donors should also be noted in the Sunday School report, as well.

Zarvin Kasparian questioned why income from New England Region service fees (page 75) was listed as \$1100 when he had canceled checks for \$1200. The Treasurer will investigate this matter and the financial records will be corrected, if necessary.

Scott Najarian made a recommendation that the Annual Report be readily available in the church office, as he had difficulty obtaining one during the week. The Parish Council agreed to make the Annual Report easily accessible in the future. Edward J. Bilzerian made a motion to accept the Auditing Committee Report, seconded by Mrs. Rose Aslanian. The motion was approved. Mr. Bilzerian congratulated the Parish Council on a job well done in handling the finances of the church.

#### Adoption of 1998 Operating Budget

Edward J. Bilzerian questioned the figure proposed for "Pledges Collected" in the 1998 budget, and whether uncollected 1997 dues were taken into account. Louis S. Mikitarian explained that a big "carryover" in uncollected 1997 dues was not expected in 1998 (as was the case in 1997) because the Parish Council now sends out dues statements regularly. Louis mentioned that "calendar year" duespaid members rose from 251 in 1996 to 434 in 1997. Mr. Bilzerian also asked whether our Diocesan Assessment should be going down more, since our dues paying membership was significantly less than in prior years. Louis explained that there were several factors that determine our Assessment, and offered a handout for further clarification. Our church paid \$83 per member to the Diocese in 1997. Mr. Bilzerian felt that we should be generating more funds per member. Charles Sharigian said that the church should have a membership drive.

Thomas Garabedian suggested that the actual prior year's results be also listed in the Supplementary Budget Analysis pages for comparative purposes along with the proposed budget figures. Thomas also pointed out that a shortfall is projected for 1998 (before capital expense items) and asked how this would be made up. Louis said that if there was an actual shortfall, it would be made up from the church's reserve funds.

Zarvin Kasparian asked about other repairs that were needed that were not listed under the capital expenditures, such as refinishing the Dean St.doors, repairing the front steps, and painting the peeling wood window casings. Jay Kapur responded that he is assisting the Parish Council in getting minor repairs done, and that the Council has already approved getting the doors done, as well as other

minor paint and plaster work. Louis mentioned that there are many other things that need to be done, but that the Council has had to prioritize by addressing the most crucial items, and that funds would have to be raised in order to make more substantial renovations. He pointed out that the Council is proposing a separate fundraising effort (consisting, in part, of three-year pledges) that would raise a minimum of \$40,000 per year to cover the major capital expenses.

John Toromanian asked about the Contract Services expense item. Louis explained that this covers outside janitorial and snow removal services. He also said that the Council has budgeted for hiring either a full-time or part-time custodian(s) during the year, and that this accounts for some of the increased expenses. John expressed that a hired custodian needs to be on hand to do basic things. Steven Migridichian suggested that the church have a permanent building & grounds committee to oversee capital expenditures and maintenance related issues and enthusiastically volunteered to serve on such a committee. Steven made a motion, seconded by Agnes Sahagian to form a Building and Grounds Committee. The motion was approved.

Arthur Yagjian made a motion, seconded by Edward Bilzerian to approve the 1998 Proposed Budget, as presented. Herman Purutyan questioned whether this meant that all aspects of the budget (capital expenditures and fundraising) are assumed. The Chairman responded that this was correct. Thomas Garabedian felt that item 13a. (Preliminary Renovation Plans and Fundraising) should be addressed prior to voting on the budget. Louis Mikitarian and Jay Kapur gave detailed background about the status of and plans for replacing the Cultural Center roof.

Richard Maksian questioned the \$14,000 for a new copying machine. Louis said that the church makes 250,000 copies per year and that our existing copy machine has gone through twice its expected life (2 million copies). He explained that copier companies will no longer sign maintenance agreements for our machine because of frequent repairs. The budget figure was based on a demo model that appeared to be a good value. The total cost per copy still works out cheaper if the church owns its own machine.

Zarvin Kasparian felt that special assemblies were needed to address specific capital expenditures as more detailed information became available. Berjoohie Zakarian said that the Assembly should have faith in the Parish Council's judgment, and that no special assemblies were needed because these capital improvements require immediate attention. Der Hayr said that ultimately, it was the Parish Council's responsibility to ensure the well-being and safety of the church, according to the Diocesan By-Laws.

Zarvin Kasparian asked about the duties of bookkeeper and that the issue of "Outside Auditors" (item 9a.) should be discussed at this time. Louis Mikitarian discussed the duties of the church bookkeeper. Kap Maksian said that he pursued the issue of outside auditors by contacting several firms for their fees. All auditing professionals that were contacted were not interested in providing their services to the church because the work would take place in January - a very busy time of the year for their regular clientele. One estimate was \$4000 minimum. Der Hayr stressed that according to Diocesan By-Laws, only elected members of the Auditing Committee are ultimately responsible for

auditing the church books.

Herman Purutyan asked about the status of the Youth Director, which was in the budget last year and again this year, but that nobody has been hired. Der Hayr responded that a full-time position was not practical, and that part-time candidates were difficult to find, especially those who are familiar with our church traditions. However, volunteers like Kap Maksian have helped out tremendously with the youth, and have done a good job.



Thomas Garabedian asked about the approximately \$100,000 that was transferred to the church after the closing of the Bingo Account, and if these funds could be utilized for the capital improvements. Der Hayr explained that the Parish Council agreed, as requested by the Bingo Committee, to create a separate fund for this money, so that the legacy of Bingo would perpetuate into the future.

Edward J. Bilzerian requested that the question on the approval of the 1998 Budget as proposed be moved. The motion was approved.

#### Old Business:

As per previous discussions, the Parish Council reiterated that, at this time, additional outside accounting help was not needed. A motion was made by Scott Najarian, seconded by Kap Maksian to accept the Parish Council's recommendation. The motion passed.

Edward J. Bilzerian asked about the status of the Pastor's health insurance policy, and if anything was done to reduce the cost, such as investigating the use of HMO's, etc. Louis Mikitarian said that during 1997, Der Hayr voluntarily entered the Tuft's Community HMO health plan, which costs just under \$500 per month (including dental insurance), saving the church a considerable amount of money. The Assembly commended Der Hayr and the Parish Council for their efforts.

With regards to Stewardship, Agnes Sahagian and Charles Sharigian volunteered to start a member-ship drive.

#### Annual Report of the Pastor

A motion was made by Edward J. Bilzerian, seconded by Dorothy Yagjian, not to read and to accept the Pastor's Report. Scott Najarian expressed that we should encourage our pastor to attend the ACYOA Assembly held during Memorial Day Weekend. Der Hayr said that it was his prerogative whether or not to attend this event, given his busy schedule blessing graves locally during that weekend. The motion passed.

#### Annual Report of the Parish Council

A motion was made by Edward J. Bilzerian, seconded by Charles Sharigian, not to read and to accept the Annual Report of the Parish Council. Steven Migridichian wanted to recognize the outstanding efforts of Richard Maksian and the Parish Council for bringing back the regular publication of the Messenger. Agnes Sahagian said that she and Steven Sahagian donated the chandelier outside the front of the church. The Parish Council said that the donation would be recognized. The motion passed.



#### **Annual Reports of Church Organizations**

A motion was made by Edward J. Bilzerian, seconded by Berjoohie Zakarian, not to read and to accept the Annual Reports of the Church Organizations. Zarvin Kasparian wanted to know why no funds were transacted by the ACYOA Juniors, and why they did not put their money in a checking account that could have earned about \$40 in interest. Kap Maksian explained that although activities

were held by the ACYOA Juniors, they did not entail any transaction of funds. In addition, the checking account has no fees and gives no interest. Steven Migridichian noted spelling corrections of donors on page 55 (Memorial Endowment Fund) - Yervant and Janet Annaian, Gladys Zeytoonian. The motion was approved.

#### **New Business:**

#### **Preliminary Renovation Plans and Fundraising**

Although most of this discussion took place during the budget deliberations, the issue of capital improvements and fundraising was revisited. Agnes Sahagian requested additional clarification on how the funds would be raised. Louis Mikitarian said that the Parish Council's tentative plan is to send out a letter to the parish encouraging separate 3-year pledges specifically for the purpose of building renovations. The minimum goal is to raise \$40,000 per year for three years. It would be a straightforward process, however Louis encouraged other ideas and suggestions. Edward J. Bilzerian made a motion to continue with these plans, seconded by Annie Kachajian. The motion passed.

#### **Diocesan Centennial**

Der Hayr spoke of the upcoming plans for the celebration of the Centennial Anniversary of the Eastern Diocese of the Armenian Church. The Catholicos will be attending. There are representatives from the New England churches coordinating the programs, under the direction of the Primate. Zarvin Kasparian was appointed the local chairman of these activities. There will be a Badarak in Worcester on May 17, 1998.

#### **Promotion of Cultural Center**

Jay Kapur spoke of the continuing efforts to promote the rental of the Cultural Center for income. Jay said that last spring, extensive renovations were made in the Cultural Center as a result of insurance claims for water damage. Jay said that all of the renovations were made with virtually no additional cost to the church. Jay said that Joan Wakeen, a retired professional interior decorator (and mother of parishioner Diane Strazulla), donated her services and assisted with the decor selections.

Jay said that, with the support of the Parish Council, an aggressive marketing approach has been taken, especially in targeting the bridal market. A professional four-color brochure, designed by Edward Kachajian and Surabian Advertising, was produced and initially distributed at the recent Wedding Expo at the Worcester Convention Center (at which the church had a booth). The church also advertises in the Bride & Groom Magazine. Another general brochure is planned in order to target a broader rental market (i.e. business functions, parties, etc.).

In 1997, through the efforts of Jay Kapur and the Parish Council, the church generated over \$10,000 in hall rental income (only \$4,000 was generated in 1996). \$17,000 was budgeted for 1998, and Jay reported that, as of the date of the Assembly, he already had bookings equaling all of 1997. Louis Mikitarian thanked Jay for his efforts in this area.



#### Youth Programs

Seth Bilazarian expressed concern about the lack of participation by our parish youth in Diocese-sponsored programs like St. Vartan Camp and St. Nersess. Seth felt that more personal contact was needed in order to attract youth to these programs. Der Hayr said that a lot of behind the scenes work was done last year to recruit youth for these programs, and that three youngsters attended the St. Vartan Camp. Der Hayr said that five youth would have attended the St. Nersess Summer Studies programs, were it not for summer work commitments and busy activity schedules, in general. Der Hayr suggested that Seth put together a committee to contact prospective youth for this year's programs, and Seth volunteered.

Herman Purutyan felt that we have not spent enough money and effort on the youth. Kap Maksian said that he has spent many volunteer hours working with the ACYOA Juniors, and that they have over fifteen active members that have planned events such as Poon Paregentan, ACYOA Day, field trips, etc. Kap did say, however, that he felt that there was a definite lack of commitment by the parents, who have not encouraged their children to be active and to participate. Kap also pointed out that the Parish Council made every effort to schedule the Assembly on a date that did not conflict with school vacation schedules, but that unfortunately, participation in the Assembly by parents of school-aged children was still minimal. Herman asked what the church can do to reach out to these parents. Rich Maksian spoke of competing activities, such as sports, that are held on Sunday mornings are among the challenges facing Sunday School teachers. Der Hayr said that the situation is the same across the Diocese. Existing programs such as Bible Study (taught by Paul Avakian) and Lenten services and speakers have only been supported by elderly. Seth Bilazarian made a motion, seconded by Hazel Eljanian to form a committee to address youth issues. The motion was approved.

#### Results of the Elections

The Chairman called on Richard Bedrosian to announce the results of the Elections. A total of 89 members cast votes. Elected to the Parish Council were:

Louis Mikitarian thanked the members of the Nominating Committee for their efforts. Louis also thanked the Assembly Chairman, Gary Dodakian, for a job well done, especially since this was his first time. Louis also thanked Assembly Secretary, Jay Kapur. Louis extended special thanks to Der Hayr for his leadership and guidance throughout the year.

Der Hayr expressed his thanks to Parish Council Chairman, Louis S. Mikitarian, for his tireless efforts over the past year. Der Hayr also thanked retiring Parish Council members Marion Aharonian, Michael Gulbankian, and Kap Maksian. Michael served for the maximum of six consecutive years.

A motion was made by Annie Kachajian, seconded by Bizer Simonian to adjourn the meeting. The Assembly was adjourned at 4:45 p.m. followed by the closing prayer by Der Hayr.

# 96th Annual Diocesan Assembly May, 1998

Diocesen N. Delegates Report

The 96th Diocesan Assembly was held at St. Vartan Cathedral in New York City, from May 7-9th, 1998. Delegates from the Armenian Church of Our Saviour in attendance were: our Pastor, Der Aved Terzian, Parish Council Chairman Louis S. Mikitarian, the Diocesan delegates Jay Kapur, Agnes Sahagian and Asbed Zakarian, and alternate delegates Thomas Garabedian and Herman Purutyan.

Over 140 delegates were present representing parishes throughout the Diocese. Five business sessions were held with the focus on the numerous issues affecting the Diocese, along with the special emphasis on the celebration of the 100th Anniversary of the Diocese.

His Holiness Karekin I, Supreme Patriarch and Catholicos of all Armenians spoke of two major themes, urging us first to "get involved" in building a strong church community, and second to lend a helping hand to the motherland of Armenia.

Thursday's first session consisted of a full report by the Auditing Committee, followed by a "State of the Diocese" message given by the Primate, His Eminence Archbishop Khajag Barsamian, focusing on the achievements of the Diocese during the eight years as our Primate. He noted that there are currently 66 communities in the Diocese, including 43 parishes and 23 mission parishes. Areas of achievement which support this growth were the Department of Mission and Outreach, the Department of Youth Ministry, Fund for Armenian Relief [FAR], and the Children of Armenia Sponsorship Program [CASP].

His message also stated that there is a major challenge which we all face and that is the financial strength of the Diocese. The Centennial Endowment Fund, which was established on the occasion of the 100th Anniversary of the Diocese, had already raised over \$5,000,000 in pledges in the support of this major challenge.

"A point of major disappointment has been the inability to bring about the unified Church in our Diocese," the Primate stated, "and this is something that must not continue."

On Friday, elections were held for the Primate, the Board of Trustees, the Nominating Committee, Proposals Committee and the Auditing Committee. Our Primate, His Eminence Khajag Barsamian, was re-elected to a third four year term.

Under New Business, the Assembly considered a number of proposals brought by different parishes. One proposal that passed the Assembly called for the Diocese to prepare an inventory of all religious items etc. and to update this inventory annually.

Regarding term limitations of delegates, a proposal was presented that would allow Diocesan Delegates other than the parish priest(s) and Parish Council Chairperson to serve a maximum of two consecutive terms, and after an interim of one year, to serve again as a Diocesan Delegate. The rationale of this amendment was to allow currently serving delegates to continue in service for up to

twelve additional consecutive years while encouraging future young adults to take positions of responsibility in the Diocesan Assembly, as well as to promote a greater participation of parish members in Diocesan matters. The assembly voted to return this proposal to the submitting parish for revision to correct wording that was in conflict with the Diocesan By-laws.

A proposal was put forth to appoint a five member committee to act on behalf of the Diocese to meet with Parish Councils and Diocesan Delegates of any parish

delinquent in its Diocesan assessments for six or more months, in order to resolve any delinquency. The rationale of this amendment was to address the issues that parishes use to justify their delinquencies, and to explain to parish representatives the mission of the Diocese and how their parish plays an important part in the fulfillment of the mission. This proposal was defeated.

Another item under New Business proposed that disbursements from restricted funds that are over \$1000 should be signed by two persons, not under direct supervision of the requesting party. An amendment to not fill the administrator position and to shift \$70,000 to the Department of Youth Ministry failed. This proposal passed.

A proposal that was submitted resolved that the Diocesan Council address the responsibility for payment by the Diocese of the Clergy longevity stipends, which was passed in 1974 and reaffirmed in 1982 and 1983. The rationale for this proposal said, since our clergy are as important to the Diocese as are the many programs of the Diocese, than we feel that parishes should not carry that burden any more than they carry other Diocesan Programs. This proposal passed.

Another Proposal, related to issues of the clergy, called for a committee to be formed, composed of three clergy and two lay members appointed by the Diocesan Council for one four year term. This committee would prepare yearly stipend guidelines, investigate and advise the Diocesan Council on matters of insurance, create a pension plan, create a schedule for clergy to further their education and for retreats and sabbaticals. This committee would also make allowances for recovery from illness or injury, and investigate and advise the Diocesan Council on proper insurance coverage in cases of misconduct, breach of confidentiality, wrongful advice and other liabilities that could create a vehicle for the Diocese, Diocesan Council, clergy and parishes to assist in resolving issues before they become major problems. This proposal passed.

Related to the functioning of the Diocesan Assembly itself, a proposal was put forth to alter the agenda of the Assembly by implementing a workshop format in place of the panel discussion format used. The purpose of workshops would be to provide practical tools that delegates can use in their respective parishes and to address new and contemporary topics presently facing our people. This proposal passed.

A proposal passed that called for parishes in our Diocese at their own discretion to adopt a sister Armenian Church in the Republics of Armenia, Nagorno-Karabagh and other countries of the former Soviet Union, in order to create a fraternal relationship and to provide financial support. The parishes would follow a plan developed by the Diocesan Primate and Council and approved by the Diocesan Assembly.

The proposed budget was accepted.


The Diocesan Unity Committee recommended adoption of a resolution jointly promulgated with the Diocesan Council that through its unity committee, the Diocese move forward to complete the unity process when the Prelacy is prepared to proceed in implementing the 1982 guidelines. The Resolution looks to the direction and blessings of His Holiness Karekin I, Supreme Patriarch and Catholicos of All Armenians, and to His Holiness Aram I, Catholicos of the Great House of Cilicia, for



#### **ANNUAL ASSEMBLIES**

#### Diocesan Assembly:

Along with delegates from our parish, I attended the annual Diocesan Clergy Conference and Diocesan Assembly which was held, May 4 through May 9, hosted by the Diocese in New York City. We were honored by the presence of His Holiness the Catholicos, to kick-off the Centennial Celebration. Also in attendance were representatives from North and South America, whose roots also stem from our Diocese in New York. His Eminence Khajag Barsamian was re-elected for a third term as Primate.

#### A.C.Y.O.A. Assembly:

The General Assembly of the A.C.Y.O.A. was held, May 22–26, 1998 in Detroit, Michigan. As our Church's A.C.Y.O.A. Seniors are not active at present, we did not have any representatives at the meetings. Unfortunately, other Church's are facing similar situations and attendance has dropped significantly. We are hoping that this trend will change as more and more Juniors become of age.

#### Choir Assembly

The 52nd Annual Assembly of the Armenian Church Choirs was held in Cambridge, MA. Our Choir was represented by its Chairman Norman Noorjanian, who is a member of the Choir Association's Central Council. As the Assembly was held close to home, we had a very good representation of Choir members present at the meetings and functions. I was able to participate and attend several very informative lectures on Friday.

#### <u>VISITATIONS</u>

As part of our ministry, I have made regular weekly visitations to all Worcester area hospitals, and on many occasions, visitations to our parishioners in Boston, the Cape and Rhode Island hospitals.

Although routine telephone calls are made to each area hospital by our office, we sometimes learn that a parishioner has been hospitalized and released after he or she has been discharged. Due to the increase of day surgeries and limitations on hospital stays, it has become more and more difficult to visit parishioners during short hospital stays.



Again, we must remind our parishioners that **hospitals do not notify the Church** or pastor of a hospitalized parishioner. We request the assistance of each of our parishioners to rectify that situation, sot that no one feels neglected in their time of need. Names of hospitalized individuals may be withheld from the Church Bulletin upon *upon request*.

We encourage families to notify us of all hospitalizations, even if they are out-of-town. if it is not possible for me to visit, I will request that another Armenian priest make the visitation, as we have done in the past, when parishioners of another Church are hospitalized in the Worcester area.

We have also visited parishioners in Worcester and Greater Worcester area nursing homes, during the Christmas and Easter seasons, and as requested, to offer them Holy Communion.

On many occasions, I have gladly visited the homes of the sick or elderly (shut-ins) who are not able to come to Church, to offer comfort and Holy Communion. In 1998, I have made over 55 such visitations (in addition to hospital visitations). They are most beneficial to the elderly who have felt forgotten by the Church. As much as I enjoy these visits, my schedule does not usually permit me to make these visitations unless they are requested. Please, do not hesitate to make such requests known to me.

We have also visited area cemeteries to bless the graves of departed loved ones: on Memorial Day, following 40-day mass (karrasoonk) services, and at the special request of the bereaved families.

In addition, when our schedule allows, we have taken part in many family celebrations: anniversaries, engagements, birthdays, retirements, achievements, testimonials and social gatherings, at the request of our parishioners. Please notify us in advance, as we are often faced with scheduling difficulties.


#### COUNSELING

Most of my evening hours are passed in counseling sessions. On various occasions, I offered counseling assistance to individuals and families who were facing difficulties, including youths and college students, some of whom are non-Armenian. I consider this an **integral** part of our ministry. I pray that with God's help I offer comfort to those whom I counsel. I feel strongly about the necessity for prenuptial and marital counseling (*creating stronger ties with the Church*), pre-confirmation counseling, counseling of bereaved families and pre-baptismal counseling of the parents and godparents. And, to ensure that the participants are properly prepared, many of my evenings are spent helping to educate and bring these individuals closer to their Church in anticipation of these sacraments. We pray that the Holy Spirit grant them spiritual growth.

#### Social Services:

In recent years there has been an increased number of parishioners, in need of attention, assis-

-xx04x2 This year, I have once again called upon the services of Sona Hardgrove and Sonia Gabeshian, both local Armenian social workers. I have come to rely upon their professional expertise. and they have been most helpful. I am grateful for their support and assistance.

At times we are faced with parishioners who are in desperate need of temporary financial assistance for food, rent or other necessities. They often do not qualify or cannot wait for public assistance and come to their Church as a last resort. The assistance made to them is available through the Outreach Fund and Pastor's Discretionary Fund – however, the need is greater than we can afford. I sincerely thank those who selflessly donated to these funds this year, so that we may continue to help those in need. I also thank the Parish Council for their support in this endeavor.

Further, I try to make myself available for the sick, troubled and the needy of our community, as they are in spiritual as well as physical pain. I pray that my visits lighten their burdens and help ease their suffering.

#### <u>The Messenger:</u>

Our Church Newsletter, The Messenger, has become an important means of dependable communication once again. Our sincere appreciation to the efforts of Rich Maksian and his devoted staff: Nancy Bedrosian, Marianne Dodakian, Alma DerKazarian, Vahe Jardarian, Mary Ann Nalbandian and Richard Maksian. We encourage the efforts of the Messenger Staff and urge all Church Organizations and parishioners to contribute to its pages.

#### The Sunday Bulletins

The Sunday Bulletins are prepared in our office and are distributed each Sunday to our congregation, informing them of the day's Requiem Service, English translation of the Gospel reading and announcements.

#### Flyers, Booklets, and More!

We sincerely thank Yeretzgin Vivian, who alleviates some of the pressure on the Church Office by preparing most of the flyers, booklets and special Bulletins, that are published throughout the year.

#### **ECUMENICAL RELATIONS**

Our relations with all non-Armenian Churches throughout the Worcester area are mainly through the ecumenical Council of Churches, in which we continue our membership. On several occasions, we have had the opportunity to perform sacraments with non-Armenian clergy, giving us the opportunity to

share the richness of our service with them and they with us.

In January, our Church was the host for the Annual Week of Prayer for Christian Unity. Representatives of various Christian churches joined together in an Ecumenical Celebration at our Church. Over 200 people were in attendance. The service was officiated by Bishop Daniel P. Reilly of the Diocese of Worcester and me. The Telegram and Gazette described our Church this way: "richly adorned for the holidays in sways of greenery tied with maroon and gold bows, the interior of



the Church shined like a jewel, as a light snow fell on the street outside. Red, pink and white poinsettias graced the altar while a huge crystal chandelier cast light over the gathering." The article was accompanied by a nice photo of our Choir. It generated a great deal of favorable publicity and interest.

We also attended •The Pre-Advent Assembly •Lenten Ecumenical Assembly •Lenten Pentecost Assembly in Worcester •Tenebrae Service, Blessed Sacrament Catholic Church (represented by Dn. Suney Kachadoorian).

Zaven Kasparian continues to serve on the Board of the Ecumenical Council, Dialogue and Prayer Commission. Betty Sheehan is a delegate and attends meetings of the Ecumenical Council.

#### Notre Dame Academy Visits Church of Our Saviour

In March, I conducted three 1 1/2 hour lectures for graduate students, who were studying world religions at Notre Dame Academy. I immediately realized that they knew little or nothing about Armenians, before visiting our Church. Approximately 80 students and teachers learned about our Christian roots, the Genocide and our traditions, and asked many thoughtful questions. They were quite taken by the beauty of our Church, who many of them had seen from the outside. I received a very nice note of appreciation by the director of the Religious Studies Department, who has already requested to return with next year's class. We look forward to the opportunity to teach others about ourselves.

#### Neighborhood Involvement

At my suggestion, the North Main and Lincoln Square Clergy, under the umbrella of Worcester Interfaith, met to identify the common outreach needs in our area. Every Church is faced with people coming off the street asking for money, clothing, food. Although each Church had its own way of dealing with these requests, we had this dialogue to consolidate our efforts, and to form a network amongst us. We are now better equipped to refer someone to a particular place for food, clothing or money. Now that we are working together we are less vulnerable as well.

Once again we participated with our neighbors on Salisbury Street, including the area churches and the Worcester Art Museum, Worcester Polytechnic Institute, Worcester Antiquarian Society, and the National Guard, in a program known as "Salisbury Street Samplers" in which we each opened our doors to our neighbors. We have discovered that our Church has been the best kept secret on the street. It has often been admired from outside, but they were very pleased to be invited in to see the beauty of our Church. Our appreciation to Liz Avakian and Vahe Jardarian for organizing the volunteers for this event, and Irene Shooshan for filling the Church with her lovely organ music.

Worcester's Commission and Executive office of Elder Affairs invited community religious leaders on



Thursday, November 12, to discuss the quality of life for older adults and families. We had several strategic planning sessions which proved to be productive. Their goal is to build a functional Senior Center for Worcester.

On April 29, we donated the use of our Cultural Center to the Big Brothers, Big Sisters of America Inc. They came to celebrate their 35th Anniversary in Worcester. Several of our parishioners are involved in this worthwhile organization and we were

pleased to be able to help them with their celebration.

#### **NEW ENGLAND REGIONAL COUNCIL**

In 1998 the Diocesan Council took action to dissolve the New England Regional structure due to the lack of leadership and support. Personally, I feel we missed the chance to consolidate our efforts on many levels. I have always felt that regionalization would have been beneficial to the parishes, especially those who are geographically far away from the Diocese. Unfortunately, the many hours of planning, time and energy invested in this effort were short-lived. Hopefully, in the future, idea of regionalization will be resurrected in order to benefit the Diocese.

#### JOINT COMMEMORATION OF THE 83RD ANNIVERSARY OF THE ARMENIAN GENOCIDE

Over 300 people attended a moving tribute to the Survivors of the Armenian Genocide. The committee, consisted of pastors and representatives from our Church, Holy Trinity Armenian Apostolic Church, Armenian Church of the Martyrs and Soorp Asdvadzadzeen Apostolic Church of Whitinsville, and held in our Church Cultural Center. We were delighted by the songs and recitations offered by the rector and eight seminarians of St. Nersess Seminary. It was a good opportunity to get to know them and we were truly inspired by them! The traditional blessing of the Madagh followed the program.

#### 100TH ANNIVERSARY OF THE DIOCESE OF THE ARMENIAN CHURCH

His Holiness Karekin I, Supreme Patriarch and Catholicos of All Armenians, presided over the service and banquet to celebrate this momentous event. We were honored by the representation of clergy, dignitaries and parishioners from throughout the area, totalling over 500 in all. An eloquent banquet which was attended by state representatives: Mayor Raymond Mariano, US Congressman James P. McGovern, State Senator Matthew J. Amorello and Governor Paul Cellucci was held in Mechanics Hall. Our congratulations to the hardworking Committee, chaired by Zarvin Kasparian, for a nearly flawless event! The only thing that went "wrong" was the one thing they could not control - the weather!

#### EDUCATIONAL PROGRAMS

#### Armenian Language Classes for Children

The Armenian Language Program for children had a productive year. Through the efforts of Yeretzgin Vivian, the program was re-evaluated over the summer months to meet the needs of the participants, on three distinct levels. Due to the mild winter weather, we enjoyed very good attendance at special educational lectures which were held following a Lenten meal, on Wednesday evenings after Church Services. The guest speakers were (in order): Rev. Fr.



Ibrahim Haddad, Rev. Father Tateos Abdalian, Dr. Gregory Ciottone, Very Reverend Father Daniel Findikyan, and I offered an audio-visual presentation. We thank the members of each of our Church organizations who prepared and served an appropriate Lenten meal on their assigned day. As the Lenten period is a time for inner reflection, we strive to bring forth informative programs to our parishioners and hope that many more of them will take part in the future.

**Vacation Bible School** Next summer's program: Monday, July 26 – 30, 1999

Vacation Bible School was held during the week of July 20th. Thirty children ranging in age from two to twelve years old engaged in a variety of activities. A typical day started with an Armenian Language lesson followed by a candlelighting and prayer ceremony, the lesson of the day - on the miracles of Christ, snack, craft and recreation time. After the language lesson, the children were brought into the Church where they lit their candles at our new side altar, said a prayer and attentively waited for Der Hayr to tell them the story of the day and then took them to each part of the Church. Following snack time, our goal was to tie in a craft with the lesson of the day.

Every day Bible School ended with the younger children playing various games at Institute Park, while our older group played a well-deserved game of basketball outside in our Church parking lot. The highlight of the week was our field trip to Tougas Farm in Northboro. Children were able to pick blueberries, visit the petting zoo and play in the playground. The overall program was extremely successful largely due to the outstanding contributions of the parent volunteers! Parents' enthusiasm and dedicated ensured that each child's experience was a happy one. Thank you to our special assistants: Onnig Terzian and Nieri Varjabedian. Our appreciation once again to Kitty Dodakian, for helping to make this program possible through her hard work and energetic involvement.

#### Sunday School

I truly appreciate the efforts of our dedicated Superintendent Linda Donoian, and the devoted staff of our Sunday School. Enrollment and weekly attendance has risen nicely and atmosphere is a happy one!

I am grateful that I have had the opportunity on four occasions this year to meet with the teachers and then visit the Sunday School. I enjoyed conducting the Assembly program and visiting the classrooms, where the children felt free to ask me impromptu questions. I'm glad I had the answers!

In a recent visit to our area, the Pope of the Coptic Orthodox Church, His Holiness Pope Shenouda III, age 86 said "Sunday School is very important, parents are the most important people when it comes to teaching religious and spiritual values to children. I say to parents 'your child goes to

Sunday School one hour a week and they spend the other 167 hours each week under your guidance.' "

How true! The Sunday School teachers and Superintendent can give their all for the 1 1/2 hours the children are in their care, but you must teach them all the time. The best way to teach them is by example. I know I have said this many times before, but it cannot be said enough - **set a good example** for your children, they watch and learn from you.

#### **Babies and Toddlers Program**

The Toddlers' Program provides a place for infants and toddlers to get their first taste of Christian Education, in a loving and playful atmosphere. The parents enjoy each other's companionship, and many friendships have formed or been renewed in that classroom, amongst the children and parents. The "graduates" of the Toddlers' Class are all enrolled in the Sunday School, and many of their parents have become teachers, sing in the Church Choir, and often attend Church Services.

I see it as a unique opportunity for the little ones to share the experience of hearing their first stories of the Bible with their parents. It opens a door for the parents to pray with them before meals, cross themselves, and repeat the stories they hear in class. In addition, the children see their parents participating in the classes, during project and song time. This places an unquestionable sense of importance upon their Christian education. Upon graduation, the children, and equally important, the parents, are better equipped to participate in Sunday School.

#### **Deacon's Training Program**

This year five sub-deacons completed the Deacon's Training Program which will culminate in their being ordained Deacons by the Primate in February 1999. My thanks and appreciation to Deacon Suney Kachadoorian and George Sogigian for their invaluable assistance in this training program.

#### **CHURCH ORGANIZATIONS**

The Church Organizations and Special Committees are among the fundamental necessities that sustain the Church. Their success and stability are vital to our Church's future. It is not only through their fund-raising efforts, but in the service they provide that we can offer a wide variety of programs for the social, spiritual, educational and enjoyment of our parishioners.

We acknowledge the monetary support of our Church organizations in the past, however over the past few years, this support has been not a primary concern. Perhaps, we have not stressed the importance of the fund-raising function of the organizations. We are pleased that the organizations are, for the most part, enjoying increased attendance, however, due to increased financial obligations, once again, we must urge the executive boards of all Church organizations, to concentrate on at least one fund-raising activity, for the purpose of securing a monetary contribution to the Church, at year-end, and

again thank those who have done so this year. I take a personal interest in each Church Organization, and generally attend each group's regular meetings and functions, and we maintain regular contact with the Chairmen, to keep abreast of their respective organizations. May God bless all who serve His Church, through our organizations.



#### A.C.Y.O.A.

We applaud the efforts of Kap Maksian for keeping the enthusiasm alive in our A.C.Y.O.A. Kap has devoted another year as overseer of the activities of the A.C.Y.O.A. Jrs. He has organized several meetings and successful functions and has developed a good relationship with the members. The group enjoyed an active year and membership is growing. We strongly urge parents to become more involved with the A.C.Y.O.A. Jrs. and to provide the necessary support and guidance that is required. Previous methods are no longer applicable, innovative ways must be found to entice these young and restless youths, faced with so many other outside forces. We want them to choose the Church Youth Group and to provide a safe, pleasant atmosphere in which to grow, to experience friendship, and lead to Church service.

The A.C.Y.O.A. Seniors group is in great need of reorganization and leadership, unfortunately they were inactive as a group in 1998, however they do play basketball on Sunday evenings, and individually assist in Church functions.

#### Avak Group

For over 20 years, this organization has provided a place for our Senior Citizens to gather weekly. For many of them, it is the highlight of their week. The hard-working committee provides social activities, holiday dinners, and fair-weather outings. It is difficult to witness the loss of members each year. It is important that we never forget the elderly and their contributions to our Church. New members are always welcome.

#### Basketball Teams

We currently have several active Basketball Teams in our parish. The Sunday Night League, which involves members of the Men's Club, Junior and Senior ACYOA, is run by Gary Dodakian and Bryan Davis. Sunday School

Meetings

During 1998, the Parish Council, under the Presidency of the Pastor, Rev. Fr. Aved Terzian, held fifteen regular meetings.

Church Membership

At year end, we are pleased to report that there were **405** dues paying members of our parish. At the writing of this report, **55** additional dues paying member have been counted for 1998, for a total of **460**, 12 fewer than in 1997. These results reflect our commitment and ability to pursue new members through pledge cards and letters, to send dues contribution statements based on pledges and to follow up with all dues inquiries to our Treasurer. We rely on our faithful Church members to do their part to fulfill their obligation. Throughout the year, we have attempted to politely and tactfully remind each parishioner of their annual financial obligation to their church.



We thank you, our parishioners, for responding to our efforts in this area. It is not an easy task to request money and keep track of over 500 dues accounts, but those of you who reacted to the dues letters and statements sent by us have made it a rewarding task.

#### Meeting With Diocesan Delegates

The Parish Council met with the Diocesan Delegates during its April 14th meeting and reviewed proposals that would be presented at the Diocesan Assembly.

#### Parish Council Farewell Dinner

The Parish Council Farewell Dinner for "outgoing" Parish Council members Marion Aharonian, Michael Gulbankian and Kap Maksian was held on April 15th. The Parish Council extends its gratitude to Marion, Michael and Kap for their years of dedicated service to our Church.

#### Financial Highlights

The detailed financial reports are enclosed. The Church's investment account grew 11.94% (not including deposits and withdrawals) during 1998, 6.99% in realized gains (interest, dividends and capital gains).

#### Centennial Celebration - Catholicos' Visit

Our Church was honored to be the site of New England's celebration of the Diocese's Centennial. The highlight of the celebration was the blessed visit of His Holiness Karekin I, Supreme Patriarch and Catholicos of all Armenians. On Sunday, May 17th, after it rained on the original planned site of the Divine Liturgy, Institute Park, His Holiness presided over the Holy Badarak in our very crowded sanctuary.

Although we were unable to hold what would have been a unique open air Badarak, the initial poor weather did nothing to prevent this from being a momentous and memorable event. True to New England form, at the conclusion of Badarak, the sun shone on His Holiness and our Church.

His Holiness was accompanied by many clerical dignitaries from around the world, including our Primate, His Eminence Archbishop Khajag Barsamian.

Later in the day, a banquet commemorating the Centennial was held at Mechanics Hall. It was attended by dignitaries from throughout New England, including Worcester Mayor Raymond Mariano, U.S. Congressman James P. McGovern, State Senator Matthew J. Amorello and Governor Paul Cellucci. The Governor issued a proclamation for May 17, 1998 as Centennial Day of the Armenian Church of America.

This special day was planned by the New England Diocesan Celebration Committee consisting of the pastors and representatives from all the New England Armenian churches, which was chaired by Zarvin Kasparian. Because the activities of this day revolved around our Church, volunteers from our parish contributed greatly to the success of the day. In addition to Zarvin, the members of our Church who served on the committee were: Edward Atamian, George Migridichian, Lutwig J. Stepanian and John Toromanian. Of course, this event could not have been executed so well without the contributions of many other parishioners in our parish. In particular, we credit and thank all the people who helped prepare for the open air Divine Liturgy, and with disappointment, returned all the liturgical items to our Church in a orderly fashion in the middle of a downpour.

#### **Church Hall and Cultural Center Rentals**

Under the direction of Jay Kapur, the rental of our facilities has increased tremendously. This year, we

continued to expand our rental of the Church's facilities for private functions, leading to exceptional revenue. Several wedding receptions were booked as the result of advertisements in Bride & Groom Magazine and renting of a booth at the Wedding Expo at the Worcester Centrum Centre.

On January 25th, our Church was represented at the 1998 Wedding Expo at the Worcester Centrum Centre. Color brochures were created and handed out to prospective brides and grooms with hopes that they would select our Cultural Center for their wedding reception. Thanks to Jay Kapur, Rebecca Kapur, Susan Atamian and Ed Kachajian who represented our Church at the booth.



Other opportunities occurred by word of mouth, by informal promotion and sometimes completely by chance. Our Cultural Center offers some very unique characteristics and fills a niche that is attractive to different organizations and people looking for a place to hold their event. This renting of our facilities has had improving results for the last 3 years. Thanks to Jay for all the hours he has invested in this project and his professional management of our facility rentals. Refer to the separate Facility Rental report for additional details.

### Church Office Administrator/Secretary Resignation

Resignation

Our Church Secretary, June Jardarian, resigned in March. The Parish Council held a fellowship in her honor in May to thank her for her five years of service to our Church. June occasionally voluntarily assisted the Church office during the remainder of the year.

Hiring of New Office Administrator/Secretary

Eileen Charbonneau, our Church's new Office Administrator/Secretary, was hired in December. We are pleased to welcome Eileen to our Church family.

The Parish Council thanks Linda Poldoian who organized the hiring process, interviewed candidates and provided her professional expertise in finding the right person to match our Church's needs. She spent a significant amount of time advising Father Aved and the Parish Council and effectively screened all the candidates, a time consuming process. Also, the Parish Council thanks Gary Dodakian for his contributions to the hiring of our new Office Administrator/Secretary. Prior to Ms. Charbonneau's hiring, another Secretary was hired. After a period of orientation and evaluation, it was mutually determined that this Secretary did not meet our needs and requirements.

Intermediate Secretarial Support

While the Parish Council was searching for a new Secretary, several individuals stepped forward to lend their support to the Church office. Elizabeth Avakian, who had been assisting the Secretary as a part time paid employee, put in significantly more hours in the Church Office and performed most of the weekly Secretarial tasks. The Parish Council thanks Liz for the additional effort she put in the Church office this year and her assistance in the training of Ms. Charbonneau.

Hiring of Part Time Custodian

At the end of November, the Church hired a part time custodian, Bill Chaleki, to handle the majority of



the cleaning tasks on the Church complex. Bill is working mostly in the late afternoon and early evening. Bill has already been involved in some special projects such as thoroughly washing and organizing our china into new china racks, installing new soap dispensers in bathrooms, installing new contact paper in the kitchen cabinets and performing some minor repairs. He has also set up and overseen many of the rental events at the Church.

When Mr. Chaleki was hired, we discontinued our use of Nu England Services, a contracted custodial service.

### **Donations**

### Church Handrail

A much needed brass handrail, donated by Elizabeth Kirk, was installed near the entrance at the left side of the altar. We're sure the handrail will be very helpful to the many individuals that will use it.

### Refrigerator

In early October, the Parish Council voted to purchase a new refrigerator for the Cultural Center. The previous refrigerator, the original refrigerator in our Cultural Center kitchen (over 30 years old), was requiring more frequent and more expensive repairs over the past year. Soon after the refrigerator was purchased, an anonymous donor, a member of our parish, stepped forward and reimbursed the Church for cost of this commercial quality refrigerator. While we honor that donor's wishes to remain anonymous, we thank the donor for providing a reliable refrigerator for our facility. Since the new refrigerator was installed, we have heard many positive comments from our parishioners.

#### Vacuums

When our aging primary vacuum was on its last legs and was not worth sinking repair money into, a decision was made to purchase a new one. When the decision was made by the Parish Council, Archie Torosian, Jr. and Ed Kachajian donated funds to purchase an industrial vacuum and an additional small vacuum to clean the steps in the Cultural Center.

### Church Complex Door Locks

After reviewing and revising the existing keying and locking plan on the Church complex, Seth Derderian donated the planning and implementation of a new key and lock system. This new system makes it easier for the Church to selectively allow access to certain areas of the church while prohibiting access to others. It also includes a new master keying system which makes access to the Church simpler for the Parish Council and Der Aved.

### Cultural Center Kitchen Cabinet Security System

For many years parishioners have complained because kitchen items became missing or even stolen. After Jay Kapur and Mark Markarian initiated discussion with Seth Derderian on how to secure our valuable pots, pans, china, silver and kitchen equipment, Seth donated and installed locks on the kitchen cabinets in the Cultural Center kitchen. The locking of the cabinets is part of a larger project to better control the use of our china, silverware and pots and pans. The increased rental of our facilities has caused us to recognize the need for securing these items in our kitchen.

### Mas Dough Machine and Table

Edward and Marion Bilzerian donated a new dough shaping machine to our Church. This commercial type machine, which is employed by many baking businesses on a daily basis, can be used to flatten out dough in a variety of thicknesses. Although this machine has many uses, Ed and Marion donated the machine so that it could be used for preparing Mas dough.

Vahan and Anna Pogharian donated the commercial stainless steel table on which the dough machine sits. It has caster wheels to make it easy to place anywhere in the kitchen.

Ed and Marion and Vahan and Anna performed considerable research and evaluation of these items and selected one that would save significant time and effort of our Mas Committee volunteers. Thank You so much!



### Stained Glass Window

Marjorie Sohigian generously donated a beautiful stained glass window to our Church. The image in the window is that of the Good Shepherd.

### Cultural Center Fover Mirror and Table

Agnes Markarian donated an impressive mirror and table combination in memory of her husband Gilbert. The mirror and table significantly enhances the attractiveness of the Cultural Center foyer.

#### Printer

Ed Kachajian donated a laser printer for the Church Office when the old printer failed. This printer is used by our bookkeeper to print out financial reports for the Treasurer and Parish Council.

### Church Exterior Light Fixture

In 1997, Steve and Agnes Sahagian donated a beautiful light fixture for the exterior front entrance to the Church. The Parish Council failed to acknowledge this donation in last year's reports and this corrects that oversight.

### Major Renovations, Repairs and Maintenance

#### Cultural Center Roof

The replacement of the Cultural Center roof was completed at the end of 1998. This major task was planned since it was discussed and approved at the 1998 parish assembly. Since the roof originally began leaking over four years ago, it was determined that a complete replacement was required. In the meantime, temporary repairs that were intended to last 3-5 years were performed so that the Cultural Center interior, which has been damaged as the result of the leaking, could be repaired without risk of further damage.

As part of the roof replacement, the old roof was completely removed. A new set of tapered insulation panels, which create the slight pitch required for proper drainage, was installed. The final layer of the roof employing a newer rubber membrane technology was installed over the insulation panels.

We thank Ray Hovsepian, our architect for this project, for donating his time and services to this effort. Ray prepared the detailed engineering specifications and bidding format, reviewed the bids that were sent in by the contractors and oversaw the project through its inspection.

#### Completion of Cultural Center Carpeting

In January, the carpeting of the Cultural Center foyer steps, cloak room and "VIP" room was completed. This completed the carpeting portion of the renovations that began in early 1997 and serves to further enhance the Cultural Center as an attractive facility for renting.

### Church Wooden Doors

Much-needed refurbishment of the exterior wooden doors of the Church was also completed in early 1998.

Repairs to Stovetop and Coffee Machine
 Repairs to the Cultural Center's kitchen stovetop and coffee machine were performed.

Digital Printer/Copying Machine

In April, the Parish Council made a decision to replace the existing aging copying machine with a large volume digital printing machine and a small volume photocopying machine. The replacement of our copying machine was forecasted, discussed and approved as part of the 1998 budget.

The digital printer will take care of the Church's large volume copying needs for at least the next 15 years. Its life expectancy is over twice an equivalent photocopying machine and 10 times the life span of the machine it replaced. It is also less costly to maintain than a typical photocopy machine. It's primary application is large volume copying.

Because the digital printer requires the use of a "relatively expensive" master copy to print hundreds of copies, it is not a cost effective tool for small volume copying which is also a requirement at our Church office. Therefore, a small inexpensive photocopying machine was also purchased to compliment the digital printer.

The Parish Council felt that the combination of these two office machines was the most cost effective approach to the Church's copying needs.

### **Armenian Festival**

In April of this year, the Parish Council was making its final appeal for leaders to step forward and organize the Armenian Festival. In short, the Festival, which has been such a tradition and contributor to our Church's success, was in danger of not being held. At a meeting late in April, a number of individuals took the bull by the horns and became the 1998 Armenian Festival Committee. The number of volunteers on this core committee eventually rose to eleven people and they held their first meeting early in June.

This year, the members of the Festival Committee were: Kap Maksian, Agnes Sahagian, - coordinators; Tony Barsamian, Kitty Dodakian, Tiran Garabedian, Jay and Becky Kapur, Mark Markarian, Paul Wasgatt, Dorothy and Arthur Yagjian.

We observed their chemistry unfold in the months leading up to the Festival, the excitement and anticipation of a major event on the horizon. While reaching for higher goals, they overcame some of the typical frustrations. The result was a rejuvenated festival with our traditional offerings merged with new ideas, new spirit and new enthusiasm. The Festival Committee took great pride and ownership in what they were doing, yielding tremendous results. And of course, they could not have accomplished their goals without the many parishioners who contributed their time and talents (many on multiple tasks and projects). As always, our parishioners responded when they were called upon to prepare for and work during the Festival.

The Parish Council hosted a Festival Follow-up dinner and meeting to thank all the Festival volunteers and solicit feedback on the Festival.

The Parish Council extends a gracious THANK YOU to all the members of our parish who played a part

in this year's successful Armenian Festival. Our spirit of working together toward a common goal demonstrated what it takes to achieve success both for the Festival and for the Church overall.

### **Golf Tournament**

The Church held its 4th Annual Golf Tournament on Tuesday August 18th. A great time was had by all the golfers. Golf was played at the Juniper Hill Golf Course during the morning and afternoon with 71 golfers enjoying sunny skies and ideal conditions. After golf, an outstanding awards banquet was served at



the Cultural Center. We received terrific compliments (as we have each year) on the meal, which is as much if not more of a feature than the golf. Thanks to the Meals committee chaired by **Jan Mikitarian** and **Kitty Dodakian**.

A successful raffle was held after the meal. Our tournament has become a significant fundraiser for our Church and an enjoyable experience for all the participants. Thanks go to the golf committee, meals committee, volunteers, golf booklet and hole sponsors, and various donors. Also, a very special thank you to **Edward Kachajian**, who, while recovering from surgery, put the Golf Booklet together. Overall, a wonderful day was had by all. The golf booklet listing all the sponsors and committee members was previously mailed to the parish.

### **Christmas Dance**

On December 12th, our Church held its fourth annual Christmas Dance in our Cultural Center. A festive time was had by the over 125 people who attended the dance. The Parish Council thanks **Ed Atamian**, for chairing this affair, and his committee. Thanks also to **John Fashjian**, who generously donated the band expense with hopes that this affair continue to grow in popularity on an annual basis.

Also on that evening, the ACYOA organized their own Christmas gathering in the lower Cultural Center Hall. ACYOA members from other parishes in New England attended the party and migrated upstairs to the Armenian music and dancing.

#### Christmas Eve

On December 24th, members of the Worcester Holy Trinity Church joined the members of our parish on the traditional Feast of St. Stephen for Christmas Eve services at the our church. It was a thrilling sight to see so many members from both of the Worcester Armenian Apostolic churches participate in this evening of joy and caroling for the third year in a row (last year, the services were held at our Holy Trinity Church). After the service, everyone attended a special Christmas eve fellowship organized by our Church's Parish Council and Holy Trinity's Board of Trustees. Thanks go to Father Aved and Father Vazken Bekiarian for "making this happen".

### The Messenger

The Messenger, with **Rich Maksian** as its publisher, celebrated the 1-year anniversary of its rejuvenation. With co-editors **Nancy Bedrosian** and **Marianne Dodakian**, the Messenger staff, and its contributors, the Messenger has again become an effective pleasing resource which the parish waits to receive every 2 months. Thanks to Rich and the whole Messenger staff for diligently producing the Messenger, something our parish is very proud to have.

### Camp Vartan Attendance and Subsidy

Our Church awarded subsidies for one week of Camp Vartan to Kirk Atamian, Mardig Mardirossian, Varnia Mardirossian, Stephanie Johnson, Onnig Terzian and Raffi Terzian. Each of them wrote a note reflecting their experience at Camp Vartan and thanking the Church for sponsoring them. The Parish Council encourages all the parents and youth of our parish to discover and participate in Camp



Vartan, the St. Nersess Summer Religious Study Conference, and other retreats and religious programs. Each year, funds are budgeted to subsidize the young men and women and boys and girls of our parish for these activities.

### Parish Council Attendance at Calling Hours

The Parish Council continued its policy of attending and participating in all Wake Prayer Services of our parishioners who have passed away. Also, on behalf of our Church, a cooked ham is provided to the family of the deceased.

### **Active Standing Committees**

The Parish Council was once again pleased and thankful to have the valuable assistance of the Standing Committees. The volunteers of these committees have lent their time and talents to their associated activities. Their work has reduced some of the Parish Council's burden and resulted in benefits to our parish for which the Parish Council is grateful.

### Zakarian Scholarships

Through the generosity of the Asbed and Margaret Zakarian Scholarship Fund, the Church awarded \$500 scholarships towards undergraduate education expenses to four young members of our parish: Barry Bohigian, Stephanie Chaparian, Adam Markarian and Nirva Penbeyan. # ARMENIAN LANGUAGE PROGRAM FOR CHILDREN

I am very pleased with the progress our Armenian Language Program for Children. The classes, outlined below, meet every Sunday morning, during the School year, from 10:00 a.m. to 10:30 a.m. at the conclusion of which the students are led to the Sunday School Assembly area. We continued to enjoy good attendance through May. Our "kick-off" in September resulted in the registration of approximately 35 children. Although there is a good core of students who attend faithfully, and are benefitting the most from our efforts, there are many who attend sporadically, which makes progression with the lessons difficult for our instructors. With repetition and constant reinforcement of past lessons, the class is beginning to develop working knowledge of vocabulary, common phrases and verbs, each on their own level.

The breakdown of our Program (as of September 1998) is as follows:

Ara Bilian — instructs a class of approximately 18 students, who already have a working knowledge and comprehension of the language. He fortifies their knowledge of the spoken language by concentrating on the conjugation of verbs and the constant addition of new vocabulary words. The class is conducted mostly in Armenian.

**Michael Mamishian** — instructs the smallest group of approximately 5 students, with varying degrees of knowledge of the language. These students are able to read and follow along in a curriculum book. Having a small group, Michael has the advantage of being able to adapt the lesson to their individual needs and personalities.

**Dawn Varjabedian** — has the utter joy of teaching the youngest members of the Program. The class ranges in size from 8 to 10 students, who are not yet able to read. Their curriculum material is prepared specifically for them with coloring pictures - key words are written on the sheets for the parents. Again, the pace of learning new material is somewhat slow, and dependent upon the grasp of the material previously presented. In this class as well, there is a core group of students who attend regularly; however, some attend sporadically and repetition is key.

The organization of the Toddler Classrooms made possible the usage of the three connecting rooms for Armenian School. We have found it most beneficial to have the three classes in adjoining classrooms. Because we begin promptly at 10:00, we have a solid 20 minutes of conversation. All three classes come together at 10:22 for the singing of the Armenian National Anthem "Mer Hayreneek." In September we began with the first verse and added another verse following the Christmas vacation - even the non-readers are learning it well!

We teach the language the way we learned it, by hearing and using it. We make an effort to say "Paree Looys" when they arrive and "ahbrees" to praise them ... we end each class by saying "Yertak Parov" and "Mnak Parov" to one another. These words are now familiar to our students and with each passing week it becomes more and more natural. ### **BABIES' AND TODDLERS' PROGRAM REPORT**

In 1998 we had approximately 30 students registered in our Class (and counting...)! In September 1998 the registration was considerably lower, but growing fast. The class meets every Sunday morning, during the School year, from 10:30 a.m. to 12:00 Noon. Parents are welcome to stay with their children, or attend Church Services, at any time during the Class.

The Toddler's Class is both a learning and fun experience for our "littlest Churchgoers" - and their parents. We strive for easy goals – learning the Sign of the Cross, hearing the name of Our Saviour Jesus, and simplified Bible stories. A very short Armenian Language lesson precedes the Bible Story of the day and is well-received. The children have learned a few words, through over-exaggerated gestures and movements, and are beginning to count to 10 in Armenian. We are very pleased at the response from both the children and their parents! The parents are each scheduled to prepare a project or snack approximately 3 times a year. Most parents and children attend regularly. With babies and very young children illness is inevitable, and inclement weather prohibits weekly attendance, but that's okay! What we try to convey is that whenever they attend, they have a place, both in Church and in the Toddlers' Classroom.

My deepest appreciation to Sarkis Balian who volunteered to make a wonderful bookcase for our Playroom. Sarkis designed and worked on the piece over the summer, and then installed it in time for Opening Day in September. Sarkis not only constructed this wonderful storage unit, but donated the materials as well. The organization of the Playroom not only made our clean-up time easier, but now that the toys are neatly put away each week, it allowed us to use the Playroom for Armenian School as well

I look forward to Toddler's Class each week, the bewildered faces looking at me when I'm telling a Bible Story, the little hands trying to make the sign of the cross, the smiles and laughter at song time, hearing a child repeat something I taught them, and, of course, the kisses, makes me very happy – and I'm so happy it has made others happy as well. I thank God for the opportunity to serve Him, through this Holy Church, by helping in some small way to bring His Children closer to Him. Thank you all for showing support of our Program which is now in our 11th year. I am grateful to Der Aved, and the parents of the Toddlers' Class who show their appreciation for our little program each week. May this program continue to flourish, for its benefits are numerous.

### THE MEMORIAL ENDOWMENT COMMITTEE

The Memorial Endowment Committee met on five separate occasions in the calendar year 1998 as prescribed by our official by-laws. This year's Parish Assembly will select one individual to replace departing member Amar Kapur and unofficial committee member, Stephen R. Sahagian. Mr. Sahagian volunteered to remain on the Committee this past year in an advisory capacity, thus lending credence and continuity to past committees. Father Aved and current committee members wish to thank both of these parishioners for their dedicated service to the Church and the Endowment Committee over these past many years. The contributions of these two individuals have been invaluable and will be sorely missed.

The Endowment Committee is delighted to report to the Parish Assembly that 1998 has proven to be a banner year. Total contributions to the Memorial Endowment Fund in new or existing accounts amounted to \$60,000. Contributions in calendar year 1997 were \$39,200 -- thus 1998 saw an increase of about 35.53% over the prior year. Committee members are very gratified and eternally grateful to those parishioners who saw the wisdom in the concept of the Memorial Endowment Fund and came forward to open new accounts or contributed to existing accounts. It is the eternal hope of the committee members that those who are not yet aware of this invaluable program will elect to join the "Endowment Fund Team" in calendar year 1999.

Parishioners may initiate an Endowment Fund Account with a minimum donation of \$500 or through a series of smaller contributions, which when reaching the required sum, activates an account. Endowment Fund accounts may be started either under the contributor's name or to memorialize a deceased loved one. Another alternative could be a gift through your will or trust account of a percentage of the estate of a specific amount — a very convenient and effective method of gift giving to your church. A third alternative could be a bequest of a specific property or financial instrument such as stocks or bonds. Whichever the avenue of giving, the important point to bear in mind is that your church will be the beneficiary of your benevolence and better able to enter the next millennium in a more positive financial position. I should remind parishioners that only the interest generated by the funds in these various accounts within the Endowment Fund are utilized. Endowment Fund accounts may be earmarked towards Sunday School, Altar Flowers, General Operating Expenses, Church Candles, Hokehankist (Repose of Souls), Youth Activities, Armenian Language Program or if you so desire, a category of your own choosing.

We should feel a strong sense of pride and dedication when thinking of our church as did our fore-fathers over one hundred years ago when they established the first Armenian Church in North America here in this city. As parishioners, we should build a bridge into the future for the benefit of our current youth and those yet to breathe the spirit of our church. The Memorial Endowment Fund is a means to fulfill this dedication and commitment.

I wish to thank Der Aved and the past and present committee members for their counsel, guidance,

support and cooperation. I am also deeply grateful for the support and assistance provided by Miss Elizabeth Avakian and our illustrious Parish Council Treasurer, Mrs. Katherine Dodakian -- both dedicated servants to the Church.

In conclusion, I wish to reiterate a statement printed in the report submitted by the Memorial Endowment Committee to the 1997 Parish Assembly:

"Remember, the ultimate goal of the Memorial Endowment Fund is to benefit your Church and all of its members. Reach out and help yourself and your fellow parishioners."



### **CULTURAL CENTER RENTALS**

1998 was another record year for revenues associated with renting our Cultural Center. Through aggressive marketing and "word of mouth," we have booked events from a diverse group of people. This is now becoming a leading source of revenue for the church, and is close to replacing the lost revenue from Bingo operations.

The Cultural Center was booked for a number of different events in 1998, including Wedding Receptions, Christening Parties, Dances, Engagement Parties, Reunions, and Fashion Shows. A total of 35 events were booked, resulting in gross revenues in excess of \$24,000. Of the 35 events that were booked in 1998, 5 were booked by parishioners.

In addition to rental fees, income is also generated from the rental of church-owned property such as china, silverware, serving platters, and cookware. In addition, as a result of favorable arrangements with local vendors, we have been able to rent items such as linens, helium balloons, etc. All of this has enabled the church to compete favorably with other function facilities in the area.

The church has a running ad in the leading bridal magazine in Worcester County, as well as a professional brochure targeting the wedding rental market. This year, we hope to produce a general promotional brochure and possibly advertise in other markets. As we approach our capacity of booking Saturdays during the year (the most favorable day of the week for social events), we will be working on a plan to book more events (such as business functions) during the week. We hope to also make additional improvements to the facility such as purchasing new chairs and replacing the outdoor light fixtures.

We have thoroughly cleaned and organized our kitchen. All cabinets are under lock and key, and all china and silverware is stored on special moveable carts in the Bingo room. We are fortunate to have found a responsible custodian that works during all of the events. His duties include cleanup, break-down of tables and chairs, and general supervision of the event. For events that extend past 1:00 am, uniformed Worcester Police officers are hired (at the renter's expense). Security deposits are taken for any rental involving the kitchen.

We expect to rent the Cultural Center virtually every weekend in 1999, and should have another successful year. However, the responsibility of renting the facility is becoming too much for only one person to handle, and more volunteers will be needed to ensure an efficient operation. Mark Markarian, Kap Maksian, and Tiran Garabedian have offered their services. Of course, please do not hesitate to contact Jay Kapur with any questions regarding renting the Cultural Center.
