Your Eminence,

We are happy to inform your Eminence and the Diocesan Council that on Sunday, Febrary 7th, 1993, at the annual parish assembly of the St. James Armenian Church of Westchester, the following resolution was passed:

"To purchase for \$1,350,000 a parcel of 10.5 acres located at 1131 North Street, White Plains, NY."

The property, which will serve as the site for our new church, is immediately adjacent to Exit 25 of the Hutchinson River Parkway.

The necessary quorum was met and the resolution passed with forty-four votes in favor and four opposed.

We respectfully request the approval of your Eminence, the Diocesan Council and the Board of Trustees. Your approval is required by March 12th; otherwise the contract will be cancelled.
