We are happy to inform your Eminence and the Diocesan Council that on Sunday, February 7th, 1993, at the annual parish assembly of the St. James Armenian Church of Westchester, the following resolution was passed:

"To purchase for \$1,350,000 a parcel of 10.5 acres located at 1131 North Street, White Plains, NY."

The property, which will serve as the site for our new church, is immediately adjacent to Exit 25 of the Hutchinson River Parkway.
