1996 ANNUAL PARISH ASSEMBLY MEETING February 2, 1997

The annual Parish Assembly meeting was convened immediately following Church Services. The Chairman of the Parish Council, Mr. Nubar Dorian, conducted the meeting. Mr. Dorian asked for nominations for chairman and secretary for the Parish Assembly. Mr. Nubar Dorian and Ms. Alice Bozoyan were unanimously elected to their respective positions.

The meeting was adjourned to the Church Center and reconvened at 1:15PM, after lunch which was served by the Women's Guild. Our Pastor, the Very Rev. Vazken Karayan, presided as President.

After the opening prayer by Hayr Soorp, the Chairman requested a motion to close the voting. A motion was made, seconded and passed to close the balloting at 1:30 PM.

The Chairman dispensed with the reading of the minutes from last year's meeting and invited Father Karayan to present his report. Mr. Dorian noted that this was the largest assembly in quite some time giving credit to our pastor.

PASTOR'S REPORT

Due to the presence of many non-English speaking parishioners, Hayr Vazken explained the rules and voting procedures in Armenian. Hayr Soorp thanked Mr. Dorian and all the members of the Parish Council for their wisdom, knowledge and dedication. He later reported the activities of each church organization and praised the hard work and dedication of each chairperson and his/her group.

Hayr Soorp expressed appreciation to all those who were instrumental in organizaing the banquet in honor of his elevation to the degree of Dzayrakooyn Vartabed. Sincere gratitude was extended to His Beatitude Archbishop Torkom Manoogian, Patriarch of Jerusalem, for his approval for the elevation and His Eminence Archbishop Khajag Barsamian, Primate, for bestowing the rank of Dzayrakooyn Vartabed.

He attended all the meetings of the Women's Guild and brought encouragement to the members. The Guild is headed by dedicated member, Diana Burggraf, for whom he extended his heartfelt gratitude.

Hayr Soorp complimented Carolina Ak and Tanya Gullep for a job well done with the ACYOA in coordinating and their group activities and membership. The activities included chocolate sales and an ice-skating trip to Rockefeller Center followed by a pizza party. Fifteen members took part on this memorable day. These youngsters are "climbing the ladder of life step by step."

The Parish Council decided to have the church paper, VISION, printed every other month. The quality and the content continues to improve. Hayr Soorp thanked Mr. Richard Tarzian who donated the printing of the VISION.

Hayr Soorp indicated also that the Sunday Bulletin that he prepares has been accepted by the parishioners as being spiritually enlightening and enjoyable to read.

Continuing his report, he expressed words of appreciation to the Deacons, especially Hagop Hovsepian, Archdeacon, and Ann Dadaian, Choirmaster. This year the Choir has added two young members.

Regarding the Armenian School, Hayr Soorp contacts the parents by mail and phone reminding them of the importance of sending their children to Armenian School. Appreciation was expressed to the entire teaching staff of the school. The irregular service of the bus problem has been solved by having the parents form a car pool. Hayr Soorp commended them for their dedicated service which also helps the school financially.

Speaking about the Sunday School, he said that parents were contacted by letter as well as by personal phone calls and visits - all of which were in vain. All of these efforts were either forgotten or ignored. He stressed that parents must realize that it is their responsibility to bring their children. Ms. Sylvia Bozoyan was deeply commended and appreciation was expressed for her many years of dedication and her firm belief that has kept the Sunday School open.

He closed his report by stating that he actively participated in Clergy Meetings by attending meetings in different parishes. He was a member of committees honoring both Catholicos Karekin I and His Beatitude Torkom Archbishop Manoogian. He also participated in the Divine Liturgy held at St. John the Divine Cathedral and St. Vartan Cathedral.

Home visitations brought parishioners closer to God and church. Many have become members and attend church on a regular basis. Our church attendance every Sunday is more in ratio when compared to other churches.

REPORTS

The Parish Council Report as well as the Reports of the Women's Guild, Armenian and Sunday Schools, Choir, Senior Citizens, had been already distributed to the members for their review. An addition was made to the Parish Council Report under Acknowledgments to include: Thanks to Mr. Hagop Balian for the work he did on the renovations of the Church Office.

Treasurer's Report: The Parish Council Treasurer, Mr. Harold Azmelian, went through the detailed report of the Council and answered all questions relating to it.

Auditing Committee Report: Mr. Armen Kalbian, Chairman of the Auditing Committee, reported that in line with audit and accounting principals, the Committee found all reports to be in order and commented on the outstanding job all organizations had done.

Dr. Ed Sahagian made a motion to accept all the reports as presented and amended. Motion was seconded and passed.

NEW BUSINESS

The following items were discussed under New Business:

MAINTENANCE: Mr. Andy Avedesian, chairman of the Maintenance Committee, reviewed the expectations for the current year as follows:

- 1. Fire and smoke alarm systems for church and parish house.
- 2. Plexiglass covering on the stained glass windows in the church

A motion was made and seconded and passed to accept both suggestions.

Additional renovations that were presented:

- 1. Audio system for church and center
- 2. Iron fence be scrapped and painted
- 3. Railing for center of stairs in front of church

MAINTENANCE (cont...)

Parish Council suggested the following renovations for the Church Center:

- 1. Lowering the ceiling
- 2. Complete change of lighting system
- 3. New windows and curtain

The Parish Council will consider all the above proposals at their Parish Council meetings.

ENDOWMENT FUND: As in prior years the Holy Cross Endowment Fund Committee distributed its detailed activity report to all members present. Mr. Harold Azmelian, the Chairman of the Fund, noted that during 1996 the interest and dividend income of the Fund was \$94,653.24 out of which \$50,000 was transferred to the Parish Council treasury to offset the short fall in the church's 1996 budget. He also read from the report that the total value of the Fund was \$1,462,462.99 as of December 31, 1996, and asked that members review the report containing the whole list of donors since the Fund's inception along with the list of C.D.'s, Mutual Funds, unit trusts, corporate bonds, government securities and stocks which comprised the Endowment Fund position as of December 31, 1996.

Before introducing for adoption a resolution to legally formalize the Endowment Fund to an Endowment Trust, Mr. Azmelian gave a brief history of the Fund beginning with the late Mr. Lud Shahbazian's proposal at a prior Annual Assembly to start an Endowment Fund with Harold Azmelian to supervise the Fund. After the motion was passed, Mr. Shahbazian promised to donate a certain number of shares of Mass. Investors' and PSEG. With the Estate of the late Mrs. Mason's donation of \$5,000.00 the Fund started to grow. When the Endowment Fund grew to some \$250,000.00, Mr. Azmelian informed the 1988 Annual Assembly that he no longer wanted to be a committee of one and asked that Mr. Armen Kalbian and Mr. Philip Arpiarian join him as permanent members of the Endowment Fund to report each year to the Assembly regarding the Fund's progress. This motion was unanimously approved and the Fund Committee thereafter each year distributed a written report of its activity.

ENDOWMENT FUND (cont...)

After explaining the reasons for legally formalizing the Endowment Fund, Mr. Azmelian stressed that the original conditions of the Fund will remain. The same, namely the interest and dividends only would be available for church needs and the general guidelines for investing would be 75% top quality bonds with maturity of 2 to 8 years; 20% in long-term government maturity Bonds and only 5% in managed stocks for growth, with Messrs. Azmelian, Kalbian and Arpiarian as the three permanent members of the Trust.

Before voting on the motion, Mr. Azmelian answered all the questions raised, most important of which were the following:

Question: Was legal counsel consulted by the Committee?

Answer: Yes, the move is perfectly legal and desirable as it does not change any

of the conditions of the Endowment Fund under which it operated

since its inception. It merely finalizes it.

Q.: If one of the members of the Trust resigned, became non-functional

or died, what procedure would be used for the vacancy?

A.: As in all Endowment Funds - including our Diocesan Endowment

Trust, the remaining members will appoint an individual knowledgeable

in investments and familiar with security strategies and more importantly who is also a dues-paying member of the Holy Cross

Armenian Church.

Q.: Why can't the Assembly vote for vacancies when they occur?

A.: A person who while very popular and active in church affairs

could be elected and be ignorant of Fund strategies or the financial markets and thus be of no value to the Trust. As indicated before,

the Endowment Funds are self-perpetuating bodies and fill vacancies as

permanent members.

ENDOWMENT FUND (cont...)

Q.: Mrs. Alice Yigitkurt asked why the Trust membership could not be

expected to have on or two more members added to the Trust and

moved that the Assembly adopt this motion .

A.: Expanding the number of our Trust would cause some problems with

regard to the decision making process on how best to proceed. All Trusts consult either a market specialist or a security's firm for making proper investment recommendations. Our Trust is fortunate to have such a specialist who charges almost nothing to the Trust - last year his fee was \$150.00 - and as you note his recommendations on our prudent investments have been unprecedently fruitful. Besides, the Diocesan Endowment Fund which tops our by millions and millions have only a handful of members. For our Trust, the committee feels three is an adequate number of members.

After Mr. Azmelian's presentation the Chairman of the Assembly entertained a motion to adopt the trust as presented by Mr. Azmelian. After it was moved and seconded with no more discussion, the Chairman called for a vote. The results were as follows:

31 in favor of adoption

11 against adoption

14 abstentions

The remaining members left the meeting prior to the discussion of the Endowment Fund.

The Chairman declared the motion passed and hereafter our Endowment Fund will become a Trust with the official name of Holy Cross Armenian Church Endowment Trust.

CHRISTMAS PARTY: Asked if parish members wanted a Christmas Party next year. Ms. Mary Shalakian suggested everyone be invited and charge a nominal fee. Mr. Philip Arpiarian suggested we no use the church funds for the party. Mr. Zack Aparkian gave the members a check with reality in sating that we were losing track of what Christmas was all about. He said that "this was good-will party."

Motion was made and seconded to have a Christmas Party next year. Motion accepted overwhelmingly to have a Christmas Party with the understanding that a fee be charged.

MEMBERSHIP DUES: The Church pays in excess of \$9,000.00 a year in Diocesan Dues. Sixty percent of this is marked as membership dues. Motion was made and seconded to raise the present membership dues from \$25.00 to \$50.00 per year for 1997. Motion was passed. This fee would be one sum which will apply to seniors as well as students over the age of 18. Anyone that has already paid \$25.00 for 1997 will be asked to pay the remaining amount.

1996 PARISH ASSEMBLY - The minutes of the Parish Assembly held on February 2, 1997, are included in the Annual Report. The following issues were voted for this year:

- c. CHURCH: We are proud to announce that during our pastorate as we have witnessed our church attendance and membership has noticeably soared. New faithful parishioners are attending and participating in our church services and social activities. Our Sunday services were conducted promptly and efficiently. During our three weeks vacation we were still available to serve and conduct services. During our pastorate 5 acolytes have been newly ordained. This past year our Sunday School enrollment fluctuated. Not because we lack in our responsibilities, but because of the parents who come with endless excuses. Countless times we contacted parents urging them to bring their children to Sunday School. This year we are fortunate to have an experienced Sunday School teacher, Diane Pekmezian, join our Sunday School staff. Thanks to our talented, committed and dedicated Sunday School Superintendent, Sylvia Bozoyan, our Sunday School doors are wide open. She certainly deserves our sincere and deepest appreciation and applause for her superb and outstanding job.

CLERGY MEETINGS: Almost every other month we attended clergy meetings in different parishes to discuss about the past and the future of the Armenian Church. During these clergy meetings, cultural, spiritual, pastoral, canonical, doctrinal, administrative and financial issues are discussed. The lack of the youth and faithful within the Armenian church is the grave concern of the clergy. These meetings were not only enlightening and informative, but also gave an opportunity to share our grave concerns in order to improve the quality of life in each and every parish community. This year we have been nominated by His Eminence Archbishop Khajag Barsamian, primate and elected by the clergy to chair the clergy conference in Cleveland, Ohio, where four consecutive days almost forty clergy participated from different states.

PASTORAL VISITATIONS: For pastoral visitations we have been invited by many parishioners on both good or bad, happy or sad occasions - such as baptisms, birthdays, graduations, sweet sixteen's, engagements, weddings, anniversaries, home and store blessings, funerals and karasoonks. During our pastoral visitations our aim and goal was: a) To emphasize the mission of the Armenian Apostolic church and their vital role as well as to participate and contribute as parishioners in the church's life. b) To urge families to attend Church services, enroll their children in Mesrobian Armenian and Sunday Schools. c) To instruct and remind them that the success and the perpetuation of this divine and sacred institution depends and lies solely on them and to enroll them as church members. Not responding to our visitation requests due to their busy schedule and personal reasons, some families were contacted by phone. At times, some pastoral visitation requests were unfortunately either, canceled, postponed or simply neglected. Occasionally we accommodated parishioners by visiting them during business hours in their place of work. The purpose was to inform them that we were aware and concerned about their absence from Church.

Hospital and Nursing Home visitations were our priority and were made periodically upon request and voluntary. We visited patients at their convenience providing them with Prayers, Holy Communion, Pastoral and Spiritual counseling. We made sure to schedule our monthly visitation to the Armenian Old Age Home in Emerson, NJ conducting morning services, delivered homilies and gave Holy Communion. The faithful, on numerous occasions, brought to our attention that our pastoral visitations were uplifting, encouraging, and fruitful. We didn't hesitate to provide our pastoral and spiritual care for those who were eager and willing to seek assistance and guidance during emotional, physiological, financial, and spiritual times. We graciously acknowledge those who expressed their appreciation and made positive comment and remarks in person and in writing.

VISION & Sunday Bulletin - Our official newspaper, **VISION**, is a bridge to communicate and convey pastoral messages and to inform about community activities to our parishioners in English and Armenian as the quality and the content have been improved. Our informative and enlightening **VISION** and Sunday Bulletin are appreciated by all. We humbly and proudly acknowledge and appreciate compliments and the generous donations from our parishioners as well as our friends. \square

A.C.Y.O.A. - This year our A.C.Y.O.A. was active and preoccupied with scripture readings, chocolate and ice-cream sales, few social programs and etc. On several occasions they had the opportunity to socialize. Their activities included trips to Rockefeller Center in New York City to ice-skate, to the Diocese, and to the performance of the French NAVASART Dance Group accompanied by pastor - Fr. Vazken Karayan, Apo Boghossian, Alice Yigitkurt, Richard & Diane Pekmezian, and Sylvia Bozoyan.
