PASTOR'S REPORT

In January 1962, I held my first parish assembly here, and today I am participating in my last parish assembly. On this occasion, I can't help but reflect on some of the significant aspects of my ministry in this parish.

I used to come to NYC from Detroit every month for Diocesan Council meetings, of which I was chairman. Nazar Nazarian, who was a parish council member then, picked me up from the airport and brought me here to take a look. The framework for the hall was up---and there was nothing else on this property but woods! I accepted the challenge, and today our parish is one of the most vibrant in the Diocese. The Detroit parish could not believe I would leave them to come here. And in those early days, when we had only 129 members, summer pay days sometimes were payless.

29 years ago we had our newly-built hall (now known as Saddler Hall) and celebrated Badarak on the stage every Sunday. Every week after Badarak we had Sunday School, and occasionally followed by a dinner. On those Sundays we used a lot of incense to cover the odors of the food! There are several of those early altar servers/choir members who are still serving with me today: Deacon Joseph Kalemkerian, Sub-deacon Armen Basmajian, Edward Daghlian, Arthur Azarik, Tony Ajemian, and a couple of years later, Susan Shamamian joined. Tish Basmajian was standing at the door then, and 29 years later, he is still at the door greeting worshippers as they arrive. Nazar Nazarian was responsible for my coming to this parish, and I have always enjoyed his friendship. I consider one of my greatest accomplishments of those early days was to convince Ed Bashian to become Building Committee chairman.

I reflect that while now we have a staff, I used to depend solely on my Yeretzgin, who has always been willing to help me in my ministry. For years she prepared the BEACON, for years she took care of all my clerical work, for 12 years she served as superintendent of the Sunday School at a time when our enrollment was 320 students and we had no classrooms, she served as Women's Guild chairman when no one else would take the position, and has been totally supportive throughout my pastorate.

And now after 43 years in pastoral ministry, I am retiring. I wish God's blessings upon you all individually, and upon St. Thomas parish. May this parish continue to grow and work to do God's will in Bergen County, and be a witness to our Armenian Apostolic Orthodox faith in this area.

During my years here, I have seen numerous changes in the parish. New faces have come forward to enlarge our St. Thomas family; at the same time we must never forget those who are no longer with us. We were proud to celebrate the 25th anniversary of the consecration of our church in April.

A hearty "thank you" to all our church organizations, and all the untiring members of the Parish. Each organization has submitted its own report, and our Parish Council Chairperson, Joanne Torigian, has acknowledged their service in her report; therefore I shall concentrate mainly on the sacramental and pastoral activities of the past year.

<u>WORSHIP SERVICES</u>: Divine Liturgy was celebrated every Sunday but 4. There was no Badarak on April 22 (all area churches were closed on the occasion of the 75th Anniversary of the Genocide), on May 6 (Diocesan Assembly weekend), July 29 (my vacation), and December 30 (my illness). We were pleased to have the Very Rev. Khajag Barsamian, Vicar-General, celebrate the Badarak and preside over our services on Palm Sunday, April 8, and were proud to welcome him back as Primate to celebrate the Divine Liturgy on July 8. Frs. Carnig Hallajian, Mardiros Chevian, and Garen Gdanian each celebrated the Badarak and delivered the sermon during the year. Deacon Joseph Kalemkerian

conducted Jashou services and preached the sermon in my absence, and also preached on several other occasions as well, always receiving favorable comments. Elise Antreassian, Director of Religious Education of the Diocese, and our own Gregory Doudoukjian each spoke in place of the sermon one Sunday. Badarak was also celebrated at the Emerson Home for the Aged on the occasion of Armenian Christmas (January 6) and Holy Thursday (April 12). We also conducted a service for the Blessing of Grapes on the Feast of the Assumption (August 12). St. Thomas continues to be the only parish which celebrates the Divine Liturgy at the Home. We celebrated American Christmas Eve, December 24, with a service led by our A.C.Y.O.A. Juniors.

I participated in several ecumenical services, one at St. Patrick's Cathedral for the Armenian victims in Azerbaijan, a HRASHAPAR service at St. Vartan Cathedral when our Primate returned from his episcopal consecration, and another at the Coptic Cathedral in Jersey City honoring our Primate. With our sister congregations in Tenafly we worshipped at the Week of Prayer for Christian Unity service on January 21 at Mount Carmel Church, and participated at an Inter-faith Thanksgiving service on November 20 at Temple Sinai.

<u>SACRAMENTAL SERVICES</u>: During the year, 37 baptisms were performed, (44 last year); 28 weddings were blessed (16 the previous year); 22 funerals took place (18 in 1989). At this time let us remember our departed members: Ophelia Topalian, Vartouhi Halebian, Sara Mateosian, Lillian Gedachian, Helen Davidian, Hripsime Gulbenkian, Mary Melikian, Marshall Nigosian, Helen Boghosian, Victoria Magarian, Garabed Safarian, Eliza Alyanakyan, Goulaz Goulazian and Artin Kevorkian.

<u>ADMINISTRATIVE</u>: As ex-officio President of all church organizations, I attended many of their meetings. I directed, advised and in many cases, helped in the implementation of their decisions. I attended the Clergy Conference and Diocesan Assembly at the Church of Our Saviour in Worcester, MA, in May.

<u>PUBLICATIONS</u>: We have published and mailed the BERGEN BEACON every month to about 1000 addresses, and prepared flyers for our various affairs. Each month the BEACON is mailed to our college students residing on campus. A special thank you to Alyce Parseghian for providing many of the photographs, and also to Albert Papazian for the rest.

We continue to issue a special periodical just for our college students entitled NOW AND THEN. It is published several times a year to enable us to keep in touch with them, and the students with each other. The young people have been very complimentary about it.

This year peaceful cooperation and harmony in the parish council and in the parish have prevailed, due in large measure to Joanne Torigian, our chairperson. The longer I know Joanne, the more I love her. Her compassion and understanding for all sides, her good will, her charm, her sense of humor, her diplomacy, and her vitality enable her to follow through on every task. What impresses me most about her is that is she is not on an ego trip, and very gracefully shares credits for her accomplishments.

It has been a real blessing to have the support of a staff. I am happy to state that not only does St. Thomas have a staff, but that they are devoted, competent and work together as a team. I am referring to my Pastoral Assistant, Louise Kalemkerian; Office Manager, Toni Barker, and our custodians, Yang and Azizah Harun. They are all project oriented rather than clock watchers. I have asked Louise to write her own report for two reasons: one to make mine shorter, and secondly, to make explicit some of the endeavors which have been her responsibility altogether. Here I especially want to emphasize the very valuable assistance of Louise Kalemkerian to my pastorate during the past $3\frac{1}{2}$ years. She proved that pastoral ministry is more than performance of church rituals and services, and she did real pastoral work by being a minister of visitation, a minister of education, a minister of youth.

Down the hill from us in Tenafly, we have churches half the size of ours, which draw members only from the local community. And they have ministers for education, for youth work, for visitations, besides the pastor. We are an important parish (5th in our Diocese), and if we are to meet people's needs, we must not be short-sighted. We must spend money to serve our people. If you wish your new pastor to be successful, you must consider these things. Let's not fool ourselves into thinking that this is a one man shop and the pastor will do everything.

I have enjoyed many warm and wonderful years here at St. Thomas with my family. I am sure that my successor will be received as warmly, and I wish him the same fruitful pastorate. I pray that this parish keeps prospering and continues trying to advance God's kingdom through worship and fellowship, and maintains its Armenian character.

PASTORAL ASSISTANT'S REPORT

I have never written a report describing my function and activities before this. They are by nature covered in the Pastor's Report, but this year I was asked to write my own report to touch on some areas not mentioned heretofore.

I have tried to assist Fr. Arnak in every aspect of his pastorate, while at the same time exercising my own ministry. He and I work together on his sermons every week, conduct Bible study every other week, and lead the Nareg prayer group each month. I have worked with him in the preparation of special services of prayer conducted on various occasions during the year.

I compose office correspondence, prioritize the office duties, write or cull the educational/ inspirational sections of the BEACON and Sunday Bulletin, and am generally responsible for administering the office. I author the newsletter for our college students, NOW AND THEN, which we publish and send to them periodically. I have prepared the information sheets on the sacraments of baptism and marriage which are sent to families requesting those sacraments. I readied a pamphlet of explanation and translation of the services of Holy Week. I have also drafted a pamphlet of prayers and scripture readings to take on hospital visitations.

One area of my responsibilities has been the ACYOA Jrs. I have worked with the young people and their adults advisors, planning educational programs, activities and discussion, and conducting an overnight Lock-In for them in March. I also worked closely with the Executive Committee in preparation for their 1990 and 1991 Sports Weekends held in conjunction with St. Leon parish.

Another aspect of my responsibilities has been programming. I arranged evening Armenian conversation classes, a slide presentation and program on the Earthquake aftermath, Fr. Dajad's third annual day-long spiritual program, a congratulatory reception for high school and college graduates, and a holiday gathering and supper for our college students. I am working on forming an organization for singles 25-45.

The most satisfying aspect of my work has been the home and hospital visitations I do. Fr. Arnak and I have tried to do home visitations together in the evenings, generally to new families and signed them

up as dues-paying members. I have tried to reach out to hospitalized or grieving members or friends of the church whenever possible.

Three and a half years ago Fr. Arnak and the Parish Council gave me the opportunity to serve this parish in pastoral ministry, a previously untested endeavor. I still am the only woman serving in this capacity in any Armenian Church parish. This is my profession. I was prepared, trained and educated for pastoral ministry and I look forward to the day when I will be able to utilize my skills and abilities to serve the Armenian Church as other women have served their denominations. I thank Der Hayr and the Parish Council for their confidence in me and affording me the opportunities I've had at St. Thomas.

PARISH COUNCIL REPORT

When I attended my first Parish Council Meeting after the 1990 elections, and was re-elected to be Chairperson, I was truly apprehensive. Why? We were starting in a confused and deficit position! Those of you who were in attendance at the Assembly will recall that the budget was imperfect and was then hurriedly rearranged on the spot. In spite of that the Council was diligent in supporting its principal. We had great support from all the Church organizations this year, especially the Men's Club and the Women's Guild. Each exceeded their commitments voluntarily. Because of the hard work, support and faith of not only these organizations but many individuals in our parish, we have been able to turn the deficit around.

I truly believe that this Council's adoption of an attitude of being a "healer rather than a hater", resulted in this turnabout. I thank them with all my heart. "I luv-ya Troops"!

STATUS OF VARIOUS PROJECTS

<u>Anniversary Dinner</u>: This year it will be held on Sunday, March 24th (Palm Sunday). It will be co-chaired by Garabed and Mario Yazidjian. We will be honored by the presence of our Primate, Bishop Khajag Barsamian.

<u>Budget Computerization</u>: The computer program mentioned last year has been implemented. We now have better data management for payrolls, accounts payable and receivable and budget management. We have refined our Chart of Accounts which permits us to automatically break down expenditures allowing us to determine net income from our various affairs.

<u>Building Committee</u>: Building Committee notified the Council that as of December 2nd, 1990 they unanimously agreed to agreed to dissolve their committee which was organized in 1984. We are indebted to Al Victoria who negotiated the following: 1) The amount of \$10,000 will be withheld from the final settlement to Kiseli (the building contractor) for 90 days pending the completion of re-caulking sky light windows and tracking down leaks in the new roof and to replace one or two doors as necessary, 2) Fifty-five thousand dollars will be paid immediately to Kiseli upon completion of legal documents and the balance of funds, after all payments are completed, will be turned over to the Council (approximately \$20,000).

<u>1991 Diocesan Assembly</u>: Hosted this year by St. Thomas, and to be held at Loew's Glenpointe Hotel in Teaneck, May 7-12, it will be co-chaired by Frank and Susan Avakian-Stoneson. Much effort has been expended on this project. All is on schedule, thanks to Susan and Frank and their excellent committees.

<u>Hall Rentals</u>: While the original 1990 budget proposed was \$15,000, the Assembly arbitrarily raised the figure to \$26,000 in order to show a balanced budget. \$12,000 had already been booked for 1990, for which we thank Virginia Victoria. Sales in 1990 were over \$25,137 which are recorded in the new budget system as \$21,393 NET, from which expenses had been deducted because our new accounting system now reflects actual income rather than sales. Sales of \$12,000 have already been booked for 1991.

Because the Council recognized the need to produce greater income for the Church, and Hall rentals provided a positive alternative to fund raising, a promotional program was instituted including the preparation of a test brochure, a promotional photo album, some minor advertising and a fresh appraisal of our banquet facilities; all were accomplished with limited funds.

The very shabby condition of our chairs was determined to be a major factor for rejection by prospective renters. Here, your Chairperson approached our major benefactors who very graciously and equally shared the donation of \$15,000 for these 350 new chairs. Of course, these benefactors were the Haroutune Mekhjians, Nazar Nazarians and Rupen Saddler.

Additional funds were donated by Nazar Nazarian and Rupen Saddler in order to do other refurbishing of the Hall facilities. These must include professional marble treatment of the Atrium flooring, window treatment of Saddler Hall and other minor accoutrements, i.e. Bistro tables and chairs for the Atrium. All should be done in good time.

The increased usage of our Hall facilities, including our own affairs produced a major problem with garbage handling. This was solved by the Council's purchasing of stronger garbage containers; and through the generous donation and work efforts of our ever supportive Men's Club (led by Jerry Keosayian), a garbage shed was constructed adjacent to the kitchen.

The Council embarked on a program to increase our Church's good will through sharing. Occasionally an Armenian organization or a parishioner approached us for use of our facilities but could not afford our standard rental fees. We made special arrangements, as long as the use of our facilities was for youth encouragement, cultural, and especially for Sacramental purposes. The Council feels that this policy is in concert with the efforts of St. Thomas to increase good will. The policy has proven rewarding.

<u>Library/Cultural Center</u>: The primary committee was composed of Ani Capan, Suzanne Daghlian, Yer. Violet, Shaké Mekhjian and Arax Parseghian. The services of Gloria Boyajian, Interior/ Industrial Designer, and Randy Preston, Electrician, were given gratis. Bookcase/Cabinets and lighting fixtures have been installed. We wish to thank the committee for their fine work. The Parish Council is expected to form a special library operating committee.

<u>Parsonage Repairs</u>: This year a new roof was installed on the Parsonage. The Parsonage is to be refurbished for the new Priest and I have been advised by Dr. Mekhjian, Chairman of the Board of Trustees, that the trustees will fund the necessary expenditure.

<u>Priest Search Committee</u>: The committee, chaired by Dr. Haroutune Mekhjian consists of Paul Kahaumjian, Ara Martaian, George Mekenian, and Joanne Torigian. On July 26, the parish members met with the Priest Search Committee to offer their suggestions and recommendations with regards to a new pastor. Since that date, the following has transpired: 1) Contact was made with 11 clergy, 2) Four indicated interest, 3) As of this date, three have been interviewed and one was eliminated, 4) Two of the candidates, after serious consideration, decided to withdraw on the objections of their

Yeretzgins who did not want to make the move, 5) The fourth candidate, who comes highly recommended, is scheduled to be interviewed in mid February, 6) The search continues, 7) As previously agreed with the candidates, all names are withheld.

BUILDING COMMITTEE REPORT - 1990

Chairman: Nazar Nazarian Co-chairman: Vahan Najarian

There were two meetings held during the past year during which fonal plans were established to bring the church expansion project to a proper conclusion.

On April 4 the committee met with Joanne Torigian, Parish Council Chairlady. The thrust of the meeting was to see who would negotiate with Kiseli, the builder, to settle on a final figure in order to close the project. The question was whether the Building Committee or the Parish Council should have the responsibility. After considerable discussion, it was agreed that the Technical Committee (Moses, George, Andy and Al) or whichever members were willing to participate, would meet with Kiseli to present a clear package of the necessary steps to conclude the project.

On December 2, Albert reported that he had met with Kiseli's son and that from claims equaling \$137,478.09, Al had successfully negotiated a settlement of \$65,000, subject to mutual verification of figures involved. The agreed upon amount less \$10,000 will be paid to Kiseli upon the proper completion of legal papers. The remaining \$10,000 will be paid within 90 days on the condition that Kiseli recaulk the skylight windows and track down leaks on the new roof as well as repair two doors.

Michel reported that there is currently a CD for \$80,000 due on December 20 as well as \$6,000 in the bank. The committee then unanimously agreed to conclude negotiations and approve payment of a settlement not to exceed \$72,000. (The final amount agreed upon was \$65,000.)

Chairman Nazarian requested that three letters be sent to the Parish Council. 1) Notifying them of the Building Committee's decision to settle with \$10,000 withheld from the final payment for 90 days pending recaulking and leak repair. 2) Notifying them that they or a designated representative had the responsibility of notifying Kiseli within 90 days whenever leaks occur. 3) Notifying them that fas of December 2, the Building committee had unanimously agreed to dissolve. All records and monies will be turned over to the Parish Council - with a letter of confirmation of their receipt given to the Building Committee.

CASPAR M. KASPARIAN MEMORIAL FUND

The St. Thomas Armenian Church, Caspar M. Kasparian Memorial Fund was established in 1979 by the St. Thomas Parish Council from in-lieu of flower donations in memory of its devoted Vice-Chairman who served the Armenian Church for many years. Other donations are occasionally made to the fund and gratefully received. The Charter, approved by the Annual Parish Assembly in 1980, stated that the purpose of this fund is "To provide full or partial scholarships to primarily further the religious education of the youth of St. Thomas and in exceptional cases full-time seminary students of the Diocese of the Armenian Church or the youth of the Holy Cross Parish (N.Y.C.) and St. Mary Parish of Washington, D.C." The money from the Kasparian Fund has been invested in the Armenian Church Endowment Fund, and it is the interest from that sum which is used annually to assist the young people of our parish.

During the summer of 1990, three St. Thomas youngsters were awarded scholarship assistance by the Board of Directors to attend the St. Nersess Summer Study Program. During the past eleven years the Fund has awarded 153 scholarships to young people from the St. Thomas Parish.

Through activities such as the Summer Study Program and Retreats, the Fund seeks to expand the religious ecucation experience of St. Thomas youngsters and encourage them to grow in the Armenian Christian faith. KIRIKIAN ARMENIAN SCHOOL

Our Armenian School is an integral part of our parish, teaching our children their language and instilling pride and knowledge of their ethnic heritage.

The record enrollment is 97 students this year with classes ranging from nursery to seventh grade. Due to a need, the 2nd and 4th grade currently have 2 classes; one for English speaking students and another for bi-lingual students. All children must take a reading and spelling test at the end of each year. The seventh graders have to pass a comprehensive three hour test to graduate, and an optional Armenian history test of 100 questions to qualify for an award. Every grade must also take a standardized test from the Diocese to go on to the next level. Also, an incentive gift is given to encourage promptness.

Trophies or certificates are given at the annual Hantes and graduation for the following achievements: George Shahinian Award for perfect attendance, the Edward Bashian Award for Armenian history, the Rupen Saddler Award for Armenian reading and the Dr. Harout and Shaké Mekhjian Armenian Spelling Award.

Sponsored a Hoki Hankisd on the second anniversary of the cartly goaks in Armenia.

The Kirikian Armenian School has a paid faculty and other expenses as are noted in our financial report. Funds are raised by the school largely through tuition. The Mothers' Committee is responsible for the Bazaar booth, annual Armenian Christmas Dinner, luncheons, the publication of our cookbook (the second printing of 500 copies is sold out) and many other events. We are also deeply grateful for the help our benefactors continually give us.

CHRISTIAN EDUCATION

A. CHURCH SCHOOL

The Church School began its academic year on Sunday, September 9, with an enrollment of 116 students (compared to 110 last year.) A "Welcome Back Barbeque" for students, parents and friends was held on the following Sunday, September 16, and was well-received. A number of new families have joined the Church School this year, as a result of a recruitment drive. Of course the best recruiters are our parents and students themselves. The students are divided into 12 classes, plus the 11th graders who meet occasionally for discussion. Classes are held on Sunday mornings, 10:15-12:15. The students' courses of study are prescribed by the Diocesan Department of Religious Education. Since 1987, the new curriculum texts published by the Diocese have been in use. Bibles, Divine Liturgy books and St. Thomas tote bags are provided to each student.

One of the goals of the Church School is to help its young people develop into worshipping members of the Armenian Church. To this end, the students attend Divine Liturgy every week for at least 45 minutes as part of the regular Sunday morning schedule. An important benefit is that the children, even the very youngest, feel a part of the worshipping community. It is heart-warming to see the young people receive Holy Communion on a regular basis. Two Assembly programs are conducted, according to age-levels, and include opportunities for learning the hymns and songs of the Badarak, as well as the meaning of the Badarak. Current issues and discussions are also part of the upper grades Assembly. Students of the eighth, ninth, tenth and eleventh grades read the Scripture lessons during the Armenian Christmas Eve and Easter Eve services.

The current 11th grade students (12 in number) are spending this academic year in service to the parish, singing in the Choir, and assisting in the Church School. They produced and directed the Christmas program by themselves. Six young people received the Diocesan graduation diploma in June, upon completion of all the requirements for graduation, including a year of service to the parish.

The Church School is blessed with dedicated teachers who try to provide our children with a firm Christian foundation, especially by their own example. Some of them have been teaching for many years. Their devotion deserves the gratitude of the entire St. Thomas family. It is promising that several Church School "alumni" are members of the teaching staff, and they serve as very positive role models for the children. During the current academic year, two St. Nersess seminarians, Robert Boyajian and Richard Bohajian, have been assigned to St. Thomas Church School to teach and participate in our activities.

Our Lenten project was to raise money for religious education materials for Armenia. At Christmas this year, the children and their families sent new hats, gloves, sweaters and school supplies to their brothers and sisters in Armenia. Child-to-child outreach always seems to have the most meaning. The children also took part in the "Trick or Treat for UNICEF" campaign at Halloween. Church School students participated in the preparation of the monthly meal for St. Paul's Men's Shelter in Paterson this fall, and collected non-perishable foodstuffs for the Center for Food Action in Englewood at Thanksgiving time.

The Church School sponsored a Chinese Auction in April, which was a huge success. In June, staff and students travelled by bus to attend a first ever regional Pentecost celebration at Sts. Sahag-Mesrob Church, Wynnewood, PA.

Annual events of the Church School include the Armenian Christmas Eve supper, Easter Communion breakfast, Christmas dinner and program, and graduation reception. We are thankful for the support and cooperation of the entire parish family which ensures the success of these events.

B. ADULT EDUCATION

A monthly periodical, AVEDIS, published by the Diocesan Department of Religious Education, was distributed to all Church School families and other interested parishioners during the year.

A Lenten educational program entitled "Improving Family Communication", led by Jane Bardes, Director of the Bergen County Parent Workshop, was held in March.

20 adults and young people participated in the CROP Walk for Hunger on October 21, along with 500 other Christians from all the communities around Tenafly. St. Thomas continues to be the first and only Orthodox congregation that participates in the Walk, and our walkers raised \$2329.00 through pledges and donations for this worthy cause.

MINUTES OF ANNUAL PARISH ASSEMBLY ST. THOMAS ARMENIAN CHURCH, TENAFLY, NJ FIRST SESSION - SUNDAY, JANUARY 28, 1990

Chairman George Mekenian called the meeting to order at 11:45a.m. There were 52 people present, adequate for a quorum.

Der Hayr pronounced the opening prayer.

The Chairman announced the officers for the Assembly: Der Arnak Kasparian, President; George Mekenian, Chairman; Ron Kenderian, Vice-Chairman; Alin Papazian, Secretary. Susan Shamamian will substitute today for Alin Papazian who had to go out of town. A tape will also be made of the meeting. George Mekenian asked if that was acceptable. The Assembly responded in the affirmative.

Mr. Mekenian announced that the Annual Report including the minutes of last year's assembly would be distributed at this time. Rose Mekenian, Assembly Secretary for 1989, read the 1989 Parish Assembly minutes.

The Chairman asked if anyone had additions or amendments to the Minutes. Sam Demirjian said he wished to supplement his remarks regarding the Kasparian Fund. He had questioned who was aware of the anonymous donation to the Kasparian Fund in addition to George Mekenian and the response had been that in addition to the Kasparian Fund Directors, those who knew of it were the Pastor and the Parish Council Chairman. A brief discussion followed.

George Mekenian said that the Kasparian Fund has made a comprehensive report that is part of the 1989 Annual Report. He suggested that any further discussion of this subject be held over until the Parish Assembly on February 4th.

Yeretzgin Violet Kasparian moved that the Minutes be accepted as read and amended. She commended Rose Mekenian on an excellent job as Secretary. The motion was seconded. The Assembly accepted the Minutes as read and amended.

Chairman Mekenian asked if anyone had suggestions regarding time of ballotting at the Parish Assembly. Edward Parseghian made motion to conduct ballotting from 11:30a.m. - 1:30p.m. Motion was seconded and passed with mone opposed.

The Chairman invited Zaven Poosikian, Chairman of the Nominating Committee to present the nominees:

MINUTES OF ANNUAL PARISH ASSEMBLY ST. THOMAS ARMENIAN CHURCH, TENAFLY, NJ SECOND SESSION - SUNDAY, FEBRUARY 4,1990

Chairman George Mekenian called the assembly to order at 1:47p.m. Der Arnak Kasparian opened the meeting with a prayer. In answer to a question by Leon Nigohosian the Chairman stated that the procedures described by the Diocesan by-laws would be followed. If the particular situation were not covered by the by-laws then Roberts Rule of Order would be utilized.

At 1:50p.m. there were 57 people, enough for a quorum. The eligibility of the voters was verified by Zaven Poosikian.

The Chairman designated Ron Kenderian, Vice Chairman of the Assembly, as parliamentarian.

The Assembly changed the order of the items on the agenda.

The following motions were made and carried regarding procedural matters: to accept the new order of the agenda; for the various chairpeople to present a commentary on their reports rather than read them; to take a "yes" as well as "no" vote on motions.

Der Arnak said a special prayer for parishioners who were deceased during the past year.

PASTOR'S REPORT: A discussion followed Der Arnak's published report.

Leon Nigohosian asked what was being done to bring back parishioners who had left the parish. He was told by Der Arnak and by Joanne Torigian, Parish Council Chairman, that the Membership Committee members were calling some of these people but there was no organized effort underway. Mrs. Torigian will form a group that will call and visit former parishioners in an effort to reinstate them. It was suggested that Der Hayr should also be calling such persons. Roxy Daghlian appealed to those people who are staying away because they feel they have been hurt should come to church and try to heal the hurts. Sandra Alpino felt that Der Hayr should initiate contact with people who stay away from church for whatever reason. Der Hayr asked for a list of such people. Eva Yazidjian commended the Parish Council for setting up the new Nursery which has been encouraging young families with small children to come to church.

Sam Demirjian accused Der Arnak of alienating some of the parishioners. He related a specific incident when a parishioner told him they would be leaving St. Thomas because Der Hayr had told them that if they did not like the way he ran the church they could go elsewhere. In an effort to mediate, Mr. Demirjian presented the problem to Joanne Torigian who wrote to both Der Hayr and the parishioner. Der Hayr apologized to the parishioner and the matter was resolved to their satisfaction. Der Hayr explained to the Assembly that the father of the parishioner involved had been complaining about the way the Badarak was done with the use of English in some parts etc. He mentioned that at St. Vartanantz things were done in the traditional way, upon which Der Hayr told him he should go to St. Vartanantz if spiritually he would be more satisfied. This upset the family and the aforementioned events took place. When Mr. Demirjian wanted to discuss other complaints of this sort, Mr. Mekenian suggested he bring such problems to the Parish Council. The Chair recommended that discussion of this subject be ended now. A motion from the floor to this effect was seconded and all present voted yes except one.

PARISH COUNCIL REPORT: In addition to her published report Joanne Torigian thanked the following people who were inadvertently omitted: Michel Izmirly who with Alice Arzoomanian and Laureen Berberian had prepared the budget in spite of his ill health; Virginia Victoria for diligently overseeing the rentals; the Delegates to the Diocesan Assembly Victor Arzoomanian, George Mekenian and Joseph Kalemkerian and the St. Thomas people who helped the earthquake victims associated with the AGBU/Airlift Project. The following corrections are to be made to her report: ACYOA Seniors - Stephen Mekenian, Chairman & Douglas Martaian, Vice-Chairman; Armenian School - Ani Capan, Director; the Parish Council has designated the Youth Room to be donated by the Women's Guild.

A discussion of the Parish Council report followed.

In reply to Leon Nigohosian's questions on the progress of the Priest Search Committee, Joanne Torigian reported that the committee had had one meeting where they reviewed three names and contacted some people who were not interested in the job. The committee will list the criteria a candidate must meet at their next meeting. When the committee makes their decision they will submit the names to the Parish Council and the Board of Trustees. The process must be a confidential one to preserve the privacy and dignity of the candidates.

Leon Nigohosian moved that there be a person on the Priest Search Committee who is not a member of any administrative body of the church (not elected or appointed); it was seconded. Rose Mekenian suggested that if anyone had a candidate in mind, they should make a recommendation to the committee. Paul Kahaumjian, a former member of the committee, said that the members of the committee were very knowledgeable about the clergy available and should be entrusted with the job. Leon Nigohosian moved to amend the motion to include Frank Avakian-Stoneson as the lay person to be appointed to the committee. Motion to amend was seconded and defeated. The original motion was also defeated.

Leon Nigohosian made a motion that the Priest Search Committee submit the names of three or more clergymen to the Parish Assembly next year to be voted on. Motion seconded and defeated.

Edward Bashian appealed for unity among the parishioners and critisized the uneasiness and divisiveness prevailing among some members of the church.

The Chair recommended that since finding a replacement for Der Arnak is such a vital issue, an evening be set aside for everyone to come and discuss their suggestions, concerns etc. Leon Nigohosian made a motion to that effect. It was seconded and passed. Greg Doudoukjian, a seminarian at St. Nersess said that finding a pastor is not an easy job because of a severe shortage of priests. We should enjoy Der Hayr's services while he is here since we may have to go without a priest for a number of years.

Sam Demirjian asked Joanne Torigian about 1) what is being done about increasing revenues and reducing expenditures; 2) not being allowed to attend Parish Council meetings; 3) accuracy of minutes taken at Parish Council meetings. Mrs. Torigian answered that 1) increased revenues would be achieved by increased pledges and more fund raising activities by parish organizations; expenses could be reduced by computerizing most operations. She praised Greg Saroyan who had donated computer equipment toward that end. The Beacon is now being produced by computer which will save a considerable amount of money. 2) According to Diocesan regulations parishioners can attend Parish Council meetings with advance permission of the Parish Council Chairman. Mrs. Torigian granted such permission to Mr. Demirjian as well as other parishioners until the Parish Council felt having observers constantly was interfering with conducting their business. 3) Mrs. Torigian commended the Council Secretary, Joseph Kalemkerian, for doing a fine job with the minutes and stated that any inadvertent mistakes he made had been corrected.

The Chair thanked the Parish Council for the fine job they did last year with special recognition for Arax Parseghian who is leaving the council after six years of service and Alice Arzoomanian who is leaving after two years as treasurer.

AUDITING COMMITTEE REPORT: Fred Karagosian reported that the Auditing Committee found the books of the Parish Council and all Church organizations in order.

FINANCIAL REPORT FOR 1989: Treasurer Alice Arzoomanian answered questions on the report. Edward Parseghian announced that the exact figure for the bazaar income is \$34,021 not \$35,343 as shown on the report. Mrs. Arzoomanian said that the discrepancy was due to a balance remaining in the bazaar checking account from the previous year left in the account to keep it open and to take care of late disbursements, etc. \$1,500 is in the account right now. Ron Kenderian said the financial report should include an accurate figure for bazaar profits in order to plan a realistic budget. The same also is true for hall rentals. Mrs. Torigian stated that the new computerized system would enable us to analyze the figures more accurately and give us a better picture.

In reply to his question on the Library Fund, Edward Parseghian was told that the \$1,560 listed as actual income for 1989 was the interest earned on a CD.

Haig Varjian questioned the increase in the salary of the Pastoral Assistant from the \$16,500 budgeted to the \$21,500 actual and wanted to

know where the additional money came from. Mrs. Arzoomanian replied that it was a line item adjustment.

Joanne Torigian explained that when the Parish Council decided to increase the Pastoral Assistant's salary by \$5,000 and only \$1,400 of it could be covered by the budget, Nazar Nazarian agreed to subsidize the remaining \$3,600 with the concurrence of the Parish Council and the Board of Trustees.

Sam Demirjian asked if any parishioner could subsidize salaries. Mrs. Torigian replied that in this instance it was done to acommodate Der Hayr's request for the continued service of the Pastoral Assistant.

Leon Nigohosian wanted to know how the salary increase for the pastor had been arrived at. Mrs. Arzoomanian explained that the Diocese provides a formula which was followed.

In discussing the deficit shown on the proposed budget Edward Bashian suggested forming a Budget Committee to work on future budgets.

Paul Kahaumjian proposed that to increase the income parishioners be asked to tithe 0.25% of their income. The chairman said that was a good idea but not a realistic one at this time.

Edward Bashian moved that the interest accruing in 1990 to reserve funds held by the Board of Trustees be given to the Parish Council for operating expenses. Motion seconded and carried by the majority with 3 opposed. \$15,262 will be added to the income.

In answer to Edward Parseghian's question Ron Kenderian said that at this time we owe \$90,000 to the builder. If litigation is resolved in our favor it would be less.

Following are some of the points raised during the discussions to try and balance the budget. Leon Nigohosian proposed to adopt the actual disbursements for 1989 to the proposed income for 1990 thereby decreasing the deficit.

Thomas Kasparian asked why the amount of the 1990 pledges was lower than the 1989 pledges. Arax Parseghian answered that a number of people have reduced their pledges by as much as a half. It was commented that this could have been due to earthquake relief. Der Hayr called "pledge" a misnomer for "membership fee" and stated that in other churches the two items are treated separately. Of the \$100 per person membership paid in this church \$67 goes to the Diocese.

After a number of adjustments, an amended budget was accepted with the majority of those present voting "yes", 4 voting "no" and 2 abstaining.

The revised adopted budget of \$243,566 for 1990 is attached.

Puzant Torigian suggested this budget be worked on for the next several months to come up with more realistic numbers. Ara Pekmezian suggested that quarterly reports be generated using the computer and checked against the proposed budget. Haig Varjian moved to appoint a committee of five to examine the budget to determine where increases and decreases can be made based on more realistic numbers and present it to the Parish Council. Motion was seconded and defeated.

BOARD OF TRUSTEES REPORT: The discussion centered around our mortgage obligations. \$50,000 (\$40,000 from the Parish Council and \$10,000 from Nazar Nazarian) was paid toward reducing the mortgage. In the absence of a member of the Board of Trustees who could answer the questions about the mortgage, the Chair proposed that the Parish Council ascertain the exact figures of the mortgage and send a letter to the parishioners within 30 days. This proposal was accepted.

BUILDING COMMITTEE REPORT: In answer to Yeretzgin Violet's query about the status of pledges to the building fund still outstanding, Mrs. Torigian said that Der Arnak had been calling some people who have not paid yet, but no figures are available at this time.

MEMORIAL FUNDS REPORTS: Caspar M. Kasparian Fund: Sam Demirjian raised the issue of the anonymous donation of \$150,000 to the fund which was discussed during the 1989 assembly. He wanted to know what had become of the \$41,000 in interest generated by the donation and why it was not reported before 1989. At this time George Mekenian temporarily relinquished the chair to Ron Kenderian due to his involvement in the Fund. Mr. Kenderian told Mr. Demirjian that since the money has been reported and disbursed as discussed in the Kasparian Fund report no issue remains; that the donation had not been reported before because it was a contingent gift.

ORGANIZATIONAL REPORTS: The Chairman commended the officers of the various organizations for the splendid job they did and asked for comments on the reports.

WOMEN'S GUILD: Chairwoman Adrienne Tenbekjian made the following corrections: Yeretzgin Violet Kasparian, Rose Mekenian, Alyce Parseghian and Roxy Daghlian as chairwoman of the Women's Guild attended the Diocesan Women's Guild Assembly as delegates. Fish and Chips dinner chairman was Dikris Malool.

CHRISTIAN EDUCATION: Vahan Soukiasian questioned the thrust of the Sunday School. Chairman Mekenian answered that Der Hayr, the Parish Council Liaison and the Director of Christian Education would take his concerns into consideration when planning their program.

NEW BUSINESS: Leon Nigohosian made a motion that the minutes of this assembly be made available within 30 days. Motion seconded and carried.

Sam Demirjian recommended having two or three more meetings between assemblies. Ron Kenderian re-iterated the Diocesan by-laws which direct any one group of 10 or more who want to have a meeting to present it to the Parish Council for approval and scheduling.

Yeretzgin Violet proposed that the Parish Council send a letter to the Diocesan Assembly asking them to decrease their disbursements so they

can lower the assessments of the parishes, thus lightening the heavy burden placed on parish budgets.

Alyce Parseghian proposed increasing the annual pledge to \$125. After discussion George Mekenian recommended this be made a voluntary rather than mandatory action.

Leon Nigohosian moved to end discussion of New Business and announce the election results. Motion seconded and passed.

ELECTION RESULTS: Zaven Poosikian, Chairman of the Nominating Committee announced that 152 ballots had been cast and the following (given alphabetically) were elected;

Parish Council - Suzanne Daghlian, John Derderian, Ara Martaian, Ara Pekmezian and Garabed Yazidjian; first Alternate: Virginia Victoria, second Alternate: Richard Keurajian.

Nominating Committee: Victor Arzoomanian, Eileen Barsamian, Edward Daghlian, Arax Parseghian, Edward Parseghian; Alternate: Albert Papazian.

Auditing Committee: Charles Amerkanian, Artemis Nazarian, Ardis Waldron; Alternate: Charles Doudoukjian, Sr.

Diocesan Delegates: Victor Arzoomanian, George Mekenian, Shakae Shahinian; Alternate: Arthur Azarik.
