Dear Father Papken:

We wish to draw your attention to an error made by your Nomination Committee in conducting this year's parish elections for Auditing Committee. The sample ballot you have provided indicates that three persons were to be electd which according to Bylaw 14 item F (page 6 of new Bylaw's book) is in error. The Bylaw states that each year, only one person is to be elected to the Auditing Committee. Each member serves three years; one elected for a two year period, one for a one year period. It appears that you have not complied with this Bylaw procedure.

We recommend that you hold a special parish assembly for a new election to comply with the aforementioned process.

Also we wish to draw your attention to two other adjustments that need to be made regarding your annual report:

- a) Diocesan Delegates Certification should have been signed by the Parish Council Secretary and Chairman.
- b) Page 17 of your 1993 Report should bear the signatures of the Pastor, Parish Council Chairman and Parish Council Secretaries.
