Rev. Papken Maksoudian read the Pastor's annual report to the membership.

The next item on the agenda being the reelection of the Pastor, Parliamentarian Charles Garabedian brought the membership up to date regarding the by-laws pertaining to this matter. Subsequently Rev. Papken Maksoudian was given a standing vote of confidence to remain in office for another year.

At this juncture there was a brief intermission so that the voting for the Parish Council members took place.

The Parish Council report was presented by Mr. Daniel Dorian, Secretary. Significant in his report was the fact that since the Diocesan Council has raised our assessment two dollars for each member, our Parish Council recommended that we add three dollars more and make the yearly dues for each member \$15.00. A discussion on the matter followed, after which time the membership <u>Voted</u>: to accept the recommendation of the Parish Council.

Rev. P. Maksoudian reminded the membership that Mr. Nubar Hintlian, Chairman of the Memorial Plate Committee, is working zealously to further the objectives of this committee.

Due to some misunderstanding, there was no report from the Auditing Committee; therefore, a recommendation was made by the chairman that the same committee remain in office and submit a report in the near future. In order to avent this situation occurring again in the future, it was suggested that the Parish Council Secretary in writing, notify all committees four weeks prior to the annual assembly of their obligations.

The financial report of the Parish Council was distributed to all those present. Treasurer, Peter Talanian, gave a breakdown of the report wherever indicated. The financial report was accepted pending the audit of the Auditing Committee.

Mr. Hiram Diranian, representing the Building Committee, gave a financial report of this committee. Noteworthy in his report was the fact that the mortgage has been reduced \$50,000,

and now remains at approximately \$148,000.
