



ANNUAL PARISH ASSEMBLY Sunday, February 12, 1989

The Annual Parish Assembly of the Holy Trinity Armenian Apostolic Church of Greater Boston was held on Sunday, February 12, 1989, following the Divine Liturgy, in the Charles and Nevart Talanian Cultural Hall.

The Opening Prayer was offered in Armenian and English by Reverend Father Mampre A. Kouzouian, Pastor, who asked those present to join with him in reciting the prayer.

The Assembly was called to order by Nancy Kasarjian, Chairman of the Parish Council. In her opening remarks, Mrs. Kasarjian welcomed the parishioners and expressed her appreciation for demonstrating their interest in the functioning of the Church by attending and participating in the Agenda for the day. One hundred twenty-five parishioners were present and 111 votes were cast.

The selection of the Tivan for the Assembly was announced by George Haroutunian, member of the Nominating Committee, as follows:

Chairman - Aetna Tashjian and Donald Tellalian English Recording Secretary - Rose Minassian

Mr. Tashjian declined his nomination. Additional nominations for both offices were asked from the floor. There being no further nominations, a Motion was made and seconded that Donald Tellalian be elected Chairman of the Assembly. <u>MOTION PASSED</u>. A Motion was made and seconded that Rose Minassian serve as English Recording Secretary for the Assembly. MOTION PASSED.

Mr. Tellalian, in addressing the Assembly, thanked the Nominating Committee. He stated that, as in past years, the reading of each report would be suspended unless a formal request is made otherwise. There being none the Assembly proceeded.

A Motion was made and seconded that the Minutes of the 1988 Annual Assembly be accepted as published. MOTION PASSED.

George Haroutunian, a member of the Nominating Committee, was called upon by the Chairman to present the slate for elective offices as put foward by the Nominating Committee. They were as follows:

Following an interval designated for voting purposes, the Annual Assembly was again called to order by the Chairman.

Father Mampre was invited to comment on the Pastor's Annual Report for 1988. He informed the Assembly that this report differed from those of past years and that instead of his usual accounting of Church services, Sacraments, visitations and his other duties, he emphasized major events which occurred in our Parish during 1988. These included the renovation of the Cultural Hall and on June 5, 1988 an official dedication took place and it was named for its benefactors, Charles and Nevart Talanian; the twelve stained glass windows in the Dome made possible through the generosity of its contributors; the 86th Annual Diocesan Assembly held in May, 1988 with our Church as host. This, he stated, was a monumental achievement due to the efforts of its Chairman, Helene Dorian, and all the affiliated organizations of our Church and many individuals who volunteered their services. Father Mampre further commented on the Pilgrimage to St. Vartan's Cathedral in New York to demonstrate our support for our suffering brethren in Karabagh; the Annual Banquet in October which honored Professor Charles B. Garabedian as "Man of the Year"; a Reception on October 30th honoring John Soursourian, Diocesan Delegate, who was granted a Pontifical Encyclical and the St. Nersess Shnorhali Medal by His Holiness, Vasken I, Supreme Patriarch and Catholicos of all Armenians, for 50 years of dedicated services to our Church. Referring to the devastating earthquake in Armenia, Father Mampre noted thus far \$280,000.00 in contributions has been forwarded to the Diocese to be used in the rebuilding of the area and the needs of the survivors.

A Motion was made and seconded to accept the Pastor's Annual Report for 1988 as published. MOTION PASSED.

The 1988 Parish Council Report was reviewed by its Chairman, Nancy Kasarjian. Mrs. Kasarjian noted that this has been a remarkable year for our Parish and many successful activities have been accomplished. She noted, however, that further renovations are required due to the age of the complex which is nearly 30 years. Mrs. Kasarjian told those present the Sunday School area has been refurbished and there is a possibility that a remaining section could be used for rental purposes, but not on a large scale.

The Chairman of the Parish Council stated at a recent meeting of the Council, a proposal was approved to increase membership dues to \$50.00 a year (now \$25.00 a year) and the Senior Citizen dues be increased to \$50.00 a year (now \$15.00 a year). This increase for the Senior Citizens would be effective January 1, 1990. Mrs. Kasarjian stated the increase in membership dues is necessitated to better meet the Diocesan assessment. She asked for a Motion in support of this Proposal.

In a discussion which followed, it was noted there has been an increase in the Cost of Living Index, but our membership dues have not been increased. Also, the increase does not present a problem since the first \$50.00 towards contributions to the Stewardship Program is applied to membership dues. Regarding the proposed increase in the Senior Citizen's category, an opinion was expressed that there might be many older members of our Church who could not afford this increase. Mrs. Kasarjian noted the Parish Council has addressed this fact and would advise that those who felt the increase would be a hardship could speak to the Pastor who would then use his discretion. An opinion was expressed by a parishioner that this could prove embarassing to our older members.

A Motion was made and seconded that the Annual Membership Dues be increased to \$50.00 per year and that the Senior Citizen's rates remain at \$15.00. MOTION PASSED.

Mrs. Kasarjian informed the Assembly that the 12 original windows in the Dome which were replaced by stained glass windows are in storage and in addition, the planned replacement of the original windows in the Sanctuary would be added for storage. She stated the Parish Council would like to be advised of how to dispose of the original windows. Mrs. Kasarjian stated the Council felt such windows could be offered to the original donators, be offered to other Churches in the Diocese or the entire lot could be sold or auctioned.

Two Motions regarding the disposal of the original windows were made, but were not seconded.

A Motion was made and seconded that if the original donors do not want the windows, they then be offered to other Churches and the remaining windows be sold or auctioned. MOTION PASSED.

A Motion was made and seconded to accept the Parish Council Report for 1988 as published. MOTION PASSED.

The 1988 Financial Report of the Parish Council was presented by Albert Zouranjian, Treasurer of the Council. A Motion was made and seconded to accept the 1988 Financial Report of the Parish Council as published. <u>MOTION</u> PASSED.

The 1989 Proposed Budget was reviewed by Albert Zouranjian, Treasurer of the Parish Council. A Motion was made and seconded to accept the 1989 Proposed Budget. MOTION PASSED.

Dr. Michael Kolligian was invited by the Chairman to address the Assembly relative to the Trust Fund. Dr. Kolligian stated the Trust Fund has increased each year since 1974 when it was established. Total investments of this Fund now is \$1,287,005.38. There was a need, he stated, to dispense \$59,000.00 of the Trust Fund in 1988 and such funds have been dispensed according to the wishes of the donors.

A Motion was made and seconded to accept the Trust Fund 1988 Financial Report as published. MOTION PASSED.

<u>Stewardship Program</u>: A Motion was made and seconded to accept the Stewardship Program Report as published. <u>MOTION PASSED</u>.

<u>Cultural Committee Report</u>: A Motion was made and seconded to accept the Cultural Committee Report as published. MOTION PASSED.

Trinity Couples Club Report: A Motion was made and seconded to accept the Trinity Couples Report as published. MOTION PASSED.

Trinity Men's Union Report: A Motion was made and seconded to accept the Trinity Men's Union Report as published. MOTION PASSED.

A.C.Y.O.A. Seniors Report: A Motion was made and seconded to accept the A.C.Y.O.A.' Senior Report as published. MOTION PASSED.

A.C.Y.O.A. Juniors Report: A Motion was made and seconded to accept the A.C.Y.O.A Juniors Report as published. MOTION PASSED.

Antranig Barsamian, Youth Director, was invited by the Chairman to address the Assembly.

Mr. Barsamian stated an interesting schedule of activities for our Youth Organizations has been drawn up and will include students attending local colleges and universities. He informed the Assembly recently \$2,000.00 was raised when these students sponsored a Dance in the Charles & Nevart Talanian Cultural Hall. This money will be used to provide for the personal needs of the four children who are victims of the Earthquake and are presently patients in the Massachusetts General Hospital. Plans have been made to visit these unfortunate childen and when they recover sufficiently, there are also plans to bring them to Church and have them attend our activities.

Diran Zahigian inquired about the status of the Monument Committee and what has been accomplished thus far. He stated we are approaching the 75th year of the Genocide and he felt it was important that action be taken soon.

Father Mampre explained that unfortunately the Chairman of the Monument Committee is no longer with us and his passing has been a great loss, not only to the Monument Committee, but to our Church and the community. Because of this and other circumstances, including the earthquake, no action has been taken in selecting the appropriate monument.

A Motion was made and seconded that the Parish Council appoint a new committee to continue with the work of establishing a monument on the Church grounds in memory of the martyrs of the Genocide. MOTION PASSED.

The Annual Parish Assembly of the Holy Trinity Armenian Apostolic Church of Greater Boston was declared adjourned at 4:23 p.m.

PASTOR'S ANNUAL REPORT 1989

Dear Parishioners:

I present to you my Pastoral Report for the year 1989. I give thanks to Almighty God for giving me the good health and guidance to serve Him and His flock within the Holy Trinity Church. During this year, we have achieved many successes. There are still things that need to be overcome as is typical to any Parish life. I thank you for your support and your dedication to our Church.

Whatever has been accomplished, has been through your efforts and we hope that during the coming year, through your cooperation and encouragement, we will continue to achieve successes and overcome any problems.

My Pastoral activities are divided into the following categories:

1. Church Services

I would like to inform you that I have observed that during this year more of our parishioners attended Church Services than in previous years which is encouraging. I hope and trust that this trend will continue and that more and more parishioners will be present at Church Services.

During the year, on every Sunday and on special occasions, the Divine Liturgy was celebrated in our Church and sermons were delivered in both the Armenian and English languages. Father Papken Maksoudian, Pastor Emeritus, and Father Oshagan Minassian, our Choir Director, have assisted me in Church Services and on different occasions have either celebrated or delivered the sermon. I wish to express my appreciation to our Altar servers and Choir members for their devotion to our Church.

During 1989, in addition to the Pastor and the Pastor Emeritus, the following clergymen have celebrated the Divine Liturgy at Holy Trinity:

On the Feast of St. Vartan, Father Dajad Davidian of St. James Armenian Church of Watertown celebrated the Divine Liturgy.

On Sunday, May 14th, Bishop Arsen Berberian of Etchmiadzin was the Guest Celebrant and Preacher. On this day, the famous singer, Rouben Matevossian from Armenia participated in the singing of the Liturgy.

On Christmas Eve, January 5th, and Armenian Christmas, January 6th, Divine Liturgy was celebrated. On the Feast of Christmas and Epiphany, the members of the Senior Women's Guild received Holy Communion, and then held their Annual Christmas Luncheon and Program. On January 7th, Holy Communion was administered to the children of our Sunday and Armenian Schools.

During Lent, on every Wednesday, Sunrise Service as well as "Peace and Rest" Services in the evening were conducted followed by lectures sponsored

by our ACYOA. During Holy Week, according to the traditions of our Church, we conducted services on Maundy Thursday, Good Friday, Holy Saturday and Easter.

On September 17th, we had Family Reunion Service followed by an Open House in the refurbished Rectory.

On November 19th, "Thanksgiving Family Service" was celebrated followed by a Turkey Dinner sponsored and served by our ACYOA.

On December 24th, "Christmas Family Service and Caroling" took place in our Church.

We must remember that the center of Church life is our Church Services where we can be in communion with our Lord and where we receive our inspiration.

2. Sacraments and Services

During 1989, the following sacraments and services were performed at Holy Trinity:

Baptisms: 22 Weddings: 19 Funerals: 43

These figures represent one of the greatest numbers of sacraments and services performed in cur Church during any year over the past ten years. During these occasions, I have been with our parishioners and their families to share their joy as well as their grief, to counsel them, and to encourage them. I have also conducted wedding rehearsals prior to each wedding.

3. Counseling Services

On 76 occasions, I have conducted counseling services with our parishioners who had personal or family problems and crises, with couples who planned to get married, and with individuals who wanted to be baptized or confirmed in the Armenian Church.

4. Pastoral Visitations

During the past year, I made 403 Pastoral visitations to the homes of our parishioners, to hospitals, and to nursing homes to visit and pray for the sick. I also visited cemeteries with families to bless the graves of their loved ones. On several occasions, I visited and conducted services at the Armenian Nursing Home and non-Armenian institutions. This year's number of pastoral visitations represents a 22% increase (74) from last year's and is the most I have done in any given year.

On special occasions, such as Christmas, Mother's Day, Thanksgiving, and others, I have reached out to the members of our community, especially the sick, the elderly, the shut-ins, and those that had been missed in Church, by telephoning them. These calls and visitations have been appreciated by our parishioners.

5. Meetings

During the year, I presided over and participated in 217 Parish-affiliated meetings. These meetings were conducted by individuals, Church-affiliated organizations, their executive bodies or various committees. I also participated in the Annual Diocesan Assembly held May 4th, 5th and 6th, in Elberon, New Jersey, and on another occasion, met with the Primate and the New England Armenian clergy.

6. Cultural and Educational Programs

We are delighted that every year, during the month of October, we have a series of cultural programs for our parishioners and neighbors. These cultural events, underwritten by the parish, are highly successful bringing credit to our community. This year, on October 1st, we offered an "Explanation of the Divine Liturgy" which was given by Donald J. Tellalian and Sona Tashjian at intervals during the Church Service. On October 6th through 8th, we were fortunate to have an exhibit of paintings by Salpi Mavian in Shahe Hall and, on October 22nd, pianist Arutiun Papazian performed "in Concert" in our Church. On October 29th, we offered a lecture on "Armenian Miniatures as Reflected in Stained Glass" which was an explanation of our new Church windows given by Donald J. Tellalian and Ara Kalaydjian.

On April 21st, the Armenian community commemorated our Martyrs' Day at the State House as guests of the Honorable George Keverian, Speaker of the House of Representatives, Commonwealth of Massachusetts. Many political leaders from the Commonwealth and Armenians from the Greater Boston area gathered this year not only to remember our martyrs, but also to mourn the victims of the earthquake in Armenia. I participated in this service and was one of the speakers.

On February 6th and October 2nd, we invited Ara Kalaydjian, Editor of the Armenian Mirror Spectator, to speak to the Trinity Men's Union on the earthquake and Karabagh tragedies. On November 6th, Speaker George Keverian spoke to the Trinity Men's Union. On November 7th, about 40 non-Armenian guests from Cape Cod visited our Church where I gave them a talk on the Armenian Church and our stained-glass windows. On April 1st, I spoke to a group of Boy Scouts who had come to our Church for a special service.

On different occasions, I have utilized the meetings of our Church-affiliated organizations to speak to them on various subjects. We have also utilized the Church's monthly publication, Dajar, for educational purposes.

I wish to thank our Sunday School and Armenian School teachers and staff for their dedication to our children. We are glad that our Youth Director is here to guide and educate our youth and young adults. We are delighted that Armenian and non-Armenian students from the universities in the Greater Boston area come to our Church to learn about Armenian history, art, and architecture.

7. Earthquake-Related Matters and Assistance to Armenia

As a result of the tragic earthquake in Armenia, our parishioners have

contributed \$304,577.65 to the Earthquake Relief Fund. In addition to this, one of our parishioners, who wishes to remain anonymous, has contributed \$160,000. We shall continue our efforts to help the land of our forefathers. On January 2nd, I was invited to Logan Airport to witness the send off to Armenia of the first airplane cargo carrying medical supplies and clothing. On January 12th, Mrs. Haigouhi Dagley invited me to the "Minuteman School" to talk to some of the students and to receive a check from them towards the Earthquake Relief Fund. On January 22nd, the Boston Musicians' Association Local 9-535 presented "Maggi Scott and Friends", a benefit concert for the Earthquake Relief Fund which was held in the Charles & Nevart Talanian Cultural Hall. Ron della Chiesa of WGBH's Music America was host and the Maggi Scott Trio, the Boston Jazz Pops Ensemble, the Greg Hopkins Sextet and the Herb Pomeroy Quintet performed under the auspices of the Couples Club of our Church. The total proceeds from this Benefit Concert were allocated to the Earthquake Relief Fund.

On January 27th, I was invited to and took part in a Press Conference at the State House hosted by Speaker George Keverian to inform and enlighten the news media about the tragic earthquake in Armenia and the relief assistance from the Armenian communities in the U.S.

On February 15th, the Chairman of the Parish Council and I went to the Massachusetts General Hospital to visit a group of Armenian children, victims of the earthquake, and their parents, who had been brought from Armenia for medical treatment. On January 9th, my family and I paid a visit to Children's Hospital in Boston for the previous-mentioned purpose.

I would like to take this opportunity to express my appreciation to many of our parishioners who attended to the needs of these children and took care of them while they were in Boston and, also, to all those who assisted during the relief efforts.

On September 26th, our parishioners hosted a Reception for His Eminence Bernard Cardinal Law, Archbishop of the Roman Catholic Church of Boston, who had raised one-half million dollars and sent it to Holy Etchmiadzin on behalf of his Diocese. We also honored the Speaker of the House of Representatives, the Hon. George Keverian, for his humanitarian assistance by helping us, through his Office, during the relief air lifts to Armenia and by forwarding to us almost \$60,000 contributed by his friends. On this occasion, we also honored Raymond Flynn, Mayor of Boston; Thomas Walsh, representative from Project HOPE; Francis Roache, Boston Police Commissioner; and Superintendent Paul Evans, Chief, Bureau of Field Services, for their assistance to our people. Special appreciation is extended to the following parishioners and foundations through whose generosity and foresight, we were able to invite our honorees to visit Armenia as our guests at'a suitable time: Mr. and Mrs. Gerald Ajemian, Drs. Paul and Joyce Barsam, Trustees of the Jack H. Kolligian Memorial Fund, the Mugar Foundation and Mr. and Mrs. Albert Zouranjian. We were pleased that the newspapers and television covered this event.

8. Stained Glass Windows

We are delighted that after 28 years, we were able to install new stained glass windows in our Church depicting events from our Lord's life, important

events from the history of the Armenian Church as well as saints of our Armenian Church. We are glad that 32 windows in the Church are completed and have been installed. The remaining windows, in the Baptisty, Vestry, Bridal Room and Parish Council room as well as the foyer, will be finished during 1990. We are most grateful to all those parishioners whose generosity enabled us to complete this task. The stained glass windows are reproductions from ancient Armenian miniatures from the 12th century to the present. I wish to thank the Sandon Studios of Little Valley, N.Y., and Architect Donald Tellalian who assisted me in this process. Various meetings took place during the year among Sandon Studios, Architect Donald Tellalian, the Parish Council and myself.

9. Special Notes and Events

On May 8th, the Parish Council invited our Diocesan Delegates and the members of the Board of Trustees of the Holy Trinity Trust Fund to discuss the possible purchase of property adjacent to our Church property if and when it comes up for sale.

On October 15th, at our Church Consecration Banquet, we honored Edward and Betty Nahabedian as "Man of the Year". Mr. and Mrs. Nahabedian have been long-standing and devoted parishioners of our Church and we are happy that the community recognized their dedication and commitment to Holy Trinity with this tribute. Also, at this Banquet, we recognized Rose Mamishian's 20 years of service, love and dedication to our Church as secretary and administrative assistant. On this occasion, we also honored Mr. Sam Babaian, one of our Church benefactors, who was celebrating his 87th birthday. We also recognized and expressed our appreciation to the following outgoing members of the Parish Council for their dedicated service to our Church: Nancy Kasarjian, Chairman of our Parish Council, for her leadership and dedication; James Kalustian and Debra Stevens.

On December 10th, the Annual Christmas Concert of the Erevan Choral Society was held under the direction of Father Oshagan Minassian.

10. Youth Ministry

We are happy that during this past year, Antranig Barsamian served as Youth Director of our Parish. Under the guidance of the Pastor, he attends to the needs of our youth. We appeal to our parents to encourage their children to take part in the Youth Ministry work of our Church.

11. Church Schools

a. <u>Sunday School</u> - For four years, Seta A. Buchter, a capable young woman, has served as the Superintendent of our Sunday School. She has recruited a group of dedicated parishioners to serve in our Sunday School as teachers, staff members and class parents. This year, over 100 students are enrolled in our Sunday School.

b. <u>Armenian School</u> - Unfortunately, the picture of the Armenian School is far from being desirable. A dedicated staff headed by long-time teacher, Araxie Janjigian, has been teaching our mother language, history and songs to our children. However, the Armenian School is not being encouraged by the community. From September to December of this year, we moved the Armenian School from Sunday mornings to Saturday mornings so that we could have more time for the Armenian education of our children. Unfortunately, this did not have the expected result and, therefore, the Armenian School Board decided to move the Armenian School back to Sunday mornings meeting prior to Sunday School. We appeal to our community to encourage their children to attend Armenian School to learn our mother tongue and the history of our people.

12. Church Office

Our Church Office is open five days a week, from 9:00 a.m. to 4:00 p.m., with a staff of six people employed, full-time or part-time, to carry out the work of our Parish. We are grateful to them for their dedicated service. I want to express my appreciation to Father Papken Maksoudian, our Pastor Emeritus, Rose Mamishian, Carol Krikorian, Seta Buchter, Tony Barsamian, Harvinder Jassal, and Ara Dermovses, head custodian, and his staff, for their dedication. I would also like to express my appreciation to the volunteers who are called upon periodically to assist our Office staff.

13. Appreciation

I wish to take this opportunity to express my personal gratitude to all our parishioners for their prayers, for attending Church Services, cultural events and social events of our Church and to generously contributing to our Church to help us carry out our Lord's mission within the Holy Trinity family. I also wish to thank Father Papken Maksoudian, our Pastor Emeritus, Father Oshagan Minassian, our Choir Director, Al Zouranjian, Chairman of the Parish Council, the members of the Parish Council, our Diocesan Delegates, the Board members of our Trust Fund, the teachers and staff of our schools, the members of the Choir, and the executive members of our Church-affiliated organizations for their dedicated service to the Holy Trinity Church. May I also thank all the benefactors of our Church through whose financial contributions we are able to undertake special projects within our Parish. May God grant you all good health and long life to serve our Lord and our people through our beloved Church of the Holy Trinity.

The 1989 Parish Council has worked diligently to see that Holy Trinity has the resources needed to sustain the Parish during the next decade. Our solid foundation of spiritual beliefs and Armenian heritage has provided us with the determination to meet the challenges that confront us in these changing times.

The Armenian Earthquake Relief efforts, that began in 1988, continued. To date, Holy Trinity has forwarded \$304,577.65 to the Diocese, where a special committee coordinates the funds and services that are needed for the rebuilding efforts. It was the feeling of the Parish Council that recognition should be made to the community for their contribution to the Earthquake Relief Fund so a special reception was held on September 26, 1989. At the reception, His Eminence Bernard Cardinal Law, The Honorable George Keverian, representatives of Project HOPE, Boston Mayor Raymond Flynn, Peabody Mayor Peter Torigian, Mrs. Kitty Dukakis, and Boston Police Commissioner Francis Roache and Superintendent Paul Evans, were recognized for their contribution extended to the Armenian people after the earthquake, and on various other occasions. It was a memorable evening, with His Eminence Archbishop Torkom Manoogian presiding, and the announcement that Cardinal Law, the Speaker, Mayor Flynn, Mayor Torigian, His Holiness Vasken I.

We also provided some assistance to a young person from our Parish, Pam ""Young, who was selected to participate in the Diocesan ACYOA House Building Project that took place in Armenia in June. Since her trip, Pam has provided the Parish with first-hand accounts and pictures of the stricken area. In January of 1989, it was decided that three rooms on the second floor of the Parish House be refurbished as offices, due to the overcrowded offices on the first floor. Much of the general work, such as plastering and painting, was able to be performed by the maintenance staff. The Renovation Project included painting, new electrical work, new light fixtures, updating of bathrooms, draperies, carpeting, and a new heat pump for heating and airconditioning. In September, a reception was held in the Parish House after Church for parishioners to see what had been done. Another change in the Office this year has been the acquisition of a new faster computer and printer.

Another significant change at Holy Trinity has been the installation of new stained glass windows for the Church. Phase I of this Project has been completed and donors have been found for most of the windows that were installed in the Sanctuary. The remaining windows will be completed in 1990.

The Maintenance Committee tended to the following projects this year: repair of the feed lines for the radiant heating system in the Church, installation of a new gate at the passageway off of Riedesel St., polyurethaning of the floor in the Charles & Nevart Talanian Cultural Hall, purchase of new freezers for the kitchen and Shahe Hall and a new refrigerator for Shahe Hall, and installation of a new display case for the lobby of the Charles & Nevart Talanian Cultural Hall.

The annual Church Picnic was held at Holy Trinity again this year with the traditional Armenian food and dancing held in the Charles & Nevart Talanian Cultural Hall, and a variety of events for the youth held on the Church grounds. The event was chaired by Helen Donabedian. The Rug Sale was held from September 28th to October 1st this year. Robert Proodian supplied the rugs for the Sale and Nancy Kasarjian served as Chairman for this annual fund raising event. In October the annual Cultural Month was celebrated. On October 1st, there was an explanation of the Divine Liturgy at intervals during the Service. An exhibit of paintings by artist Salpi Mavian was held October 6th-8th. Another memorable event was the Concert held on October 22nd with the outstanding pianist Arutiun Papazian performing in our Church. On October 29th, an explanation of the new Church stained glass windows was given by Donald Tellalian and Ara Kalaydjian in the Church.

On Sunday, October 15th, the annual Stewardship Banquet was held with the meal prepared by the Senior Women's Guild and served by the ACYOA. The Co-Chairmen for this event were Martha Boghosian, Esther Jamgochian, Mimi Kalustian, and Arax Najarian. Edward and Betty Nahabedian were honored at the Banquet as recipients of the "Man-of-the-Year" Award. Also recognized at the Banquet were outgoing Parish Council members Nancy Kasarjian, James Kalustian, and Debra Stevens. A presentation was made to Rose Mamishian in recognition of her 20 years of service working in the Church Office.

The annual Church Bazaar was held on two days this year, Friday, December 1st and Saturday, December 2nd. It was a very worthwhile fund raising effort coordinated by Co-Chairmen Arpie Highgas, Aram Hintlian, Jr., and Nancy Young. On Sunday, December 10th, the annual Christmas Concert was held in the Church with the Erevan Choral Society, directed by Father Oshagan Minassian, performing a program of classical, Armenian, and traditional Christmas music.

Special recognition should be extended to the Stewardship Committee for their efforts under the leadership of Chairman Gregory Hintlian. For the second year in a row, they have raised over \$100,000 in Stewardship pledges. This effort and the interest income that we are now able to generate from the Trust Fund have made it possible to meet the expenses incurred by the Parish.

A new Monument Committee has been established by the Parish Council. The Committee includes Dr. Paul Barsam, Diran Zahigian, Richard Zeytoonjian, the Parish Council Chairman and the Pastor.

The Parish has been ably served this year by our staff: Pastor Father Mampre Kouzouian; Pastor Emeritus Father Papken Maksoudian; Choir Director Father Oshagan Minassian; Administrative Assistant/Secretary Rose Mamishian; part-time Accountant Harvinder Jassal; part-time Secretary Carol Krikorian; part-time Sunday School Superintendent Seta Buchter; part-time Youth Director Antranig Barsamian; Head Custodian Ara Dermovses; and Custodians William Serrano and Eric Morse.

For several years the Parish Council has recognized the need for an individual to serve as an Executive Director of the Church complex. This person would oversee all Church personnel and coordinate the everyday business and operation of the Church complex under the direction of the Pastor and the Parish Council. The Council has found a very dedicated and capable person to fill this position. Starting on January 15, 1990, Nancy Kasarjian will serve as Executive Director at Holy Trinity.

The Pastor and Parish Council wish to thank all the parishioners as well as all of the Church organizations for their continuing efforts and support during the year.
