

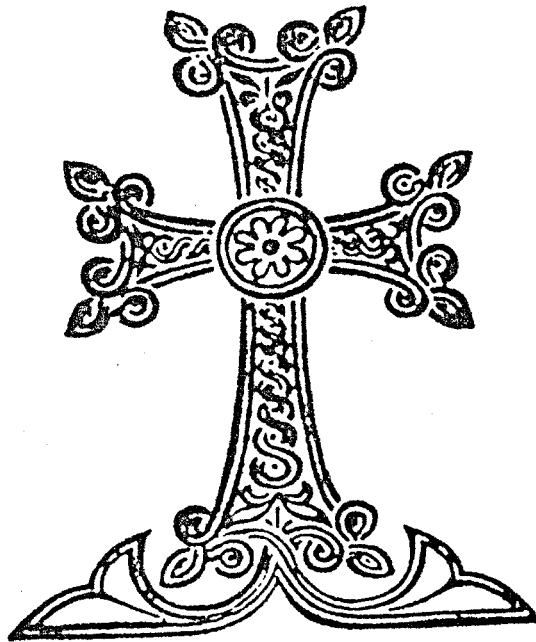

ANNUAL PARISH ASSEMBLY  
Sunday, February 11, 1990

The Annual Parish Assembly of the Holy Trinity Armenian Apostolic Church of Greater Boston was held on Sunday, February 11, 1990, following the Divine Liturgy, in the Charles and Nevart Talanian Cultural Hall. The original date of the Assembly, Sunday, February 4, 1990, was postponed due to a snow storm.

The ballots for voting were obtained by members eligible to vote before the meeting was called to order, but Reverend Father Mampre Kouzouian instructed the parishioners to hold them until the proper time within the meeting. The Opening Prayer was offered by Reverend Father Mampre Kouzouian.

George Haroutunian, Chairman of the Nominating Committee, announced the day's Tivan as follows:

Chairman: Attorney Charles Garabedian  
English Recording Secretary: June Piranian

Eugene Raphaelian, whose name had also been submitted as Chairman, declined the nomination. There being no further nominations from the floor, a Motion was made and seconded to approve the above-named Tivan. MOTION PASSED.

Mr. Garabedian thanked the Assembly for selecting him as the Chairman for the Day, and called the meeting to order. He then requested that unless there was no objection, the minutes of the 1989 meeting be accepted. Motion was made and seconded to accept the minutes as printed. MOTION PASSED.

As in the past, Mr. Garabedian pointed out that the reading of each committee report would be suspended, unless the Assembly requested otherwise. On motion made and seconded, and since there was no further objection, the MOTION PASSED.

George Haroutunian, the Nominating Committee Chairman, now called upon the Nominees for Parish Council to come forward to the Assembly. The Slate for Parish Council was as follows:

At this time, a nomination from the floor was requested by the Secretary of the Day, June M. Piranian, for Dorothea Piranian for Parish Council. This motion was seconded.  
MOTION PASSED.

Chairman Garabedian now called for an intermission for the purpose of voting. Upon completion of this procedure, he called the meeting to order again.

Pastor's Annual Report for 1989:

Father Mampre reviewed his report, in English and Armenian, and asked for any questions or corrections. There being none, Chairman Garabedian asked that the Pastor's Report be accepted. Motion was made and seconded. MOTION PASSED.

Parish Council Report for 1989:

This Report was reviewed by Chairman Albert Zouranjian, who asked for any comments or corrections. There being none, motion was made and seconded to accept this Report for 1989. MOTION PASSED.

Parish Council Financial Statements for 1989:

A question was asked about a breakdown on the stipend listed for the three clergy in our parish. (Page 5-f). The Treasurer of the Parish Council stated that anyone wishing to have this information may receive it from the Parish Council. The Chairman of the Assembly stated that many years ago, the Parish Council had decided to present the stipends in its present form. He also stated that the Diocesan House also uses this format for its employed clergymen and its staff.

In response to a question raised regarding the Miscellaneous item for \$4,000.00 (Page 5-e), it was stated that the explanation was on Page 5-g.

Proposed Budget for 1990:

On Page 5-j, Dorothea Piranian wanted to know what percentage of increase there was in the Clergy Stipend for 1990. The Treasurer responded by saying "6%." Motion was made and seconded to accept the Proposed Budget for 1990. MOTION PASSED.

Trust Fund Report:

George Hagopian was called upon to review this Report. He said that the Fund has increased 29½%. He stated that the stock for Time, Inc., was sold and the gain from this sale was \$10,900. He said that sale of any additional stock has not been decided as yet. In reply to a question, "Are we taxed?", he replied that we are tax free. A request was made that in the future, along with the "Market Value" column, the previous year's figures be shown as well. Motion was made and seconded to accept the Trust Fund Report. MOTION PASSED.

Stewardship Program Report:

Chairman Garabedian called for the Chairman of the Stewardship Committee to make any comments. The Chairman was not present. Motion was made and seconded to accept the Report as given. MOTION PASSED.

Cultural Committee Report:

Chairman Garabedian called for the Chairman of the Cultural Committee to make his comments. In the absence of the Chairman, a motion was made and seconded to accept the Report as given. MOTION PASSED.

Erevan Choral Society Report:

Motion was made and seconded to accept the Report as given. MOTION PASSED.

Senior Women's Guild Report:

Chairman Garabedian called for the Chairman of the Senior Women's Guild to make any comments. Having none, motion was made and seconded to accept the Report as given. MOTION PASSED.

At this time, Chairman Garabedian suggested that if no one had any comments to make on the balance of the Reports, we could just accept them as given.

Armenian School Report:

Araxie Janjigian stated that there have been 14 new registrations to the Armenian School. She said the school is doing very well and better than people realize.

A.C.Y.O.A. Seniors Report:

Antranig Barsamian, who is the Youth Director of the Holy Trinity Church spoke at this time. Father Mampre asked him to make a few comments. He talked of major generation changes over the next 10 years, and stated that in 1989, activities and programs had been doubled, including a regular college Round Table, Superbowl Party, and Cape and holiday events. He called for parental support and encouragement to their children to take part, and Antranig felt that the youth was renewing interest in the Church. George Omartian questioned the potential for new members, and there could be many members drawn from colleges, etc., and 8th and 9th graders should also be encouraged to join the Junior group. Edward Nahabedian made the comment that it's up to the parents to bring the children and have them become interested in these groups. It was further stated that since Antranig Barsamian has become the Youth Director, the A.C.Y.O.A membership as well as the Sunday School membership has increased.

Robert Goshgarian pointed out that the A.C.Y.O.A. Senior and Junior Reports are always the last ones in the Annual Report, and he suggested that they be moved to the front of the Report. He felt a proposed budget should be submitted to the Parish Council, and it was stated that this is "in the works". Aetna Tashjian felt that the amount of \$40,000 would be a sufficient figure for a budget for a parish of this size at Holy Trinity.

At this time, Chairman Garabedian called for a motion to accept all the organizational Reports as given. Motion was made and seconded. MOTION PASSED.

Chairman Garabedian now called upon Daniel Dorian to give a report from the Diocesan Delegates. Mr. Dorian spoke of the difficult time over the past two years in connection with the earthquake and Karabagh situations. He said that \$6,000,000 has been collected for earthquake relief, and there has been some criticism as to the allocation or lack of speed in getting things done. A request has been made to build a small city in Armenia. Great efforts have been made by Dr. Hovsepian of Columbia University in the medical areas, and by Krikor Hovnanian, who is handling the enormous rebuilding problems. Mr. Dorian spoke of Mr. Hovnanian's plans to build 250 units at between \$25-30,000 per unit. He spoke of "incentive" ideas to hasten the building projects. Mr. Dorian stated that we should all learn more about the Karabagh situation.

The Unity Issue is a very big item for the Council. Merger has been agreed to, depending on when the By-Laws will be completed. There have been many meetings involved in this Unity Issue. He spoke of political party influences, and said so far, this has been resisted, and it should not be a force in the church. But, there are many problems yet to resolve.

Eugene Raphaelian thanked Chairman Garabedian for asking Mr. Dorian to speak to us. He felt that there is not enough money to run the Diocese. They need operating funds, and he agreed that more money should be spent on the Youth Program. Chairman Garabedian thanked Mr. Dorian for speaking.

Question #11 on the Agenda, "Reconsideration of the Present Status of our Church Deed" was addressed next. Chairman Garabedian stated that the people should be made aware of some of the provisions of the By-Laws, and he reviewed the status of the deed. Anyone who wishes to submit a proposal in connection with this matter can do so, and they should be given to the Pastor, Father Mampre. Reverend Father Papken Maksoudian gave us some background on the Church deed. Father Mampre now gave some comments regarding the concern of the community about protection of the church when Unity comes about and there is a merger. With regard to properties transferred to the name of the Diocese, Father Mampre feels it should be up to the Parish how this should be handled. Robert Goshgarian questioned the number of parishes whose deeds are in the name of Diocese, and it was stated that most of the churches have turned their deeds over to the Diocese, but the number was not certain.

It was pointed out that the Holy Trinity Church deed was transferred to the name of the Diocese after we had paid our mortgage. Mr. Dorian stated that churches not in the name of the Diocese, such as in New Jersey, have different laws. Diocese is now trying to form an inter-state coverage. He did not know where the Prelacy churches stood, and he urged consideration to have the present system continue. In conjunction with this "consideration" Mr. Dorian referred to, Diran Zahigian questioned what it is we are to consider? Chairman Garabedian explained the function of the Board of Trustees, and the ten trustees have to vote.

Various possible problems were questioned, and Aetna Tashjian suggested that anyone concerned should put their ideas in the form of a motion. Anyone having any motions to propose could do so now, but none were made, and it was agreed to leave things as they are at this time. No motions were made. Mr. Dorian stated that



any Proposals to the Diocesan Assembly to be held in May in Worcester, MA, would need to be submitted 30 days before the Assembly.

Father Papken Maksoudian made a motion to appeal the Annual Diocesan Assembly to dissolve the New England Region since there was no need for such a regionalization. It is a waste of time and money and does not serve its intended purpose. The motion was seconded and was passed by the Assembly. It is now needed to submit the resolution of dissolving the New England Region and this motion should be submitted to the Proposals Committee of the Diocesan Assembly.

Eugene Raphaelian pointed out that anyone who had any ideas for further proposals could approach any Diocesan Delegate regarding it.

Robert Goshgarian wanted to propose an increase in the funds allocated to the Youth by 20%. But the question of funding is needed to make the proposal work.

Chairman Garabedian now called for any other questions or discussions. Aetna Tashjian spoke about the Proposed Budget, and reminded us that the school which used to rent space in the Church brought in \$50,000 in rental. Suggestion was made to have a small group look into renting the facility again. It was stated that the Parish Council would handle this type of matter, and that a separate committee would be out of order. It was further stated that the Parish Council is looking into this situation.

Eugene Raphaelian questioned the Monument Committee and wanted to know who is on this committee. It was stated that this is printed in the Annual Report (4-c) and only one meeting has been held so far.

A comment was made on a new position created in the Parish and that it be reviewed in the future as to its need.

George Omartian talked about past, present and future potential membership. He would be most interested in a "Census-Type" report -- whether membership is being lost or gained. He said he suggested that this be done five years previously, and made a motion that it be included in the next year's Report. Motion was made and seconded. MOTION PASSED.

Father Mampre stated, however, that he does have this information, but it is not published. He could give Mr. Omartian some figures, but what is needed is for the parishioners to respond to a census questionnaire; otherwise, an accurate estimate cannot be reached.

Chairman Garabedian stated that in his opinion, our facilities at Holy Trinity were not being fully utilized. He spoke of a California parish that has a Kufta Dinner once a month and has raised \$25,000 from this activity.

At this time, Father Mampre thanked the Chairman and Secretary of the Day. He made his observations of the state of the Parish, noting that there is a need for more students for the Armenian School. He felt the Church Organizations were doing well, except for the Coules Club. He stated that the parish is in healthy condition. Father Mampre went on to thank the Parish Council Chairman and members for their hard work and devotion. He thanked the Committee of the Trust Fund, the Choir members and all organizations for their hard work, too.

At this time, Mr. Daniel Dorian thanked the Reverend Clergy of our Parish for their dedication and hard work. He spoke of the shortage of clergymen in our Diocese and the concerns of the Diocesan Council in this matter. He reminded everyone of

how hard our Pastor works and the long hours he devotes to our Parish. He asked that a standing ovation be given to him. The Assembly responded by giving a standing ovation to our Pastor.

Chairman of the Nominating Committee, George Haroutunian, now presented the results of the voting. The newly elected were as follows:

PASTOR'S ANNUAL REPORT  
1990

Dear Parishioners:

Thanks be to God Almighty for giving me good health to serve and lead my flock during this past year.

I thank my parishioners for their support and dedication to their Church. We have worked harmoniously for the glory of God and for the edification of our Church.

I present to you my Annual Report for 1990:

1. Church Services

During the year, we have conducted Church Services every Sunday and on special holidays according to the rules and canons of our Church. Every Sunday, during the Divine Liturgy, sermons have been given in English and Armenian. Our Pastor Emeritus, Rev. Fr. Papken Maksoudian, and our Choir Director, Very Rev. Father Oshagan Minassian, have assisted me during Church Services. I appreciate the dedicated services of our Choir members who attend Church Service every Sunday, rain, snow, or shine. Our Altar Servers, with their dedication, knowledge, and conduct, serve as models within our Diocese. I am extremely proud of them and their devotion. We have one deacon and six sub-deacons, with newer candidates coming up through the ranks from our Sunday School.

During the year, we had the following guest clergymen as celebrants in our Church:

On May 6th, the Rev. Dr. Zaven Arzoumanian, Pastor of St. David Armenian Church of Boca Raton, Florida, celebrated the Divine Liturgy.

On May 27th, the Rev. Fr. Mesrob Benlian, Pastor of the Armenian Church, Sofia, Bulgaria, was guest celebrant.

On June 17th, Father's Day, which was also the occasion of the 40th Anniversary Celebration of our Pastor Emeritus, Fr. Papken Maksoudian's Ordination to the Priesthood, our newly elected Primate, the Very Rev. Fr. Khajag Barsamian, celebrated the Divine Liturgy and presided over the 40th Anniversary festivities for our Pastor Emeritus. Additionally, the new Primate met with the members of our Parish Council, the Diocesan Delegates and some of our Altar servers.

On June 24th, Rev. Fr. Gomidas Haroutunian, a clergyman of the Cathedral of Holy Etchmiadzin was guest celebrant.

On November 18th, Thanksgiving Family Service Day, Rev. Fr. Narek Madarian, a Priest of the Cathedral of Holy Etchmiadzin, was our guest celebrant and, also, participated at the ACYOA, Jrs. Thanksgiving Dinner.

During Holy Week, we conducted services. On Holy Thursday, during the Washing of the Feet Service, I washed the feet of twelve survivors of the 1915 Genocide. This was in conjunction with the 75th Anniversary of the Genocide.

On Christmas and Easter eves, I conducted a short service and administered Holy Communion to our Armenian and Sunday School students.

On Mother's Day, Family Reunion Day (September 16th), Thanksgiving and Christmas, we conducted Family Services. During these services, we urged the faithful to join the Choir in singing the hymns of the Badarak. Following summer vacation, on September 16th, we held a Family Reunion Service and hosted a Complimentary Brunch which was underwritten by the Jack H. Kolligian Trust Fund.

On January 6th, Christmas and Epiphany, on Vartanantz Day, and on the Feast of the Ascension of our Lord, Divine Liturgy was celebrated and the members of the Senior Women's Guild received Holy Communion prior to their monthly Luncheon Meetings.

*We must remember that the center of our Parish life is our Church Service, where we come in communion with our Lord and receive spiritual nourishment to go on with our daily lives. I pray and hope that during the year ahead, we will concentrate more on our spiritual growth by attending Church Services more frequently and promptly.*

## 2. Sacraments and Services

During 1990, the following sacraments and services were performed in our Church:

Baptisms: 20                      Weddings: 13                      Funerals: 35  
Bethrothal services conducted by me: 3

During these sacraments and services, I met with families and individuals to share their joy and happiness and, sometimes, their grief. I have performed 13 wedding rehearsals before weddings. I have also counseled couples prior to their marriage.

## 3. Counseling Services

On 60 different occasions, I have conducted counseling services with our parishioners who had personal or family crises, with couples who planned to get married and with individuals who wanted to be baptized or confirmed in the Armenian Church.

## 4. Pastoral Visitations

During 1990, I made 390 pastoral visitations to the homes and places of employment of my parishioners, to hospitals and to Nursing Homes to visit, pray and conduct services. I have also visited, with our parishioners, cemeteries to bless the graves of their loved ones. Three hundred ninety (390) visitations is one of the greatest number of visitations made in one year during my pastorate at Holy Trinity.

*On special occasions, such as Christmas, Mother's Day, Thanksgiving, and others, I have reached out to the members of our community, especially the sick, the elderly, the shut-ins, and those who had been missed in our Church by telephoning them. These calls and visitations have been appreciated by our parishioners.*

#### 5. Meetings

During 1990, I presided over and participated in 215 Parish-affiliated meetings. These meetings included all the Church-affiliated organizations' standing committees, their executive bodies, and various individuals. I also participated in the Annual Clergymen's Conference in Worcester, Ma., from May 1st to 2nd, and the Diocesan Assembly from May 3rd to 5th. On various occasions, I have participated in clergymen's conferences and other meetings held in New England.

#### 6. Cultural and Educational Programs

Every year during the month of October, we have a month-long series of cultural programs in our Parish. These programs are underwritten by the Parish. This year, on October 5th, Gerard Libaridian, Director of the Zoryan Institute, gave a lecture on "Armenia: Dynamics of Change". On October 7th, we offered an "Explanation of the Divine Liturgy" which was narrated by Sona Tashjian and James Kalustian at intervals during the Church Service. On October 19th, we presented a conversation with Broadway actor-singer, Michael Kermoyan, and poet, Diana Der Hovanessian, entitled "How to Make a Poem/How to Make It on Broadway". On October 26th through 28th, in cooperation with the Bush Galleries of Dover, we were fortunate to have an exhibit of original illustrations by Nonny Hogrogian, a Caldecott Award-Winning illustrator of children's books.

During Lent, under the auspices of the ACYOA Seniors, we had three Lenten dinner/programs and lectures, followed by Peace and Rest Services. These programs were conducted by the young adults of our Parish.

On December 16th, we held our traditional Christmas Concert which parishioners, friends and neighbors attended. This year, we were honored to have present, His Grace, Bishop Hovnan Derderian, Primate of Canada, who made the closing remarks. The Erevan Chorus, under the direction of our Choir Director, Father Oshagan Minassian, presented our Christmas Concert. We wish to thank our Cultural Committee, the ACYOA, and the Erevan Chorus and its Director for these cultural programs.

At the Trinity Men's Union meetings, we invite different individuals to give a short presentation about a current event. At the Senior Women's Guild monthly meetings, the Pastor Emeritus conducts Bible study. At other Church-affiliated organizations, we try to give informative talks to the members. We also utilize the Church's monthly publication, Dajar, for educational purposes.

We are delighted that Armenian and non-Armenian students from the universities in the Greater Boston area come to our Church to learn about Armenian history, art and architecture.

On two different occasions, a television station and a film company from Armenia came to our Church to interview the Pastor and tape the interior of the Church, especially its stained glass windows. In January, the Boston Globe held an interview with me about the Kharabagh conflict. On April 23rd, Channel 7 television gave coverage to the April 24th Commemorative Service in our Church of the 75th Anniversary of the Armenian Genocide. On other occasions, we have had visitors from Armenia who come to learn about the history of the Armenian people and the Armenian Church of Greater Boston.

#### 7. Assistance to the Earthquake Victims of Armenia

As Armenians, we have tried to help the victims of the devastating 1988 earthquake in Armenia. We have continued to transfer funds to the Diocesan Earthquake Relief as they become available to us through the gifts of our parishioners. Our Church-affiliated organizations have also been helpful in this respect.

#### 8. Youth Ministry

The Pastor and the Parish Council, with the involvement of some parents, help organize and create activities for our youth.

When Antranig Barsamian, our Youth Director, resigned to pursue his law career, we invited Ben Saraydarian, a student at Bentley College, to be our Youth Director, under the guidance of the Pastor and the Executive Director. We are glad that our Youth Director is here to guide and educate our youth and young adults, with the support of some of our parents.

*We make a strong plea to our parents to encourage their children to be a part of the youth organizations in our Church and to take active part in their spiritual, educational and social growth.*

#### 9. Church Schools

a. Sunday School - For five years, Seta A. Buchter, a capable young woman, has served as the Superintendent of our Sunday School. She has recruited a group of dedicated parishioners to serve in our Sunday School as teachers, staff members and class parents. This year, 100 students are enrolled in our Sunday School. I wish to thank our Sunday School teachers and staff for their dedication to our children.

b. Armenian School - This year, Armenian School classes are taking place on Sunday mornings from 9:45 to 10:30. Araxie Janjigian, a long-time dedicated teacher, continues to serve in our school. We are glad that this year we also have Apkar Potookian and his daughter, Marlene, as Armenian School staff. Mr. Potookian teaches language and his daughter, music and songs. I wish to thank our Armenian School teachers for their dedication to our children.

Both schools are tuition-free and parents are urged to take advantage of these opportunities.

*For their spiritual growth and their cultural identity, it is important for parents who have school-age children to bring them to the Armenian and Sunday Schools to receive religious and spiritual education and knowledge of their national heritage.*

#### 10. 75th Anniversary of the Martyrs

Nineteen ninety marked the 75th Anniversary of the 1915 Genocide of our people.

On the 75th Anniversary, special dispensation was given by the Primate to commemorate this event with the dissident Church.

a. On March 30th, I was invited to be present at the Governor's Office to receive the proclamation given by the Governor on this occasion.

b. On April 12th, Holy Thursday, during the Washing of the Feet Service, I invited twelve survivors and washed their feet. The Boston Herald gave coverage to this event with a picture.

c. On April 20th, the Speaker of the House of Representatives, the Honorable George Keverian, invited all Armenians to the State House to commemorate this event.

d. On April 22nd, we dedicated our new stained glass windows in the Church collectively in memory of the martyrs. We held a special dedication service in Church and honored the donors with a reception. The stained glass windows are reproductions from ancient illuminations from Armenian manuscripts that survived the deportations and the Genocide.

e. On April 23rd, with the participation of all the Armenian Churches, we held a Commemorative Service Program and Concert in our Church. All the clergymen participated in the Church Service. The Erevan Chorus performed under the direction of the Very Rev. Fr. Oshagan Minassian. His Eminence, Bernard Cardinal Law, Archbishop of the Roman Catholic Church of Boston, presided and spoke to our people. The Honorable George Keverian, Speaker of the House of Representatives, also addressed the audience. That evening, we invited survivors of the 1915 Genocide to be present in our Church. Over 800 people were in attendance and Channel 7 television gave coverage to this event.

f. On the evening of April 24th, I participated at the Requiem Service held at the monument dedicated to the martyrs in front of St. James Armenian Church of Watertown.

g. On another occasion, I participated at the dedication of a memorial plaque dedicated to the Armenian martyrs at Tuft's University.

#### 11. Special Events

a. On June 17th, we celebrated the 40th Anniversary of the ordination to the Priesthood of our Pastor Emeritus, Fr. Papken Maksoudian. On this day, our newly elected Primate, the Very Rev. Fr. Khajag Barsamian, was invited to celebrate the Divine Liturgy, deliver the sermon and preside at the Banquet. We also invited

the Armenian clergy from Massachusetts to be our guests. We are glad that our community once again honored our Pastor Emeritus for his dedicated service to the Armenian Church and to the parishioners of the Holy Trinity. The income from the Banquet was earmarked towards the printing of Father Papken's sermons into a book as a loving gift to him from his parishioners.

b. On September 30th, following Church Services, a posthumous tribute was given to our late Diocesan Delegate, Gregory Archie Kolligian. On this occasion, we presented to his family the Encyclical of His Holiness, the Catholicos of All Armenians, and the St. Gregory the Illuminator Medal in appreciation of Archie's benevolent contributions to the Mother See of Holy Etchmiadzin.

c. On October 14th, during the 29th Anniversary Banquet of the Consecration of our Church, we honored Dr. Michael Kolligian, Jr., as "Man of the Year". On this occasion, the parishioners expressed their appreciation to Dr. Kolligian for his leadership and dedication to our Church.

d. On two occasions, I was a guest of the Mayor of Boston at a luncheon: on May 14th, to mark the return of the Mayor from Armenia, and on September 11th, when the Mayor of the City of Yerevan, visited Boston.

e. On May 30th, our newly elected Primate invited the New England-area Armenian clergy to meet with him in our Church. Fourteen clergymen participated and the Women's Guild of our Church prepared and served the lunch.

f. On November 24th, we were honored to have amongst us His Eminence, Archbishop Kude Nakashian, Primate of France, who was our guest of honor at the Trinity Cotillion sponsored by the Women's Guild. His Eminence gave the invocation before the Banquet.

## 12. Stained Glass Windows

The second phase of our Church's stained glass windows was completed and dedicated on Sunday, April 22nd. The third phase will be completed before the spring of 1991. I would like to express my appreciation to Dr. Rudolph Sandon of the Sandon Studios for his artistic talents. I also want to thank Donald Tellalian, principal of Tellalian Associates Architects and Planners of Boston, for his guidance and critique during the reviewing of the drafts of the stained glass windows. On various occasions, I met with Donald and reviewed the work done.

I would also like to take this opportunity to thank all the donors of our stained glass windows. May God rest the souls of their loved ones in whose memory they have donated these windows.

## 13. Church Office

The Church Office is open five days a week, from 9:00 a.m. to 4:00 p.m., with a staff of nine people who work full-time or part-time, to carry out the work of our Parish. We are glad that this year the Parish Council invited Mrs. Nancy Kasarjian to be the Executive Director of our Church. Under her capable leadership and through the dedicated services of our employees, we try to meet the needs of our parishioners and our Church-affiliated organizations. I must say



that Holy Trinity is fortunate to have such capable and dedicated staff as our Executive Director, Rose Mamishian, Carol Krikorian, Seta A. Buchter, Tony Barsamian and Ben Saraydarian (past & present Youth Directors), Harvinder Jassal and Ara Dermovses, head custodian, and his staff. Special appreciation goes to our Pastor Emeritus, Father Papken Maksoudian, who continues to help us by carrying out his responsibilities in the Office and in the Parish. I would also like to express my appreciation to the volunteers who are called upon often to assist our Office Staff.

14. Appreciation

I wish to take this opportunity to express my personal gratitude to all our parishioners for their prayers, for attending Church Services, cultural events and social events of our Church, and for generously contributing to our Church to help us carry out our Lord's mission within the Holy Trinity family. I also wish to thank Father Papken Maksoudian, our Pastor Emeritus; Father Oshagan Minassian, our Choir Director; Al Zouranjian, Chairman of the Parish Council; the members of the Parish Council; our Diocesan Delegates; the Board members of our Trust Fund; the teachers and staff of our Schools; the members of our Choir; the Altar Servers; our Organist, Zavan Mazmanian; the executive members of our Church-affiliated organizations; and the many volunteers who come and work at Church affairs and functions, for their dedicated service to the Holy Trinity Church. May I also thank all the benefactors of our Church through whose financial contributions we are able to undertake special projects within our Parish. May God grant you all good health and long life to serve our Lord and our people through our beloved Church of the Holy Trinity.

The 1990 Parish Council respectfully submits the following Annual Report to the parishioners of Holy Trinity Armenian Church of Greater Boston. As the Trustees, we are called upon to oversee the management of our Church Parish and the many activities that go on to sustain it. Our involvement in these activities has shown us that our Parish has been blessed in many ways. We thank the parishioners who attend Church, participate in the many Church-related groups, and bring their families and friends to the many Church functions.

In April, Holy Trinity held several events for the 75th Commemoration of the Armenian Genocide. On Sunday, April 22, 1990, the stained glass windows in the Church Sanctuary were dedicated and a reception was held after Church Services. A special Requiem Service for the Armenian genocide victims was held on Monday evening, the 23rd of April. We were honored to have in attendance for the Services, survivors of the Genocide, His Eminence Bernard Cardinal Law, the Honorable George Keverian, and several area clergy members. In conjunction with the Requiem Service, the Erevan Choral Society, under the direction of Father Oshagan Minassian, performed special hymns. On April 24th, Holy Trinity participated in the Armenian community services that were held at St. James and St. Stephens Churches in Watertown.

At this year's annual Diocesan Assembly, a new Primate was elected. We were honored to have our new Primate, Bishop Khajag Barsamian, attend a special Banquet held in celebration of our Pastor Emeritus, Father Papken Maksoudian's 40th Anniversary of his Ordination to the Priesthood. The June 17th Banquet was co-chaired by Robert Proodian and George Haroutunian, and was a very successful event. Proceeds from the Banquet have been used to publish a book of Father Papken's sermons. The Parish Council and Diocesan Delegates were able to meet with the new Primate after the Banquet for a short discussion.

An issue that is a concern throughout the Diocese is the involvement of our Armenian youth in our Church. Holy Trinity has made a commitment to hire a Youth Director to encourage our young people. This year, Tony Barsamian and Ben Saraydarian have been working with our Parish young people through the ACYOA and Sunday School. Members of the Parish Council and the Pastor have also attended regional meetings to see how we can work to provide our youth with meaningful activities to involve them in our Church. We urge our parishioners to encourage our youth to participate in the many worthwhile activities that go on during the year. One of the sons of our Church, Alexan Kouzouian, was ordained into the Diaconate at the Cathedral of Holy Etchmiadzin, this summer. Upon his return home, the Parish Council hosted a reception for him after Church on July 22nd. Our Parish has generated several candidates for the priesthood which is a proud accomplishment in light of the need for new clergy.

The annual Church Picnic was held at Holy Trinity again this year in the Charles and Nevart Talanian Cultural Hall on September 9th. There were many people in attendance to enjoy the Armenian dancing to the Hye Echoes Band and the delicious Armenian food prepared by Anne Hintlian and all her volunteers who worked in the kitchen. On Sunday, September 30th, following Church, a posthumous tribute was given to Gregory Archie Kolligian. His Holiness, Vasken I, Catholicos of all Armenians, had honored him with an Encyclical and the St. Gregory the Illuminator Medal for his monetary contributions to the Mother See of Holy Etchmiadzin. The Pastor presented the Encyclical and Medal to his wife and family. In honor of this occasion, a reception was hosted by the Parish Council and Diocesan Delegates.

The 10th Annual Rug Sale was held from October 18th to October 21st this year. Robert Proodian supplied the rugs for the sale and Karen Martin served as Chairman for this fund-raising event. Also in October, Armenian Cultural Heritage Month was celebrated. The annual Stewardship Banquet was held on Sunday, October 14th. The Chairman for this event was Diran Zahigian and the meal was prepared by the Senior Women's Guild and served by the ACYOA. Dr. Michael Kolligian, Jr., was honored at the Banquet as "Man of the Year" for his services to our Church. This year's Banquet also marked the 10th Anniversary of the Stewardship Program. Chairing our 1991 Stewardship Committee is Nancy E. Hintlian. We know that the new chairman and her committee will continue to successfully raise over \$100,000 in stewardship pledges which is needed to meet the expenses incurred by the Parish.

The annual Holy Trinity Christmas Bazaar was held on two days, Friday, November 30th, and Saturday, December 1st, of this year. It was a very worthwhile fund-raising effort coordinated by Co-Chairmen Arpie Highgas, Aram Hintlian, Jr., and Greg Kassabian. On Sunday, December 16th, the Parish Council sponsored the Annual Christmas Concert for the community. The Erevan Choral Society, directed by Father Oshagan Minassian, performed a program of classical, Armenian, and traditional Christmas music.

During the year, the maintenance of our Church complex has been taken care of by our custodians, Ara Dermovses, William Serrano and Krikor Demirciyan. Besides their work for the various functions held, they have also refinished and painted the Church Vestibule, painted the Choir room and Johnson Hall, and painted the rear of the Parish House that had to be reconstructed this summer. Also, contractors had to repair the roof of Shahe

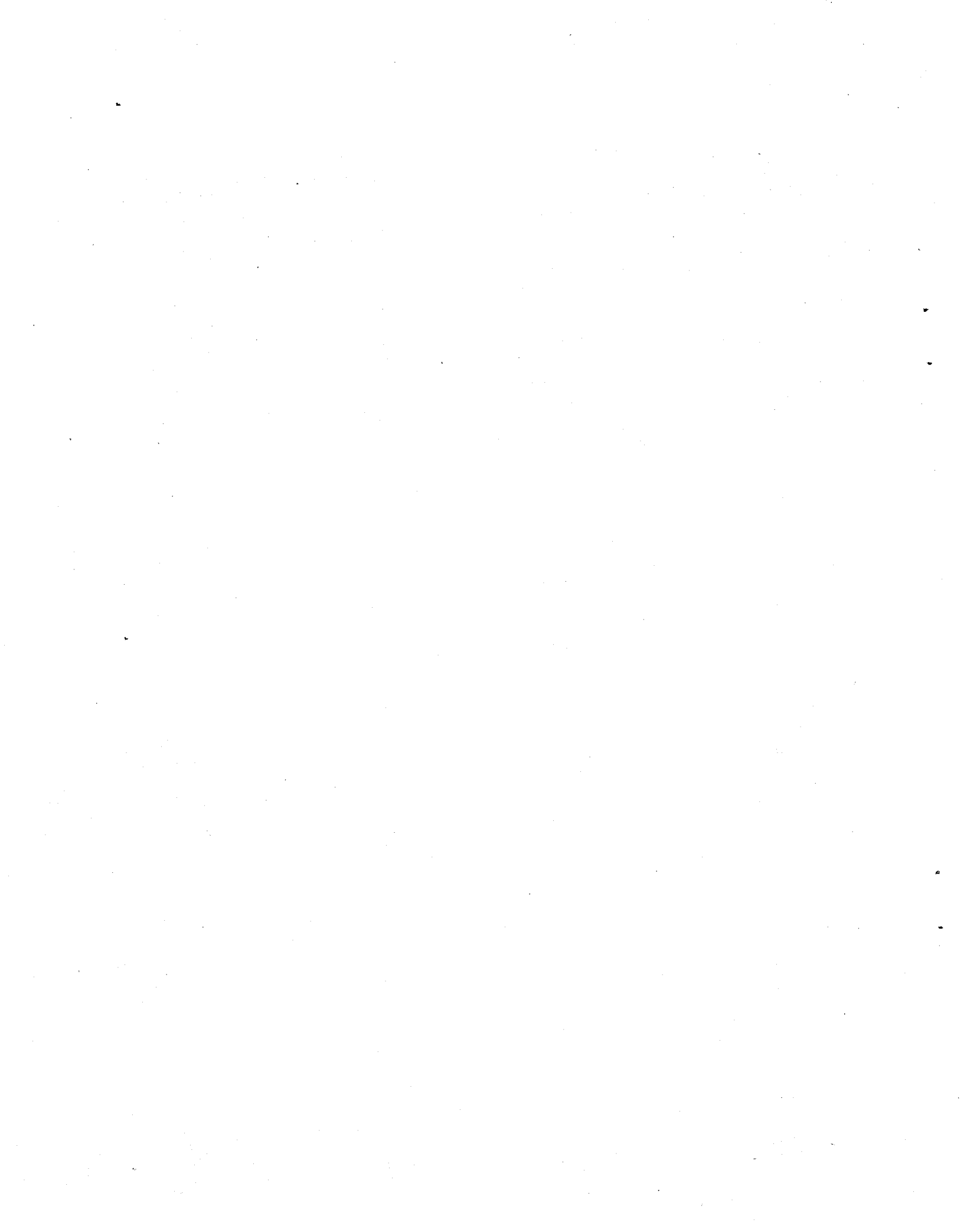
