ANNUAL PARISH ASSEMBLY
Sunday, February 7, 1993

The Annual Parish Assembly of the Holy Trinity Armenian Apostolic Church of Greater Boston was held on Sunday, February 7, 1993, following Church Services, in the Charles and Nevart Talanian Cultural Hall. One hundred thirty-six (136) dues-paying members were present.

The Assembly was called to order by Albert Zouranjian, Chairman of the Parish Council, at 1:15 p.m. He welcomed and thanked the parishioners for their attendance.

The Opening Prayer was offered by Reverend Father Mampre A. Kouzouian, Pastor, who asked those present to join with him in reciting the prayer in English and Armenian.

George W. Haroutunian, Chairman of the Nominating Committee, presented the slate for the day's Tivan, as follows:

Chairman: Donald Tellalian and Eugene Raphaelian

Eugene Raphaelian declined his nomination. Additional nominations for Chairman of the Day were asked from the floor. There being no further nominations, a Motion was made and seconded that Donald Tellalian be elected Chairman of the Assembly. MOTION PASSED.

Recording Secretary: Catherine Minassian and Nancy Young

Nancy Young declined her nomination for Secretary. Additional nominations were asked from the floor. There being no further nominations, a Motion was made and seconded that Catherine Minassian be elected Recording Secretary of the Assembly. MOTION PASSED.

Donald Tellalian, in addressing the Assembly, thanked the Nominating Committee and the Assembly on behalf of himself and Cathy Minassian for electing him Chairman and Catherine Minassian, Secretary. He expressed his appreciation for their vote of confidence and hoped to conduct the Assembly in a fair and effective manner.

In regard to the day's Agenda, the Chairman noted that between No. 10 and No. 11 New Business, the agenda item of Old Business would be inserted. Also he brought before the Assembly whether it was the desire of the group to elect a Parliamentarian for the Day, in light of the fact that he was not a student of parliamentary procedure. There was no response from the Assembly to elect a Parliamentarian of the Day.

MINUTES OF THE 1992 ANNUAL ASSEMBLY

The chairman of the assembly called for a reading by the Recording Secretary of the Minutes of the 1992 Annual Assembly. There were a number of issues set forth at that Assembly and they were read and portions were paraphrased in light of the fact that the complete version had been published and sent to all dues paying members. After the reading of the 1992 minutes a motion was made and seconded to approve the 1992 Parish Assembly Minutes as published. MOTION PASSED. Carol Krikorian was thanked for doing an outstanding job as Recording Secretary during a long meeting that year.

A motion was made and seconded that the reading of each and every report would be suspended, except for those that needed clarification at the appropriate time. MOTION PASSED.

Additional names for nominations were entertained from the floor. There being no further nominations, the nominating committee opened the Ballot Box at 1:45 p.m. for elections. There was a short recess in the proceedings for the purpose of voting.

The Chairman reconvened the Assembly at 2:15 p.m. and announced that the Ballot Box would close at 2:30 p.m. At that time it was noted that no corrections to the Annual Parish Report were apparent, so the Report stood as published.

PASTOR'S ANNUAL REPORT FOR 1992

The Pastor gave an overview of his report in both English and Armenian.

He noted that we can do better on Church attendance on Sunday mornings and that the most important part of Parish life is our Worship service.

The Pastor commented on the present situation in Armenia that we should help as a community as well as individuals since the future of Armenia depends on this. Some parishes have a line item in their budget to help Armenia. Helping sister churches in Armenia is one idea.

A motion was made and seconded to accept the Pastor's Report.
MOTION PASSED.

PARISH COUNCIL ACTIVITIES REPORT FOR 1992

At this time the Parish Council Chairman addressed the Assembly. He commented that the Council's theme this year was out reach to the parishioners. Also, he commented that in the near future additional funds would be required for needed renovations of the Parish House. A motion was made and seconded to accept the Parish Council Report as given. MOTION PASSED.

At this time the Ballot Box was closed and counting of ballots was begun under the direction of the Nominating and Auditing Committees, according to Church By-Laws. It was questioned as to why people whose names were on the ballots were also counting ballots. It was noted that no person handled a ballot if their name was on the ballot. The Chairman of the Assembly suggested that in the future the Committees put together a procedure so that those handling ballots had no interest in counting ballots.

PARISH COUNCIL FINANCIAL REPORT FOR 1992

The Assembly Chairman called upon Phyllis Martins, Treasurer of the Parish Council, to address any questions regarding the report. The amount for Clergy Stipend was clarified and it was noted that the Diocesan Dues included two years of Youth Ministry surcharges. A question was raised why there was not a line item for \$12,000 for Father Papken Maksoudian's pension. The explanation was given that since the pension had been sent three times and returned, refused by Father Maksoudian, it had been left out.

At this time the Chairman of the Assembly suggested that vote on the 1993 budget be deferred until after Old Business.

The Chairman of the Assembly thanked all the Church Organizations for their reports as printed in the Parish Annual Report as well as their contributions to the Church and community life. There being no questions or corrections to the reports as printed and in the interest of moving on to other issues, he suspended with the reading of the reports.

OLD BUSINESS

Discussion was held on the motion made at the 1992 Parish Assembly concerning a lifetime pension for Father Papken Maksoudian. Specifically, question centered on two issues, 1) What to do with the \$11,000 held in escrow and 2) what to do with the line item for the 1993 Budget.

Inasmuch as Father Maksoudian, on at least three separate and distinct occasions, had refused the pension payments and had returned the checks with a letter stating "not to bother him" further, the Chair entertained a motion by Robert Goshgarian and seconded to rescind the 1992 motion which states that "Holy Trinity Church shall pay a lifetime pension which represents the sum and total compensation of \$1,000 a month for a total of \$12,000 per year to Father Papken Maksoudian".

Discussion on this motion was held. In order to clarify Father Papken's feeling toward the pension, his most recent letter of refusal dated December 18, 1992 was read.

An amendment to the motion was entertained from the floor to change the word "rescind" to "terminate". A motion was made and seconded to change the word 'rescind' to 'terminate'. MOTION PASSED. Discussion was called, and voting was held on the original motion as amended, by a show of hands. MOTION PASSED. (Yes - 45, No - 23).

A motion was then made by Nancy Hintlian and seconded to keep the funds allocated by the 1992 Parish Assembly for Father Papken Maksoudian's pension in escrow, and consider alternative proposals that may be submitted by individuals or groups over the coming year for the use of these funds, and act upon them at the next Parish Assembly. MOTION PASSED.

It was also suggested that Church Counsel be consulted on the pension to clarify the legality of the issue.

NEW BUSINESS

A motion was made by Aram Hintlian, Jr. to increase Senior Citizen and Student church membership dues to \$50. The motion was made in light of the fact that the parish is assessed approximately \$45 per member by the Diocese and that there has not been an increase in the Parish fees in several years. The motion was seconded.

Discussion was held on what the definitions of senior citizen and student were. Senior Citizen was defined to mean age 65 and above and student was defined as anyone over the age of 18 who could provide proof of fulltime affiliation with an academic institution.

As discussion ensued, Aram Hintlian amended his motion to also increase regular church membership dues to \$75, along with the senior citizen and student increase to \$50. Question was called and the MOTION PASSED.

The Chairman of the Day expressed thanks to the Nominating Committee for their efforts and congratulated all those who had won as well as those who had lent their names to the process.

PROPOSALS FOR THE DIOCESAN ASSEMBLY

Greg Krikorian made a proposal that in light of the fact that across the Diocese there are Delegates that seem to have lifetime terms and that to increase participation he would like to propose that Holy Trinity sponsor a proposal for the 1993 Diocesan Assembly that "Dues paying members of a given parish, who have served two consecutive terms, which is 8 years, as a Diocesan Delegate, be ineligible to hold another term until at least 4 years have elapsed". The proposal was accepted by acclamation.

It was suggested that a report from the Diocesan Delegates be made to the Parish Assembly in the Annual Report.


PROPOSED BUDGET FOR 1993

Pastor's Annual Report 1993

Thanks be to Almighty God for granting us another year to serve His followers of the Holy Trinity Church. I also wish to thank the devoted parishioners of our Church for helping us to carry on our mission within our Parish.

Everything that was accomplished in our Parish during 1993, was the result of your support, cooperation and generosity. I am grateful to you for helping me execute my duties.

I would like to present to you my Annual Report for 1993.

I. Church Services

One of the most important roles of the Church is the coming together of the people of God to thank Him and praise Him through our prayers on Sunday mornings.

During this past year, we conducted Church Services according to the canons and rites of our Church. As in previous years, we conducted Church Services every Sunday with sermons delivered in English and Armenian.

I wish to express my appreciation to the following Reverend Clergy who conducted Services in our Church:

a. On January 3, 6, 9, and 10, Father Arsen Barsamian, Assistant Pastor of St. James Armenian Church, performed the Divine Liturgy.

b. On January 5, Father Dajad Davidian, Pastor of St. James Armenian Church, was our Guest Celebrant.

c. Father Massis Galstian, who was a "visiting clergyman" during 1993, celebrated the Divine Liturgy on January 24; March 7, 14, and 21; May 30; July 18; September 5; and October 3 and 31.

d. On May 23, His Grace Archbishop Nersess Bozabalian, Chancellor of the Mother See of Holy Etchmiadzin, celebrated the Divine Liturgy and delivered the sermon.

e. On August 29, His Grace Bishop Papken Varjabedian, Legate of our Diocese in Washington, D.C., presided over the Church Services and delivered the sermon.

f. On December 12, His Grace Bishop Houssig Bagdasian of Jerusalem, was our Guest Celebrant.

On some Sundays, when we had Guest Celebrants, I was able to visit the Sunday School, where I conducted the assembly program and visited the classrooms.

On several occasions, we conducted "Family Services" in our Church with the participation of the congregation. On Feast Days which occurred during the week, I celebrated the Divine Liturgy with members of the Senior Women's Guild receiving Holy Communion, followed by their monthly luncheon and program.

On Christmas and Easter eves, I conducted a short service for the children of our Armenian and Sunday Schools and administered Holy Communion to them.

I would like to publicly express my appreciation to our Choir Director, Father Oshagan Minassian, who also delivered the sermon on various occasions. I would like to thank our Deacons, Altar Servers, Choir members, and Organist, for their dedication and commitment. We are pleased that our Deacons are training some of our Sunday School boys as Acolytes and future Altar Servers.

I must say that we are living in a time when all the churches are facing problems which are affecting attendance at Church Services on Sunday mornings. We find ourselves in the same situation that most churches are facing today. In our Church however, irrespective of these problems, attendance is not what it should be. I urge our parishioners to give priority to attending Sunday morning worship service as this is where we receive our spiritual nourishment and strength. The Church is the House of God where His children gather together on Sunday mornings in His name to do His work in our world. I hope and trust, through your cooperation, that the coming year will be a better year for Church attendance. We need your support and participation.

2. Sacraments and Services

During 1993, the following sacraments and services were performed in our Church:

Baptisms: 16

Weddings: 13

Funerals: 30

Bethrothal service conducted by me: 1

Prior to these sacraments and services, I met with individuals and families to counsel them, to share their joy and, sometimes, their pain and sorrow. Wedding rehearsals were held prior to the wedding service.

On four occasions, I participated in the weddings of children of our parishioners which were performed in other churches.

3. Counseling Services

As your Pastor, one of my roles in the Parish is to be available to counsel our parishioners when they go through personal or family crises due to sickness, death of a loved one, or when

they are facing family problems. I also counseled young couples prior to their marriage. On many occasions, I reached out to our parishioners to bring them the message of the Gospels and to comfort them during a difficult time in their lives by praying, advising and supporting them. Through this counseling service, the Church reaches out to its parishioners to guide and support them.

I held counseling sessions with individuals and families, as well as young couples, on 63 occasions.

4. Pastoral Visitations

During 1993, I made 306 pastoral visitations to the homes of our parishioners, to the sick in hospitals, to the elderly in nursing homes (the Armenian Nursing Home in Jamaica Plain as well as others), to rehabilitation centers, and to hospice homes to pray and conduct services for our people. I also visited cemeteries to bless the graves of loved ones.

On August 11, I visited the Armenian Nursing Home in Jamaica Plain, with our Primate, the Primate of Canada, and five young people from St. Nersess Seminary to conduct services and visit the residents of the Home. On this occasion, the Friends/Volunteers of the Armenian Women's Welfare Association served a luncheon to the Primate and seminarians.

During Christmas, Mother's Day, Thanksgiving, and on other occasions, I called our parishioners, especially those who are elderly, sick, those alone in their homes, and those who had been missed in our Church, to congratulate them on the holy days, telling them they have been missed by the Church. These calls and the pastoral visitations are always appreciated by our parishioners.

5. Meetings

During this past year, I presided over and participated in 158 Parish-affiliated meetings, which included all the Church-affiliated organizations, their standing committees, executive bodies, and various individuals.

I also participated in the Regional Conference of the Clergymen of New England, as well as met with the regional Diocesan Delegates on two occasions.

6. Cultural and Education Programs

Under the auspices of the Holy Trinity Church, we held a series of cultural events in our Church and in the Charles and Nevart Talanian Cultural Hall, during the month of October, as part of our "Celebrate Armenian Cultural Heritage" program.

- October 1-3 Sculpture Exhibit featuring artists, Eugene Raphaelian, Kegham Tazian, and Robert Mardirosian
- October 10 Explanation of the Divine Liturgy during Badarak

- October 29-31 Photographic Exhibit: "Armenian Images: Church, Landscape, People" by Sam Sweezy, photographer, Country Roads/Armenia Cultural Project
- October 31 Concert by Sahan Arzruni, pianist, Celebrating Aram Khachaturian's 90th Anniversary

We wish to express our appreciation to all the artists who exhibited their work or performed in our Parish.

On December 12, we held in our Church our Christmas Concert, performed by the Erevan Choral Society and Orchestra under the direction of the Very Rev. Fr. Oshagan Minassian. The Primate of our Diocese was present and gave the closing remarks.

The Dajar, the monthly publication of our Parish, serves as a vehicle of information and education for our parishioners.

I conducted Bible Study for the Senior Women's Guild at their monthly meetings. Gregory Tashjian conducted Bible Study for our parishioners on Sunday mornings from 10:30-11:15 a.m. At the monthly meetings of our Church-affiliated organizations, individuals were invited to give presentations on various subjects.

We provided scholarships for higher education to worthy and needy students from our Parish. Funds were made available for Deacon Training Programs and for our Seminaries for preparation of clergymen for the Armenian Church. The Church also awarded partial scholarships to our Armenian and Sunday School students who attended St. Vartan Camp.

7. Our Schools

We are pleased that 104 students are enrolled in our Sunday School and 16 in our Armenian School.

The Armenian School meets on Sunday mornings from 9:45-10:30 a.m., under the leadership of Abgar Potookian and Sarkis Kavlakian. Marlene Seferian serves as the music teacher.

Our Sunday School convenes every Sunday from 10:30 a.m.- 12:00 noon, under the capable leadership of Seta A. Buchter, Superintendent. A group of dedicated teachers and staff members teach religion and Armenian culture to our children in 14 classes ranging in age from Pre-School through 12th grade.

The Armenian and Sunday Schools are tuition free and we urge our parishioners to enroll and bring their children to both Schools.

I would like to take this opportunity to express my appreciation and gratitude to all the teachers and volunteers for their commitment and devotion to our Schools and our Church.

8. Youth Ministry

Paula Jurigian served as our Youth Director until April. We wish to express our appreciation to Paula and her sister, Lana Jurigian, who volunteered her time to assist our Youth Ministry, for their devotion to the youth of our Parish. In mid-November, Leanne Dagavarian was appointed as Youth Coordinator of our Parish.

On Poon Paregentan, the ACYOA Juniors sponsored our pre-Lenten celebration.

During the Lenten season, the ACYOA Seniors provided Lenten dinners and special programs which were followed by participation in the "Peace and Rest Service" in the Church.

On Palm Sunday, the ACYOA held their annual Banquet and Program in the Charles and Nevart Talanian Cultural Hall, and on the Sunday preceding Thanksgiving, the ACYOA Juniors hosted their annual Thanksgiving luncheon for our parishioners.

On August 10, Nancy Kasarjian, our Executive Director, and I had a meeting with Anthony Barsamian, Esq., a former Youth Director of our Parish, and Nevart Hamamjian, Co-Chairman of the ACYOA Seniors, to cultivate ways and means to strengthen the youth organizations in our Parish.

The youth are a very important part of our Church community life, and we urge our parishioners to encourage their children and young adults to take part in the ACYOA programs and activities.

9. Special Activities and Events

- On May 28, the Diocese sponsored, with the participation of the Armenian Churches of Greater Boston, a reception in honor of Mayor Raymond Flynn of Boston, a staunch friend of the Armenians, on his appointment as Ambassador of the United States to the Vatican. The reception was held in the Charles and Nevart Talanian Cultural Hall. Our Primate spoke of the appreciation of the Armenian community for Mayor Flynn's friendship and efforts on behalf of our people and then presented Mayor Flynn with an Encyclical from His Holiness, the Catholicos of All Armenia.
- On June 3, Congressman Joe Kennedy was honored at a reception in Arlington, and I was invited to represent our Parish.
- I was interviewed twice by Belmont Cable Television; on July 21, I was interviewed for one-half hour, and on November 11, on the occasion of the 30th anniversary of the assassination of President Kennedy.
- On August 11, our Parish hosted the "1000 Mile Mission of St. Nersess". The Primate of our Diocese, accompanied by the Primate of Canada, and five young people from St. Nersess Seminary, were our guests for two days. They visited the Armenian Nursing Home in Jamaica Plain; conducted Church Services in our Church, spoke to our parishioners, and attended a reception held in their honor in Johnson Hall. The students were housed in our Rectory.

- On September 18, at the Mount Auburn Cemetery Chapel, I took part in an ecumenical service, addressed the guests and offered prayers.
- On September 26, I offered the Invocation at the Banquet honoring the Ambassador of the Republic of Armenia held at the Charles Hotel in Cambridge.
- On October 24, we celebrated the 32nd anniversary of the Consecration of our Church. On this occasion, we honored Mr. and Mrs. Sarkis Boghosian as the recipients of the "Man of the Year" award. We also honored Walter Sullivan, the former Mayor of Cambridge, as well as the outgoing members of our Parish Council.

We wish to inform our parishioners that from January 18 to December 18, Rev. Fr. Massis Galstian of Armenia, was our guest in the Rectory and assisted me on different occasions. Fr. Massis and his family have moved to Watervliet, NY, where he will administer to the spiritual needs of St. Peter's Armenian Church of Watervliet.

We wish to express our deep appreciation to all the kind parishioners who, in various ways, helped Fr. Massis and his family while they were in our midst.

10. Assistance to Armenia

We are grateful to our parishioners who made contributions during the year, either to our Church or to the Diocese, to aid our brethren in our motherland. We appreciated the efforts of our Women's Guild and the Sunday School who raised funds to help the children in Armenia.

During the year, we sent \$4,000.00 to the Seminary of Holy Etchmiadzin for the preparation of clergymen for the Armenian Church. We also sent monetary gifts to Holy Etchmiadzin to be distributed to the needy of Armenia. We sent \$1,000.00, through our Diocese, for the restoration of the Harija Monastery and the newly-established Seminary in the Diocese of Shirak. We sent \$1,000.00, which was collected by our Sunday School, through Holy Etchmiadzin, to the Diocese of Gugark, to buy shoes for the children who desperately need them. Armenians in the Diaspora need to make great sacrifices for our people and our motherland to survive. I appeal to you all to help us in these sacred endeavors.

During the past few years, we have helped individual Armenians who have come from Armenia to the Greater Boston area to study. We have given them a room in the Rectory on a temporary basis until they were able to find a more permanent place.

We have continued to assist Armenians in the Greater Boston area who have fled Baku, Azerbaijan, and settled here.

11. Church Office

Our Church Office is open five days a week, from 9:00 a.m. to 4:00 p.m. Under the capable leadership of Nancy D. Kasarjian, our Executive Director, and through the dedicated services of our employees, we continue to meet the needs of our parishioners and our Church-affiliated organizations.

We are sorry to say that at the end of October, Rose Mamishian, our Administrative Assistant and employee of our Church for over 24 years, had an accident in the Rectory and was confined to the hospital. We are glad that she is recovering and hope that she will be returning to the Church Office soon.

I would like to express my deep appreciation to Nancy D. Kasarjian, Rose Mamishian, Carol Krikorian and Seta A. Buchter for their professionalism and dedication to our Church. My appreciation is extended to Harvinder Jassal, Ara Dermovses, Paula Jurigian and Leanne Dagavarian for their unselfish devotion. I must publicly praise the capability and the total commitment of our employees to their work. I also wish to express my gratitude to the many volunteers who are called upon during the year for special projects and who come and assist the Church Office when needed.

12. Appreciation

I wish to publicly express my appreciation to our parishioners for their support and dedication to the Holy Trinity Church. I wish to thank Father Oshagan Minassian, our Choir Director; George W. Haroutunian, Parish Council Chairman; the members of the Parish Council; our Diocesan Delegates; the Board members of our Trust Fund; the teachers and staff of our Schools; our Deacons, the members of our Choir; the Altar Servers; our Organist; the Executive Members of our Church-affiliated organizations; and the many volunteers who come and work at Church affairs and functions, for their dedicated service to the Holy Trinity Church. May I also thank the benefactors of our Church through whose financial contributions we are able to undertake special projects within our Parish. May God grant you all good health and long life to serve our Lord and our people through our beloved Church of the Holy Trinity.

The 1993 Parish Council respectively submits the following Annual Report to the parishioners of the Holy Trinity Armenian Church of Greater Boston. As Trustees, our responsibility is to oversee the management of our Church Parish and the many activities it undertakes to sustain itself. Our involvement in these activities has shown us that our Parish is blessed in the fellowship of the Christian Spirit.

One of the most important items this year and one which demonstrated our true fellowship as a Christian community was in our reaching out to help Der Massis Galstian and his family in their time of need. By providing Der Massis the privileges of "visiting clergy" and a financial gift for the services he rendered, as well as housing, we were able to help him and his family while a Parish assignment was sought. Through the combined efforts of the Primate, our Pastor Der Mampre, and members of the Parish Council, Der Massis was offered an assignment at St. Peter's Church in Watervliet, NY. The kindnesses of our parishioners were rewarded in the satisfaction of reaching out to a family in time of need.

A Compensation Committee reviewed the salaries and job profiles of all church employees and made appropriate adjustments as necessary and where possible, to bring them more in line with the general workplace.

We continue to self audit our accounting practices throughout our Church bookkeeping systems and that of all the Church organizations to be assured of proper accounting methods. We will continue to work closely with our accountant for suggestions and guidance.

With the purchase of a new Hewlett Packard LaserJet 4 printer, we have been able to improve the efficiency and quality of printed materials; i.e., Dajar, weekly Sunday Bulletins, flyers, etc., produced by the Church Office, while simultaneously being able to reduce some costs. We will continue to seek ways to improve the operations of our Church Office, while keeping an eye on cost control.

The Dome continues to be a problem in inclement weather, but the Maintenance Committee is abreast of the problem and seeking a permanent solution.

As previously reported, the Parish House, which is over 100 years old, has been showing serious signs of age and wear and tear. The third-floor interior was extensively refurbished in 1993. However, there are serious and extensive problems on the exterior of the house as well as major renovations needed in the interior. With the assistance of an architect, the Building Committee has embarked on a plan which will be presented in the near future to renovate and remodel the Parish House.

The Church heating system continues to plague us. However, until such time that repairs and patching can no longer be administered, we shall make no changes as advised by an engineering consultant.

The floor in Johnson Hall was recently replaced due to the kind generosity of Hrant and Charles Johnson & Family. We are also evaluating the degree of upgrading that should be done to Shahe Hall.

In November, Leanne Dagavarian joined the Holy Trinity staff as our new Youth Coordinator, replacing Paula Jurigian who resigned in April. The Parish Council welcomes parents and grandparents to become involved in their Church, thereby involving their children.

During these difficult times in our daily lives and throughout the world, we appeal to our parishioners to attend Church Services more regularly and frequently. We all need your prayers, your physical presence, and your encouragement.

The Martyrs Monument Committee, whose responsibilities include the approval of the sculptor, the design of the monument, its location on the Church grounds, raising of funds, and ultimate dedication, continue in their efforts as the recent changes in Armenia have complicated a number of issues.

In support of the new independent country of Armenia, the Tricolor flag is now proudly displayed in the Charles and Nevart Talanian Cultural Hall.

The Church is a part owner of land in Florida and owner of another portion of land in Tewksbury. Each of these is non-income generating properties for which the Church is paying real estate taxes. A review is being made of the possible disposition of each property.

Our friend and Administrative Assistant, Rose Mamishian, had a fall and suffered injuries in late October. We are happy to report that she is doing very well, and we expect her to return

to some Office duties very soon. Krikor Demirciyan, our custodian, died suddenly in mid-October. The Parish Council extend their sympathy to his wife and children. The Parish Council express their appreciation to Carol Krikorian and Seta A. Buchter who increased their work hours since October, to meet the demands of the Office and, also, to Ara Dermovses who worked many extra hours to compensate for a short staff. In each case, they have been compensated accordingly.

Due to the efforts of so many of our parishioners who give so much of their time, our Annual Church events held in 1993, were both financially and socially successful.

- On Friday, May 28, a Reception was held in the Charles and Nevert Talanian Cultural Hall for Mayor Raymond Flynn of Boston, in recognition of his service to the Armenian community and to celebrate his recent Ambassadorship to the Vatican. The Reception was attended by our Primate, His Eminence Archbishop Khajag Barsamian, and various clergy and parishioners from different parishes.

- In September, the Annual "Trinity Festival", our Church picnic, was again held on the Church grounds. The traditional offerings of shish and losh kebabs and kheyma were all provided. Good food and good friends combined to make for a wonderful event. Many thanks to Co-Chairmen John Kefeyan and Bill Martin for a job well done.

- "Celebrate Armenian Cultural Heritage" month, held throughout October, began October 1-3, with an exhibit of sculptures by Eugene Raphaelian, Kegham Tazian and Robert Mardirosian. On October 10, an explanation of the Divine Liturgy in English was given during the Badarak. Our annual Stewardship Banquet celebrating the consecration of the Church in Cambridge, was held on Sunday, October 24. From October 29-31, a display of photographs of the landscape and people of Armenia was presented by photographer Sam Sweezy, as part of the Country Roads/Armenia Cultural Project. On October 31, pianist Shahan Arzruni gave a concert, performing selections celebrating Aram Khachaturian's 90th Anniversary.

- The Annual Banquet honored Martha and Sarkis Boghosian as recipients of the "Man of the Year" award for their continued support of and dedication to the Church. Over the years, their individual and combined efforts have been instrumental to the success of a multitude of Church events and service work.

- The 13th Annual Oriental Rug Sale was held October 14-17. This event continues to be a viable fund-raising activity for the Parish. This year's Committee of Debra Stevens, George D. Hagopian, George W. Haroutunian, Robert Proodian, the Church Office staff and many volunteers should be congratulated on a job well done.

- Under the direction of Marilyn Takvorian and Cathy Minassian, Co-Chairmen, and many key people, including the support of so many Church members, the 1993 Trinity Christmas Bazaar was another memorable and successful event. The Parish Council is grateful to all participants for their efforts and dedication. Parish involvement serves as a major means of support for the Church.

- Under the direction of Father Oshagan Minassian, the Erevan Choral Society once again led the celebration of the Christmas season with its Annual Christmas Concert on Sunday, December 12.

- On Sunday, December 19, the Sunday School presented its annual Christmas play after Church Services. A Reception was hosted for parishioners by the Parish Council and Sunday School following the play.

- "First Night at Trinity" brought together many friends from a number of parishes to bring in the new year. The sounds of the Hye Echoes Ensemble and DJ Robert Vartanian filled the Charles and Nevert Talanian Cultural Hall at this second consecutive New Year's Eve Dinner/Dance. We would like to thank the Committee for a memorable evening.

None of the above would have been possible without the hard work and dedication of so many parishioners to whom the Parish Council extends its appreciation.

The Pastor and Parish Council wish to publicly acknowledge and express their appreciation to the staff for their professionalism and total dedication to their work and to Holy Trinity Church. Special thanks to Nancy D. Kasarjian, Executive Director; Rose Mamishian, Administrative Assistant; Carol Krikorian, Secretary; Seta A. Buchter, Sunday School Superintendent; Harvinder Jassal, Accountant; and Ara Dermovses, Head Custodian.

The Pastor and Parish Council wish to thank all those parishioners who give freely of their valuable time to serve as volunteers for the many activities and organizations that meet the needs of our Church.

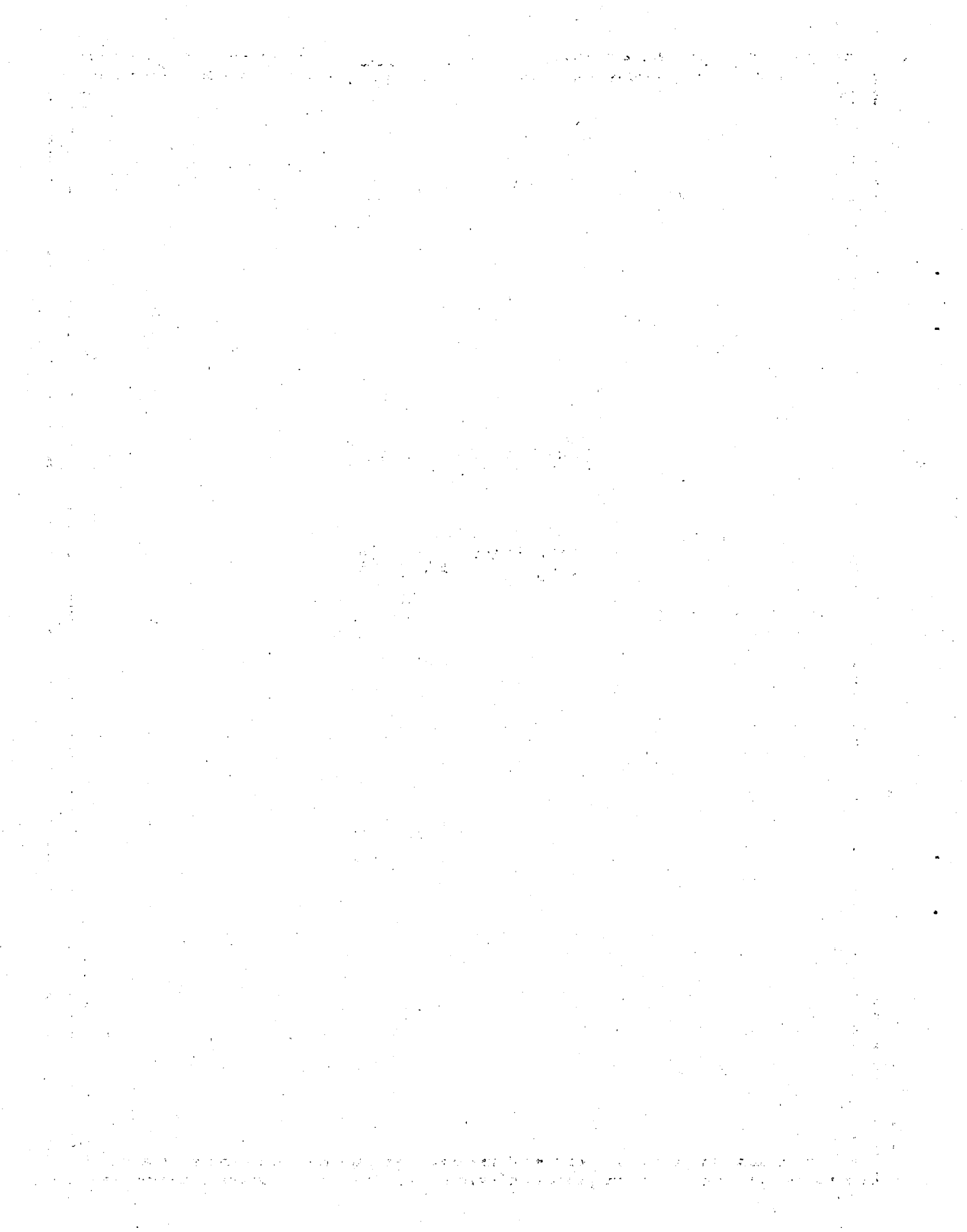

The success of the 1993 Stewardship Program was due to:

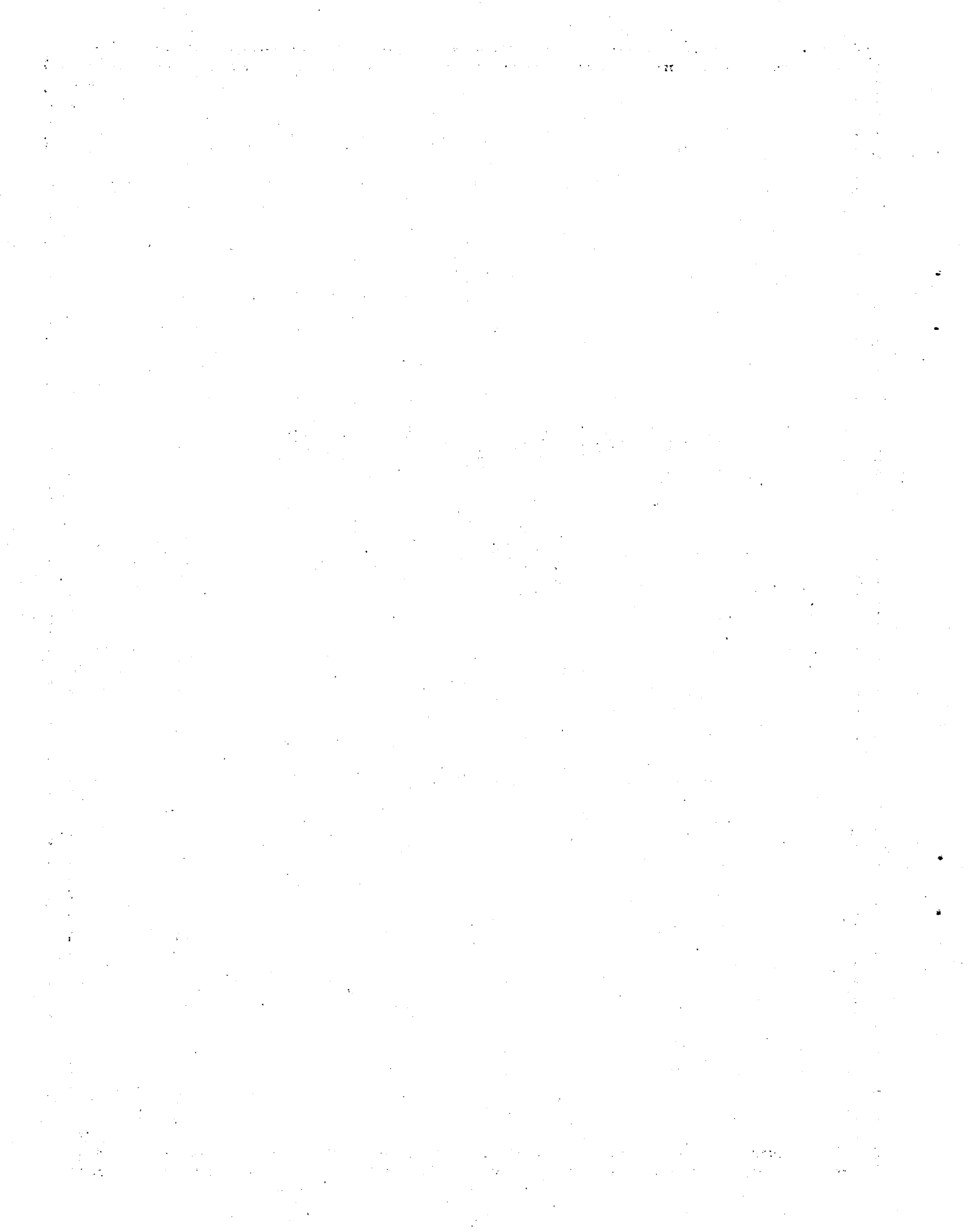
- parishioner participation and contributions,

3. The Armenian Issue: The membership has always been highly vocal when the subject of "state affairs" in our homeland has come up for discussion. During the past year, continuous recognition of the devastation, as it takes a variety of shapes and forms, in Armenia, goes without saying. In fact, three of our speaker presentations focused on some of the major issues as well as the geographic and cultural attributes of the country. They were as follows:

Rev. Fr. Massis Galstian presented a first-hand account of the Armenians as they exist with a tenacious commitment to survive in a difficult economy with very little natural resource and external supply of goods and services. He presented the Armenian people as a major contributing factor to Russia's scientific as well as business community.

Tony Barsamian presented an update of the issues surrounding the plight of the Armenians with respect to the Norgano/Karabagh issue and the state of relations with Azerbaijan.

Dr. Paul Barsam presented an interesting slide show depicting the condition of the medical care facilities, or lack thereof, in Armenia. The message was made clear that medical supplies and services are in short supply. Dr. Barsam also highlighted some very beautiful and religiously historical geographic sites during his visit. The encouraging aspect of his presentation concerned the care and support that he and many others were able to solicit from the international medical community. Our objective to both stimulate and sustain interest in Armenia and its destination is alive and doing well.

4. Interesting Meetings: The meetings throughout the year seem to captivate the interest of the membership as a whole. Other than those meetings mentioned above, the average agenda contained either video tape presentations or guest speakers relating topics of current events and other interesting information. Needless to say, food quality and quantity are always a big hit at these meetings and if that's the only attraction in some cases, then, so be it. On the subject of food, special thanks are extended to Helen Donabedian and Evelyn Dermenjian for food preparation as well as to those members who consistently volunteer for cooking and other kitchen duties.

In conclusion, I wish to extend my sincerest thanks to all the members for their continued attendance as well as financial support in keeping the organization together and whole. Additionally, our appreciation to the Church Office for correspondence and general clerical support is most heartily extended. As my term comes to a close, let it be known that it has been truly an enjoyable experience to serve as your Chairman as well as a member.
