Also approved at this meeting were the three (3) amendments to the constitutional by-laws of our Diocese.

Article 14(b): to elect a Nominating Committee composed of not less than three and not more than five members for a one year period. Said elected members to serve a maximum of two consecutive terms and after the interim of one year may be eligible for election again as members of the Nominating Committee. The remainder of article 14(b) shall remain

unchanged.

Article 61 (m): Parishes which fail to pay their previous year's Diocesan assessments automatically forfeit their right to vote at the Diocesan Assembly. Such parishes may reinstate this right by payment of their assessments in arrears of the prior years at the Diocesan Assembly.

Article 14(c): To elect Diocesan Delegates from the parish membership, said elected delegate to serve a maximum of two consecutive terms, and after an interim of four years, may become eligible for election again as a Diocesan Delegate. Those who receive the next highest number of votes in the same election shall be considered alternates in the order of their plurality.

A proposal was made to change the number of Parish Council members from the present 9 to 7. The proposal was accepted with 24 in favor and one against.

The meeting was adjourned and a closing prayer was said by Der Hayr Barsamian.
