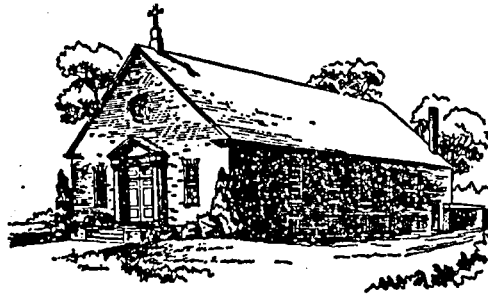

Parish Council.

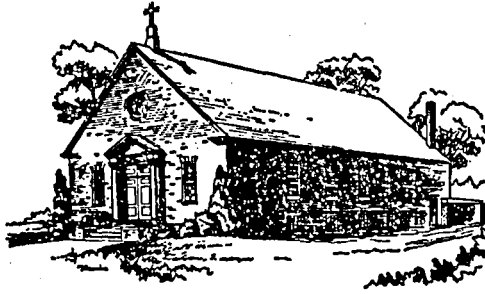
At a Parish Council meeting the matter was discussed
