

  - 2. That the marriage of the parties is irretrievably broken.
- 3. That the parties have freely and voluntarily entered into a Property Settlement Agreement dated March 10, 1992, providing for the disposition of all matters of the parties.

A. That the Findings and Recommendations of Special Master are approved and are incorporated herein by reference.
