

ACYOA Report to Parish Council
Feb 10, 1963.

Elections of the new officers for the Executive committee of ACYOA for the year starting June 1962 to 1963 took place on June 1962 at the church hall. Of the eight positions of the executive committee six were filled by five members (one person taking two positions recording secretary and publicity director). The following is the list of officers as elected in June.

1. chairman - Hagop Boyadjian
2. Vice chairman - Carl Zeytoonian
3. Treasurer - John Barouyrian
4. Recording secretary - miss Sylvia Kurkjian
5. Publicity director - " " "
6. corresponding secretary - Charles Takejian
7. 2 Advisers - None

During the months of June, July & August ^{activities} ACYOA was ~~in~~ ~~an~~ inactive except for the ^{following} Detroit Assembly to which a deligate was sent, ~~and also~~ and also in the promotion of new members into ACYOA. By Sept. 27 1962, when we had our first executive meeting, we had 12 members in good standing, and \$260.09 in the treasury.

By this time we had lost our vice chairman, and we also needed a publicity director due to the fact that one person (Sylvia Kurkjian) had assumed the responsibility of recording secretary and publicity director, a task too time consuming for one person. Thus miss Joyce Khosrofian gladly accepted ~~the~~ position of publicity director upon our request, and ~~so~~ Dick Hatchigian by becoming vice chairman.

Our activities for this year included the following:

- (a) Picnic at Norair's farm. on Sept 30, 1962 a profit of \$264.51 was made.
- (b) Regional conference: on Oct 20, 1962 in Richmond VA. with Miami Richmond & Philadelphia chapters
- (c) Ladies Auxiliary Bazar Oct 26, 27 1962

ACYOA helped in cleaning and setting up the church hall for the Bazar, and also provided girls and boys as waiters and waitresses.

(d) Clean up day on November 17 1962, as decided by a parish council meeting. ACYOA members cleaned up the church hall.

(e) Christmas Party; sponsored jointly by ACYOA and the Shnorhali group, at Gary and Queenie Avedikian's home, on Dec 8 1962. As a result of this party ACYOA increased its membership by two.

(f) Initiation of the new ACYOA members took place on Dec 16, 1962. 7 members were initiated. The Sponsor for the initiates was Ann Antonian.

(g) ACYOA Anniversary ball on Feb. 2 1963, at the Holiday Inn motel, in Arlington VA. This was our main Project for the last two months for ~~two~~ simple reasons:

1) Dances in the Washington area involve the most expense compared to our other functions,

2) Dances bring the least profit, if not losses.

Thus the executive committee together with the Anniversary ball committee worked very hard to ~~get~~ make the dance a success at the least possible cost. Although we still have some outstanding bills and income, at the present our profit on the ball is 43.06; this is subject to slight changes. This amount we have to send to the central council. At the present we have in our treasury \$284.04

This year we have paid \$100 to the parish council and \$105 to the central council in taxes.

It is our wish, and we hope to be helpful to the church and the other church organizations. Also we will appreciate any suggestions and constructive criticism from any one of the members of this church. And lastly we hope that you inform us of any prospective ACYOA members who for some reason are not acquainted with it presently. This will help us increase membership, thus building a stronger organization and consequently being of more service to our church.
