

Minutes of the Parish Assembly of St. Mary's Armenian Apostolic Church February 26, 1995

The Parish Assembly was called to order at 12:40 p.m. on February 26, 1995. Der Hayr opened the meeting with a prayer. Der Hayr asked that our dearly departed and greatly missed parishiners Knar Janigian, Lt. Col. Kenneth Perkins, Astrik Aznavoran, Ebrouhi Brown, Herman Carson and Ogda O'Gulian be remembered. The reading of the roll revealed that 52 of the 224 dues paying members were in attendance which constituted a quorum. David Zenian and Linda Ekizian were elected by secret ballot to serve as Chairman and Recording Secretary of the Assembly, respectively.

1. Minutes of the 1994 Assembly

The minutes of the 1994 Assembly were accepted without comment.

2. Nominating Committee Report

The nominating committee submitted candidates for Parish Council, Auditing Committee, Nominating Committee and Finance Committee as set forth in the Annual Report to the Parish Assembly. Der Hayr expressed his disappointment with the quantity and with the absence of some of Parish Council nominees at the Assembly. Parish Council Chairman Brig. Gen. Albert Kaehn Jr. emphasized that nominees are fully aware of the responsibilities of service on the Parish Council which oversees the daily operations of the Church. A motion was made to close the nominations which was seconded and the nominations were closed. The Nominating Committee submitted the ballots.

3. Pastor's Report

Der Hayr summarized the main points of his report contained in the Annual Report highlighting visitations of distinguished clergy, fundraising efforts as well as continued relief efforts for Armenia. Der Hayr expressed a desire to see that parish members welcome and assist in the acclimation new members of our Church who have arrived from Armenia. Der Hayr stated that fragmentation may result for the lack of effort in this regard. Der Hayr noted the success of the Bible Study sessions and welcomed greater participation. He was grateful for the response given for donations for earthquake victims in Japan. Der Hayr made an appeal to the parish for financial support. He noted that this is the 60th anniversary of St. Mary's and asked that the Parish Council propose ideas to mark this event. In closing, Der Hayr expressed his gratitude to the outstanding services of Yeretzgin and Brig. Gen. Albert Kaehn Jr. A discussion followed about the need for a revitalization of a membership drive. Dean Shahinian stated that Der Hayr is a member to the Diocesan Council and thanked Der Hayr and Yeretgzin for their guidance.

4. Parish Council Report

Parish Council Chairman Brig. Gen. Albert Kaehn Jr.led the report by expressing his appreciation to the members of the parish council. He summarized the report as submitted in the annual report. He highlighted the success of the joint New Year's Eve Celebration and hoped that this will continue. The Bazaar is a fund raising event that has become increasingly difficult to execute. He stated that the economics and energy expended on the annual Bazaar should be evaluated. A review of the Church renovation project was presented as per the Annual Report.

It was emphasized that no additional work or expenditures will proceed without the consent of the Parish Assembly. The need for the increase of dues paying members was emphasized to support the financial needs of the Church. Special thanks were directed to Beth Tutunjian, Jerry Hekimian and Onnik Sivaslian for their support. In discussion, it was stated that the Parish Council, Renovation Committee and the Finance Committee must review and enter into deliberations on building and renovation expenditures. A motion was made for the acceptance of the report, which was seconded and the report was accepted.

5. A.C.Y.O.A. Jrs. Report

Rober Safak read the report as submitted in the Annual Report. He stated that membership has grown to thirty plus members and asked for more parent support. To further emphasize the use of the Library, it was suggested that book reports be part of the Merit Award Program requirements. The report and Financial Report was accepted as read.

6. Diocesan Report

Dean Shahinian presented the report which summarized the Assembly meeting which convened during April 28 to May 1 in Houston, Texas. He stated that there was no further progress on unity. He stated that 2.5 million dollars have been spent on Cathedral renovations. The A.C.Y.O.A. participants expressed their desire to receive support from the Diocese. There is fraction between the Department of Youth Ministry and the A.C.Y.O.A. and a lack of response to the needs of the youth from the Diocese has caused considerable frustration. A Special Assembly has been called for the election of the Catholicos. Dean Shahinian was elected as a delegate and Der Hayr as an alternate. There has been no progress on the request to publish a guide to Church positions on issues. Dr. Kumkumian raised his concern that we lack guidance from the Diocese to embark on the 21st Century of the Church. Dean Shahinian and Der Hayr expressed disappointment in the Agenda of the Special Diocesan Assembly. Dean Sahinian recommended that we publish our concerns and proposals in Armenian/American newspapers which tend to receive the attention of the Diocese. In conclusion, Dean Shahinian stated that the Diocese is financially secure and is supported with the professional assets of our community offering a future potential that could be tremendous.

Der Hayr noted and thanked Clara Andonian for her services as our Parish Liaison to the St. Nersess Seminary, Mary Perkins and Col. George Juskalian as liaison for the Armenian Church Endowment Fund and Carl Bazarian who serves on the Board of Directors of DFAR and is Chairman of the Armenian Assembly.

A motion was made to accept the report, which was seconded and the report was accepted.

7. Treasurer's Report

Beth Ann Tutunjian offered the Treasurer Report and the proposed budget. It was stated that FY94 showed a loss because 1994 Bazaar expenditures were reconciled in 1995. Cost control measures were enacted on telephone service costs by cancelling the long distance service on the phone in the kitchen. Also, SHNORHALI mailings were reduced and the reply cards for donations were a success. Candle shells were donated to cut the cost of the purchase of wax candles for the Sanctuary. A suggestion from the floor was made to review and upgrade the

thermostat system. Collection envelopes were discussed and it was recommended that envelopes be distributed at the Christmas celebration. An emphasis was placed on increasing dues paying members. A motion was presented to accept the report and proposed budget, which was seconded and the reports were accepted.

8. Women's Guild Report

Lucy Murad presented the report on behalf of the Women's Guild. She stated that the Embassy of Armenia has relied on the Guild for many of their affairs and stated that this is labor intensive work. The report was reviewed as submitted. The co-chairs of the Women's Guild for 1995 are Seta Sivaslian and Alice Baker.

9. Choir Report

Clara Andonian read the report as submitted in the Annual Report. Der Hayr recognized Dr. Socrates Boyajian and expressed our deep appreciation for the publication of "Revised Sacred Music of the Armenian Church" in two volumes. The Treasurer's report was distributed at the Assembly. In answer to an inquiry from the floor regarding expenses, Arto Hovanessian offered an explanation that money was spent to celebrate those members of the choir who have offered many years of dedicated service to the Church Choir. He emphasized the desire to have young children participate in the Choir as part of the spiritual growth which is the backbone of our Church.

10. Shnorhali Report - Armenian Program

Jerry Hekimian submitted the report as published in the Annual Report. A motion was made to accept the report, which was seconded, and the report was accepted.

11. 3M Adult Fellowship Report

The report was accepted as published in the Annual Report.

12. Ararat Avak Society

The report was accepted as published in the Annual Report.

13. Shnorhali Report - Christian Education Program

Linda Ekizian offered the report as published and displayed the Shnorhali School book bag. She thanked the new teachers, Teri Tossunian and Janel Moosakhanian for their enthusiasm and Yeretzgin for the tremendous work she has done in educating our students during the half-hour assembly. It was stated that the Department of Religious Education of the Diocese completely supports our efforts as a school, through their publications, workshops and special projects throughout the year.

14. Bookstore and Balian Library Report

The reports were submitted as published in the Annual Report. It was stated that the current location of the library detracts from its use and a consideration is being made to for its relocation in the area of the old bookstore. Supervision of the room is recommended should the library relocate.

15. Armenian Church Endowment Fund

The report was submitted as published in the Annual Report. It was suggested that the specific purposes for each endowment (if any) should be identified in the Annual Report as it was done in the SHNORHALI newsletter.

16. Finance Committee Report

Ed Onanian presented this report by offering a historical overview of the foundation of the committee. It started as a building fund committee in the 1960 which received 50% of Bazaar proceeds for the purpose of building St. Mary's. The Parish Council receives the balance of proceeds. In the 1980's the Committee offered financial support to the renovations of the Church (to include air-conditioning). This was followed by the notion of renovating the Sanctuary. Following the earthquake in Armenia, investments were redirected for the purposes of relief. The proposed Endowment fund is established to meet 50% of Church operating expenses. The renovation project has been rejuvenated and the committee is waiting to see what the financial requirements will be to embark on expenditures and fund-raising campaigns. The Fidelity investment showed a loss for 1994 but the committee determined that since this fund was purchased as a long term investment, a withdrawal would be premature. A revised total expense contribution of The Finance Committee Financial Report was changed to \$77,443 through the funds established to memorialize Mrs. Ebrouhi Brown, Lt. Col. John Kenneth Perkins, Dr. Hovsep Yeni-Komshian and James and Angele Barouyrian. A motion was made to accept the report, which was seconded, and the report was accepted.

17. SHNORHALI Newsletter

Thanks were extended to Grace Sahinian for tremendous work and we offered our prayers for her full recovery.

18. Auditing Committee

Raffi Karahisar offered the report stating that the financial activity of the SHNORHALI is, unlike in other years, reported through the Parish Council's Treasurer's report audit. All active committees were audited and found to be sound. It was stated that the computerization of financial records is a great asset. It was suggested that each organization should be responsible for the monthly reconciliation of their bank statements.

PASTORS REPORT 1995

At the conclusion of the year 1995, I completed the nineteenth year of my service as the pastor of St. Mary's Parish. The following is a summary of my activities of the past year as your parish priest, which I humbly offer to God and to you.

A. SACRAMENTS AND SERVICES

B. SOCIAL SERVICES, PASTORAL ACTIVITIES & GUEST CLERGY

In addition to the regular Sunday worship, special services were held:

- 1. Christmas Candlelight Service. On December 24, in honor of the Western Christmas celebration, we held a candlelight service. The spiritual message was delivered by Miss Nairy Ohanian. The participation of the young adults and the Kalusdian Children Trio under the direction of Dr. Socrates Boyajian added special beauty and enjoyment. Those who attended will attest that it was spiritually rewarding and uplifting.
- 2. Baltimore Community. This is the seventeenth year we have been conducting Christmas Services with our choir participating. I continue to be in touch with the community and administer to it's spiritual and social welfare. Yeretzgin and I visited Baltimore on 3 consecutive Saturdays to hold classes. Yeretzgin taught the youth and I taught the adults.
- 3. Counseling and Social Services. The areas covered were hospital; nursing homes; personal, premarital and family counseling; job placement; housing; immigration and naturalization; Armenian heritage research guidance; personal recommendations; scholarship applications; court appearances and translation; educational testing translations; mediation and/or marriage counseling; lectures; social service, etc.

C. OFFICE ACTIVITIES

- 4. Church Office. During the year we had the services of a part-time secretary. Office hours were 9:00 AM 2:00 PM. The afternoon and almost all evening hours I personally use to carry on my responsibilities. We welcomed Deacon Hamlet Mehrabian as Pastoral Intern. He has been a great help and we wish him success in his future plans.
- <u>5. Publications.</u> The parish newsletter, the SHNORHALI, and full-size special issues were published five times, totaling over 200 pages (8.5 x 7) of information concerning our parish activities. Special thanks and gratitude I extend to Mrs. Grace Shahinian, the Editor of the SHNORHALI. Our general mailing list is over 1300, and the SHNORHALI, was mailed to 750 addresses. The average Sunday Bulletin printing was 130. In addition, numerous flyers, letters, and reminders were mailed for direct and effective communication with the parishioners. Often we had to follow up with extensive phone calls.

D. DIOCESAN AND OTHER ACTIVITIES.

- 6. Annual Diocesan Assembly. In May, I attended The Diocesan Clergy Conference and Annual Assembly held in Chelmsford, Massachusetts. Please read the details in the Diocesan Delegates' report. Prior to the General Assembly the Clergy Annual Conference was held at the same location. As a Diocesan Council member I attended the monthly regular meetings until May of 1995.
- 7. HAVAD. We continued to work on the Committee for the Propagation of the Faith of the Armenian Church (the Armenian acronym is HAVAD), I as the Vice-Chairman and Yeretzgin as the Secretary. Yeretzgin participated in an evangelical mission in July and I had the opportunity to continue the activities of Children's Christian educated-oriented camps in Armenian in July-August for three weeks, using my vacation time. Unfortunately I had to cut my stay short due to my illness as the group of volunteers who went with me continued the program effectively.
- 8. Visiting Clergy. We welcomed among us the Very Rev. Abraham Dz. Vartabed Mkrtchian, Diocesan Primate of Siunik, Armenia; who visited us with a special mission. We assisted him to accomplish his various missions. In my absence we also had several guest clergy who celebrated Badarak, delivered sermons and sacraments.
- 9. Armenian Evangelical Association. For a number of years now, we have welcomed the Armenian Evangelical Association's use to Church facilities for their meetings and worship. We had, in the past, frequently joined our efforts for common Armenian-Christian objectives. We shall continue to do the same.

E. ACTIVITIES RELATED TO ARMENIA

Being in the Nation's Capitol our community is in a special position to do a little more than other parishes.

- We continue to host a regular stream of official delegations from Armenia, with receptions and by providing transportation and escort assistance.
- We have welcomed artists, performers and have provided them with our hospitality.
- A number of visitors as well as those who have settled in this area have received medical, dental and other necessary care. We thank our medical and dental doctors in the area for their gracious and generous help.

We continue to:

- Support the mission of HAVAD
- Support the Diocesan Fund for Armenian's Recovery (FAR)
- Support the Orphan's Fund
- Support the "ARMENIA FUND"
- Support the Diocesan sponsored Sister Sunday School "School Bag" program.
- Act as conduit to help those who have relatives in Armenia.
- Support the Washington based Armenian-American Health Association.
- support the Armenian Embassy here in Washington with volunteers.
- We have helped the Embassy during the commemoration of the 80th Anniversary of the Genocide held on Capitol Hill.

There is a new reality which must not escape our attention and care. In addition, to all the previous "Tzees" (= Kharpertzees, Malatyatzees, Arabgirtzees, Beirut-tzees, Bolsetzees, etc.) now we have the Hayasdantzees. We can't compete with California with numbers but we can compete by being hospitable and helpful.

I am happy to inform you that we now have two special classes in the Shnorhali School teaching Eastern Armenian in response to the growing number of Hayasdantzees and Barsgahays (Armenians from Iran).

Last but not least we should also be politically active in support of Armenia and Artzakh. I assure you I am not asking anything that you already are not doing....except we should do it consistently and vigorously - by letters, phone calls, telegrams, faxes etc. - to our Senators, Representatives and to the President of the United States to bring peace to the region.

F. ORGANIZATIONAL

I carried on a direct effort to solicit ideas and suggestions through private and group consultations on a variety of subjects.

- 10. Parish Council. As the Pastor/President, I presided over and participated in the deliberations of the Parish council at the regular and special meetings, except when I was ill or out of town. It was a productive year and the Parish Council members should be commended for their dedication with the leadership provided by the Chairman Mr. Paul Murad.
- 11. Auxiliary Organizations. I continued to work closely with the church organizations and presided over their regular and special meetings except when they were held on Sunday after church services or when I had to be away for an emergency. Women's Guild, Choir, Shnorhali School, Jr. ACYOA, Three "M" Adult Fellowship, and Ararat Avak Society continued to function effectively. My special thanks to all the Executive committees and their respective chairmen, principals, teachers and advisors for their diligence and dedication.

I would like to single out the choir because of the increased activism as well a improved performances. Our thanks to all the members as well as to Mr. Arto Hovanessian, Chairman and Dr. S. Boyajian, Choir Director.

G. EDUCATIONAL, CHARITABLE AND CULTURAL ACTIVITIES

- 12. I regret for the second time to report that there was none to benefit from the educational experience provided by the St. Vartan Summer Study Conference and St. Vartan Camp this year. Funds to encourage the participation of our youth were available from the Hovaness and Marie Simonian fund, Valentine Bostonian Stahl Fund and the Fr. V. Kalayjian Fund.
- 13. Lenten Evening Services, lectures and Mediations. By guest speakers and parishioners were offered not only for worship but also for an opportunity to learn and mature in our Christian heritage. the Friday Night Lenten talks were offered along with a traditional light Lenten supper. For Lenten Sundays I invited our parishioners to offer the Sunday Meditations in lieu of the pastor's sermons. We shall continue these inspirational activities.
- 14. Young Adult's Sunday. Along with the first Sunday of the month being Sunday School Communion Sunday, the third Sunday was observed as Young Adults' Sunday. To complement these Sunday programs a series of lectures were organized by Dean Shahinian under the title "Armenian Life". I have observed that these lectures are received as very informative, educational and inspirational. We thank Dean for his continuous contributions to the spiritual enrichment of our community.
- 15. St. Mary's Charitable Fund. The Fund continued to be an avenue through which parishioners made contributions to help those in need of assistance. Also, the SHNORHALI School students regularly bring non-perishable food for the homeless of the Metropolitan Area. In addition the

Funds raised for Armenia, other charitable activities included helping to re-locate Armenians from Armenia.

- 16. Bookstore. We thank Mr. Rostam (Armik) Khatchaturian who has effectively taken the responsibility. We thank him for his dedication.
- 17. St. Mary's Balian Library. Our thanks to Ms. Elizabeth Kayaian Garabedian, who continued her task with concern and dedication. The library's change of location has not materialized yet. We hope it will happen this year.

H. MISC, CULTURAL EDUCATIONAL AND SOCIAL ACTIVITIES.

18. Church Anniversary. We were hoping to celebrate our community's 60th Anniversary as usual with candle lighting and expressions of appreciation to the members of the Women's Guild. As in the past years "Pastor's Recognition Award" was given this year also. The recipients were: Mr. Jerry Hekimian and Mr. Vartkes Keshishian. The "Volunteer of the Year" award was given to Brig. Gen. Albert Kaehn.

The celebration of the 60th Anniversary with the necessary attention did not materialize. We hope on April 14, 1996 when the Primate visits us we will do better.

- 19. Armenian Memorial Weekend. (April 24) Art Exhibit and Memorial Services with Madagh was held with area artists and our church youth participating. The Diocesan Cathedral Choir of Children and Students of the Diocesan Khrimian Educational Institute participated in the celebration of Holy Badarak and presented an exciting and beautiful program that made us all feel proud.
- As mentioned earlier On the Hill, The Armenian Embassy hosted a commemorative program and as a church we took part in the planning and execution of it.
- <u>20. Cultural Events</u> are being held more frequently. We have given our assistance and encouragement to as many as we can. I ask you to be responsive to them all.
- 21. 125th Anniversary of Komitas. We thank Mr. Arsen Sayian whose 40 plus year of service to the Armenian culture through Choral music, was recognized by our Community. A special concert celebrated the 125th Anniversary of great Komitas with groups from Richmond. Baltimore, Philadelphia and Washington area participating, 125 singers strong in the Ani-Knor Choral group.
- <u>22. President's Visit.</u> A memorable reception banquet was held for Mr. Levon Ter Petrosian, President of the Republic of Armenia.
- 23. The New Year's Eve celebration, with the whole Metropolitan Washington Baltimore community supporting and participating was another milestone creating goodwill and fellowship. We thank our co- chairman Mr. Paul Murad.
- 24. Yeretzgin and I launched a mini-program for the ACYOA Jrs. which is called "Merit Awards for Armenian Religious & Cultural Education". Through this program our youth will be exposed to the parish life practically in all it's endeavors and receive spiritual and cultural education as well. We thank Dean Shahinian, Esq. and Mr. Vartan Vartanian who graciously accepted to teach approximately 30 of our youth on Sundays alternating each other. The first phase of the program has ended. I have begun to instruct and train approximately 15 of them as acolytes, altar services and choir members.

- <u>25. Weekly Bible Studies</u> are now on a regular part of our activities. On Friday from 7-8 we meet to study the scriptures and to pray. We thank Dr. Gregory Kumkumian who spearheaded the effort and to a number of young adult parishioners who take turns in leading these studies. It is open to all, and we welcome all. Along with that, Deacon Hamlet has started Bible Studies for young adults on alternate Sundays.
- <u>26. "In House Retreat / Seminars"</u> were organized for the youth, young adults and adults on a variety of subjects and themes; Prayer Life Understanding / Appreciation and Participation in Holy Badarak Legal, Real Estate, Insurance and Financial matters.
- 27. We have even a more action packed and ambitious season ahead of us. As I have said before the challenge is just being there.

- 30. Altar Care. The list of the ladies helping to give the altar area the necessary care has remained strong. I thank all who made and donated MAS, repaired and made altar covers and vestments. Special thanks to Miss Ann Kavookian who continues to take care of the altar flowers and Christmas Greetings in addition to numerous other tasks she performs so lovingly.
- 31. The names of the parishioners to whom I feel particularly indebted. both as a person and as the Pastor, are too numerous to list. I am indebted to all the Executive members of the church organizations who, one and all, helped to make 1995 a rewarding year. I take the risk of sounding repetitious and routine by expressing my profound appreciation and gratitude to someone who happens to be, also, my life-partner / colleague / irreplaceable advisor in my pastoral duties and activities. She has also been serving on the Women's Guild Central Council in New York for the 3rd year. She has been the Spiritual and Armenian Education Program Director of Camp Nubar for the last 22 years. She also serves on the Executive Committee of the Armenian Medical Association of Metropolitan Washington. So, on your behalf and mine I thank Yeretzgin Anahid Kalayjian. Lest we take it for granted, we thank Deacons Vartkes Keshishian, Mark Krikorian and Stolebearers Jack and George Guiragosian who continue their services along with the choir members with almost perfect attendance.

As the new year begins, along with some of the visible accomplishments. for which we are proud and thankful to our Lord and grateful to all participating parishioners, we face new challenges. With God's blessing and your cooperation we hope to meet these new challenges during the months ahead.

Parish Council 1995 Annual Report

On Sunday, February 25, 1995, we held our Annual Parish Assembly. At that time, the new Parish Council was elected. With confirmation from the Diocese, a Special Parish Council meeting was held in April to elect officers for the calendar year 1995 with a term to last until the next annual Parish Assembly in early 1996.

The 1995 members of the Parish Council were:

The Parish Council meet usually twice a month during the year with special sessions to treat unusual events such as the Bazaar. Minutes for these meetings are available for review. Invitations were extended to Mr. Dean Shahinian and Dr. Ed Onanian who were Diocesan Delegates to attend these meetings. In general, the feeling of the new chairman was that many programs were actively underway and that these efforts should continue because they were in the best interest of the church and the Armenian community as a whole; this include a joint New Year's affair with Soorp Khatch. The following provides a list of the accomplishments and issues which are currently under advisement and planned activities.

- 1. One of the immediate activities undertaken by the Chairman was to discuss pertinent issues with each of the leaders of the various church organizations. These discussions focused upon current problems, issues, and solutions that would be addressed in the near future. Most of the problems identified by the chairman were minor and he felt that the state of the church and these organizations was healthy. Activities to correct some of the problems usually involved maintenance which were completed under Vartkes Keshishian.
- 2. Parish Council Liaison/Points of Contact for each church activity was assigned as follows:

Women's Guild- Evelyn Vartabedian
Finance Committee- Paul Murad
Choir- Arto Hovannesian
Shnorhali School- Arto Hovannesian

ACYOA- Greg Murad

- 3. Mr. Garabed Grehian had to resign from the council accepting a position in Saudi Arabia. He demonstrated expertise that was extremely helpful especially in areas involving building renovations. We expressed our gratitude and were sorry to see him leave. We wish him much success in his new endeavor.
- 4. Additionally, Mr. Veruir Aghamalian also left the council due to a change in vocation and time schedules that precluded his activities in supporting the council. The Chairman had to partially accept the responsibilities of Treasurer. Veruir's activities were also missed. On both of the above issues, the Primate was notified about these resignations and recommended to the Parish Council that a special assembly be convened to hold elections and vote for additional members for the council.

- 5. In keeping with previous Parish Assemblies' wishes, the council accepted Deacon Hamlet Mehrabian to join the St. Mary's staff. Deacon Hamlet's activities would grow from participating in altar and liturgical activities to include functions that included the Shnorhali School and the youth. Funding for the Deacon was provided by funds accumulated over the years for the Youth Advisor as well as from the Diocese. It also enabled the Parish to afford an opportunity of internship upon a future clergyman and prepare him for real-world problems that he would eventually face as a future Der Hayr.
- 6. During the summer in the absence of Der Hayr Kalayjian who went to Armenia with the HAVAD Mission and subsequent illness, we experienced a few problems in managing the Church's affairs. During that time period we were very fortunate to have the services of several clergymen who celebrated the Holy Badarak. It was during this Baptismal of Fire that Deacon Hamlet also extended himself assisting the Parish Council and the Chairman by daily communicating problems involving the needs of the Parish, and potential solutions that could be implemented during this time. His efforts were very much appreciated.
- 7. The date of the Picnic was initially moved from the beginning of summer to the end of summer as the new Parish Council grew to understand their responsibilities. This council had lost several members and had a very large turn-over. Five members were newly elected to the council. The Chairman and council decided that the picnic should occur and it proceeded with the help of many Parishioners under the leadership of Vartkes Keshishian and Arto Hovannesian. David Andonian made a donation to cover entertainment costs. The efforts of these individuals as well as others such as George and Jack Guirogossian are appreciated very much. The picnic was not a financial success and with only about 75 people in attendance, the Parish Council barely broke even.

- 8. We held a special Parish Assembly which had a twofold purpose; this was to elect additional members to the Parish Council as well as to inform the Parish Assembly about planned renovation activities involving the large hall, the front of the church, and the altar area. Members elected to the Parish Council included: Anahid Ayrandjian, Steve Evereklian who accepted the position of treasurer. Based upon these discussions, renovations on the large hall which were planned to be completed within two months for the 60th Anniversary celebration and the Bazaar were delayed.
- 9. The Docter's will which is a scholarship fund for children having one or both Armenian parents, is currently in probate and completion of probate is expected in January 97. At that time, the P.C. Chairman Paul Murad and Brig. Gen. Al Kaehn will proceed with legal advice as well as consultation from the parish council on establishing the William E. Docter educational fund.
- 10. Following the lead of the previous Parish Council, we entered into negotiations with Soorp Khatch for a joint New Years Affair. Because of the newness of the Chairman, the Parish Council Chairman of Soorp Khatch agreed to once again chair this event for the second year in a row. The affair took place at the Georgetown Convention Center which had the capacity to entertain 800 individuals.

Unfortunately due to unexpected factors such as the Government shut-down and His Holiness' visit which was not planned for, the event drew approximately 270 people with reservations for dinner for an income of \$18,005.00 and an additional 25 individuals took part in the dance portion of the festivities with an income of \$1,150.00. Additional funds amounting to \$723.00 were a result of

- a lottery for a total of \$19,877.80. Expenses to include the hall rental fee, the band, noise makers, cheese and other incremental costs were \$19,877.63. Considering expenses, the net profit of which St. Mary's share was of the order of \$0.20. Despite this, a net profit was realized in that both churches were brought together and a good time was had by all that attended.
- 11. At the request of our Church Choir under the Chairmanship of Arto Hovannesian, the Choir hosted an affair that honored Mr. Arsen Sayian for his over 40 years of service. This function was quite successful and other choir members were also acknowledged.
- 12. The Annual Bazaar was a success and a basic source of revenue for St. Mary's. Its success hinged strongly upon contributions from the Women's Guild and the Parish Council. The Council would also like to thank the contributions of the Bazaar Chairman Brig. Gen. Al Kaehn as well as his Assistant Chairman Mr. Onnig Sivaslian for their long hours and excellent contributions in making the event successful.
- 13. Our rug sale was also successful. Special appreciation and thanks go to Mr. Arut Koseian of Arut Oriental Rugs for his hard work. In addition to donating a beautiful oriental rug for the Bazaar raffle, Arut and his team moved these rugs from the store to St. Mary's for the sale. His time and energy are greatly appreciated by the Parish. Proceeds of \$2,914.00 from the rug sale are included in the Bazaar report.
- 14. An Anniversary Candle-Lighting Dinner was held. The Church honored recent recipients of the Pastor's Recognition Award. These included awards to Mr. Jerry Hekimian and Mr. Vartkes Keshishian for their dedicated services to the Church and to Brig. Gen. Al Kaehn as the "Volunteer of the Year". The wonderful meal was donated by the Mardirosian Family/The Flaming Pit who provided lamb shanks and by master chef Onnig Janjigian who makes the best fish in the world. Moreover, the Parish Council should also be thanked for their efforts in preparation of the meal, under the guidance of Yeretzgin A. Kalayjian.
- 15. Meetings were underway during the course of the year regarding the church renovations. This involved special meetings with the Architect and the Renovation Committee and included separate meetings with the finance committee, the Women's Guild as well as major sessions that were blocked-out during Parish Council meetings to discuss details and options.
- 16. During the course of the year, the Parish Council accepted contributions from the following organizations:

These contributions were greatly appreciated and helped the council meet its financial obligations. A loan was also received from the Finance Committee for \$10,000.

17. The Council contacted the Finance Committee to pay \$4,400 to have the sidewalk broken-up, crushed stone put in place, tamped, and repoured around the School building. STM construction performed this task and it included placing rebar and a mesh within the cement sidewalk. Prior to the repair, there was evidence of potential water damage in the basement of the School building and the sidewalk had separated both laterally and away from the building by as much as four inches in places allowing for rain seepage during heavy downpours.

18. The Parish Council recognizes the Chairperson and Executive Committees of our Church's organizations to include: Mrs. Alice Baker and Mrs. Seta Sivaslian of the Women's Guild; Miss Linda Ekizian of the Shnorhali School; Dr. Socrates Boyajian the Choir Director; Mrs Arousiag Kumkumian and Miss Ann Kavookian as Avak Society Coordinators; Mr. Armik Khatchaturian of the bookstore; Mrs. Elizabeth Garabedian for the Library; Mrs Grace Shahinian for the Shnorhali and our unending gratitude to Yeretzgin for her assistance whenever needed. We also offer our thanks to our Diocesan Delegates Mr. Dean Shahinian and Dr. Edward Onanian. We would like to thank the many others that have helped the Church during the past year and appreciate your future assistance as we enter an era of challenge that will eventually renew our faith.

19. The Priest, Deacon, and several members of the Parish Council and Parish were part of the Committee responsible for the Catholicos' visit to Washington. Unfortunately, the visit followed the Blizzard of 96 and despite snow covered streets and a very complex agenda, all events were performed according to schedule. A Herashapar service was performed by his Holiness at Saint Mary's and members from Soorp Khatch were invited to attend. Church service was followed by a question and answer session where his Holiness answered several questions provided by the youth from St. Mary's and Soorp Khatch. A dinner affair, M.C.ed by the Parish Council Chairman, was held at the J. W. Marriott with about three hundred people in attendance. In addition to the Armenian Ambassador, high level members of the Armenian government, the Ecumenical Council of Catholic Bishops which sent representatives as well as his Eminence, Cardinal William Keeler of the Baltimore Diocese, were in attendance. His Eminence Abp. V. Hovsepian, Primate of the Western Diocese, was also present as well as our own Primate. We congratulate Bishop Papken who received the title of Archbishop from His Holiness at the end of the Herashapar Service The visit in Washington was completed with a held at St. Mary. productive twenty minute conversation between His Holiness and President Clinton.

We agree that the following financial and related considerations shall apply to Fr. Kalayjian's services as Pastor of St. Mary's Church during the period set forth herein:

1. Stipend and Allowances:

These figures are based upon Diocesan guidelines regarding 1996 Clergy Stipend. In addition to this amount, the Parish Council voted for an additional cost-of-living increment of \$1,375.00 and a bonus of \$2,000. Which brings the total to \$46,580. The Parish will also make the required contributions to the Clergy Insurance and IRA accounts which are estimated at \$12,400. The Parish will assume the payment of all utility expenses (heating, electricity, water, sewer and telephone) at the Parish house.

2. Vacation: In accordance with the Diocesan vacation schedule, we agree that Fr. Kalayjian is entitled to four weeks of vacation to include four Sundays. Leave may be accrued with the prior consent of the Parish Council. As of 1/1/96, Fr. Kalayjian has no accrued leave from the 1995 calendar year.

As in prior years, except in emergency situations, two weeks notice will be provided by Fr. Kalayjian for extended leave. In addition, Fr. Kalayjian shall not be charged leave on the Sunday of the Diocesan Assembly weekend provided his return to Washington for services proves inconvenient. A similar policy shall apply in the event he chooses to attend the ACYOA and/or Choir Assemblies. An allowance shall be provided by the Parish toward lodging and travel expenses for attendance at the Clergy Conference and at the Diocesan Assembly. In the case of the ACYOA or Choir Assemblies, it is expected that these particular organizations provide lodging and travel expenses.

3. Duration: this memorandum of understanding becomes effective on January 1, 1996 and continues through December 31, 1996 provided that it receives the approval of the Annual Parish Assembly.

BAZAAR - 1995

The Church Bazaar was held on 8, 9, 10, 11 of November 1995. Due to a lot of hard work by dedicated and talented people, it was successful, although not as profitable as we would like. The Bazaar yieled revenues of \$ 19,907.13. That compares with a Bazaar profit of \$ 22,111.10 in 994. We conserved on our expenses this year but were hurt badly by the weather on Saturday, 11 November 1995. The rain at noon which turned to snow and wind kept the attendance down on what is usually a good day for the Bazaar.

Special recognition goes to the following individuals and groups of parishioners, whose contributions were particularly noteworthy: Onnik Sivaslian and Al Kaehn, the Co-Chairmen for the event; Jean Sayian, Clara Andonian, Alice Baker and Seta Sivaslian, for their leadership, guidance and toil in every phase of the Bazaar; the Team Chiefs, and all their Women's Guild people for organizing workshops for preparation of the food items which have become so well known; Mary Perkins for her special work in publicity; Ann Kavookian and Queenie Avadikian, who made the White Elephant a success; Valentine Stahl, who wouldn't let the gift table fade away; Jeanette and Leo Torokhanian, who handle the banners and a host of other logistic matters; Jerry Hekimian, the invaluable assistant treasurer; and Parish Council members who were active during various phases of the Bazaar.

We wish it were possible to include everyone's name who worked the Bazaar. Rest assured, that no matter how big or how small your contribution, it is deeply appreciated; with it, the Bazaar could not succeed!

FINANCE COMMITTEE REPORT

CALENDAR YEAR 1995

The Committee's activities during 1995 didn't include anything out of the ordinary. We continued to process memorial donations, meet the mortgage payments on the parish house, cover the cost of improvements and repairs at the church, and monitor our long-term investment account. Our interaction with the parish council included a briefing on the Committee's resources and activities which the council requested as it developed plans for the proposed sanctuary renovation. Committee members are Souny Kodjanian, Lucy Murad, Ed Onanian, Michael Sahakian, and Boghos Sivaslian.

Reviewing our financial experience in 1995, bequests (\$33,500) were our principal revenue source: we received \$25,000 in restricted funds from the estate of Philip and Oghda O'Gulian and a partial distribution of \$8,500 from the estate of Hermine O'Reilly. The Committee received its share (\$12,080) of the 1994 Bazaar proceeds in February, and anticipates a distribution from the 1995 Bazaar in early 1996. Donations in lieu of flowers (\$3,150) were at their lowest level since 1990, while interest income (\$4,428) was higher than in 1994. With the exception of a donation (\$100) to the altar fund, other earmarked donations (\$1,160) were for the Armenian Church Endowment Fund (ACEF).

On the disbursement side, the Committee met the cost of replacing the flooring (\$7,277) in the original hall, and provided \$1,150 from an insurance claim to renovate rooms behind the altar. In addition to monthly payments on the parish house mortgage, an advance payment (\$5,000) was made toward reduction of principal which now stands at \$28,800. Distributions of earmarked funds were made to the ACEF (\$1,000) for the Knarig and Dickran Janigian Family Fund and to the Armenian Assembly Tree Project (\$2,700) for a forest of 500 trees in Armenia in memory of Philip and Oghda O"Gulian. (The James and Angele Barouyrian Fund at ACEF was enhanced by \$2,000, but the funds were transferred directly from the donor's account.) In September, the parish council requested and received a transfer of \$10,000 for its operating fund, bringing the amount transferred since 1991 to \$25,000. An advance of \$15,000 to the Bazaar Committee was repaid following the event, and thus does not appear in our financial report.

Through October, we made monthly additions totaling \$10,000 to our long-term investment account. Later in the year, we began to transfer some of our assets from a balanced (stock/bond) mutual fund to a growth fund. With regard to the parish's holdings with ACEF, these amounted to \$81,678 at the end of 1995; the annual income from the ACEF is received directly by the parish council and is used either for operating expenses or the purposes stipulated by the donors.

As we look toward 1996, we find that most of the Committee's present and anticipated cash assets are earmarked for specific purposes and contingencies. Unless we embark on a fund-raising effort to generate additional income, the Committee will find it increasingly difficult to respond as it has since its inception to requests from the parish council for assistance. For several years now, the Committee has deferred such a campaign because of the uncertainty surrounding the proposed sanctuary renovation project. The parish's wishes regarding renovation are still uncertain, but it is very clear that the parish will have to generate additional operating and reserve funds if St. Mary's is to continue to provide the current level of services to its parishioners.

1995 SHNORHALI SCHOOL REPORT

The 1995-96 school year started with 96 registered students. Three students joined us recently increasing the number to 99. Five students dropped out and appropriate notes have been sent to their families. The average Sunday attendence is 60-65 students. Our school hours are 10.00am to 1.00pm. Classes start with Armenian language instruction, followed by Religion classes. The assembly period is conducted by Yeretzgin Anahid Kalayjian, followed by Armenian History and Culture class.

We are happy to report that our children are tought by such dedicated teachers as Miss Linda Ekizian, Rel. Program Director, Mesdames Anna Derderian, Tery Tossounian, Rita Bush, Jenel Moosakhanian, Talar Matikyan, Ani Derderian, Zvart Bolat, Marie Zulikian, Asanet Hachikoglu, Violeta Vartanian, Hripsime Sivaslian, Miss Ann Kavookian, Miss Debbie Onanian, Mr. Saro Kalayjian and Mr. Alfred Moosakhanian. Our substitute teachers are Mesdames Sona Bakirçi, Seta Sivaslian, Takuhi Hallajian, Louisa Baghdasarian, Dr. Ara Avedisian, Rita Tavitian, Nadia Koseian, Aida Guerigian, Evelyn Vartabedian and Rosemary Arkoian. About religious program and activities please read Miss Linda Ekizian's report.

This year we established a special class teaching <u>Eastern Armenian Dialect</u>. This newly formed class is tought by Mrs. Violeta Vartanian Kazarian.

Dean Shahinian, Esq. continued to conduct the special religious instruction one semester program for the young adults.

Mrs. Talar Matikian demonstrated a very good performance and her students liked her very much. Mrs. Hripsime Sivaslian has kindly taken her place and will teach the class during the second semester.

For the purpose of having a better working atmosphere in the school we published a discipline guidelines which basically follow MD Public School guidelines. They were mailed to all parents.

We recognize that it is important to reach out to the parents and secure their cooperation for the success of our objective. Therefore, we have formed the P.T.A. which holds its regular meetings under the leadership of Mr. Aram Paul.

Miss Silva Der-Stepanian, Director of the Diocesan Armenian Language Lab Center, was with us on November 19, 1995. She spent the first part of the day with the students in the classrooms and later met separately with the teachers and parents. She expressed her pleasure with the classroom instructions and gave helpful advise and kept the PTA updated on the curriculum materials and supplements.

On October 27, our school had its Halloween Party which was enjoyed by all....including parents. We also had a Christmas Family Nite on December 16, Mesdames Ellen Mooradian and Tery Tossounian with the help of a host of teachers and parents organized these events.

Every first Sunday of each month our staff and students continue to attend the Divine Liturgy, take Holy Communion and listen to Der Hayr's special sermons.

Our school, as any institution, is not free of challanging issues. For that reason we had a meeting with the entire teaching staff where we discussed some of the issues that we still need to overcome and proposed suggestions for the betterment of our small school family.

During 1995 Fall semester all our teachers showed great dedication in faithfully attending and successfully carrying out their classes each Sunday. We all owe sincere thanks and gratitude to each of our teachers for their great dedication. For the good attendance of our students our thanks go to all our parents for bringing their children to church every Sunday.

I must state that we have an **urgent need of classrooms**. At the present time we need at least three classrooms. Due to the lack of rooms we have been using the vestry as a classroom while the priest celebrates the Divine Liturgy a few yards away. Mr. Dean Shahinian holds his classes in the hall with constant interruptions of our parishioners. We have students to form a third grade but due to the lack of classrooms so far we have left few of them in the second grade and a few of them in the fourth grade. This causes its own difficulties for the second and fourth grade teachers.

I personally thank Der Hayr for his very helpful advice and ideas for the betterment of the school he generousely gave me all the time. Mr. Hekimian's help was tremendeus in introducing me with the school and some necessary prosedures as I newly arrived at St. Mary's. I thank him very much. We all should also remember our long time treasurer Mr. Raffi Karahisar and thank him for his excellent work.
