Dear Dr. Avedisian,

As a follow-up to the Parish Council's and The Parish Annual Assembly's decisions of last year, the election of two additional Trustees took place on January 24, 1999 at the regularly scheduled Annual Parish Assembly.

The result of the election conducted by a secret ballot shows that Mr. Vartkess Balian and Mr. George Dunyan received sufficient number of votes to be declared elected as Trustees of St. Mary's Armenian Church William E. Docter Education Fund. Mr. Vaughn Sayian, having received the next highest votes was elected as the **Alternate** who may be called upon to serve as a Trustee in the event of a vacancy. The result of this election was subsequently confirmed by The Primate and The Diocesan Council as our bylaws require.

According to the resolution #1 adopted at the same Annual Parish Assembly of January 24, 1999. The term of a Trustee shall be for three (3) years with the right to be re-elected for two consecutive terms for a total of six (6) years and after the interim of one year a Trustee may become eligible again for election.

The same resolution #1 stipulates further, to maintain continuity, that at the first election The Trustees shall be elected for **One, Two and Three** year term according to the plurality of votes they each receive. Thereafter, the election shall be for one Trustee each year to replace the one whose term is up. The result therefore is as follows:

Dr. Ara Avedisian, having already been appointed by the Parish Council and approved by the Virginia Courts, will serve Three years and his term will expire in the year 2002.



Mr. George Dunyan, having received 49 votes will serve One year and his term will expire in the year 2000.

Mr. Vaughn Sayian, having received 37 votes will be the alternate.

We submit these results of elections and the decisions reached at legally constituted Annual Parish Assembly with a legal quorum present for your implementation after securing the legal confirmation and /or approval of the Virginia Courts.
