

Your Grace,

I am writing to report very good news for our Armenian Church community. We have found land to purchase for a future church location.

The land, located in the greater Ann Arbor area will cost us \$27,500 for 1.74 acres. This land will be a tangible expression of our faith and commitment to building a church in this area. We also sincerely believe that this land will bind the Armenians together in a common cause and vision.

As of this date we have approximately \$11,000 in our bank account. We plan to deposit this amount as a down payment and borrow the remainder as a five year loan. We have calculated the monthly mortgage payment to be \$350, A dues system and a pledge program will be implemented to cover this amount. We have faith that we will be able to meet our financial commitments.

Personally, I am eager to donate \$1,000 to our church building fund in the hope that we will get your Grace's blessing to name our local church "Soorp Mariam", This name would be in honor of my beloved mother and would suit our community well.

We understand that the next Diocesan Board meeting is on November 24 and we hope to hear from you soon after regarding this matter. The proposed closing for this purchase is December 12, 1996.

We hope this information meets with your approval and that of the Diocesan Board. Your blessings and guidance are paramount in the success of this venture. We rejoice with you as you celebrate 25 years in the priesthood. We send our blessings and regret that we cannot personally participate in the celebration.

Your Eminence:

I have read the letter of the Ann Arbor Mission Parish dated November 7, 1996, and addressed to you. I have opted to abstain from voting on this issue for the following reasons:

- 1. Who is to take title to the land the Diocese or the Mission Parish if the latter, is it incorporated?
- 2. If part of the purchase price is to be borrowed, will it be in the form of a mortgage; if so, who will sign the mortgage documents?
- 3. The letter does not indicate that it has been approved by a majority of the members of the parish; nor is there available a copy of the resolution or minutes approving the sale.
- 4. A copy of the Contract should have been submitted so that the terms and conditions of the sale could be available.

In view of the lack of important information, I cannot approve of the proposal.
