Your Eminence:

We would like to express our heartfelt thanks and gratitude for your pastoral visit to our parish on February 22, 1981. Your presence in our midst was a great source of spiritual joy and encouragement.

During your gracious visit to us the parish council had the pleasure of presenting to you the plans for our new church building and had the privilege of receiving your constructive comments. We are happy to inform you that the development of the plans is rapidly progressing toward fruition and will soon be presented to the Planning Board and City Council of the Borough of Scarborough. Our architect is diligently working on the elevation plans of the new church building and will be making a special trip to Armenia in order to acquire further inspiration from our historic architecture.

As you are well aware the Toronto chapter of AGBU has acquired and held on our behalf a parcel of land of one acre adjacent to the soon opening Alex Manoogian Cultural Centre. The cost of that one acre lot will be about \$260,000, toward which we have already disbursed \$50,000 as initial payment some time ago. As the time is approaching the transfer of title of the land, we feel obligated to make a further payment toward the remaining major portion of our commitment to the AGBU and honour our agreement. Having received your authorization and blessing for our project the parish council would like to obtain the consent of your Eminence in order to effect the payment.
